PRESIDING OFFICER: (SENATOR DEMUZIC)

SENATOR VADALABENE:

Yes, on a point of personal privilege, Mr. Fresident.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Yes, state your point.

SENATOR VADALABENE:

I have in the gallery behind me the chief of the Madison Police Department and with him his pen pal from Surrey, England who is spending a month in the State of Illinois. He is a governor...he is a government investigator, Tony Farrell. Would you please stand and be recognized?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Oh, please stand and be recognized by the Senate. Welcome to Springfield. Senator Vadalabene.

SENATOR VADALABENE:

Yes, on another matter, Mr. Fresident and members of the Senate. Is the Rules Committee going to meet anymore?

PRESIDING OFFICER: (SENATOR DEMUZIC)

I...I don't...the Chair is not prepared to answer that, but I don't believe they are.

SENATOR VADALABENE:

All right, then. Let me...let me make this motion. The Motor Vehicle Laws Commission has a safety motor vehicle law bill which did not get out of Bules and it is of an emergency matter. And I...I would move to have House Bill 2784 discharged from Senate Rules Committee to be heard in Senate Transportation Committee on June 7th, 1984, which would be tomorrow.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Vadalabene has moved to discharge the Committee on Rules from House Bill 2784 and have that bill for consideration by the Transportation Committee on June 7th. Senator Fhilip.

SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. When Senator Bock and I had breakfast this morning, and I think our discussion came to the conclusion we'd probably not have another Bules meeting. To my knowledge that's where we are. Secondly, this side of the aisle has not been talked to or explained to the emergency nature of this motion and this bill. So I kind of think at this time, unless somebody has something to the contrary, we shouldn't entertain this motion.
