PRESIDING OFFICER: (SENATOR HALL)

PRESIDING OFFICER: (SENATOR HALL)

Senator Johns.

SENATOR JOHNS:

Thank you, Mr. President. I move that the Journal just read by the Secretary be approved unless some Senator has additions or corrections to offer.

PRESIDING OFFICER: (SENATOR HALL)

You've heard the motion. All in favor say Aye. The motion carries. Senator Johns.

SENATOR JOHNS:

PRESIDING OFFICER: (SENATOR HALL)

State your point.

SENATOR ETHEREDGE:

Mr. President and Ladies and Gentlemen of the Senate, my wife Joan and daughter Regina are seated in the President's

gallery and I would like to have them stand and be recognized.

PRESIDING OFFICER: (SENATOR HALL)

Will our guests please stand and be recognized by the Senate. For what purpose does Senator Davidson arise?

SENATOR DAVIDSON:

I need to ask leave of the Body for Senator Luft become the primary sponsor of House Bill 1772, to have it read Luft-Davidson.

PRESIDING OFFICER: (SENATOR HALL)

You heard the motion, is leave granted? Leave is granted. Resolutions.

SECRETARY:

Senate Resolution 221 offered by Senators Hall, Newhouse, Rock and all Senators. It is commendatory.

PRESIDING OFFICER: (SENATOR HALL)

... would like to suspend the rules for the immediate consideration of Senate Resolution 221. Is leave granted? Leave is granted. I move the adoption of Senate committee... Senate Resolution 221. All in favor say Aye. Opposed. So ordered. The resolution is adopted.

SECRETARY:

PRESIDING OFFICER: (SENATOR HALL)

Senator Maitland, what action do you want on your resolution?

SENATOR MAITLAND:

Just to...thank you, Mr. President. To suspend the appropriate rules and ask for the immediate consideration of Senate Resolution 222.

PRESIDING OFFICER: (SENATOR HALL)

Senator Maitland has asked for the suspension of the rules for a congratulatory resolution, Senate Resolution 222.

Is leave granted? Leave is granted. Senator Maitland now moves for the adoption of Senate Resolution 222. All in favor say Aye. Opposed. The Ayes have it. It's so ordered. The resolution is adopted.

PRESIDING OFFICER: (SENATOR HALL)

Consent Calendar. What...for what purpose does Senator Darrow arise?

SENATOR DARROW:

Point of personal privilege.

PRESIDING OFFICER: (SENATOR HALL)

State your point, Senator.

SENATOR DARROW:

In the gallery back behind us are four individuals in wheelchairs. If I could have some attention. These four came down to Springfield from the Quad Cities, the distance of a hundred and sixty miles. What's different, however, is they came down in their wheelchairs. At about ten miles per hour, it's taken them a number of days to get here. They contacted their legislators' offices to complain about vocational rehabilitation not funding the program for the disabled and turning money back to the State. And rather than write, they took upon themselves the task of coming down there in their wheelchairs. One thing it's proved to me as their State Senator is the Senate Chamber is not accessible to the handicapped. The best we could do, and I'm somewhat ashamed, is to have them back here in the gallery. There's no place in this Chamber for the handicapped, and I'm going to see if we can change that. But nonetheless, I wish we'd all give them a hand for their efforts in coming down here to seeing that the handicapped programs are funded in Illinois. Thank you.

PRESIDENT:

Senator Zito, for what purpose do you seek recognition? SENATOR ZITO:

Thank you, Mr. President. I would ask leave to suspend the appropriate rules so that House Bill 1164 can be heard in Local Government Committee today.

PRESIDENT:

House Bill 1164, the gentleman requests leave to have that heard in Local Government this afternoon. Is leave granted? Leave is granted. Senator Nedza, for what purpose do you arise?

SENATOR NEDZA:

PRESIDENT:

Senator Philip, for what purpose do you arise?
SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like to have the...believe it or not, I made a mistake. Senator Grotberg was not here yesterday because of illness, and I'd like the record to reflect that. Thank you. PRESIDENT:

The record will so reflect. Senator Hall, for what purpose do you arise?

SENATOR HALL:

Senator Newhouse is absent today because of death in the family, and I'd like for the record to so reflect.

PRESIDENT:

The record will so reflect. Senator Nedza, for what purpose do you arise?

SENATOR NEDZA:

Thank you, Mr. President. For a purpose of announcements, and there seems to be a lull in our proceedings. I would like to request that all the Senate members who are the sportsmen, basically baseball players, that we will have a practice this evening between the hours of five and six, we don't want to overtax anybody, at the school yard at the Capital and New Avenue. We'd ask that you come out there just to throw the ball around and see if we're still capable, because I think we can field a team this year that we can beat the House, God willing.

PRESIDENT:

Senator Mahar, for what purpose do you arise? SENATOR MAHAR:

PRESIDENT:

SENATOR DEGNAN:

Thank you, Mr. President. I would like to waive the Six-day Posting Rule on House Bill 1812 so it can be heard in Elections tomorrow.

PRESIDENT:

Request to waive the posting requirement for House Bill 1812. I might point out to the members, if anybody has a similar request, will you please contact Senator Bruce. We are attempting to compile a list to accommodate all members with respect to all bills, and...and we will, hopefully, get that done. But 1812, the Senator has requested that the posting requirement be waived and that it be heard in Elections tomorrow. Is leave granted? Leave is granted. Senator Smith, for what purpose do you arise?

SENATOR SMITH:

I'd like to request that Senator Savickas would be the hyphenated sponsor on House Bill 312, please.

PRESIDENT:

312?

SENATOR SMITH:

Yes.

PRESIDENT:

House Bill 312, the Senator requests that Senator Savickas be shown as a cosponsor. Is leave granted? Leave is granted. Senator Degnan.

SENATOR DEGNAN:

Thank...thank you, Mr. President. I'd also like to announce that the subcommittee on House Bill 663 will hear the bill at nine o'clock tomorrow morning in Room 400.

PRESIDENT:

Senator Netsch, for what purpose do you arise? SENATOR NETSCH:

Thank you, Mr. President. If this has not already been taken care of, and I did not hear it, House Bill 1280, I would like to...I'm assuming it has been assigned to Revenue, I would like to waive the Six-day Notice so that it can be heard at our meeting tomorrow afternoon.

PRESIDENT:

You've heard the request.

SENATOR NETSCH:

House Bill 1280.

PRESIDENT:

1280, requests leave to waive the posting requirement so that it can be heard in Revenue. Is leave granted? Leave is granted. Alright, House bills 1st reading. This is the last call today for House bills 1st reading.

SECRETARY:

House Bill 830, Senator Schaffer is the Senate sponsor.

3rd...1st reading of the bill.

PRESIDENT:

Senator Joyce, for what purpose do you arise?

SENATOR JEROME JOYCE:

Thank you, Mr. President. I would like to waive the

appropriate rule to hear House Bill 2106, 2234 and Senate Bill 1081. These are dealing with the interstate compacts on nuclear waste. They will be held the morning of the 14th of June at nine o'clock. This is a special order of business that we...we have...we waive the appropriate rule for Senate Bill 1081 so that it may be...and it...it is exempt from our rules now.

PRESIDENT:

Alright. Senator Joyce requests leave of the Body to hear House Bills 2106, 2234 and Senate Bill 1081 this Friday morning at 9 a.m. Is leave granted? Leave is granted. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I would like to have leave to add as my hyphenated cosponsor Senator Porest Etheredge to House Bill 670.

PRESIDENT:

670, the Senator seeks leave to show Senator Etheredge as the cosponsor. Is leave granted? Leave is granted. Senator Rupp, for what purpose do you arise?

SENATOR RUPP:

Mr. President, a point of personal privilege.
PRESIDENT:

State your point, sir.

SENATOR RUPP:

In the gallery to the left back of the Chamber we have a new man in politics in Macon County, and I'd like to have a chance to introduce him. He's H.D. "Skinny" Taylor, our county chairman. He's just been our county chairman for thirty-five years. And with him is Ben "Sonny" Bradley, a member of the board in Macon County.

PRESIDENT:

Will our guests in the gallery please rise and be recognized. Welcome. Committee reports.

SECRETARY:

Senator Savickas, chairman of Assignment of Bills Committee...assigns the following House bills to committee: Executive - 2277; Insurance, Pensions and Licensed Activities - 1048, 1611, 1707; Judiciary I - 1342 and 1466; Labor and Commerce - 2202; Public Health, Welfare and Corrections - 830.

SENATOR SAVICKAS:

SECRETARY:

Senator Vadalabene, chairman of the Committee on Executive Appointments, Veterans Affairs and Administration to which was referred the Message from the Governor of June the 3rd, 1983 reported the same back with the recommendation that the Senate advise and consent to the following appointments. SENATOR VADALABENE:

PRESIDENT:

You've heard the request. It appears it's without objection. Leave is granted, Senator.

SENATOR VADALABENE:

Mr. President, will you put the guestion as required by our rules.

PRESIDENT:

The question is, does the Senate advise and consent to the nominations just made. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 58, the Nays are none. A majority of the Senators elected concurring by record vote, the Senate does advise and consent to the nominations just made. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. And to be public administrator, guardian and conservator of Montgomery County for a term expiring December 2nd, 1985, Frederick D. Floreth of Litchfield.

And, Mr. President, having read the unsalaried appointments, I now seek leave to consider those appointments on one roll call unless some Senator has objection to a specific appointment.

PRESIDENT:

You've heard the request. Is leave granted? Leave is granted. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. Will you put the question as required by our rules.

PRESIDENT:

The question is, does the Senate advise and consent to the nominations just made. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? PRESIDENT:

SENATOR MAROVITZ:
