# PRESIDING OFFICER: (SENATOR BRUCE)

Will our guests from Senator Geo-Karis' district please rise and be recognized by the Senate. Senator Zito, for what purpose do you arise?

#### SENATOR ZITO:

Thank you, Mr. President. I would...I would ask leave of the Body to remove Senator Collins from chief sponsorship of

House Bill 104 and in...in her place add Senator Zito-Senator Carroll.

#### PRESIDING OFFICER: (SENATOR BRUCE)

Have you spoken to Senator...okay. The motion is to remove Senator Collins and have Senator Zito and Carroll as sponsors of House Bill 104. Is there leave? Leave is granted. For what purpose does Senator Schaffer arise?

SENATOR SCHAFFER:

Mr. President, to ask leave of the Senate to go on as a hyphenated cosponsor with Senator Dawson and Senator Smith on House Bill 207.

## PRESIDING OFFICER: (SENATOR BRUCE)

Alright, Senator D'Arco, let's...why dont' you hold the motion. We'll...we got to work out a few little technicalities here. (Machine cutoff)...Nedza, for what purpose do you arise?

#### SENATOR NEDZA:

Thank you, Mr. President. For the purpose of waiving the Six-day Notice for House Bills 1602 and 1603...leave to hear the bill at two o'clock this afternoon in Room A-1 in the Stratton Building.

#### PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Is there leave to waive the Six-day Posting Notice as to House Bill 1602 and 3, and that they might be heard in the Senate Committee on Local Government this afternoon? Is there leave? Leave is granted. (Machine cutoff)...Jones on the Floor? Senator Jones. (Machine cutoff)...purpose does Senator Demuzio arise?

#### SENATOR DEMUZIO:

Well, I think...the Transportation Committee, I think, is still going upstairs and I think that's where Jones is.

PRESIDING OFFICER: (SENATOR BRUCE)

Is Senator Dawson on the Floor? Senator Dawson. (Machine cutoff)...leave to go to the Resolutions Consent Calendar? Leave is granted. Mr. Secretary, have any Senators filed objections to any of the...the resolutions on the Resolution Consent Calendar?

#### SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock on the adjournment resolution.

# SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate.

PRESIDING OFFICER: (SENATOR BRUCE)

May we have some order, please. If we can take our conferences off the Ploor. Thank you. Senator Rock.

## SENATOR BOCK:

Senate Joint Resolution 53 is the adjournment resolution. When we close business today, it will call upon us to return to Springfield next Tuesday at the hour of noon. Next Tuesday at noon. In the meantime, the Calendar does not reflect the fact that the Executive Committee is scheduled to meet at two o'clock in Room 212. Two o'clock this afternoon in 212

for Executive. I would move for the suspension of the rules and the immediate consideration and adoption of Senate Joint Resolution 53.

## PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to suspend the rules for the immediate consideration and adoption? Hearing no objection, that is the order. On the motion to adopt, is there discussion? Those in favor say Aye. Opposed Nay. The Ayes have it. The resolution is adopted. Senator Lemke, for what purpose do you arise?

#### SENATOR LEMKE:

I just checked with my minority...spokesperson and we have a meeting set for Judiciary I immediately following Session. In reviewing the bills, we'd like to cancel that meeting and put those bills in the subcommittee.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Lemke.

## SENATOR LEMKE:

Judiciary I Committee, I am cancelling the meeting.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Sangmeister, for what purpose do you arise?
SENATOR SANGMEISTER:

Well, Mr. President, I want to speak to...was that a motion that was just made by the chairman?

PRESIDING OFFICER: (SENATOR ERUCE)

Well, Senator Lemke...Senator Lemke, in reviewing the rules...may I have your attention, please. There may be some interested parties. Senator Lemke has sought leave of the Senate to cancel the Judiciary Committee scheduled for two o'clock this afternoon. Under the rules of the Senate, that committee is scheduled for a hearing this afternoon, Senator Lemke, and I believe the only way that that meeting can be cancelled is with the...the leave of the Senate. Is there leave to cancel that meeting? I hear objection, Senator

Lemke. You, obviously, can...can adjourn the meeting with a requisite number of members when the meeting is...is convened. Senator Lemke.

#### SENATOR LEMKE:

Of course, under Robert's Rule, we can convene...the way that...that it reads, it starts after Session. So, when the chairman gets there, we'll start the meeting. That might be next Tuesday.

# PRESIDING OPPICER: (SENATOR BRUCE)

Well, Senator Lemke, under our rules it says at the time and place designated. And so, once a quorum is there, I believe that the committee can conduct business. Senator Sangmeister.

#### SENATOR SANGMEISTER:

Well, I don't want to get this into a hairy mess, but under...you know, there's a lot of bills that are important to a lot of people and to the people of the State of Illinois to be heard. In light of that statement, I now move that he be removed as chairman of Judiciary I for the purpose of this hearing this afternoon.

# PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Well, Senator, I believe that the Committee on Committees would make that determination as to the...alright. Senator D'Arco.

## SENATOR D'ARCO:

I just conferred with Leroy and we are going to have a meeting.

## PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator Geo-Karis, for what purpose do you arise?

# SENATOR GEO-KARIS:

Mr. President, we are going to have the meeting. I just conferred with my chairman since I'm the minority spokesman. So, I don't think it's necessary to go any further. We are

having the meeting right after the adjournment of this meeting here at this Session according to...Senator Lemke.
