2nd reading of the bill. Amendments No. 1 and 2 having been...Amendment No. 1 having been Tabled, Amendment No. 2 having been adopted, previously. Amendment No. 3, by the Committee on Finance and Credit Regulations.

PRESIDENT:

Senator Berman.

SENATOR BERNAN:

Mr. President, did I...there's Amendments 2 and 3 are what was adopted in committee, is that the status at the moment?

PRESIDENT:

No. Amendment No. 2, I think, is...is a leftover from the old bill. Alright. Senator Berman, we are dealing with Committee Amendments Nos. 3 and 4. On Amendment 3, Senator Berman.

SENATOR BERMAN:

Thank you, Mr. President. Let me...explain Amendments 3 and 4 together and then we'll move for their adoption as committee amendments. Amendment 3 and 4 together are the proposal regarding the Continental Bank situation, and the amendments together allow for a...a bank that has assets of over one billion dollars to certify certain facts, including that the bank is experiencing liquidity difficulties, that there has been an offer for acquisition and that that offer is desirable to protect the interest of the bank's,

depositors and creditors and such bank holding company has made an offer in form and with conditions acceptable to the bank, and that there has been no offer...by an in-state Illinois bank regarding that acquisition. Further, that there is a certification by the regulatory agencies as to those facts that I've just recited, and that the Federal Banking Agency approves the proposed acquisition. The time period upon that certification then runs and under Amendment 4, there is a fourteen-day period which allows an Illinois bank to submit an offer for the acquisition of the bank which is in trouble and if that fourteen day's period passes and no Illinois offer is received, then the acquisition may proceed. There is a sunset provision in here which repeals this Act as of July 1, 1985. Together, these amendments were both ... are, I think,...fair to say are the Continental Bank Amendment which is Amendment 3 as refined by Amendment No. 4 which was submitted by the Illinois Bankers Association and they represent and...in-state opportunity and if that is not available, an out-of-state opportunity for acquisition of Continental Illinois Bank. Be glad to respond to any guestions, and I solicit your Aye vote on adoption of Amendment 3 and then Amendment No. 4.

PRESIDENT:

Alright. Senator Berman has moved the adoption of Amendment No. 3 to Senate Bill 1236. Is there any discussion? If not, all in favor of the adoption of the amendment indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SENATOR CEMUZIC:

Thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. This is really an...technical amendment. This bill is a bill that would...coal mine saftey bill that would provide for one of the coal miners to accompany the State Mining Inspector. Unfortunately, in the bill

that's in the plural and, as a result, it is of the nature of representatives which theoretically can mean five, ten or fifteen or twenty. Amendment No. 1 to House Eill 2775 effectively deletes everything after the enacting clause. 2775 is the...was the Intergovernmental Missing Children's Becovery Act. It amends...it is an amendment to Chapter 127 and, frankly, in looking around for Chapters 127, this popped up. This amendment, Amendment No. 1, is an amendment to the Illinois Governmental Ethics Act and it is similar to that proposed by the Attorney General of this State with respect to changes in the disclosure of economic interest law. Effectively it will establish May 1st as the deadline for filing an ethics statement under this law. It will require the Secretary of State or county clerk within seven days after May 1 to notify persons who fail to meet the May 1 deadline. and it requires such persons to file then by May 15th and subjects those who file late to a late filing fee of fifteen dollars, which it has been related will pay for the costs incumbent upon such notice by the Secretary of State or the county clerk. Further, it subjects those who fail to file by May 15th to a hundred dollar per day penalty in addition to the fifteen dollar late filing fee. It will require the Attorney General with respect to State officials and employees and the state's attorneys of the respective counties regarding local officials to bring forfeiture of office

quo warranto proceedings against persons who fail to file altogether by the 31st day of May. It will allow an additional one month grace period for filing to persons who become subject to disclosure thirty days before May 1. This is a subject that has raised, obviously, a lct of interest. It's a subject that we debated at some length back in when, in fact, it turned out that a number of candidates for local office had not, pursuant to this new...then newly enacted law, in fact, filed their ethics statements. penalty of forfeiture of office is an extremely severe one and one that, frankly, ought to have as conditions precedent some safeguards. The Attorney General feels and I agree that it ... at the very least there cught to be a subsequent notification, so that if one forgets to file, one does not necessarily forfeit one's office. I would move the adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

On that question, the Ayes are 54, the Nays are none, none voting Fresent. House Bill 2711 having received the required constitutional majority is declared passed. Senator Sommer, for what purpose do you arise?

SENATOR SOMMER:

Mr. President, due to the fact of Senator Mahar's illness, I've been asked to replace him as the sponsor on three appropriation bills. Those bills are House Fill 2634, 2644 and 2647, and I would so move.

All right, you ve heard the request. Senator Sommer has..has requested to replace Senator Mahar on House Bills 2634, 2644 and House Bill 2647. Is leave granted? Leave is granted. It's so ordered. Senator Bock, for what purpose do you arise?

SENATOR ECCK:

Thank you, Mr. President and...Ladies and Gentlemen of the Senate, in the form, I guess, of an announcement. We have Appropriations scheduled to meet immediately after adjournment, and so I think it would be in our best interest to afford that committee the opportunity to meet as early as possible. I have deliberately distributed these to every member today to afford the members an opportunity to take a look, to see what, if any, changes they might wish to make and Senator Philip and I have agreed tomorrow we will get to that order of business on Senate Bills 3rd reading and deal with Senate Bills 1892, 1893, 1894 and afford any member who wishes the opportunity to submit any amendments. In the meantime, I hope that you'll take the opportunity to take a look at this amendment. I will say to you, again, that it essentially incorporates the recommendations of the Governor's Task Force on Tourism, but I think rather than delay the proceedings today, we will just if ... if the Body agrees get to that order first thing tomorrow, at moon tomorrow or shortly thereafter and attempt to deal with it then.
