You mean in the next fiscal year? You want the percentages, Senator Bruce? I can... I can read those off to you if you like. For the Legislative...for the Legislative Pension System, it will be three hundred and forty-five percent of the previous years contribution. And for the other systems, for the State Employees Retirement System, it starts out at a hundred and sixty percent for the first year, it goes up in...in yearly increments and reaches a high point in 1994 of two hundred and sixty percent. That's for the State For the State Universities Retirement Employees System. System, we start out at a hundred and six percent of the preceding years contribution and go to a high of two hundred and fifty-four percent in year 1994. For the Illinois...for the Downstate Teachers Retirement System, it starts out at a hundred and forty-five percent in 1984, goes to a high of one hundred and sixty-five percent in 1994. For the judges, it starts out at two hundred and eighty-six percent and goes to a high of three hundred and seventy-six percent. This, Senator Bruce, is the components that were ... were contained in Senate Bill 1223, as I recall. That was not are was not beard on 3rd reading.

PRESIDING OFFICER: (SENATOR DENUZIO)

Any further discussion? Senator Bruce.

SENATOR ERUCE:

Well...I'd like to know what the cost is? And I would like to know the justification...since we took out the substantial amount of money that was taken from the Downstate Teachers System this year, what the justification is, given the size of the system that we reimburse the teachers at a rate of a hundred and forty-five percent and we reimburse the poor old tired judges at two hundred and eighty-six percent.

I, you know, it just...equity is as equity does but it seems to me that to put the poor old judges at two hundred and eighty-six percent and the little old teachers at a hundred and forty-five and we've...after the end of this schedule we get them up to a hundred and sixty-five and I didn't see any-body that started less than a hundred and sixty-five. What's the rationale there?

PRESIDING OFFICEB: (SENATOR DEMUZIO)

Senator Maitland.

SENATOR MAITLAND:

Senator Bruce, I was not in the Pension Laws Commission when..., when this particular provision was...was debated. It is a...it is a...bill that came out of the Pension Laws Commission. It was an attempt to do what you and I both don't like what is happening as far as the contribution to the pension system. And this is a...an opportunity to put the Legislature, it seems to me, on...on record and ready to move forward to a very positive funding of all...all the pension systems, the five that we are responsible for.

Senator Bruce.

SENATOR ERUCE:

How much is it going to cost next fiscal year...the...the fiscal yearstarts July 1984?

It's my understanding it will be in excess of seventy-two million dollars over what is...is now planned.

Well, we're at fifty-one percent. Are you telling me we're going to fund at fifty-one percent and go up another seventy million, or are we talking about the budget amount of 74.5 percent of payout and then going another hundred and some million?

SENATOR BAITLAND:

What I'm saying to you is that...that the cost of this provision right here for next year will be seventy-two mil-lion dollars above what is now in the budget.

Just...just so we're clear that when the budget was submitted by the Governor before the doomsday, he told us that he would fund all these systems at 74.5 percent. So it's your statement here that it is...it is at the budget amount of 74.5 percent for the five systems plus...plus a replacement of the seventy-two million dollars we stole this year. So we're...we're back to where we were in the beginning, is that right, Senator Maitland or is this just...

Senator Bruce, I... I can't tell you for sure whether this

takes it to seventy-seven percent or above, I...I can't do that now, I'm sorry. All I can tell you is it's seventy-two million dollars in excess of what was in the Governor's budget, that's what the information before me indicates.

Well, I...there's a lot of controversy regarding this, I think it ought not to be in this Eody as an amendment. Now, there was a bill sent over from the Bouse, I don't know where it's at, but I think it would be rather inappropriate at this time to put on an amendment of this magnitude.

PRESIDING OFFICER: (SENATOR ERUCE)

Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. Fresident and members of the Senate. This bill was a House Bill 85, it passed the House, it had a fair hearing and it was approved by the House. It came over here, it was in the Senate Education Committee and it was never called by the Senate sponsor who picked up the bill. It's unfortunate that this is the way the Senate would have to consider this measure, but I do think since this bill received a fair bearing and was passed in the House that it should at least have an opportunity to be considered and voted on by the full Senate. This bill has received much fanfare in the media, back in Cook County and down here in committee and on the Floor. And it isn't as though anything is going to be sneaked through at the last minute. It's an issue that ought to be heard and debated on 3rd reading, and at that time this Senate can decide whether it wants to pass the measure.

SENATOR KEATS:

I was just going to rise in support of my seatmate and say; ope, the technical side, he ought to get his bill in the shape he wants it; but number two, we've passed a very similar bill although much harsher than this amendment. In fact, about thirty-four, thirty-six Senators voted for it last time when it passed the Senate last year, Don Totten was the sponsor of the bill, and that bill was a heck of a lot tougher than this amendment. So, I might throw in, it's not as if it's something we've never discussed, we've discussed it in the past. It has passed both Charlers and if the Senate sponsor wants it on his amendment, let him do it.

PRESIDENT:

SENATOR SHITH:

--- and also that Senator Newhouse would become a sponsor.
PRESIDENT:

207...show Senators Dawson and Newhouse. Leave granted?

Leave is granted. Further discussion on the Conference

Committee report on Senate Bill 328? Senator Mahar, you wish

to close?

SENATOR MAHAR:

Yes, thank you, Mr. President. While I agree with Senator Sommer is in the amount that's being paid to Mr. Hart is probably a little bit high, I want call the Body's attention to the fact that we have eleven million dollars of much needed funds for many agencies. This Conference Committee report has been bounding around for a couple of weeks now and things have been added to it and we have some agencies that are missing their payrolls because of it, and so I would ask a favorable vote.
