SENATOR RUPP:

Thank you, Mr. President. Republican Caucus immediately, Senator Pate Philip's office.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDENT:

(Machine cutoff)...will please come to order. Hessage from the House, Mr. Secretary.

SECRETARY:

A Message from the House by Mr. O'Brien, Clerk.

Mr. President — I am directed to inform the Senate the House of Representatives refused to adopt the first Conference Committee on Senate Bill 1010 and request a second conference to consider the differences between the two Houses and the Speaker has appointed the members on the part of the House.

PRESIDENT:

All right. Senator Carroll moves that the Senate accede to the request of the House. All in favor of the motion to accede indicate by saying Aye. All opposed. The Ayes have it. The motion carries. It's so ordered. Resolutions, Mr. Secretary.

SECRETARY:

Senate Resolution 1337, by Senator Dunn. It's congratulatory.

1338. by Senator Dunn and it's congratulatory.

1339, by Senators Rock and Jones and it's congratulatory.

PRESIDENT:

Consent Calendar, Mr. Secretary. If I can have your attention, the Secretary informs the Chair that Supplemental Calendar No. 1 has been distributed. Supplemental Calendar No. 1 deals with gubernatorial action in terms of specific recommendations for change on Senate Bill 2116. Mr. Secretary, with leave of the Body, we will move to the Order of Supplemental Calendar No. 1, motion in writing on Senate...with respect to Senate Bill 2116, Mr. Secretary.

I move to accept the specific recommendations of the

Governor as to Senate Bill 2116 in the manner and form as follows. Signed, Senator Weaver.

PRESIDENT:

Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. All this does is make the effective date immediately, and I would move that we accept the recommendations of the Governor.

PRESIDENT:

All right. Senator Weaver has moved to accept the specific recommendations of the Governor as to Senate Bill 2116. Any discussion? Any discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 2116 in the manner and form just stated by Senator Weaver. Those in favor will vote Aye. Opposed vote Nav. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. Mr. Secretary. On that question, there are 56 Ayes, no Nays, none voting Present. The specific recommendations of the Governor as to Senate Bill 2116 having received the required constitutional majority vote of Senators elected are declared accepted. All right. With leave of the Body, we'll move to page 7 on the Calendar. On the Order of Conference Committee Reports is a Conference Committee report on House Eill 2642. Middle of page 7, House Sill 2-6-4-2. Mr. Secretary.

SECRETARY:

This is the second Conference Committee report on House Bill 2642•

PRESIDENT:

Senator Joyce.

SENATOR JEROME JOYCE:

Yes, thank you, Mr. President. This bill...the original bill affects the municipalities and how they impose taxes or

license fees on vending machines. What it would do now is...currently, they can just put a license...or tax on them, this would require them to give a thirty-day notice before they did that. The second part of the bill...the overall effect of that part would be...it's a...provision that would simplify some taxes affecting the rental of motor vehicles in the City of Chicago. The City of Chicago would exempt...rental vehicles from the one percent sales tax on vehicles purchased outside the city and used in the city. Rental vehicles would then be subject to an increase leasing tax on all rental agreements written in...in any municipality which has or will enact such a law. The tax would increase from one dollar to two seventy-five per rental transaction. This legislation would implement an agreement worked out between the City of Chicago and the rental and leasing industry to remove all the road blocks to an orderly and implementation of the payment of the taxes. I'd be happy to answer any questions if there...

PRESIDENT:

Any discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Would the sponsor yield for a question?

PRESIDENT:

Sponsor indicates he'll yield, Senator Geo-Karis.

SENATOR GEO-KARIS:

The original bill said that this talks about your vending machine...problems, but it also says that it specifies cities...Senate Amendment 1. and I'm not sure if it's back in the bill, specifies cities and villages under the commission form of municipal government may vest themselves with a managerial form of municipal government. Is that still part of your bill?

PRESIDENT:

Senator Joyce.

SENATOR JEROME JOYCE:

Thank you. No, that part is out, Senator.

PRESIDENT:

Senator Geo-Karis.

SENATOR GEO-KARIS:

And then your second part of the bill, I think that you just explained, relates as to the rental of automobiles in the City of Chicago only as to one percent fee. Now would you explain that a little more because I wasn't quite sure I got that.

PRESIDENT:

Senator Joyce.

SENATOR JEROME JOYCE:

No, it...it's any city that would impose this...this law, and...and it would increase the tax from a dollar to two seventy-five per transaction. What happens, I guess, is the people don't pay their parking tickets and so forth with rental cars and this is seeking to correct that.

PRESIDENT:

Senator Geo-Karis.

SENATOR GEO-KARIS:

In other words, if I understand you correctly then, are you saying that rental cars...excuse me, if they have any parking fees they have to pay them? Is that what...is that what you're...I don't quite get it. Yeah, but I'm...

PRESIDENT:

Senator Joyce.

SENATOR JEROME JOYCE:

No, it just...it would simplify all of the road blocks that they've had. I guess there's been several court cases there and what it does is just increase the fee from a dollar to two seventy-five per transaction. So that would take care of those problems.

PRESIDENT:

Further discussion? Senator Savickas.

SENATOR SAVICKAS:

Well, Mr. Speaker...Mr. President, I was just going to add that originally when it was passed to solve a problem...the parking ticket problem, it was at a dollar. Then the court cases got involved and the city wanted to raise the fee, the car dealers or car rental agencies agreed to it just to get this going to clear up all the backlog and start fresh to accept the two seventy-five charge.

PRESIDENT:

Further discussion? Is there any further discussion? Senator Joyce, you wish to close?

SENATOR JEROME JOYCE:

Roll call.

PRESIDENT:

The question is, shall the Senate adopt the second Conference Committee report...on House Bill 2642. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, no Nays, none voting Present. The Senate does adopt the Conference Committee report on House Bill 2642 and the bill having received the required constitutional majority is declared passed. Resolutions, Mr. Secretary.

SECRETARY:

PRESIDENT:



Consent Calendar. If I can have the attention of the membership, we are obviously in a position again, as we always are at the close of a Session, waiting for paper to come back and forth and for copies to be distributed. We have four or five matters yet pending. It is hopefully our intent to conclude the business of the 84th General Assembly today before we leave. So, I think if we move with some dispatch, we can wind up our business, hopefully, within the hour. With leave of the Body, if you'll turn to page 4 on the Calendar, on the Order of House Bills 3rd Reading is House Bill 3133, and Senators Hall and Carroll have requested leave of the Body that that bill be returned to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd Reading is House Bill 3133, Mr. Secretary.

SECRETARY:

Amendment No. 2 offered by Senator Carroll.

PRESIDENT:

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is the three-thirty or now ten to five version of the most recent supplemental request for Fiscal *87 of the Office of the Governor, the other constitutional officers and the General Assembly requests. It has, I believe, been distributed in memorandum form to both sides of the aisle, so than rather go...than go through it in detail let me just identify that it is basically pass-throughs of Federal funds and other non-GR sources as a general rule certain specific General Revenue Fund requests that it was felt that there was sufficient general revenue to handle and that had to be done in a timely fashion such as continuing certain lawsuits. And...and also anything that had to do with implementing a

substantive law that has been signed into law by the Governor but for which no funding had been provided. We have attempted to take care of certain other emergencies that have been brought to our attention by various members of the General Assembly. It is a total package of some hundred and thirty-seven million of which however a hundred and eleven million is non-GRF items. I would be willing to answer questions and would ask for a favorable adoption.

PRESIDENT:

Any discussion on the motion to adopt Amendment No. 2 to House Bill 3133? Is there any discussion? If not, all in favor of the amendment indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

SECRETARY:

Amendment No. 3 offered by Senator D*Arco.

PRESIDENT:

Senator D*Arco on Amendment No. 3.
SENATOR D*ARCO:

Thank you, Mr. President. This amendment appropriates the sum of eight hundred and fifty thousand from the School Construction Bond Fund to the Capital Development Board for a grant at Andrew Jackson Elementary School in Chicago. This proposal...in fact, there have been numerous editorials in the Chicago Tribune on this proposal, and what it amounts to is a provision where the University of Illinois and the Chicago Board of Ed. are going to work in conjunction with teachers from the university and teachers from the Board of Ed. to develop a laboratory school to facilitate approaches to learning that have heretofore been unknown in the Chicago Board of Education School System. They're going to do research, they're going to have an early childhood development program, they are going to...do experimental training and...faculty training at this new laboratory school.

money for the budgets for this new school is going to come out of the budgets of the university and the Board of Ed. in conjunction. So there is going to be no new additional funds appropriated for this school. We are very high on appropriating money for gifted children and we created a school to help gifted children, and that was a noble idea and it was a noble thing for this Assembly to do. This program is going to be in the City of Chicago to help develop programs to help inner-city kids so they could become gifted students someday. just like kids that come from the suburbs and other areas of this great State of Illinois. That's what this program is going to do, and these dollars are yoing to be used for that purpose. It's a good idea because it deals primarily with early childhood development education, and that's what we got to do in our educational systems today that we're not doing is develop children at early ages when they are more susceptible to learning. And that's what this facility is going to do among other things. This bill deserves our attention and I ask for an adoption of Amendment No. 3.

PRESIDENT:

All right. Senator D*Arco has moved the adoption of Amendment No. 3 to House Bill 3133. Is there any discussion? Senator Etheredge.

SENATOR ETHEREDGE:

Will the sponsor yield, please?

PRESIDENT:

Sponsor indicates he'll yield, Senator Etheredge.

SENATOR ETHEREDGE:

Senator, I m trying to clarify in my own mind how you...you propose to...or what the source of the funding for this proposal is. This is an idea that is kicked around several times over the last several months. It has been vetoed by the Governor. And...the earlier vetoes, one of the reason was because it was proposed that the funding come from

the Capital Development Fund. Did I understand you correctly that you are proposing funding from another source at this time?

PRESIDENT:

Senator O'Arco.

SENATOR D'ARCO:

The original...I...I think what happened was that the Governor's objection to the proposal was that it was coming from an...inappropriate funding source. What we did was say that it would come from the School Construction Bond Fund which is the identical fund that originally passed the appropriation for the school in its initial stages which was...which we appropriated last year. So we're saying that it will not come out of the Capital Development Fund, it will come out of the School Construction Bond Fund and be appropriated to the Capital Development Board for that purpose the way it was originally.

PRESIDENT:

Senator Etheredge.

SENATOR ETHEREDGE:

At this...are we constructing a school here, Senator, though? That is the purpose for which that money is intended. Are we...I didn't understand that this proposal call for a construction of a school.

PRESIDENT:

Senator D'Arco.

SENATOR D'ARCO:

Yeah, we're constructing the...classrooms for the early childhood development and the research of...you know, this school was at originally a six million dollar school and it...it was a part of the package of the Hispanic schools. It was on the near west side of the City of Chicago which is...which is where the University of Illinois at Chicago is located. The university and the board got together and

says, hey, let's try...let's take some of your teachers, let's take some of ours, let's use their expertise, develop an experimental program, develop a lab school here. In order to do that we need a little more money than the six million to develop the early childhood learning classrooms and the research facilities that are necessary in order to develop this new type of school. That's how the genesis of this additional eight hundred and fifty thousand dollars evolved. PRESIDENT:

Senator Etheredge.

SENATOR ETHEREDGE:

Senator, may I ask, what is the emergency? Why do we have to do this in the closing hours? It seems to me that this may be a...a very well worthwhile program, but why can't we move this through the regular appropriation's process, why must we do it now?

PRESIDENT:

Senator D'Arco.

SENATOR D'ARCO:

Well, they're...they're going to break ground in April and...you know, so there is an emergency to it in the sense that they're going to break ground while we're in Session and we won't be able to fund the appropriation before June.

PRESIDENT:

Senator Etheredge. Further discussion? Any further discussion? If not, Senator D*Arco has moved the adoption of Amendment No. 3 to House Bill 3133. All in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

Amendment No. 4 offered by Senators Demuzio and Watson.

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Yes, Amendment No. 4 addresses itself to a unique problem that has occurred in the Highland School District. This is a one shot, one bump appropriation for this school year because of the increase in enrollment that has exceeded over fifteen percent. And I would move adoption of Amendment No. 4.

PRESIDENT:

All right. Senator Demuzio has moved the adoption of Amendment No. 4 to House Bill 3133. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments? SECRETARY:

Amendment No. 5 offered by Senator Demuzio.

PRESIDENT:

Senator Demuzio, Amendment No. 5.

SENATOR DEMUZIO:

This...this one is a technical amendment that...a Build Illinois project, simply drops the name of the specific watershed project that was to be studied and broadens it so that it would include water surveys in the entire County of Macoupin and it's simply a technical change. I would move adoption of Amendment No. 5.

PRESIDENT:

Senator Demuzio has moved the adoption of Amendment No. 5 to House Bill 3133. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

No further amendments.

PRESIDENT:

3rd reading. Senator Hall and Carroll have asked leave of the Body, to go back to that after intervening business so that it can get on its way to the House. All right. With leave of the Body we'll move to Supplemental Calendar No. 2. Secretary informs the Chair that Calendar...Supplemental

SECRETARY:

The second Conference Committee report on Senate 3ill

PRESIDENT:

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. This bill no longer calls for the division of the Chicago public schools into twenty elected school districts as the Calendar said, although maybe we can put that in any-But in the interim what it does do is do some handicapped access language needed by the Chicago Board of Flections and equally and probably more important is allowing for the precinct referenda that has been discussed by the Save Our Neighborhood - Save Our Cities Coalition on the Guaranteed Home Equity Programs in the several Chicago neighborhoods in the April elections of 1987. There are other issues that have been previously discussed as potential candidates for this particular piece of legislation, they are not, I repeat, not in there now. So this is a solid absent solidarity proposal and I would ask for a favorable adoption of Conference Committee Report No. 2.

PRESIDENT:

Any discussion? Is there any discussion? If not, the question is, shall...I beg your pardon, Senator Dudycz. I $^{\circ}m$ sorry.

SENATOR DUDYCZ:

Thank you, Mr. President. Ladies and Gentlemen of the Senate, I stand in opposition to Conference Committee Report

No. 2 to Senate Bill 1010 for the following reason. Last year when the Save Our Cities and Save Our Neighborhoods Coalition of Chicago came to the Legislature asking to be allowed to submit advisory referendums to the voters of their neighborhoods, we voted last fall on Conference Committee Report No. 1 of Senate Bill 1010. Now the Conference Committee report that we voted and passed and sent to the House contained a language that the Save Our Cities and Save Our Neighborhoods people requested. However, our colleagues in the House failed to act and now we see Conference Committee Report No. 2. The advisory referendum proposal for the neighborhoods is watered down to almost nothing. What's the difference between Conference Committee Report No. 1. No. 2 is...is the following. Number 1 allowed any type of advisory question to be submitted to the voters and the question could be submitted at any election. What No. 2 does, it limits the type of questions which can be submitted to the voters to only home equity questions and the questions can only be submitted in elections held in 1987. Now, as we're all aware there are no November elections this year and the only election at which this question will be able to be submitted is the April 7th Mayoral Election. Now in order to get on the ballots for the April 7th Mayoral Election, the petitions for the advisory referendum will have to be submitted this coming Monday, January 19th. Now this bill may not even be law by Monday; therefore, for all practical matters, this provision can do absolutely nothing at all. If it does, it gives the community a very, very limited amount of time in which to attempt to do it. According to the Election Code, petitions for the advisory referendum must be held no later than seventy-eight days prior to an election. Again, I stress it's this coming Monday. What we are...what we are telling the Save Our Cities and Save Our Neighborhoods Coalition is that we are giving them absolutely nothing with Conference

Committee Report No. 2. I spoke this afternoon with the representatives of the coalition and they informed me that Conference Committee No. 2 is totally...totally unacceptable to them as it stands. So later on this afternoon I plan to meet with staff and to have meaningful legislation drafted which gives the real substantive changes which the neighborhoods need. And as for now, I'm voting Present and I ask my colleagues, at least on this side of the aisle, please to join me and vote Present.

PRESIDENT:

Further discussion? Senator Rigney.

SENATOR RIGNEY:

Well, Mr. President, if I'm reading this Conference Committee report correctly, and the sponsor...can correct me if I'm wrong, but I think on page 17 that language is still in there that provides that, for instance, the school district or someone that wants to have some type of a referendum procedure, if certain precincts are not open because there is no one running in those particular precincts, there will be the requirement to have them open, is that correct, Mr. Sponsor?

PRESIDENT:

Senator Carroll.

SENATOR CARROLL:

Senator Rigney, yes, and that is identical to Conference Committee Report No. 1 which, as Senator Dudycz pointed out, we had passed in the Fall Session. That language has not changed. The other changes were the result of House action, but that did not change.

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

Well, I think it's maybe perhaps a minor objection but I would point out that it's not a level playing field, for

instance, when one part of the district is running officers for various local offices and other parts of the district do not have those people on the ballot; in fact, then the only thing that brings people in to vote will be just that particular referendum itself. So, like I say, it may be a minor objection but I'm not really happy with the language in that part of the bill.

PRESIDENT:

Further discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Thank...thank you, Ar. President. I rise on that same point and I think for those of us who represent downstate areas we should be cautious about the fact that we may be allowing our units of local government, notably school districts, to hold referenda under this section that would...that would not be allowed under current law. Now if that...if that's what you want to do, okay, but I think that there has not been enough attention paid to this point and that Senator Rigney has raised a valid point, particularly for those of us who represent rural districts.

PRESIDENT:

Further discussion? Is there any further discussion?

Senator Carroll, you wish to close?

SENATOR CARROLL:

Merely by saying, Mr. President, as to that particular section, of course, we...we know that was a request of Morris, Illinois for a particular library district issue to be on the ballot. As to the other, Senator Dudycz, we thought that this was within accord within the limitations that the House by its action had placed upon the availability of referendum at this time. This would, you're correct, allow a referendum for April of '87, which is a very limited scope, and that we would have to take further legislative action to open it up for '88 or other years. It was our

understanding that because of the House action this was all that was available and that this small step was better than no step at all. I would ask for adoption of Conference Committee Report No. 2.

PRESIDENT:

The question is, shall the Senate adopt the second Conference Committee report on Senate Bill 1010. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 29 Ayes, 6 Nays, 20 voting Present. The Conference Committee report is not adopted and the Secretary shall so inform the House. On Supplemental Calendar No. 2, the Conference Committee report on House Bill 2630, Mr. Secretary.

SECRETARY:

SENATOR D'ARCO:

I didn't know I was so popular, Are President. Anyway...no...no...no jokes. I don't know if the Governor is listening, but there's a lot, you know, that...that this bill contains and there's a lot that it doesn't contain. I honestly believe that the provisions that were deleted from this bill, particularly the...constitutional officers' provision, will reemerge in the subsequent General Assembly. There is much merit to the provision. There is no doubt in my mind that the constitutional officers'...pensions should be based on their salaries. I think that's a very legitimate purpose and if our pensions are based on our salaries, then their pensions should be...based on their salaries. I think that's simple logic. But there are problems with putting that provision in this bill and the problems I will not

address right now, but they will be worked out in the upcoming Session of the General Assembly. Now the other deletions in the bill involve the last day of service for the downstate police and the twenty-five years...of the State Police. There was some disagreement about those two provisions. We had a lengthly discussion and debate on those two provisions, and even though the downstate firemen pension is based on the last day of service, the argument was made we shouldn't extend it to the police and I disagree with that. I think that if it's good for the firemen, it should be good for the police but in the spirit of compromise...and Dudycz is agreeing with me. in the spirit of compromise. we removed that provision. The South African provision is in the bill and that was worked out. There are numerous other provisions in this bill and they affect many of our pension systems throughout the State of Illinois. I will be happy to address any one of those provisions if you have any questions; if not, I would ask that we adopt Conference Committee Report No. 2.

PRESIDENT:
