March 5th at noon for approximately an hour, an hour and a half, and at the beginming of the Sessions thereafter, depending upon the requests for testimony, an opportunity for us all to hear comments regarding these reports and recommendations and allow us all to have the time to ask questions and get answers so that when substantive bills do emerge from the substantive committees that we will all have some familiarity with this subject and that we all can respond to our constituents with greater knowledge and expertise in this critical area. So at the appropriate time, Mr. President, I would ask that the appropriate rules be suspended for immediate consideration and adoption of Senate Resolution 48.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Berman moves that the rules be suspended for the immediate and adoption and consideration of Senate Resolution 48. Is there any discussion? Senator Maitland. Leave granted? Leave is granted. Further...now, any discussion? Senator...well, Senator Marovitz.

SENATOR MAROVITZ:

We all look alike, Vince.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, the board hasn't been changed. Senator Marovitz. SENATOR MAROVITZ:

Senator Berman,...is the...the purpose of the hearing for the...the general discussion of school reform or...specific bills that have...that have been introduced? The entire school reform concept? Okay. So any...anybody who wants to have some input...on suggestions on school reform would be coming in?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Maitland.
SENATOR MAITLAND:

Well, thank you, very much, Mr. President, Ladies and Gentlemen of the Senate. I rise in support of Senate Resolution 48. There are several very good initiatives around this spring. A lot of effort has been put forth by several groups to attempt to improve the quality of education in Illinois, and indeed this...this Session has been billed as the educational reform year. There's no way that everyone can know everything that's in all of the reports and we understand that, but this provides an excellent forum for everyone to get at least a superficial overview of all the reports and then the more detailed debate obviously will take place in the committee hearing; but I think it's an excellent idea, and I would urge all those on this side of the aisle to support Senate Resolution 48.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Rock.
SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I think the calling for a Committee of the Whole is an excellent idea; as you well know, next Tuesday at the Governor's request we will convene in joint Session for the purpose of hearing the Governor's recommendations. But given the amount of work that has been done by members in this Chamber, particularly on the Berman Commission, I think it's well in order that the Senate, again, as we have in the past years literally set the agenda for what's going to ultimatley happen. Senator Philip and I have discussed this at length, and we feel, frankly, that we ought to be in a position in the Senate to arrive at a consensus and to put a price tag on those consensus reforms and then send them to the House with the hope at least that they will reach the Governor's Desk. So I, too, rise in support of Senate Resolution 48 and look

forward to the hearing on March...March 5th.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Berman has moved for the suspension of the rules and immediate adoption of Senate Joint Resolution 48. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator Berman now moves for the adoption of Senate Joint...Senate Resolution 48. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The resolution is adopted. All right. Mr. Secretary, have there been any objections filed to the Resolutions Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock moves to...the adoption of the Senate Resolutions Consent Calendar. Those in favor signify by saying Aye. Opposed...all right. I am told on the Senate Resolutions Consent Calendar there has been some additions, Senate Resolution 42, 43, 44, 46, 45 and Senate Joint Resolution 12. Strike 45. It's 42, 43, 44, 46, Senate Joint Resolution 12. Are there any objections to those additions to the Resolutions Consent Calendar? Senator Rock has moved the...the adoption of the Resolutions Consent Calendar. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Resolutions Consent Calendar is adopted. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. If there's no further business, I would move pursuant to the adjournment resolution passed last week that the Senate stand adjourned until Wednesday, February 27th, at the hour of noon. Remember if you will please, that we will be convening in joint Session at twelve-thirty at the request of the Governor. So we will convene here on the 27th day of February at the the hour of noon.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Philip, for what purpose do you arise?
SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate, I'd like the record to indicate that Senator Ralph Dunn is convalescing from an operation and have the record indicate that, and also Senator Bloom is not here because of illness in his family.

PRESIDING OFFICER: (SENATOR DENUZIO)

The record will so indicate. Senator Rock has moved that the Senate stand adjourned till Wednesday, February 27th, at the hour of...of noon. Those in favor signify by...Senator Dawson. Senator Dawson, what purpose do you arise?

SENATOR DAWSON:

That Senate Bill 62 has Senator Emil Jones and Prescott Bloom as hyphenated cosponsors.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Is leave granted? Leave is granted. Senator Rock has moved that the Senate stand adjourned till Wednesday, February 27th, the hour of noon.
