Mr. Secretary, have there been any additions to the Resolutions Consent Calendar that's been printed?

SECRETARY:

Senate Resolution 61 was added.

PRESIDING OFFICER: (SENATOR DENUZIO)

Is that congratulatory?

SECRETARY:

Yes.

PRESIDING OFFICER: (SENATOR DENUZIO)

With leave of the Body, we'll add Senate Resolution 61 to the Resolutions Consent Calendar. Is leave granted? Leave is granted. Senator Poshard now moves the adoption of the Resolutions Consent Calendar. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The Resolutions Consent Calendar is...is adopted. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank...thank you, Mr. President, Ladies and Gentlemen of the Senate. With leave of the Body, I'd ask that we go to the Order of Senate Bills 3rd Reading. Senate Bill 139 contains a number of appropriations of an emergency nature, and I am told also that they are without objection. And I think in order to move the process along, the State Treasurer has indicated that the amount appropriated for him is of an emergency nature as is the lottery money which was added by amendment by Senator Carroll yesterday. So with leave of the Body, I'd like to go to that order and get that bill out of here.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. With leave of the Body, we'll go to Senate bills on...on 3rd reading. Is leave granted? Leave is granted. Mr...Secretary, on page 2 is Senate Bill 139. Read the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 139 is a supplemental appropriation and as amended it would appropriate fifty-one million four hundred and forty thousand dollars: fifty million of which is for lottery prizes, which the superintendent tells us he needs in hurry. There's a five hundred thousand dollar appropriation to begin the commitment to the super conductor. There's a nine hundred thousand dollar super collider. appropriation to the Department of Energy and Natural Resources for homeowner loans, and the bill as it started out, the main provision, obviously, is the fifteen thousand dollar appropriation to pay the interest on the coal development bonds which the Treasurer says he needs by the middle of And additionally, we have taken an eleven million dollar amount that the State Board of Education suggested could be reallocated and we have reallocated that ... along the lines for the categorical grants so that they are in fact each will be funded at a hundred percent. I know of no objection and I would solicit a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Any discussion? Any discussion? If not, the question is, shall Senate Bill 139 pass. Those in favor will
