SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Joint Resolution 136 is the adjournment resolution. At the conclusion of business tomorrow, and tomorrow you will recall when we adjourn today we will adjourn until nine o'clock tomorrow morning for the sole purpose of introduction of bills. So, the Senate will remain open from nine o'clock in the morning until five in the afternoon for the purpose of affording members the opportunity to introduce



their bills, the deadline being tomorrow. This adjournment resolution calls for us to return to Springfield next Tuesday at the hour of noon when we conclude the introduction session tomorrow.
