Senate Resolution 127 offered by Senators Lemke, Zito, Kelly, Vadalabene and others.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LEMKE:

I'd like to make the appropriate motion to have this resolution heard immediately today and passed as I must have it for tomorrow.

PRESIDING OFFICER: (SENATOR DEMUZIO)

You've heard...Senator Lemke has moved for the suspension of the rules for the immediate consideration and adoption of Senate Resolution 127. Is leave granted? Leave is granted. Senator Lemke.

SENATOR LEMKE:

Okay, what this resolution does is simply...is sent to the College of DuPage, a two-year tax supported community

college, that we're not happy with their religious defamatory actions. It's similar to what we did for the University of Illinois expressing our views before they get into an activity of having a play which is anti-religious to a particular large segment of the population in this State. This resolution is supported by the Catholic...Chicago Chapter of the Catholic League of Religious...and Civil Rights and also by the B'Nai B'rith Association and other antidefamation activities. It's the...it's the play "Saint Mary Ignatius" which is a national play. It's been national and has been attacked nationally by the particular defamation leagues and I think it's fitting in this State not to have a...to us, as a Senate, to pass a resolution telling a tax supported body that you are not to allow to have religion in the school but we also don't want you to have anti-religious activities in the school also 'cause it could happen to any religion and in this case it happens to be the Catholic religion, in other cases it could be some other religion. I think it's something we should do and send to that president of that particular college expressing our disagree because the play is starting tomorrow night, and I want to take this resolution and present it to them before they have the play.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, is there any discussion? Senator Fawell.

SENATOR FAWELL:

Thank you, very much, Mr. President. I...I know of the college that you are speaking of because it happens to be within blocks of my neighborhood. I think perhaps the Assembly should know; number one, the president had nothing to do with picking out that play, there was a committee that picked out that play and I think if we're going to direct this resolution at anybody we should direct it at that committee, not at the president. I'm sure he would love to...some way or another to sink that...that committee, that he has been told

off by any number of people. I think if we're going to be fair, let's at least make sure that the ones that we are expressing our anger at are the ones that are guilty of the sin. Number two, I...I also think that...that this play was originally supposed to be scheduled in a very small auditorium which would hold approximately fifty people. It was a...a play that was really supposed to be for a...a small group. They have put on four plays a year. I am not...I by no means mean to say that I think this was a good choice. I don't think it was. I think that...that...I know the college professor...college president regrets, indeed, the...the choice, but that is not his right to sit there and tell a faculty member what...what they can put on as far as a play is concerned, that's...that's not...not within his realm of responsibility. It's within that department's realm and I...I think, you know, let's...let's put the blame where it belongs.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further discussion? Senator Kelly.

SENATOR KELLY:

Yes, thank you, Mr. President and members of the Senate. I rise to support this resolution. While I have had a conversation with the president and is a very excellent gentleman, a fine gentleman, and it...pointed out that the committee had actually made this determination. I think the fact remains that the president is still the president of his institution and, in fact, you have responsibilities if you are the...the head of that institution. And I think that brings us to the important point in this item, this play has been shown privately where you can go out to a show or a theater and...and partake in it, but this is a public institution and public funds, and people who are providing these funds are resisting the...the play. And I think it's taxpayers' money and it's a very good point that we should bring

the attention...not only of...of the College of DuPage but certainly for other institutions. We had the some thing, if you recall, at the University of Illinois with an art display about a year ago along the same line and...and if we don't do something when these things occur, they're going to come in more often and it won't be just the certain religion, it'll...it'll be all of them that will be effected. So, I strongly urge your support for Senate Resolution 127.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Davidson. Senator Davidson.

SENATOR DAVIDSON:

Question to the Senator that has DuPage...College of DuPage in.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates...Senator...Senator Fawell...indicates she will yield. Senator Davidson.

SENATOR DAVIDSON:

I've had some of this controversy with an institution that's located in my district. Sometimes the things that are put on are sponsored by the student affairs which is paid out of their fees, there's no taxpayers' money...whatsoever involved and the administration of the college has no veto power over that activity. Is this the case in this play that was put on or do you know?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Fawell.

SENATOR FAWELL:

I'm not sure...I'm not sure.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson.

SENATOR DAVIDSON:

Does...does Senator...the sponsor of the resolution have an answer to that question?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lenke.

SENATOR LEMKE:

My understanding that the president of the university...the...of the...of this particular community college granted permission for this group to...use a bigger auditorium and he's quite aware. I understand the people I talked to who are involved in this have talked to him many times and he has been...very indignant to him, but this resolution does not defame the president of the university, it just says that we don't want this going on and he should exercise his authority. It's all we're saying. We're not running him down or anything else, we're just saying that since it is tax supported we think that he's the president, he should stop it and come up with the necessary things to stop it, just like the University of Illinois.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Davidson.

SENATOR DAVIDSON:

Well,...a question to the maker of the motion. You stated it was public money. Is it or is it not public money or do you know?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lenke.

SENATOR LEMKE:

Well, I...I understand that the auditorium has employees that are paid with public funds and who will get paid overtime with public funds for running this auditorium; therefore, it is public funds and I think indirectly if the play makes money, then it isn't public funds, but if the play loses money, it is public funds and I will assure you this play is not going to make money, it's going to lose public funds, like most plays do. So, I think indirectly it's going to be public funds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further discussion? Senator Fawell, for a second time.

SENATOR FAWELL:

Thank you, very much and I apologize for...for speaking for a second time, but let me tell you, I live about four blocks away from this college. They constantly have these kinds of plays on. I have never in my life even gone to see one of these much less know whether the plays are on or not. They do not normally broadcast this, this was going to be held in an auditorium where a classroom was going to see the...the play, period, until...until all this publicity came about. Once all this publicity came about and all these letters started arriving and everybody wants to see the play. You know, I...my personal feeling is if...if they had just let the class see it, shut up about it, they would have been much better off. Now, everybody knows the play is on. I didn't even know that they even put these productions on and this is my college, within four blocks of my...my...my home. You know, I...I...I just think they've...they've created a monster that...that was supposed to be a classroom exercise, basically.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further discussion? Senator Lenke has moved the adoption of Senate Resolution 127. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The resolution is adopted. Further resolutions?

SECRETARY:

Senate Resolution 128 offered by Senators Kustra and Dudycz. It's congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. All right, with leave of the Body, we'll go to the...page 8 on the Calendar, Secretary's Desk Resolutions. A request has been made by Senator Lemke on Senate Resolution 47. Is leave granted? Leave is granted. On the Order of Secretary's Desk Resolutions is Senate Resolution 47, Mr. Secretary.

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SECRETARY:

...oh, I'm sorry, we have an amendment in committee from Executive which is Amendment No. 1, Senator Lemke.

SENATOR LEMKE:

I believe that's a...could you read that amendment?

SECRETARY:

Yeah, I think what happened was when the resolution initially was they forgot the Governor's Office and this adds the Governor's Office to the rest of the people to be notified.

PRESIDING OFFICER: (SENATOR DEMUZIO)

A suggestion by the educators in line 25, deleting "school" and inserting "churches and school," which was suggested and also deleting "local law enforcement officers" and inserting "law enforcement and health officers." I think these are words of technical changes. I ask for their adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Lemke has moved the adoption of Amendment No. 2 to Senate Resolution 47. Is there any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is a piece of legislation suggested by the Governor's Office to afford those boards under the Executive Agency who are in mid-term the opportunity to be restructured so that they can take advantage of the compensation increase. Amendment No. 1 calls for the expiration of the terms of the Prisoner Review Board to happen at the end of May to afford the Governor an opportunity to reappoint and to allow the Senate to advise and consent, and I would move the adoption of Amendment No. 1.

This morning, myself and Representative Richmond had a conversation with Jim Reilly who is the Governor's Chief of Staff, and the Governor has indicated that he is amenable to four substantive changes in House Bill 485 as well as the Senate bill, and that with the adoption of this amendment that this bill would have his approval on Tuesday of next week when we manage to get it to his desk for...for his signature. The substantive changes are that all payments, adjustment and commitments on farm loans should be made by June 15th of 1985. Therefore, if the loan is not made by June 15th of 1985, obviously, it's not going to do anyone any good anyway, so June 15th is certainly a date that is a matter of compromise that we've accepted. The other parts of the...of the substantive parts of the...of amendment indicate that we were...cleaning up the language in terms of the definition of an operating loan to assure ourselves that it would be, in fact, for our spring planting money and that the operating loans would not be utilized for preexisting debt. The third provision indicates that we would assure ourselves that the interest rate would be no more than thirteen percent. We, in debate here, argued one day that the Illinois Farm Development Authority by rule or regulation could, in fact, establish the ceiling on the particular interest rate. They feel more comfortable with it being in

this matter of Statute, we have no objections to it and therefore seek to...to have that put into the statutory language. And the fourth provision that I think...or the substantive provision is to assure ourselves that it is a...a program that is not perpetual, that it is, in fact, a one-time program and that it, in fact, will expire...or shall expire sometime in 1985 and the date escapes me, I don't see it here. But for matter of compromise for...it seems to me that...that we do have a reasonable proposal, and I would move the adoption of Amendment No. 1 to House Bill 485.
