PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rupp.

SENATOR RUPP:

Yes, sir, thank you, Mr. President. There'll be a Republican Caucus, Senator Philip's Office immediately following the adjournment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right...further business to come before the Senate? Senator Rock moves that the Senate stand adjourned till tomorrow morning...all right, Senator Hall, for what purpose do you arise?

SENATOR HALL:

Mr. President, Ladies and Gentlemen of the Senate, today is the last day for...okay...going to change it from adjourn-ment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Recess for how long? All right, the Senate will stand in Recess till the hour of one-thirty. Senator Carroll, for what purpose do you arise?

SENATOR CARROLL:

Just a reminder that the Appropriations I Committee will be meeting in Room 212 at two o'clock sharp. We will get started at exactly two. We have a lot of agencies on the calendar.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, the Senate's at Recess till one...(machine cutoff)...

RECESS

AFTER RECESS

Senator Marovitz, for what purpose do you arise?
SENATOR MAROVITZ:

I'm sorry to do this, Mr. President, but I would respectfully request another Democratic Caucus and I would like a show of hands of those who would join me.

PRESIDENT:

Well, we...we haven't got enough here to...we haven't got a corporal's guard here. Senator Hall has a motion of some importance. All right, the Senate will come to order. As Senator Carroll earlier announced, the Appropriations Committee will be meeting at two o'clock or immediately upon adjournment. We have only one item to deal with. Senator Marovitz has indicated that there will be an advisory council briefing at three o'clock here in the Senate Chamber. I had the opportunity earlier to meet with members of this council. and I would urge all of you who are otherwise not occupied to be at the briefing. It is very, very informative and something that's of great importance. It's on the Senate Floor. On the Calendar...if you turn to page 4 on the Calendar,...Rules Committee will meet at three-thirty so that can take advantage of this briefing or at least most of it. Page 4 on the Calendar, on the Order of Item Vetoes...on the Order of Item Vetoes, Senate Bill 226, Mr. Secretary. SECRETARY:

I...I move that the item on page 37, line 22 through 31 of Senate Bill 226 Do Pass, the Item Veto of the Governor to the contrary notwithstanding. Signed, Senator Kenneth Hall. It was...offered to me on April the 2nd, 1986.

Senator Hall.

SENATOR HALL:

PRESIDENT:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'll be brief. I won't take a lot of your time. I want to thank all of you on both sides of the aisle which

allowed and helped to put on this 6.4 million for the cost of living for people to bring them up...of AFDC and GA recipients to bring them up to fifty—two percent of need. Now all that this does is it actually comes out to about forty cents a day. There are around nine hundred thousand people in this great State who are below the poverty level. Now, if you just think, out of a budget that we had of 19.5 billion dollars, if you had spent one thousand dollars every day since Christ walked upon this earth, one thousand nine hundred and eighty—six years ago, you would not have spent a billion dollars. Mr. President, may I have a little order, please? May I have a little order...there's a conference going on.

PRESIDENT:

Yes. If you'll lend the gentleman your attention, please.

SENATOR HALL:

Thank you. If you had spent a thousand dollars every day since Christ walked upon this earth, and I reiterate, you would not have spent a billion dollars. To make it even and drive it home closer to you, you could almost spend two and a quarter million dollars every day for a year and you would not spend a billion dollars. And just think, in this great State that we have a budget last Session of nineteen and onehalf billion dollars. Can you imagine that we cannot find 6.4 million to give to the less fortunate and it comes out to forty cents a day? I just want to cite that and it's not pointing the finger at anybody. I think that all of you...if you'd just stop...and I'm not trying to play on anyone's conscience, but this is the right way to go and the right thing to do. Now with his Message, the Governor said and, I quote, he states that appropriations for such items...and I understand that everybody is for what they get in their own area, now when they cite all the other things like math and science

academy and State fairs, he calls this investments. For example, he calls the math and science academy an investment in our children's education. The Governor managed to invest in nearly everything but that. What I'm simply saying is this, the right, fair way for us to go is to at least see that out of that budget there's an additional four hundred million more supplementary that he got. I ask you and I plead to you to override this veto. It takes thirty-six votes and it's the right way to go. Just think, people who get two to three hundred dollars a month and many of the people are walking the streets. I know we don't want to see that happen. So, with that, Mr. President and Ladies and Gentlemen of the Senate, I simply ask for an affirmative vote to override the Governor's veto.

PRESIDENT:

All right, Senator Hall has moved that the item on page 37, lines 22 through 31 pass, the item veto of the Governor to the contrary notwithstanding. Discussion? Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I just want to make clear to everyone on the Floor what it is that we're being asked to vote on. This is...as been pointed out by Senator Hall, this calls for the cost of living adjustment for public aid. As the Senator has pointed out, it is...an expenditure on the order of six million dollars for the present fiscal year. What also needs to be said is that it represents an automatic increase in State spending for FY '87 of twenty-five millions of dollars. He are...in that twenty-five million dollars, I don't need to tell anybody here is not there. We are now going through the appropriations process. Just yesterday afternoon in Appropriations II, Senator Carroll pointed out that it is...it may very well be necessary for us to...to trim our budgets in

education possibly or in other areas to the tune of perhaps three...three hundred million dollars or more in order to continue to...to fund programs that we've already committed ourselves to. This is not the time to be in further increasing...making further programmatic commitments. I would ask that you vote No.

PRESIDENT:

Any further discussion? Further discussion? Senator Hall, you wish to close?

SENATOR HALL:

Thank you, Mr. President. Senator Etheredge, I want to thank you for calling that to my attention and I got the opportunity to also say that out of that four hundred million dollars additional money that we put...and he talks about public aid, do you realize that the Department of Public Aid is going to lapse eighty million dollars? Eighty million dollars, the Department of Public Aid is going to lapse, money that we gave them, and you say that we cannot give 6.4 million. Well, I'm appalled and I know when you think and ponder on this thing...and I call it to your attention again, the Department of Public Aid is lapsing eighty million dollars. Now, if they cannot find 6.5 million...again, I ask for your affirmative vote on this override.

PRESIDENT:

Question is, shall the item on page 37, lines 22 through 31 of Senate Bill 226 pass, the item veto of the Governor to the contrary notwithstanding. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 26 Ayes, 27 Nays, none voting Present. And the motion fails. Senator Demuzio for what purpose do you arise? SENATOR DEMUZIO:

Yes, on the Consent Calendar is Senate Resolution 818.

It is congratulatory and I*m told that there*s some urgency to that and I would like to move to pass that as quickly as possible.

PRESIDENT:

All right, the gentleman seeks leave to go to the Order of Resolutions. On the Resolutions Consent Calendar for Senate Resolution 818, a congratulatory resolution that is to be presented, I think, this evening. That's the...without objection, leave is granted. Senator Davidson, for what purpose do you arise...on this...on 8187

SENATOR DAVIDSON:

Mr. President, I'd like to remind all members of the Senate again, as I did earlier, tomorrow is the day for the physical fitness check down in Room 114. Starts at seven—thirty. If you do want to participate in the blood screening test, remember no food or drink after mid—night...before you go down there; otherwise, they'll be glad to see you any time from 7:30 a.m. to 2:00 p.m. Thank you. PRESIDENT:

All right, Senator Demuzio has moved to suspend the rules for the immediate consideration and adoption of Senate Resolution 818. All in favor of the motion to suspend indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Senator Demuzio now moves the adoption of Senate Resolution 818. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Further business to come before the Senate?...resolutions, Mr. Secretary.
