Have you spoken with the chairman of the...Assignment of Bills...?

# SENATOR D'ARCO:

Yes.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The bill is on 2nd reading in the Senate. It is on page 4 of your Calendar, Senate Bill 326. Senator D'Arco has...has moved that the bill be rereferred to the Committee on Financial Institutions. Is...is there any discussion? All right. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The bill is rereferred to the Committee on Financial...Finance and Credit Regulations. All right. Senator Geo-Karis, for what purpose do you arise?

### SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, my Senate Bill...823 was assigned to Executive Appointments and Veterans' Affairs. Senator Lechowicz' Office called me and suggested I make a motion to discharge 'cause it was then referred to Executive Committee. PRESIDING OFFICER: (SENATOR DEMUZIO)

Ladies and Gentlemen...if we can have some order, please.

If we can have some order, please, and break up the caucuses.

Senator Berman.

### SENATOR BERMAN:

Thank you, Mr. President. Ladies and Gentlemen, if I could have your attention for a moment. A short time ago... PRESIDING OFFICER: (SENATOR DEMUZIO)

Ladies and Gentlemen, if we can have some order, please.

The members would be in their seats. Senator Berman.

# SENATOR BERNAN:

...we are in the middle of a week that has been commemorated by resolution of the Governor of this State, by the President of the United States and by this Senate Resolution 143 to commemorate the Holocaust. And I would ask at the appropriate time to waive the appropriate rules for immediate consideration, Mr. President, of this resolution and to be allowed to read the resolution for this Body.

## (Senator Berman reads SR 148)

Mr. President and members of the Senate, I stand here and I wear a yellow armband with the Jewish Star of David. These were worm by the participants this morning at eleven o'clock at the Old State Capitol at a memorial service attended the Governor of this State who spoke eloquently and by other participants including a number of our colleagues from the Illinois Senate that joined us. The atrocities cannot be adequately enumerated, they can never be remembered ade-We try on this day in this week to recall a terquately. rible chapter of our history of man's inhumanity to man, and it is not only for the Jews that died but for all persons that perished in the Nazi Holocaust and even more so for the indifference shown by all peoples in the world to that terrible tragedy. Accordingly, Mr. President, I would move for the immediate adoption of Senate Resolution 148 and I appreciate your courtesies.

### SENATOR POSHARD:

Amendment No. 1 offered by Senator Lemke.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lenke.

### SENATOR LENKE:

What this bill does is...is what we talked about in committee. This bill gives the parents the right to recover civil damages against drug pushers who sell drugs to minor children. The amendment expends...expands the bill's scope to cover the drug supplier which gets into the chain. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Dudycz.

### SENATOR DUDYCZ:

Senator Dawson is representing the entire City of Chicago?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator Darrow.

# SENATOR DARROW:

No, but on occasion I think his ward committeeman does.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? All right. On that, Senator Darrow

On Senate Bill 262, the Amendment No. 3 that was added by the House, I doubt very seriously if there's anybody in this Chamber that is not aware of the provisions that are in this supplemental request. We sent a twenty-five million dollar appropriation bill for the emergency farm relief to the...to the House and...and it is back. It has some of the controversial...perhaps the most controversial, I guess, provision is the money for the pay raises of approximately seventy-seven million dollars. It has seventy-five million dollars of revenue, lottery prizes; fifty-five million dollars worth of income tax refunds, debt service on the Coal Bond Development Act, Inheritance Tax distribution of eight hundred and seventy-five thousand, reapportionment fees...in-home services operations,

Southworks study, debt service on the civic centers in Rockford and Danville, the Federal Solar Bank, energy conservation, the Fermi Lab study, the general and refugee assistance, which I am told is a...or at least it's shown as a transfer. It would seem to me that this has been debated on numerous occasions, everyone knows what's in it. I would move for the concurrence of Amendment No. 3 to Senate Bill 262.

### PRESIDENT:

The gentleman has moved that the Senate concur in House Amendment No. 3...Mr. Secretary, is that the amendment number?

### SECRETARY:

Number 3, yes.

## PRESIDENT:

All right. House Amendment No. 3 to Senate Bill 262. Is there any discussion? If not, the question is, shall the Senate concur in House Amendment No. 3 to Senate Bill 262. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 28, the Nays are 25, none voting Present. Senator Demuzio.

# SENATOR DEMUZIO:

Perhaps we might have a postponed consideration.

PRESIDENT:

All right. The gentleman seeks leave to have further consideration postponed. Resolutions, Mr. Secretary. SECRETARY:

(Machine cutoff) ... Joint Resolution 44.

(Secretary reads SJR 44)

### PRESIDENT:

Senator Demuzio, the adjournment resolution.
SENATOR DEMUZIO:

Yes, Mr. President. I...would move for the...adoption of the Senate Joint Resolution 44 which is, in fact, the resolution that calls for us to return to Springfield...

#### PRESIDENT:

Tuesday at noon.

### SENATOR DEMUZIO:

... Tuesday at noon. Would... move the adoption.

### PRESIDENT:

All right. Senator Demuzio has moved to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 44. All in favor of the motion to suspend indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Senator Demuzio now moves the adoption of Senate Joint Resolution 44. All in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

For what purpose does Senator Geo-Karis seek recognition? SENATOR GEO-KARIS:

Yes, I do...Mr. President, Ladies and Gentlemen of the Senate, I would like to add as an immediate cosponsor to Senate Bill 617, Senator Emil Jones.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion. Is leave granted? Leave is granted. Senator Geo-Karis.

### SENATOR GRO-KARIS:

And I would like to be added as an immediate cosponsor to Senate Bill 372 of Senator Lemke's and with his okay.

### PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the second motion by Senator Geo-Karis. Is leave granted? Leave is granted. For what purpose does Senator Demuzio arise?

### SENATOR DEMUZIO:

Yes, Mr. President, I would...with leave of the Body, I

would request that we go to the Order of Consideration Postponed, House Concurrence for the purpose of reconsidering...Senate Bill 262.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion by Senator Demuzio. Is leave granted? Leave is granted. Mr. Secretary, on the Order of Bills Consideration Postponed...read House Bill...Senate Bill 262...concurrence. Senator Demuzio.

### SENATOR DEMUZIO:

Yes, Mr. President, apparently there was some confusion during the last debate relevant to what was in this proposal. I would, in fact, request that the Senate concur with House Amendment No. 3 to Senate Bill 262. It seems to me that we need to do this today, it is immediate. Most of these items that are in this appropriation are going to pass anyway, sometime during this Session. And I would ask that we now give thirty affirmative votes to the concurrence of Senate Bill 262.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? Senator Rock.

# SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise in support of House Amendment No. 3 to Senate Bill 262. This bill was just obviously within the hour reported to us having received sixty-two affirmative votes in the House. And for those who are playing some games, let me just point out that we have had a great deal of debate on the Ploor of this Senate with respect to the plight of the farmers. And there is twenty-five million dollars that the Governor is waiting for to...to sign into law today to alleviate that problem. In addition, there are fifty-five million dollars in income tax refunds, and I dare to say that there is not a single member of this Chamber or the other who has not in their district office heard from people who are

awaiting their income tax refunds. Well, it's right here and it can be signed into law today. And the fact of the matter is, we have been subject to unfortunately some demagoguery with respect to the seven hundred thousand dollars that's necessary to fulfill the will of this Body with respect to the compensation of State officials. fact of the matter is that is the law and we ought to be responsible enough to fund our action. It's not going to go away and we ought to do it and we ought to own up to our We approved by the will of this Body, responsibility. increased compensation long overdue for Cabinet officials, yes, for legislators, some of you enjoy, some of us do not, because we are in midterm; but the fact is that that's a decision that has already been made, and now as we are required by our oath of office to do we are fulfilling our statutory and constitutional responsibility by funding the programs that we have approved. I urge an Aye vote on the motion to concur.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall the Senate concur in House Amendment No. 3 to Senate Bill 262. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? All voted who wish? Have all voted who wish? Senator Luft.

## SENATOR LUFT:

Mr. President, having voted on the prevailing side, I'd like to move to reconsider the vote by which Senate Bill 262 failed.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator, as soon as I announce the vote, you can make that motion. On that question, the Ayes are 27, the Nays are 25, none voting Present...the Ayes are 29, the Nays are 25, none voting Present. Senator Luft.

### SENATOR LUFT:

Thank you, Mr. President. I'd like...having voted on the prevailing side, I move to reconsider the vote by which Senate Bill 262 failed.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Luft moves to reconsider the vote by which the Senate failed to concur in House Amendment No. 3 to Senate Bill 262. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Mr. Secretary.

### SECRETARY:

Senate Bill 262 with House Amendment No. 3.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

## SENATOR DEMUZIO:

Thank you, Mr. President. Apparently there was still some confusion relevant to the last explanation and therefore I would...I think the confusion has now been cleared up, and I would ask for the Senate's concurrence of House Amendment 3 to Senate Bill 262.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall the Senate concur in House Amendment No. 3 to Senate Bill 262. Those in favor will vote Aye. Those opposed vote...Senator Joyce.

# SENATOR JEREMIAH JOYCE:

I would just like to explain my vote...and I don't think I've...I've done that in all the time I've been here. I'm going to vote Yes on this bill because I think that's the right vote, but I was very disappointed in the members of the House who stood in this Chamber waiting to reap the benefits of legislation that I thought was proper the last time and then ran and scurried across to the other side and cast a vote to, I assume, insulate themselves from their constituencies. So I am voting Yes on this bill, but I would like that message to be in the record.

PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall the Senate concur in House Amendment No. 3 to Senate Bill 262. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On...on that question, the Ayes are 30, the Nays are 25, none voting Present. The Senate does concur in House Amendment No. 3 to Senate Bill 262 and the bill having received the required constitutional majority is declared passed. Senator Rock.

### SENATOR ROCK:
