And basically what the element of employment was exposed to is a cutback in Pederal funds of approximately 14.2 million dollars and, for that reason, the adjustments that had to made. I'd like to commend her and her...entire staff in conjunction with our staff for thoroughly investigating some very serious charges. Thank you, Mr. President. I have no objection but I thought it important for the record, these nominees were...their consideration was...were...was held up for a number of weeks. Essentially, the reason was because of the

terrible delay that has occurred in the decision-making process at the Industrial Commission. One of the commissioners in particular was the object of much criticism because of the large number of cases to which he was assigned and which there was an undue delay. Without going into the merits of that particular situation, I wanted to inform my colleagues in the Senate that the chairman, Chairman Bachman, has undertaken and has gotten the consent of all of these nominees...all of the commissioners to a procedure that hopefully within thirty days the backlog of cases will be substantially reduced; and those cases that are not disposed of within . thirty days will, within the power of the chairman, be reassigned. 1 have alerted. as has the chairman of the... Executive Appointments Committee, that the Senate intends to watch very carefully that these cases that have long sat dormant will be expeditiously handled and justice done on behalf of both sides in the controversy. I wanted to share this information with the members of the Senate. Thank you, Mr. President.

PRESIDENT:
