Thank you, Mr. President and thank you, Senators. On behalf of Senator Joyce and myself, I'd like to...thank you for your attention. On behalf of Senator Joyce and myself, I should like to introduce to you the State Championship Basketball Team from Mt. #### SENATOR ROCK:

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock requests to be added as a hyphenated cosponsor of Senate Bill 171. Is leave granted? Leave is granted. Senator D'Arco. Senator D'Arco, for what purpose do you arise?

SENATOR D'ARCO:

All right. I would like to rerefer Senate Bill 572 to the Public Health Committee. When this bill was presented in the committee, the opponents apparently were taken off guard and they were not prepared to testify. So we do want the opponents to be able to testify on the bill and therefore I would move to rerefer the bill back to Public Health.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator D'Arco, would you give us the number and the location of the bill again, please?

SENATOR D'ARCO:

It's 572 and it's on 2nd reading in the Senate and we want to rerefer it to Public Health.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator D'Arco seeks leave of the Body to recommit Senate Bill 572 to the Public Health, Welfare and Corrections Committee. All right, Senator D'Arco, is that where the bill came from?

SENATOR D'ARCO:

...I don't know.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, is leave granted?...leave is granted. 572 is recommitted. Senator Collins, for what purpose do you arise? SENATOR COLLINS:

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator, your motion is out of order until...included in your motion has to be the location for where the bills are. So, if you would, we can come back to you. Okay? Senator Lemke, for what purpose do you arise? SENATOR LEMKE:

Just the purpose of an announcement.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, what's your announcement?

### SENATOR LEMKE:

The Secretary of State and I would like to announce that...being deeply interested in ethnic heritage of the...our great country, I thought it would be proper to invite you all and to let you know that on Monroe Street side of the Capital, the exhibit ... "The Move to Freedom" exhibit is there. This exhibit is a traveling display...housing a forty-eight foot highway wedge van designed to recreate the images and impressions arrived by immigrants shared...of Ellis Island and the Statue of Liberty. My grandparents and my forefathers came and were part of that, as many of us; and the creative display is of history and patriotism, including a multimedial production, historical photography and film footage of the 1976 bicentennial celebration in a three and a half minute audio-visual presentation. It concludes with the direct request for visitors to the exhibit to support Statue of Liberty restoration project financially, and the exhibit will be there from 9:45 a.m. today to 6:00 p.m. think it's appropriate that we all should go there and advise as many of our staff and everybody else to go there because this is a symbol of patriotism in this country. This is the first symbol that my forefathers or most forefathers saw when they came to this country was the Statue of Libsrty, and I ask you all to take time out today to look at this exhibit. Thank you, very much.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator O'Daniel, for what purpose do you arise?
SENATOR O'DANIEL:

Mr. President, I would like leave to be added...with permission of the sponsor to be added as a cosponsor of Senate Bill 665. No, just...no, just a cosponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator, you can simply do that by giving the notice to the Secretary. Senator O'Daniel seeks leave of the Body to be added as a cosponsor of Senate Bill 665. Is leave granted? Leave is granted. It's so ordered. Senator Etheredge, for what purpose do you arise?

#### SENATOR ETHEREDGE:

Two...two items, Mr. President. Pirst, I would be...like...I would like to be identified as hyphenated cosponsor on Senate Bill 492, and then I would also like to move to Table Senate Bill 797 which is presently in the Transportation Committee.

## PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request. Senator Etheredge seeks leave of the Body to be added as the hyphenated cosponsor of Senate Bill 492. Is leave granted? Leave is granted. It's so ordered. Senator Etheredge...Senator Etheredge now moves to discharge the Committee on Transportation from further consideration of Senate Bill 797 with the purpose of Tabling. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The committee is discharged. Senator Etheredge now moves to Table Senate Bill 797. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The bill is Tabled. Senator...Senator Netsch, for what purpose do you arise?

#### SENATOR NETSCH:

Thank you, Mr. President. For two purposes; one, I want to Table a bill of my own that was a duplicate of an earlier one. So, I would then move to discharge the...the Committee on Agriculture from further consideration of Senate Bill 917 for the purpose of Tabling.

### PRESIDING OFFICER: (SENATOR DEMUZIO)

What would happen if these two are closed, which is being considered right now by the Mercantile Exchange; if these are closed, then it would cost the...the...cattle

feeders in this State the transportation costs when they would deliver these cattle the to Mercantile Exchange...if...if they bought on the futures and the price went down, they would have to deliver them to Omaha or Kansas City and that would...the cost of doing that is like a dollar and eighty cents a mile. So, it would...it would cost about six hundred dollars a truckload...or nine hundred dollars a truckload more than it currently costs to deliver in Joliet So, I'd ask for immediate consideration of this or Peoria. resolution.
