Senator Rock, for what purpose do you arise? SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. If I could have your attention, the committee schedule obviously is burdensome this week. We will begin again tomorrow at the hour of one o'clock to afford those committees that are meeting tomorrow morning an extra hour. In the meantime, while we are here, and we do have approximately forty-five minutes before the next committee begins, my suggestion is, and I've spoken with Senator Philip, that we start on Senate bills 2nd reading. As you know, as bills are amended particularly with committee amendments they...of necessity go upstairs to Enrolling and Engrossing so that copies can and will be made available, and the paper work is almost insurmountable. What I would ask is if the members would each knowing obviously their own legislative proposal, if we can attempt to move those that are not so very controversial, and attempt...there are bills that came out of committee without any controversy, there are amendments that are to go on virtually without any controversy, and if we could kind of discipline ourselves to handle the noncontroversial ones, we'll have plenty of time within which to fight, but let's see if we can move the paper along. So in that regard, Mr. President, I'd suggest that we start on Senate bills 2nd reading, asking the members to skip only those where there might be some controversy and try to move as many as we can in the next forty minutes.

## SENATOR BERNAN:

This is a six line amendment or five?

# SECRETARY:

4...in the other type of...

#### SENATOR BERMAN:

All right. Thank you. Amendment No. 2 is a request from the Christian Science Church to add the inclusion of any other type of remedial care within the coverage of this provision. I move the adoption of Amendment No. 2.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Berman moves the adoption of Committee...Amendment No. 2 to Senate Bill 299. Is there any discussion? If not, those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

# SECRETARY:

Amendment No. 3, by Senator Berman.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Berman.

## SENATOR BERMAN:

This is a technical amendment requested by the Department of Public Aid dealing with cash assistance and food stamps.

I move the adoption of Amendment No. 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Berman moves the adoption of Amendment No. 3 to

Senate Bill 299. Any discussion? If not, those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 3 is adopted. Any further amendments?

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. Senator Rock, for what purpose do you arise?

#### SENATOR ROCK:

Thank you...thank you, Mr. President and Ladies and Gentlemen of the Senate. The hour of two is rapidly approaching. I think this is a logical break point with one exception, Senator Holmberg has a bill that I understand is of an emergency nature, and that is Senate Bill 339, which is to be amended. If we could go to that order of 339, then Senator Netsch has a motion in writing and that will conclude our business until one o'clock tomorrow.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. With leave of the Body, we will go to Senate Bill 339, middle of page 7. Is leave granted? Leave is granted. Mr. Secretary, Senate Bill 339.

# SECRETARY:

Senate Bill 339.

(Secretary reads title of bill)

2nd reading of the bill. Committee on Appropriations I
offers one amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Holmberg.

## SENATOR HOLMBERG:

Thank you, Mr. President. The amendment reduces the amount asked for by the choir from fifteen thousand to twelve thousand five hundred. We're moving it today because the tour begins June 1st and it's necessary to get these funds from the Tourism Fund to them very quickly.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Holmberg has moved the adoption of Committee Amendment No. 1 to Senate Bill 339. Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Any further committee amendments?

PRESIDING OFFICER: (SENATOR DEMUZIO)

# SECRETARY:

Amendment No. 2 offered by Senator Donahue.

Senator Donahue.

# SENATOR DONAHUE:

Thank you, Mr. President. This amendment is for the sum of six thousand dollars that would be appropriated from the Department of Commerce and Community Affairs...Tourism Fund for the Ashland High School band to go to the Independence Day Parade July 4th in Washington, D.C. We have...are amending Senator Holmberg's bill simply because it must...the payment of these funds need to be by July 4th when these kids go to Washington.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Donahue moves the adoption of Amendment No. 2 to Senate Bill 339. Any discussion? If not, those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

#### SECRETARY:

No further amendments.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. On...Senator...Senator Jones, for what purpose do you arise? Senator Jones. Senator Jones.

## SENATOR JONES:

Yes, thank you, Mr. President. I have a motion to suspend the...the posting rule...Six-day Posting Rule so that Senate Bill 56, 60, 96, 101, 140, 293, 369, 424, 566, 591, 614, 622, 630, 637, 638, 710, 715, 716, 717, 718, 726, 752, 817, 873, 907, 974, 1030, 1048, 1062, 1066, 1068, 1069, 1080, 1131, 1132, 1138, 1220, 1221, 1222, 1223, 1224, 1226, 1247, 1258, 1299, 1309, 1353, 1354, 1355, 1362 and 1375, that these bills be posted for a hearing tomorrow in the Insurance Committee at 5:00 p.m. Due to a mix-up, the bills were inadvertently not posted, and that I...I'd like to suspend the posting rule that...so that these bills can be posted in hearing tomorrow in the Insurance Committee.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've...heard the motion. Senator Jones wishes to suspend rule 7C for the purpose of waiving the posting requirement so that the bills, in fact, can be heard this week. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Motion is carried. All right. Senator Etheredge, for what purpose do you arise?

Mr. President, I move to discharge the Committee on Local Government from further consideration of Senate Bill 780, and further move that that bill, 780 be referred to the Senate Revenue Committee. I have discussed this with the two chairmen.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...Senator Etheredge has moved to discharge the Committee on Local Government from further consideration of Senate Bill 780 and that the bill be rereferred to the Committee on...on Revenue. Senator...Senator Netsch.

I would think then, Senator Etheredge, you might want to, just to cover us, to make sure to waive the Six-day Rule and

it will be posted for Thursday, right?

PRESIDING OFFICER: (SENATOR DENUZIO)

Let's...let's take one at a time, all right? All right...Senator Etheredge has moved to discharge the Committee on Local Government from further consideration of 780, that the bill be rereferred to the...Committee on Executive. Those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. It's so...Committee on Revenue...I think I said Executive, Committee on Revenue. I...all right, now, Senator Etheredge wishes to move to suspend Rule 7C for the purpose of allowing this bill to be heard...suspending the rules on the Order of Posting. Is leave granted? Leave is granted. It's so ordered. On the Order of Motions, Senator Netsch.

## SENATOR NETSCH:

Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator Netsch, for...we'll have the motion read. Mr. Secretary, read the motion.

# SECRETARY:

I move to suspend Senate Rule 5C for the purpose of allowing Senate Committee on Agriculture, Conservation and Energy to conduct a hearing and to make a recommendation on Senate Bill 1021 on or before May the 10th, 1985. Signed, Senator Netsch.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Netsch.

## SENATOR NETSCH:

Thank you, I...I think it is important for all the members to listen to this. This with the concurrence...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Hold on...hold on...just a moment, Senator Netsch. If we can have order for a moment, please. We're getting ready to adjourn. This is an important announcement and certainly we

want to afford Senator Netsch every courtesy. Senator ... Netsch.

## SENATOR NETSCH:

...this relates to the bill of the ... that represents the findings of the Joint Committee on Utility Regulation. we are requesting is that the bill be heard and acted on after the deadline of this week. This is with the concurrence of the chairman and minority spokesman of the Committee on Agriculture, and the President of the Senate and the minority leader. It obviously is a very complicated bill and, in fact, it is about two hundred and four pages. It is not fully available to the members as yet and it seemed only reasonable that it be given an ample opportunity to be fully heard. So what ... we will do is, the bill is posted for tomorrow. If the amendment is available, and we hope it will be, it will be put on the bill tomorrow so that people can see the text of the bill. It is only a shell bill at the moment. I understand from Senator Joyce there will some witnesses heard, but the bill will not be finally heard and acted on until next week when there is more time for it. That is the purpose of the motion and I would now move adoption of the motion.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've...you've...you've heard the motion...is there any discussion on this motion? All right.

Senator...Senator Netsch has moved to...to suspend Rule 5C to extend the deadline in reference to Senate Bill 1210 to May 10th. All right. Senator Netsch has moved to suspend Rule 5C for the purpose of allowing the Senate Committee on Agriculture, Conservation and Energy to...conduct a hearing and to make a recommendation on Senate Bill...1021 on or before May 10th, 1985. Those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. The motion is adopted. All right. Senator Geo-Karis, for what purpose do you arise?

## SENATOR GEO-KARIS:

Mr. President, Ladies and Gentlemen of the Senate, I would like to remove myself as chief sponsor of Senate Bill 1153 and substitute Senator David Barkhausen as chief sponsor on Senate Bills 1153 since this topic takes mostly...takes place mostly in his district.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the motion. Is leave granted?

Leave is granted. So ordered. Senator Barkhausen will be substituted in place of Senator Geo-Karis on Senate Bill 1153. Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Thank you, Mr. President. I'd ask leave of the Body, please, to offer the name of Senator Keats as hyphenated sponsor to Senate Bill 74.

# PRESIDING OFFICER: (SENATOR DENUZIO)

All right. Senator Smith...requests Senator Keats be added as a hyphenated cosponsor to Senate Bill 74. Is leave granted? Leave is granted. Senator Barkhausen, for what purpose do you arise?

## SENATOR BARKHAUSEN:

Mr. President, in the President's Gallery we are privileged to have visiting today, Mayor Paul Neal and his wife, Mary, from the Village of Libertyville, in my district. I'd ask the Senate to make them welcome.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

If the Mayor and the First Lady would please rise and be welcomed to the Senate. All right. Senator Rock.
SENATOR ROCK:

Thank you, Mr. President. The committee schedule is a full one, so I suggest we now adjourn until one o'clock tomorrow, one o'clock on Wednesday.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock...Senator...Senator Smith.

# SENATOR SMITH:

Thank you. I merely want to ask the Body, we have in our presence today, students from Kennedy-King College, they're a nursing program, they're here lobbying today. Where are you? Will you please stand.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

Will our guests please stand and be recognized by the Senate. Are they here? All right. Senator Rock has moved that the Senate stand adjourned till Wednesday, April...or May 1st, at the hour of one o'clock.
