SENATOR DAVIDSON:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Correct.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Woodyard to be added as a hyphenated cosponsor of Senate Bill 1614. Is leave granted? Leave is granted. It's so ordered. All right, Mr. Secretary, have there been any objections filed to the Resolutions Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. On the adoption of the Resolutions Consent

Calendar which has been passed out, with leave of the Body, we will add House Joint Resolution 186, House Joint Resolution 188, Senate Resolution 854, 855, 856, 857. Is leave granted to have those added? Hearing no objections, leave is granted. It's so ordered. Senator Degnan moves the adoption of the Resolutions Consent Calendar. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Resolutions Consent Calendar is adopted. Senator Degnan, for what purpose do you arise?

SENATOR DEGNAN:

Thank you, Mr. President. To add as a hyphenated cosponsor...Senator Philip to Senate Bill No. 2087.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Degnan, would you repeat your request again, please?

SENATOR DEGNAN:

Yes. I would like to add as hyphenated cosponsor Senator Philip to my Senate Bill 2087.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Degnan to add Senator Philip as a hyphenated cosponsor of Senate Bill 2087. Is leave granted? Leave is granted. It's so ordered. Senator Rock, for what...on the adjournment resolution? We'll get to announcements in a minute.

SECRETARY:

Senate Joint Resolution 148 offered by Senator Rock.

(Secretary reads SJR 148)

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, it...it is 145. Senate Joint Resolution 145. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This calls...this is the adjournment resolution. When we conclude our business tomorrow morning, we will

return to Springfield next Tuesday at the hour of one o'clock, and I would move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 145 and then we'll explain what tomorrow is about.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock has moved for the suspension of the rules and immediate consideration and adoption of Senate Joint Resolution 145. Discussion? None. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Rules are suspended. Senator Rock now moves the adoption of Senate Joint Resolution 145. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 145 is adopted. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. We have a relatively heavy committee schedule this afternoon with Finance and Elections and Insurance again to meet. Tomorrow is the last day for bills to be reported out of committee. So, it is our hope that those committee...and Revenue, I beg your pardon, Revenue at two o'clock. It is our hope that the committees can conclude their work this evening, and tomorrow morning we will convene at 9:00 a.m. for the purpose of reading in those committee reports and adjourn just as quickly as we can so that those who feel that they have to get back to their district this evening certainly are entitled to do that. We'll commence next Tuesday then at one o'clock and move, of course, to the Order of 2nd Reading on all the bills that have come out of committee; and next week, of course, is the week for the deadline for appropriation bills, and we will again, I hope, be in a position to conclude our business on Thursday. We will not be here a week from tomorrow. We'll conclude on Thursday. Friday, May 9th...8th...9th, whatever it is, but tomorrow morning at nine o'clock. Today we have a very brief schedule. Senator Vadalabene has requested leave to go to the Order of Constitutional Amendments 3rd Reading to have that amendment read a third time and acted upon, and then we will...absent any other business, we will be in the position to adjourn until nine o'clock tomorrow morning.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, with...is there leave of the Body to go to page 11, Constitutional Amendments 3rd reading? Leave is granted. On the Order...page 11, Constitutional Amendment 3rd reading, Senate Joint Resolution 11. Mr. Secretary.

Senate Joint Resolution No. 11 Constitutional Amendment.

(Secretary reads SJR No. 11 CA)

3rd reading of Senate Joint Resolution No. 11 Constitutional Amendment as amended by House Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, can we have some order, please. Senator

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. Senate Joint Resolution 11 as amended proposes to amend the Section 6 of Article X of the State Constitution to authorize exemption from property taxation of property used exclusively for veteran organizations, and I appreciate a favorable vote. PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Discussion? If not, the question is, shall the Senate...shall Senate Joint Resolution be passed and approved. The question is, shall Senate Joint Resolution 11 with House Amendment 1 as...be adopted. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record.

On that question, the Ayes are 54, the Nays are none, none voting Present. Senate Joint Resolution 11 having received the required three-fifths constitutional majority is declared passed and approved. Further business to come before the Senate? Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, I want to remind all of those of you who do want to participate in the Governor's Prayer Breakfast next Thursday morning at the Holiday Inn East, if you want to have a seat in the area which is reserved for the legislators, please get your order and your money to me today or tomorrow morning. Tomorrow is the last day we're going be...hold any reserved seats for you. After that, you're on your own if there's anything available. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Berman, for what purpose do you arise?

SENATOR BERMAN:

Thank you, $\operatorname{Mr}_{\bullet}$ President. If I could just have a moment of order.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Ladies and gentlemen, can we have some order, please.

Senator Berman.

SENATOR BERMAN:

I just think that because of our heavy schedule we couldn't do anything that was more formal than this, but I think it's apropos for us to take just a moment, we being the Senate of the Illinois...of the State of Illinois, to recognize that today is Law Day and that we are all about passing of laws, reviewing of laws, approving them, disapproving them and that we are all very proud to live in a State and a country that is based upon laws and that we recognize this day, May 1, as Law Day in Illinois and in the United States. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Your Honor, thank you. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you, Mr. President. An announcement. The Revenue Committee will meet immediately upon adjournment in Room 212.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Well, Mr. President and Ladies and Gentlemen of the Senate, are you going to go to the motions?

PRESIDING OFFICER: (SENATOR DEMUZIO)

We . . . we . . .

SENATOR GEO-KARIS:

... cause I have filed a motion.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR GEO-KARIS:

Well, point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, state your point.

SENATOR GEO-KARIS:

I had Constitutional Amendment Resolution No. 12 in Executive Committee today. I was finally given a hearing after we defeated the motion to adjourn before the...the resolution was...called, then when it was heard, there was a motion to pass, seconded, duly seconded and then the chairman just adjourned surreptitiously. So, I have filed a motion to put on first reading, and...that's exactly what happened, as you all know, and I have filed that motion in writing with you and I would like to have it heard.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator Geo-Karis, we are not on that order of

business. Senator Kelly, for what purpose do you arise? SENATOR KELLY:

Thank you, Mr. President. For the purpose of making an announcement. The Senate Elections and Reapportionment Committee will have a meeting immediately following adjournment in Room A-1. We only have a couple of bills. I'd be very grateful if the members would join us so we can move it along expeditiously. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Poshard, for what purpose do you arise?

SENATOR POSHARD:

Thank you, Mr. President. I would like to be included, with the permission of the sponsor, as hyphenated cosponsor of Senate Bill 1798.
