PRESIDING OFFICER: (SENATOR SAVICKAS)

The hour of nine having arrived, the Senate will come to order. Will our guests in the gallery please rise. Our prayer will be...by Rabbi Israil Zoberman of the Temple B'rith Sholom in Springfield.

RABBI ZOBERMAN:

PRESIDING OFFICER: (SENATOR SAVICKAS)

Reading of the Journal. Senator Nedza.

SENATOR NEDZA:

Thank you, Mr. President. I move that reading and approval of the Journals of Wednesday, April the 24th; Thursday, April the 25th; Tuesday, April the 30th; Wednesday, May 1st and Thursday, May 2nd, in the year 1985, be postponed pending arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion of Senator Nedza's. Is there any objection? Hearing no objection, leave is granted. Committee reports.

SECRETARY:

Senator Jeremiah Joyce, chairman of Finance and Credit Regulations, reports out the following Senate bills:

PRESIDING OFFICER: (SENATOR SAVICKAS)

SECRETARY:

Message from the House by Mr. O'Brien, Clerk.

Message from the House by Mr. O'Brien, Clerk.

Mr. President - I'm directed to inform the Senate the House of...Representatives has adopted the following joint resolutions, in the adoption of which I am asked the concurrence of the Senate, to-wit:

Senate...or House Joint Resolution 41 and 42, and they're both congratulatory.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Consent Calendar. For what purpose Senator DeAngelis arise?

SENATOR DeANGELIS:

Thank you, Mr. President. Yesterday in...I requested leave of the Body to Table a bill from the Revenue Committee and, unfortunately, I gave the wrong bill number. I would like to reconsider that leave and then submit another motion to give you the right bill number.

PRESIDING OFFICER: (SENATOR SAVICKAS)

That motion is in order.

SENATOR DeANGELIS:

I would like to reconsider the motion that...having voted on the prevailing side, I would like to reconsider the motion by which Senate Bill 1136 was Tabled from Revenue. First of all, it wasn't even in Revenue. So, I'd like to reconsider that motion first.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator, then you intend to recommit 1136 back into its original committee?

SENATOR DeANGELIS:

Yeah, but I think it was on the Calendar, if I'm not mistaken.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

SENATOR DEMUZIO:

Mr. President, I...I didn't hear Senator DeAngelis' motion, so if he would restate it for us, I would be grateful.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator DeAngelis, yesterday had erred in a motion to discharge Senate Bill 1136 from committee...from the Committee on Revenue, for the purposes of Tabling. Senate Bill 1136 was reported out of committee yesterday on a Do Pass motion. So his error has caused a mechanical problem here. We wish to...just for the record, Senator DeAngelis now wishes to reconsider the motion by which that...reconsider the vote by which that motion passed, get it back in order and submit the proper bill number for Tabling. Senator DeAngelis.

SENATOR DeANGELIS:

That being done then, I would like to request leave of the Body to discharge the Committee on Revenue from further consideration of Senate Bill 1198, which is the proper number, for the purposes of Tabling the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

So to get our motions in proper form, Senator DeAngelis now moves to reconsider the vote by which Senate Bill 1136 was Tabled. Those in favor of reconsidering vote Aye. Those opposed vote Nay. The Ayes have it. The motion carries. Now, Senator DeAngelis wishes to have Senate Bill 1136 reported back on the Calendar in its proper order. On that motion, those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries. Senate

Bills 1136 is now on the Order of 2nd Reading. Now, Senator DeAngelis wishes to discharge the Committee on...on Revenue from further consideration of Senate Bill 1198 for the purposes of Tabling. Is there...Senate...Senator Netsch.

SENATOR NETSCH:

Yes, I think...just to allay the fears of some of my colleagues over here, I think Senator DeAngelis finally has it straightened out. He Tabled the wrong bill...from the wrong committee yesterday. He meant to Table a basically duplicative bill that was in the Revenue Committee, and he has now got it right on and I concede that he is doing the...the correct order of business today.

PRESIDING OFFICER: (SENATOR SAVICKAS)

On the motion to discharge, those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 1198 is discharged from the Committee on Revenue and is ordered place on the Calendar on the Order of...now with Senate Bill 1198 being in front of us, Senator DeAngelis moves to Table Senate Bill 1198. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries. And Senate Bill 1198 is Tabled. Senator Luft.

SENATOR LUFT:

Thank you, Mr. President. I'd ask leave to add Senator D'Arco and Senator Savickas as hyphenated cosponsors on Senate Bill 1074.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion. Is there any objection? Hearing no objection, leave is granted. Senator D'Arco.

SENATOR D'ARCO:

Thank you, Mr. President. I would move to discharge Public Health from further consideration of Senate Bill 572 for the purposes of Tabling it.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion of Senator D'Arco. He wishes to discharge Committee on Public Health from further consideration of Senate Bill 572. Is there any discussion? All those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 572 is discharged from committee. Senator D'Arco now wishes to...to move that Senate Bill 572 be Tabled. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 572 is Tabled. Senator Jones.

SENATOR D'ARCO:

No, wait. Hold it...

PRESIDING OFFICER: (SENATOR SAVICKAS)

Oh, Senator D'Arco.

SENATOR D'ARCO:

...I got one more. I would also move to discharge Financial Institutions from further consideration of Senate Bill 326 for the purposes of Tabling it.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator D'Arco moves to discharge the Committee on Financial Institutions from further consideration of Senate Bill 326. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 326 is discharged from committee. Now, Senator D'Arco moves that Senate Bill 326 be Tabled. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 326 is Tabled. Senator Jones. Senator Jones.

SENATOR JONES:

Yeah, thank you, Mr. President. I'd like leave to suspend the posting rule so that Senate Bill 81 will be heard in Insurance Committee...this morning.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Jones moves to waive the Six-day Posting Notice for immediate consideration of...Senate Bill 81 in the

Committee on Insurance. Is there leave granted? Hearing no objection, leave is granted. Senator Kelly.

SENATOR KELLY:

Yes, Mr. President, I'd like to get leave...on my bill, Senate Bill 234 to have Senator Rigney and Senator...Bloom added as hyphenated sponsors.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion of Senator Kelly. Is there any objection? Hearing no objection, leave is granted. Senator Poshard.

SENATOR POSHARD:

Mr. Chairman, thank you. I'd like to discharge from Transportation Committee for purposes of Tabling Senate Bill 981 and Senate Bill 985.

PRESIDING OFFICER: (SENATOR SAVICKAS)

...Poshard moves to discharge the Committee on Transportation from further consideration of Senate Bill 981 and 985. Is there any objection? All those in favor will indicate by saying Aye. Those opposed. The Ayes have it. The motion carries and Senate Bill 981 and 985 are discharged from the committee. And now, Senator Poshard moves that Senate Bills 981 and 985 be Tabled. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries. Senate Bills 981 and 985 are Tabled. Senator Dudycz.

SENATOR DUDYCZ:

(Machine cutoff)...President, I ask...I request leave to have my name removed as a hyphenated sponsor on Senate Bill 374. My name was put on without my knowledge, and I have list of Senate bills I'd like to be added as a sponsor with the permission of the chief sponsors. I'll hand it to you.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator...you've heard the motion of Senator Dudycz on the removal of his name as a hyphenated cosponsor. Is there

any objection? Hearing none, leave is granted. Senator, if you'd give the list to the Secretary. Resolutions.

SECRETARY:

Senate Resolution 192 offered by Senators Lechowicz, Nedza, Lemke, Rock, it's commendatory.

Senate Resolution...193, by Senators Keats, Berman and all Senators, and it's...congratulatory.

Senate Resolution 194, Senator Geo-Karis, and it's congratulatory.

Senate Resolution 195, by Senators Topinka, Zito and all Senators, and it's congratulatory.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Consent Calendar. Senator Chew.

SENATOR CHEW:

Mr. President, would you have the record indicate that Senator Glenn Dawson has left Springfield because of illness.

PRESIDING OFFICER: (SENATOR SAVICKAS)

The record will so indicate. Resolutions.

SECRETARY:

Senate Joint Resolution 49 offered by Senator Chew.

(Secretary reads SJR 49)

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

SENATOR DEMUZIO:

Thank you, Mr. President. This is in fact the adjournment resolution which calls us to return to Springfield on May the 7th, at the hour of twelve noon when we adjourn today. I would move adoption of the joint resolution.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion. Is there any discussion? Hearing no objection, leave is granted. The motion carries. Now on the adoption of the resolution, is there any discussion? If not, those in favor indicate by saying Aye. Those opposed. The Ayes have it. The motion carries. Resolutions.

Senators, on your desks are the Resolutions Consent Calendar.

Are there any objections to those resolutions that are listed on the Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Mr. Secretary, we also have in addition House Joint Resolutions 41 and 42, Senate Resolutions 192, 193, 194 and 195 added to the Consent Calendar. Has there been any objections to any of these?

SECRETARY:

No objections have been filed.

PRESIDING OFFICER: (SENATOR SAVICKAS)

If no objections have been...filed, those in favor of adopting the resolutions on the Consent Calendar and those that have just been added will indicate by saying Aye. Those opposed. The Ayes have it. The motion carries. The resolutions are adopted. On Senator Demuzio's motion to adopt, the motion carries. (Machine cutoff)...Netsch.

SENATOR NETSCH:

Thank you, Mr. President. I would like to...I would seek leave of the Body to change the sponsorship of Senate Bill 258, of which I am the sponsor, to Committee on Revenue. The sponsorship will be shown as a committee bill, Committee on Revenue. Senate Bill 258.

PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard...you've heard the motion of Senator Netsch. Is there any discussion or any objection?...hearing none, leave is granted. Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. President. With permission of the sponsor, I would like to be added as a hyphenated cosponsor of Senate Bill 662. I would ask leave.

PRESIDING OFFICER: (SENATOR SAVICKAS)



You've heard the motion of Senator Kustra. Is there any objection? Hearing no objection, leave is granted. (Machine cutoff)...since we have completed our business of the Senate for the day and there are committees that are waiting to start operation, we will stand in Recess until ten, and those committees that wish to start operating immediately may do so. Senator Demuzio.

SENATOR DEMUZIO:

So, we...we will...be conducting no other business, we will simply be adjourning at ten and committees can continue, is that correct?

PRESIDING OFFICER: (SENATOR SAVICKAS)

That's right, Senator. Senator Jones.

SENATOR JONES:

Yeah, thank you, Mr. President. If that's the case then, the Insurance Committee will begin at ten minutes to ten in Room 400, immediately.

PRESIDING OFFICER: (SENATOR SAVICKAS)

(Machine cutoff)...Senate now stands in Recess until ten o'clock. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I'm a little unclear, so to speak. Are we to go to our committees at ten o'clock, and...

PRESIDING OFFICER: (SENATOR SAVICKAS)

I...I would suggest if the committee chairman called it for ten to ten, that you should be there ten to ten.

SENATOR GEO-KARIS:

I see. You want us there, and then, do...if we're committees...we're not going to have to be back here, is that right?

PRESIDING OFFICER: (SENATOR SAVICKAS)

No further business will be conducted in the Senate Chamber.

SENATOR GEO-KARIS:

By the way, Mr. Chairman...Mr. President, was the adjournment resolution already passed?

PRESIDING OFFICER: (SENATOR SAVICKAS)

It was read in, passed and adopted.

SENATOR GEO-KARIS:

And when do we come back?

PRESIDING OFFICER: (SENATOR SAVICKAS)

We will return May 7th, at noon.

SENATOR GEO-KARIS:

Thank you.
