Senator Watson, for what purpose do you arise?

SENATOR WATSON:

Thank you, Mr. President. Just for an announcement.

SENATOR WATSON:

Along with Senator Demuzio we have another birthday boy here today in the...in the Senate, my seatmate, Cal Schuneman. He's a little older than forty-four and there's no cake; in fact, he's...he said he's trying to ignore the whole thing altogether, but any way I'd like to wish him a happy birthday.

PRESIDENT:

Happy birthday, Senator Schuneman. Just goes to...goes to further show that May is a very good month, indeed, yes. Senator Philip, for what purpose do you arise?

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like the record to indicate that Senator Etheredge is absent today because his mother-in-law passed away and...Senator Rupp is absent because of death in the family, he's out of State.

PRESIDENT:

The record will so reflect. Thank you, Senator. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Well, Mr. President and Ladies and Gentlemen of the Senate, we mentioned birthdays, but I think this Senate...Body should be alerted to the fact that the President...President of the Senate added a year this past week and so did Senator Berman, but you haven't told us how old you are.

PRESIDENT:

Old enough to know better.

SENATOR GEO-KARIS:

...Happy birthday.

PRESIDENT:

Thank you. If I can have...if I can have your attention,

we've distributed to all Senators a memorandum that I'd ask you to take a look at and you'll understand, I think, the urgency of it. As of tomorrow, we will have eight hundred and ninety-two bills on 2nd reading. It is pretty obvious to Senator Philip and I, at least, that an agreed bill process will be necessary, so we're asking is today and tomorrow in particular that we make every effort to move bills from 2nd to 3rd reading because at the close of business on Thursday...and Senator Philip and I have agreed that we will not be in Session on Friday, so at the close of business on Thursday afternoon, we will then be in a position to assess the 3rd reading bills and hopefully come up with an Agreed Bill List which will be presented for your action next week. In the meantime, obviously, it's necessary to move as many as possible from 2nd to 3rd reading. So, I'd ask you to take a look at the memo, if you have any questions, we'll be here all day. All right, on the Order of Senate Bills 2nd Reading, Mr. Secretary, the bottom of page 6. We'll start where we left off last week on Senate Bill 300, Senator Marovitz. Read the bill, Mr. Secretary.

SENATOR MAROVITZ:

Thank you, very much, Mr. President and members of the Senate. Amendment No. 1 to Senate Bill 300 adds certain conditions which will trigger events under which the...the rights to a conversion policy shall terminate. First of all, the former spouse's becoming an employee injured under any other group policy and, number two, the former spouse

remarries that would terminate the conversion rights, and I would ask for adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Any discussion? Senator Marovitz moves the adoption of Committee Amendment No. 2 to Senate Bill 300. Those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 2 is adopted. Any further committee amendments?

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR MAROVITZ:

SENATOR DeANGELIS:

Thank you, Mr. President. Amendment No. 1 deletes the jurisdictional enlargements of the Commerce Commission by striking out "the enlargement are for repair and maintenance of grade crossing surfaces and signals." Both Senator Joyce and Senator Rupp had difficulty with that. We have stricken that language. The bill simply now enlarges the amount of money available in that fund.

Committee Amendment No. 1 to Senate Bill 328...this amendment allows non-for-profit organizations that have vehicles who transport handicapped persons the opportunity to display the special decal and utilize the special parking privilege reserved for handicapped persons, and I move for its adoption.

...or 328, I'm sorry, removes the word "primarily" and I would move for its adoption.

SENATOR WELCH:

Thank you, Mr. President. The amendment changed the bill and what the amendment does is creates an Act to establish a Regional Service Agency Fellowship Program to be administered by the Department of Commerce and Community Affairs. It provides that fellowships be awarded to students at participating universities for work assignments in local government in

non-profit community service agencies. The idea behind this program is to have interns from public administration programs throughout the entire State of Illinois available to municipalities under fifty thousand people so that they could acquire some of the benefits through known changes of city managers of other incidents learned in college that are not available to small towns.

What the amendment says is, it amends, at line 11 of the bill, and requires each billing statement which sets forth the charges assessed against a consumer by a public utility for the furnishing of gas for heat or cold or electricity shall, and here's the amendment, "clearly identify the customer's rate classification in a manner readily understandable." That language, Senator Maitland, was worked out in conjunction with the...CIPS and the Commerce Commission and it...they offered the amendment to me. So, I believe it takes care of their problem.

territory is to be extended in lines between the boundaries of the forest preserve district annexation shall not be permitted."

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis moves the adoption of Committee Amendment No. 1 to Senate Bill 624. Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Any further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

SECRETARY:

Amendment No. 2 offered by Senators Bloom, Dawson and Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...Bloom on the Floor?

SECRETARY:

...we'll make it Amendment No. 2, by Senator DeAngelis.

All right. Senator DeAngelis on Amendment No. 2.

SENATOR DeANGELIS:

I am sorry, that was Amendment No. 2. Amendment No. 1 is the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis, why don't you explain Senate Amendment No. 1 which is the committee amendment.

SENATOR DeANGELIS:

Committee Amendment No. 1 creates the exemption for the certificate of need of up to three million dollars and thirty beds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Committee Amendment No. 1 was adopted. Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

SECRETARY:

Amendment No. 2 offered by Senator DeAngelis.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Amendment No. 2, which is the Floor amendment, takes the exemption now from thirty beds down to ten beds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator DeAngelis has moved the adoption of Amendment No. 2 to Senate Bill 624. Any discussion? Senator Bloom.

SENATOR BLOOM:

I'll withhold my remarks until we get to our amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis has moved the adoption of Amendment No. 2 to Senate Bill 624. Any further discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Would the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield, Senator...Geo-Karis.

SENATOR GEO-KARIS:

Senator DeAngelis, by your amendment are you saying...I just want to understand your amendment 'cause I'm not quite clear. Are you saying that the Illinois...the Health Facilities Planning Agency would not have any right to effect the change of number of beds under your amendment? Would you explain it, please?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator DeAngelis.

SENATOR DeANGELIS:

Are you talking about the Floor amendment?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Geo-Karis.

SENATOR GEO-KARIS:

Yes, your last amendment I believe it was.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

It lowers the exemption from thirty beds down to ten beds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Geo-Karis.

SENATOR GEO-KARIS:

What do you mean by exemption, would you explain it in easy language for me?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

Well...you could bypass the certificate of need if you were expanding by ten beds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...further discussion? Senator Bloom, your light is still on. Senator Bloom.

SENATOR BLOOM:

Well...yeah, okay. This bill by virtue of the amendment that the hospital association caused to be put on in committee and now by virtue of the two Floor amendments is rather...one Floor amendment...is rather controversial. I thought we were just going to kind of move through the Calendar and...no...okay. Because what...what this does is absolutely turn the evaluation of policy towards capital planning and health care delivery on its head by virtue of the committee amendment and the Floor amendment...Floor Amendment No. 1. And I would...say that the effects of this will be especially devastating in terms of policy and health care delivery in not only the Chicago area but in other urban areas downstate and it won't be any great shakes in the rural areas downstate. And I would caution the membership...that what we are seeing here is an end run around the Health Finance Reform Act...that this Body labored on for two

years last year and finally passed. I would urge rejection of this amendment, and as the bill presently is, urge opposition on 3rd reading.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President, if I read the amendment correctly, this will circumvent the certificate of need. You're dropping it to ten beds on the expansion but in each year if you expand by ten beds you...you just circumvent the certificate of...or...the authority's certificate of need to expand. So you could accomplish what you have to do now by showing the certificate of need just by waiting and each year expanding under the ten-bed provision. Is that correct?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis. Senator DeAngelis.

SENATOR DeANGELIS:

Senator Savickas, the bill...the amendment that was put on in committee permitted the expansion without a certificate of need of thirty beds over two years. This says it can only be ten beds over a one-year period.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Question of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Schuneman.

SENATOR SCHUNEMAN:

Our analysis indicates that in addition to changing the limitation on beds that you're also raising the capital expenditure limit from six hundred thousand to three million dollars. Is that three million dollars in any one year or what is that, Senator?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

Well, that was Committee Amendment No. 1, Senator Schuneman, and I believe it's over a two-year period. This is not the Floor amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Schuneman...Senator Schuneman.

SENATOR SCHUNEMAN:

Well, have we adopted the Floor amendment, Mr. President? I thought that's...that was the issue?

PRESIDING OFFICER: (SENATOR DEMUZIO)

We have adopted Committee Amendment No. 1, we are on Floor...the first Floor amendment, Amendment No. 2.

SENATOR SCHUNEMAN:

Okay, so how does your...how does your Floor amendment change...change that provision then, if any, Senator?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

It does not, Senator Schuneman.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Schuneman.

SENATOR SCHUNEMAN:

Well, I just think the members ought to be aware of what's going on here. Apparently we've already adopted the amendment that makes these significant changes, but in the last several years this Senate has spent many, many hours trying to accomplish some kind of cost containment within our hospital systems. We...many years ago, or a number of years ago, established the Health Facilities Planning Board which would have to give prior approval to many of these hospital expansions throughout the State and last year passed Senate Bill 495; but this bill tends to indicate that hospitals now can spend up to three million dollars without any approval,

without any certificate of need and, of course, also changes this bed requirement. Now apparently we're past that particular amendment but I think the members ought to be aware of what's happening here.

PRESIDING OFFICER: (SENATOR DEHUZIO)

All right. Further discussion? Senator DeAngelis may close.

SENATOR DeANGELIS:

Well, nobody's...there's nothing sinister about this approach, Senator Schuneman. That bill was...that amendment was aired in committee and passed in committee, there's no attempt at all to disguise that. When we get to 3rd reading the bill will be explained thoroughly and you can vote it up or down at that time.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator DeAngelis moves the adoption of Amendment No. 2 to Senate Bill 624. Those in favor signify by saying Aye. There's been a request for a roll call. Senator DeAngelis moves the adoption of Amendment No. 2 to Senate Bill 624. Those in favor of the adoption of the...Senator DeAngelis, for what purpose do you arise?

SENATOR DeANGELIS:

Let me clear...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

...let me clear up the confusion because I think...the amendment makes the bypass more restrictive. So those people who are concerned with the body of the bill ought to know what we're voting on on this second amendment. It lowers the exemption from thirty beds over a two-year period to ten beds over a one-year period.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator, the debate was

closed...the...the...those in favor of the adoption of Amendment No. 2 to Senate Bill 624 will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the...the Ayes are 21, the Nays are 24, 1 voting Present. The amendment fails. Amendment No. 2 fails. Further amendments?

SECRETARY:

Amendment No. 3 offered by Senators Bloom, Dawson and Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz, for what purpose do you arise?

SENATOR LECHOWICZ:

On a motion to reconsider the way...the Amendment No. 1 which was adopted. Having voted on the prevailing side, I move to reconsider the vote by which Amendment No. 1 was adopted. And that's in order. Amendment No. 1 was adopted by a voice vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

I'll let...I'll let you know when it's in order. Senator Lechowicz has moved...having voted on the prevailing side, has moved to reconsider the vote by which Amendment No. 1 was adopted. All right. Senator DeAngelis.

SENATOR DeANGELIS:

Yeah, I'm going to hold the bill on 2nd reading.

PRESIDING OFFICER: (SENATOR DEMUZIO)

This has to do with a permit fee system for air pollution, and the committee amendment eliminates what was in the bill previously and substitutes a fee schedule which is, I think, much more modest. It provides for sources...emitting twenty-five tons or more of pollutants at two hundred and fifty dollars a year, so-called major

polluters; the minor polluters sources emitting less than twenty-five tons at seventy-five dollars an annual fee, and provides also that those fees are to be deposited in the Environmental Protection Permit and Inspection Fund so that we will be providing approximately a million dollars more for enforcement of air pollution standards. And it provides further that the fees may not be changed beyond...by the EPA beyond what is in the Act, unless, obviously, the Legislature should further act. I would move the adoption of Committee Amendment No. 1 to...Senate Bill 658.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Any discussion...any discussion? Senator Netsch moves the adoption of Committee Amendment No. 1 to Senate Bill 658. Those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Any further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. Senate Bill 665, Senator Lechowicz. Mr. Secretary, read the bill. 665.

SECRETARY:

Senate Bill 665.

(Secretary reads title of bill)

2nd reading of the bill. The Committee on Revenue offers one amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President, Ladies and Gentlemen of the

Senate. Amendment No. 1 by the Revenue Committee amends various tax costs concerning enterprise zones and it does basically the following. It provides an enterprise zone investment credit authorizing partnerships and Subchapter S corporations to participate in the investment credit. It amends the Public Utilities Act to provide a business locating within an enterprise zone and meeting specific criteria, they may apply for a refund on State municipal utilities tax for a period of five years providing that the county or...municipality designated the enterprise zone must...must adopt an ordinance requesting that the tax is credited. It also provides that the carry-over of the enterprise zone investment credit in a job tax credit. Basically, that's what Amendment No. 1 does. It's been worked out with the Governor's Office and DCCA, and I would like to compliment both sides of the aisle on the progress of this amendment. I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Lechowicz has moved the adoption of Committee Amendment No. 1 to Senate Bill 665. Is there any discussion? Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Any further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

SECRETARY;

Amendment No. 2 offered by Senator Lechowicz.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President. Amendment No. 2 is at the

request of DCCA. As you recall, we extended the number of enterprise zones last year from eight to twelve. This is a similar request for the year of 1985, and I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Lechowicz has moved the adoption of Amendment No. 2 to Senate Bill 665. Any discussion? Senator Netsch.

SENATOR NETSCH:

...thank you, Mr. President. I would like to point out...that this is a further acceleration of the enterprise zone designation procedure. I...as I understand it, it does not add to the total number of authorized enterprise zones, but it does add to the total number that may be designated next year. Is that correct, first, Senator Lechowicz?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

It's partially correct, Senator Netsch. Basically, what it does, the original legislation which was passed in 1982...designated eight enterprise zones to be allocated per year. Last year because of the number of requests that were pending and approved locally, as you know...they have to be approved locally first, DCCA requested that we increase it from eight to twelve, and basically the same situation occurs this year where they have a number of good valid requests to accommodate over the number of eight. So they're asking for...to twelve be designated again this year, so they can accommodate twelve respective enterprise zones in the State.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Netsch.

SENATOR NETSCH:

Well,...then, actually it is an increase in the authorized number at least on an annualized basis from...from eight

to twelve.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

The total number...remains the same, but basically you're granting them the same privileges they had last year. Eight to twelve.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

Further discussion? Further discussion? Senator Netsch.

SENATOR NETSCH:

Well, I think we have the...the figures straight on it now. I just...I'm not quite sure what the rush is to get so many designated when we have not yet really gotten sufficient feedback on the extent to which they are all going to be achieving their purposes and not doing it at the expense of other areas of the State. I'm...I'm just reluctant to add the number at this early stage.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

All right. Senator Lechowicz has moved the adoption of Committee Amendment...or Amendment No. 2 to Senate Bill 665. Further discussion? Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

3rd reading. Senator...Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Two committees are scheduled are to meet, and I know a number of witnesses are waiting to testify. Agriculture will meet in Room 400 and Appropriations I will meet in Room 212. Absent any further announcements or further housekeeping business, I would be prepared to put a motion to adjourn

until Wednesday, tomorrow morning, at nine-thirty...nine-thirty tomorrow morning and we will again start on 2nd reading where we left off. 9:30 a.m.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock, if you'll hold that motion. The Secretary informs me that we moved a hundred and twenty-three bills off of 2nd reading today, thirty-nine of which were amended. Senator Keats, for what purpose do you arise?

SENATOR KEATS:

Thank...thank you, Mr. President. There are two bills, Senate Bill 845 and Senate Bill 867, of which I am listed as a sponsor, which I would like to have my name removed as a sponsor from the two bills, 845 and 867.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Keats seeks leave of the Body to have his name removed from Senate Bill 845 and 867. Is leave granted? Leave is granted. Senator Friedland, for what purpose do you arise?

SENATOR FRIEDLAND:

Thank you, Mr. President. Request leave to be shown as hyphenated sponsor of House Bill 468. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Friedland seeks leave of the Body to be added as a hyphenated sponsor of House Bill 468. Is leave granted? Leave is granted. So ordered. Senator Savickas, for what purpose do you arise?

SENATOR SAVICKAS:

Senator...or Mr. President, I would like the record to show that Senator Berman is absent today due to official business. He is in Washington D.C. with Superintendent Ted Sanders and others meeting with our Illinois delegation regarding education reform issues.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The record will so indicate. Senator Mahar,

for what purpose do you arise?

SENATOR MAHAR:

Thank you. I seek leave of the Body to be added as a hyphenated cosponsor of Senate Bill No. 564. I have permission of the chief sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Mahar seeks leave of the Body to be added as a hyphenated cosponsor to Senate Bill 564. Is leave granted? Leave is granted. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President, Ladies and Gentlemen of the Senate, I would like to seek leave of the Body to add as an immediate cosponsor to me on Senate Bill 195, Senator LeRoy Lemke.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Geo-Karis seeks leave of the Body to have Senator Lemke as a hyphenated cosponsor...along with Senator Geo-Karis on Senate Bill 195. Is leave granted? Leave is granted. Senator Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, to be shown as hyphenated sponsor on Senate Bill 619.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Vadalabene seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 619. Is leave granted? Leave is granted. Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Thank you, Mr. Chairman. I ask to seek leave of the Body to add the name of Senator Emil Jones as hyphenated sponsor on Senate Bill 653 and Glenn...and Senator Dawson as cosponsor along with Smith and Poshard.

PRESIDING OFFICER: (SENATOR DEMUZIO)

These are hyphenated, is that correct?

SENATOR SMITH:

Jones hyphenated and Dawson cosponsor along with Smith and Poshard.

PRESIDING OFFICER: (SENATOR DEMUZIO)

On Senate Bill 653?

SENATOR SMITH:

653.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Is leave granted? Leave is granted. So ordered. Senator Karpziel.

SENATOR KARPIEL:

Thank...thank you, Mr. President. I'd like leave of the Body to be added as a hyphenated cosponsor to Senate Bills 52 and 53 and I have the approval of the main sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Karpziel seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bills 52 and 53. Is leave granted? Leave is granted. So ordered. Senator Topinka.

SENATOR TOPINKA:

Mr. President and Ladies and Gentlemen of the Senate, if I might be added as a hyphenated joint sponsor to Senate Bill 508, I do have the permission of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Topinka seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 508. Is leave granted? Leave is granted. So ordered. Senator Darrow, for what purpose do you arise?

SENATOR DARROW:

I'd ask leave to be added as a hyphenated sponsor to Senate Bill 619.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow seeks leave of the Body to be added as a

hyphenated cosponsor...to Senate Bill 619. Is leave granted?
Leave is granted. Senator Karpel.

SENATOR KARPIEL:

I am sorry, I made a mistake. That is not Senate Bills 52 and 53, it's House Bills 52 and 53 that I would like to be added as a cosponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Karpel in error earlier wishes to be hyphenated cosponsor of House Bills 52 and 53 rather than Senate Bills 52 and 53 and the record will so indicate. Further business to come before the Senate? Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate, just to announce that the meeting of Appropriations I will begin as soon as we can get a quorum there immediately after adjournment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Carroll moves that the Senate stand adjourned until tomorrow morning, nine-thirty, May the 8th. The Senate stands adjourned.
