tion of Norge Industries in Herrin, Illinois. They're one of the largest industrial employers in our end of the State. They've been good neighbors to Herrin and to all of southern Illinois. They're excellent residents in our community. We're joined here in the Senate today by the president and vice—President, Mr. John Carpenter and John Nicholas of Herrin Industries, along with Mayor Ed Quaglia of Herrin and other members of his city council and Chamber of Commerce and we just... I would just like you to applaud their efforts and their contribution to southern Illinois.

Would our guests in the gallery please rise and be recognized. Welcome to Springfield. All right. On the Order...page 24 on the Calendar, on the Order of Secretary's Desk Concurrence, Senate Bill 1244. Mr. Secretary.

Senate Bill 1244 with House Amendments 2, 3 and 9.

PRESIDENT:

Senator Marovitz.

## SENATOR MAROVITZ:

I would move that the Senate do concur with the House amendments to Senate Bill 1244. In effect, what this bill does on final reading...and Amendment 9 is the crucial amendment because that becomes the bill and supersedes the other amendments. This bill allows the sale of alcoholic beverages at Navy Pier until 12-31, 1987. Currently...currently, wine and beer are allowed on Navy Pier, this would allow the sale of all alcoholic beverages and I would ask for concurrence. PRESIDENT:

Any discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Will the sponsor yield for a question? PRESIDENT:

Sponsor indicates he'll yield, Senator Geo-Karis.

#### SENATOR GEO-KARIS:

Do I understand...is this just limited to Navy Pier or does it apply to all cities and municipalities?

Senator Marovitz.

SENATOR MAROVITZ:

This is limited exclusively to Navy Pier.

PRESIDENT:

Senator Geo-Karis.

SENATOR GEO-KARIS:

...I'm...reason I'm asking the question is because I'm checking amendment...House Amendment No. 9 in our...synopsis...in our Digest, and it just says...unless I misread this thing, it says, "Not just beer to be sold in any building belonging to or under the control of any city, village or incorporated town where more than seventy-five percent of the physical properties of the building are used for commercial recreational purposes." I mean, I...I'm not objecting to it, I just want to know if it's a little broader.

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

If you read the amendment carefully, the description of the amendment applies only to Navy Pier. It doesn't mention Navy Pier by name, it applies only to Navy Pier.

PRESIDENT:

Senator Geo-Karis.

SENATOR GEO-KARIS:

It says over navigable water, so I guess if there's another water besides that abounding by Navy Pier it could apply. That's all I want to know.

PRESIDENT:

Further discussion? Senator Hudson.

#### SENATOR HUDSON:

Senator...would the Senator respond to a question?

PRESIDENT:

Sponsor indicates he'll yield, Senator Hudson.
SENATOR HUDSON:

Senator Marovitz, would you...am I right in understanding that what...what this bill does is to expand and enlarge the sale of alcohol...alcoholic beverages at Navy Pier, is that what we're talking about...law?

#### PRESIDENT:

Senator Marovitz...Senator Marovitz.

#### SENATOR MAROVITZ:

Well, that's pretty close. Presently...wine and beer are permissible to be sold at Navy Pier, this would expand that to all alcoholic beverages at the pier.

#### PRESIDENT:

Senator Hudson.

## SENATOR HUDSON:

I'm just wondering, Bill, if...if it is possible that in so doing we are encouraging our young people or giving them a message that going out to such places as Navy Pier...and that is not alone, I know our public parks have been...some of them have been interested in this too. But if it isn't giving them a message that, okay, go ahead and drink. Now, at the same time...anything, bourbon, whiskey, scotch, rye, you name it, you know, all those good things, but at the same time we seem to be tightening up...we're going through great...efforts to tighten up on DUI and all of that, do you see any inconsistency in doing one thing on one hand and something else on the other hand?

#### PRESIDENT:

Senator Marovitz.

## SENATOR MAROVITZ:

Well. I really don't see any inconsistency because we're

not...we're not dealing with the age limit whatsoever, this is still only applicable to people who are twenty-one and older, which is the law in the State of Illinois. ₩hat is happening at Navy Pier is the facility is now being used, has been renovated and is being used by a number of charities and organizations throughout the State of Illinois; for instance, the...the art community is using it this...this week and a lot of facilities, charities are using the facility and need to be able to sell...would like to be able to sell to their donors and to the people at their functions alcoholic beverages. That is strictly what this is for, it is not...it is not for kids, there's not rock shows there or we're not expanding the sale of alcoholic beverages to...to juveniles. I understand your concern but that would not be applicable here at all; otherwise, I'd be opposing it.

PRESIDENT:

Further discussion? Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. Question of the sponsor.

PRESIDENT:

Sponsor indicates he'll yield, Senator Weaver.

SENATOR WEAVER:

Senator, I was just wondering why you had the sunset provision in...in \*87?

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

A very frank answer, I really don't know. It was put on in the House, I don't know why they put a sunset provision in there.

PRESIDENT:

Further discussion? Senator Lechowicz.

SENATOR LECHOWICZ:
