PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I would like to place Senator Jerome Joyce as lead sponsor on House Bill 1000 and myself as hyphenated cosponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Geo-Karis seeks leave of the Body to be...to have Senator Jerome Joyce added as a...

SENATOR GEO-KARIS:

As the lead sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...principal sponsor of House Bill 1000, so it will read Jerome Joyce-Geo-Karis.

SENATOR GEO-KARIS:

Right.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Is leave granted? Leave is granted. It's so ordered.

SENATOR GEO-KARIS:

Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, I am recorded as being the sponsor of Senate Bill 132 and I would like to have my name removed and the sponsor be shown as Senator Joyce Holmberg.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...House Bill 132.

SENATOR VADALABENE:

House bill, yes.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right,...Senator Vadalabene seeks leave of the Body to have Senator Holmberg added as the principal sponsor of House Bill 132. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. Also,...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Wait a minute. Let's take care of this. Is leave granted? Leave is granted. It's so ordered. Senator Vadalabene.

SENATOR VADALABENE:

House Bill 981 is residing at this particular time in License and Insurance Committee. I have talked to the chairman, Senator Jones, and would like...and have leave to have House Bill 981 rereferred to the proper committee which is Local Government. Local Government.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Where is it now, Senator?

SENATOR VADALABENE:

It's in License and Insurance Activities.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Vadalabene seeks leave of the Body to...Senator Nedza, on the same subject? Senator Nedza.

SENATOR NEDZA:

Thank you, Mr. President. I'd like House Bill 99...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Oh, no, wait...wait...wait, let's take care of Senator Vadalabene's. I thought...I thought you had...

SENATOR NEDZA:

No...no...no.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene, the bill is currently now in what committee? All right, Senator Vadalabene moves...moves to discharge the Committee on Insurance and Licensed Activities from further consideration of House Bill 881 so that the bill can be referred to the Committee on Local Government. Is...those in favor signify by saying Aye. Opposed Nay. The Ayes have it. It's so ordered. (Machine cutoff)...Fawell, for what purpose do you arise?

SENATOR FAWELL:

Thank you, very much. I would like to put Senator Bob Kustra as lead sponsor on House Bill 463.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Fawell seeks leave of the Body to have Senator Kustra shown as the lead sponsor on House Bill 463. Is leave granted? Leave is granted. It's so ordered. Senator Topinka, for what purpose do you arise?

SENATOR TOPINKA:

Yes, if I might have leave, Mr. President, to show Senator Sam Vadalabene as the chief sponsor of House Bill 1510.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Topinka seeks leave of the Body to have...have Senator Vadalabene as the lead sponsor of House Bill 1510. Is leave granted? Leave is granted. It's so ordered. Senator Lemke, for what purpose do you arise?

SENATOR LEMKE:

To make a...a motion on some revisory bills that were put

in the wrong committees. Motion on one, I move that House Bill 273 be transferred from the Committee on Public Health, Welfare and Corrections to the Judiciary I Committee and, further, that House Bill 284 be transferred from the Committee on Higher Education to Judiciary I Committee. These are revisory bills that should have been...these are revisory bills that should have been with the other thirty bills we have in Judiciary I. They're noncontroversial and I ask leave.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, let's take them...one at a time. Senator Lemke moves that House Bill 273 be...be transferred from the Committee on Public Health, Welfare and Corrections to the Judiciary I Committee. All right, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. It's so...so ordered. House Bill 273 is discharged from the Committee on Public Health, Welfare and Corrections and is rereferred to the Committee...Committee on Judiciary I. Senator Lemke now moves that House Bill 284 be discharged from the Committee on Higher Education and transferred to the Committee on Judiciary I. Is that correct, Senator? Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. House Bill 284 is discharged from the Committee on Higher Education and...and it will be so referred to Judiciary I. Senator Lemke.

SENATOR LEMKE:

Next, I'd like to make a motion. I move to suspend the Six-day Posting Requirement contained in Senate Rule 7C so that House Bills 273 and House Bill 284 may be heard in committee tomorrow, on June 5th with the rest of the revisory bills....our staffs have done the analysis and I think it's...they are worked out.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Are you...

SENATOR LEMKE:

...all the reports.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke has moved to suspend the Six-day Posting Requirement contained in Senate Rule 7C so that House Bills 273 and House Bills 284 may be heard in committee tomorrow, June the 5th. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. It's so ordered. Senator Nedza, for what purpose do you arise? Senator Nedza.

SENATOR NEDZA:

Thank you, Mr...President. Change the sponsorship of House Bill 99 so that the bill would read Coffey-Nedza as opposed to Nedza. And also to be...

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Nedza seeks leave of the Body to have Senator Coffey named as the principal, lead sponsor on House Bill 99. Is leave granted? Leave is granted. It's so ordered. Senator Nedza.

SENATOR NEDZA:

And I would also like to be added as a cosponsor to House Bill 1177.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Nedza seeks leave of the Body to be added as a hyphenated cosponsor of House Bill 1177. Is leave granted? Leave is granted. It's so ordered. Senator Fawell, for what purpose do you arise?

SENATOR FAWELL:

Two...two more things. Would you remove my name from House Bill 1955 and place Philip-Rock a...

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Fawell seeks leave of the Body to have Senator Rock...

SENATOR FAWELL:

Philip-Rock.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator...

SENATOR FAWELL:

Philip and Rock.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Philp and Senator Rock as the principal sponsors of House Bill 1955 and Senator Fawell's name be removed. Is leave granted? Leave is granted. It's so ordered. Senator Fawell.

SENATOR FAWELL:

All right. And House Bill 2125 needs to be Tabled, according to the House sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

House bill what?

SENATOR FAWELL:

2125.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Where is it?

SENATOR FAWELL:

It's been worked out another way.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator, where is the bill currently? Where does it repose?

SENATOR FAWELL:

It's...it's still on 1st reading.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator, why don't we get the proper location of the bill and we can do it tomorrow.

SENATOR FAWELL:

Okay.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Okay? All right, Senator Fawell, are you the sponsor of House Bill 2125? All right, Senator...she indicates yes. Senator Fawell seeks leave...it's in Insurance and License.

Senator Fawell moves to discharge the Committee on Insurance and License from further consideration of House Bill 2125 for the purpose of Tabling. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The bill is...House Bill 2125 is discharged. Senator Fawell now moves to Table House Bill 2125. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. House Bill 2125 is Tabled. Senator Degnan, for what purpose do you arise?

SENATOR DEGNAN:

Thank you, Mr. President. I'd like to be added a hyphenated sponsor to House Bill 1567 and 1577.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Degnan seeks leave of the Body to be added as a hyphenated cosponsor of House Bill 1567 and 1577. Is leave granted? Leave is granted. It's so ordered. Senator Lechowicz, for what purpose do you arise?

SENATOR LECHOWICZ:

Thank you, Mr. President. I move that the Senate resolve itself into Executive Session for the purpose of acting on the Governor's appointments set forth in his Message of May 2nd, 1985...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Wait a minute, Senator...

SENATOR LECHOWICZ:

...and May 8th, 1985.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Mr. Secretary.

SECRETARY:
