PRESIDENT:

The Senate will please come to order. Will the members be at their desks. Will our guests in the gallery please rise. Prayer this afternoon by the Reverend...Kevin Vann, Blessed Sacrament Church, Springfield, Illinois. Father.

REVEREND VANN:

(Prayer given by Reverend Vann)

PRESIDENT:

Thank you, Father. Reading of the Journal, Mr. Secretary.

SECRETARY:

Tuesday, May the 20th, 1986.

PRESIDENT:

Senator Kelly.

SENATOR KELLY:

Thank you, Mr. President. I move that the Journal just read by the Secretary be approved unless some Senator has additions or corrections to offer.

PRESIDENT:

You've heard the motion as placed by Senator Kelly. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it's so ordered. Senator Kelly.

SENATOR KELLY:

Thank you, Mr. President. I now move that reading and approval of the Journals of Wednesday, May 21st; Thursday, May 22nd; Friday, May 23rd; Wednesday, May 28th and Tuesday, June 3rd, in the year 1986, be postponed pending arrival of the printed Journals.

PRESIDENT:

You've heard the motion as placed by Senator Kelly. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it's so ordered. Senator Welch, for what purpose do

you arise?

SENATOR WELCH:

Mr. President, having spoken with the sponsor of Senate...of House Bill 3033, I would ask leave to be named hyphenated cosponsor to that bill.

PRESIDENT:

All right, gentleman seeks leave of the Body to be added as the hyphenated cosponsor on House Bill 3033. Without objection, leave is granted. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you, Mr. President. A sponsorship change. As the first in line on House Bill 2898, I would like to shift the sponsorship so that it reads Demuzio-DeAngelis-Netsch. I come at the end of the line instead of the first of the line.

PRESIDENT:

Senator Demuzio, to justify that move. Senator Demuzio.

SENATOR DEMUZIO:

I think...when she presented the rule...the bill in Rules yesterday, the damage was already done.

PRESIDENT:

All right, 2898, Senator Netsch seeks leave of the Body to show Senators Demuzio-DeAngelis-Netsch as the Senate sponsor. Without objection, leave is granted. Senator Poshard, for what purpose do you arise?

SENATOR POSHARD:

Point of personal privilege, Mr. President.

PRESIDENT:

State your point, sir.

SENATOR POSHARD:

Mr. President, in our gallery to the rear, I'm honored to have visiting the Capitol today a junior high class of Goreville Junior High School, along with their teacher and sponsor, Mr. Wade Hudgens, and several of the parents and

teachers of that school. Would like to recognize those...those class...that class from Goreville Junior High School.

PRESIDENT:

Will our guests in the gallery please stand and be recognized. Welcome to Springfield. Senator Mahar, for what purpose do you arise, sir?

SENATOR MAHAR:

Mr. President, I seek leave of the Body to be added as a hyphenated cosponsor of House Bill 3513 and I've received permission of the chief sponsor.

PRESIDENT:

Gentleman seeks leave of the Body to be added as the hyphenated cosponsor on House Bill 3513. Without objection, leave is granted. Senator Etheredge, for what purpose do you seek recognition?

SENATOR ETHEREDGE:

Thank you, Mr. President. I seek leave to make a change in sponsorship on House Bill 2889. I would like the sponsorship to read Friedland-Macdonald-Etheredge.

PRESIDENT:

2889, the gentleman seeks leave to show Senators Friedland, Macdonald and Etheredge as the hyphenated cosponsors in that order. Without objection, leave is granted. Senator Topinka, for what purpose do you arise?

SENATOR TOPINKA:

Yes, Mr. President, I'd like leave to ask to be added as a joint sponsor of House Bill 3271 and have the permission to do so.

PRESIDENT:

All right, 3271. The lady seeks leave to be added as the hyphenated cosponsor on House Bill 3271. Without objection, leave is granted. Senator Demuzio, for what purpose do you arise?

SENATOR DEMUZIO:

Yes, Mr. President, change sponsorship on two bills. House Bill 2782 should read O'Daniel-Demuzio, and I would...to seek leave of the Body to...to make that change and then I have another.

PRESIDENT:

All right, the gentleman seeks leave of the Body to show Senator O'Daniel as the lead sponsor, Senator Demuzio as the hyphenated cosponsor on House Bill 2782. Without objection, leave is granted. Senator Demuzio.

SENATOR DEMUZIO:

House Bill 3096, that should read Poshard-O'Daniel-Dunn and et al.

PRESIDENT:

All right, gentleman seeks leave to show Senator Poshard as the lead sponsor on House Bill 3096 along with Senators O'Daniel, Dunn and...and Demuzio. Senator Demuzio.

SENATOR DEMUZIO:

I...I made a mistake. That should be O'Daniel-Poshard...Dunn...Demuzio.

PRESIDENT:

Okay, House Bill 3096...one more time, gentleman seeks leave of the Body to show Senator O'Daniel as the lead sponsor with Senators Poshard and Dunn as the hyphenated cosponsors. Without objection, leave is granted. If we can have your attention, we have with us in the Senate today some special guests and the Chair will yield to Senator John Davidson. Senator.

SENATOR DAVIDSON:

All you people who are in the sound of my voice who are not present don't know what you're missing 'cause I have some delightful individuals for...you could be looking at if you were present. Mr. President and members of the Senate, it is my pleasure to present to you the International Champions of

Small School Cheerleaders for United States. They were triple winners and they won the international competition in April of 1986 in Chicago, Illinois. I want to present to you the cheerleading squad from Kincaid, Illinois, which happens to be in my district. Girls. And Mrs. Moore, their director, will introduce the girls to you. Mrs. Moore.

MRS. MOORE:

(Introduction of cheerleading squad)

SENATOR DAVIDSON:

Girls, we want to congratulate you on an outstanding job. You already have the Senate resolution which the Senate passed for you last week congratulating you on being the International Champions. We're delighted to have you here and present you to the Senate so we can show the rest of those boys, particularly those from that small town called Chicago, that we downstate small schools do have talent. Thank you for coming.

PRESIDENT:

...Senator Philip, for what purpose do you arise, sir?

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like the record to indicate that Senator Donahue is with the Governor in her district announcing some prison sites today.

PRESIDENT:

The record will so indicate. If I can have your attention, just for the information of the members who have not yet been approached, I guess is the proper word, Senators Macdonald and Smith are in charge of the Tag Day. It's for a worthy cause. So, treat them kindly, Senator Rupp, when they approach you with...okay. Thank you, very much.

All right...all right, with leave of the Body, we will move to the Order of Secretary's Desk Resolutions, page 7. Apparently, there is some urgency to this...to this request. Is leave granted? Leave is granted. On the Order of Secretary's Desk Resolutions, page 7, Senate Resolution 907. Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Senate Resolution 907 urges Congress and the President to recognize June 21st, 1986 as Save America to Industry and Jobs Day. The resolution basically acknowledges the joint effort of labor and business in making us the greatest industrialized nation in the world, and I would like for it to be considered now so that it can get to Washington before I do.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

Sounds like an announcement or a pronouncement. All right, Senator DeAngelis has moved the adoption of Senate Resolution 907. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 907 is adopted. Senator Dunn, for what purpose do you



arise?

SENATOR DUNN:

Thank you, Mr. President. I'd like to be shown as hyphenated cosponsor of House Bill 3018. I have permission of the principal sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Dunn, seeks leave of the Body to be added as a hyphenated cosponsor of House Bill 3018. Is leave granted? Leave granted. It's so ordered. Resolutions.

SECRETARY:

Senate Resolution 1011 offered by Senator Keats.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. All right, with leave of the Body, we will return to the Order of Secretary's Desk Resolutions. Is leave granted? Leave is granted. Senator Barkhausen has made a request for Senate Resolution 894. Senator Barkhausen.

SENATOR BARKHAUSEN:

Mr. President and members of the Senate, Senate Resolution 894 is a resolution that has been requested by the Waukegan Regional Airport which has been seeking from the Federal Aviation Administration for early approval and funding for an air traffic control tower. There have been some recent incidents that highlight the need for this tower. I should...also add that the Illinois Congressional Delegation has been united in seeking the FAA's approval of this application, and the resolution has passed the Executive Committee. Because appropriations are now pending in Congress and being considered, the early adoption of this resolution would be very helpful and I, therefore, urge the Body to pass this resolution. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, discussion? Senator Barkhausen moves the

adoption of Senate Resolution 894. Those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 894 is adopted. Senator Barkhausen.

SENATOR BARKHAUSEN:

Mr. President, if I could, I wanted also to ask that Senator Geo-Karis be added as a hyphenated cosponsor on the resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Barkhausen has requested that Senator Geo-Karis be added as a cosponsor of Senate Resolution 894. Is leave granted? Leave granted. It's so ordered. If there are members who wish to pick up any additional House bills on 1st reading, there are eleven left on the Calendar. Today would certainly be the appropriate day to...to do that before we...before we depart. So, take a look at House bills on 1st reading, there are eleven bills that are remaining there and if you wish to pick one up, now is the time. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, Mr. President. For the purpose of a couple of announcements. First, I would...I would ask that the...Senator Chew's absence be...be noted. He is, obviously, absent this week due to illness and we wish him...wish him well and a speedy recovery. Senator Luft is also with Senator Donahue and the Governor. Apparently, a prison facility has been announced also in his district. So, with leave of the Body, we...he can be added to the roll call when he returns shortly to Springfield. Additionally, the...there will be distributed a new schedule for next week and I would like the members' attention to the extent that...if you look on the back page of the Calendar, the week of the tenth, we had originally scheduled four days of Session, the tenth, eleventh, twelfth and Friday the 13th. We have, based on Rules Committee activity, determined that we can probably do

our work in an expedited fashion on three days; but in order to do that, we'll require that a couple of the committees meet on Tuesday morning before the Session begins. The Session will begin, according to the adjournment resolution, at noon, next Tuesday, but there will be committees scheduled for Tuesday morning, Tuesday afternoon, Wednesday, morning and afternoon and, Thursday, morning and afternoon, with the hope that it will not be necessary for us to be here on Friday the 13th. So, I would ask your indulgence, take a look at the schedule, plan your week accordingly; and those who are members of those committees that are scheduled to meet on Tuesday, it's, obviously, important that they make an effort to be here earlier and try to get that done to alleviate or obviate the need to be here on Friday. The Rules Committee will meet on Tuesday morning at eleven-thirty and the committees are scheduled...I think Finance is scheduled for ten o'clock on Tuesday morning. That schedule will be distributed shortly. I hope it meets with everyone's approval and I...if anybody wishes to be here on Friday, they're certainly welcome to be here.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

All right, you've heard the...the request of Senator Rock. Is leave granted? Leave is granted. Senator Hall, for what purpose do you arise?

SENATOR HALL:

A point of information. I've been hearing everyone's...two people have been absent because they're with the Governor on a prison site. I read in the paper where my area was selected for the prison site. Evidently, I didn't get the telephone call.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

Senator Hall, there may not have been room on the helicopter, we don't know. All right, resolutions.

SECRETARY:

Senate Joint Resolution 167 offered by Senator Rock.

(Secretary reads SJR 167)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Joint Resolution 167 is the adjournment resolution. When we conclude our business today, which will be, I hope, very shortly, it calls for us to return to Springfield, in Session, next Tuesday at the hour of...of noon. Now the schedule is being passed out. The committees that were scheduled to meet at 10:00 a.m. on Tuesday morning are Elections, Revenue and Finance, then we will commence Session at noon and then Appropriations I and Insurance will meet. Given the action of the Rules Committee, the...the only committee that has an extraordinarily...heavy load is the Executive Committee, and I've already discussed with Senator Sangmeister the fact that Exec. will meet at nine o'clock on Thursday morning and, hopefully, in a three-hour period we can handle those matters that have been assigned to the Executive Committee. In addition, I'd like to remind the members on both sides of the aisle that Senator Philip and I along with many others are honorary...are honorary cochairman of a tribute that will be held this evening to State Treasurer Jim Donnewald honoring him for his many years of service...in the best interest of the public of the people of the State of Illinois, his service both in the House and the Senate and as a constitutional officer. I would hope that all of us would make an effort to be there at five o'clock this evening to pay tribute to Jim Donnewald. With that, I would move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 167.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock has moved to suspend the rules

for the immediate consideration and adoption of Senate Joint Resolution 167. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator Rock now moves the adoption of Senate Joint Resolution 167. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 167 is adopted. Resolutions Consent Calendar, Mr. Secretary, have there been any objections filed?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, with leave of the Body, we will add three additional congratulatory resolutions to your printed copy that has been passed out. The additions are Senate Resolutions 1007, 1008 and 1009. With leave of the Body, we will add those. Leave is granted. Senator O'Daniel now moves the adoption of the Resolutions Consent Calendar. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Resolutions Consent Calendar is adopted. Further business to come before the Senate? Senator Rock.

SENATOR ROCK:

Thank you. Given the committee switch, Mr. Chairman, there is one bill that was misassigned, House Bill 3032 and I would move that the Committee on Insurance be discharged from further consideration of House Bill 3032, and ask that that bill be rereferred...reassigned to the Committee on Revenue which will meet on Tuesday morning.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Rock that House Bill 3032...that the Committee on Insurance be discharged from further consideration of House Bill 3032 and that it be assigned to the Committee on Revenue. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Bill 3032...committee is discharged and has been

referred to the Committee on Revenue. All right. Further business to come before the Senate? All right, Senator Rock now moves that the Senate stand adjourned till June 10th at the hour of noon. Senate stands adjourned.
