Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Bill 50 requires that instruction be given to all...requires that instruction be given to all pupils in...in grades kindergarten through third grade relative to

avoiding abduction and actions which should be taken by pupils who become victims of sexual abuse or sexual assault. It's the one of a series of bills dealing with this very sensitive program to alert our young people to the dangers regarding abduction and sexual abuse. I solicit your Aye vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? If not, the question is, shall House Bill 50 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 50, the Nays are 1, 1 voting Present. House Bill 50 having received the required constitutional majority is declared passed. 51, Senator Berman. On the Order of House Bills 3rd Reading is House Bill 51. Mr. Secretary, read the bill, please.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Berman.

SENATOR BERMAN:

Thank you. This is similar to a bill that we had previously passed dealing with notification by...by school people of the absence...unexcused absence of children from school.

I'll be glad to respond to any questions. I solicit your Aye vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any questions? Any discussion? If not, the question is, shall House Bill 51 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays

are none, none voting Present. House Bill 51 having received the required constitutional...constitutional majority is declared passed. 171, Senator Darrow. House bills 3rd reading is House Bill 171. Mr. Secretary, read the bill, please.

PRESIDING OFFICER: (SENATOR DENUZIO)

House Bill 171.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

Thank you, Mr. President. At...first, I'd ask leave to add Senator Geo-Karis as the chief sponsor along with me. She's...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow seeks leave of the Body to have Senator Geo-Karis added as a hyphenated cosponsor. Is leave granted? Leave is granted. It's so ordered. Senator Darrow.

SENATOR DARROW:

Senate Bill 171 amends the Circuit Court Act in relation to administrative assistants and their salaries...their per diems. There are about twenty circuits in the State of Illinois that have administrative assistants. This merely changes their names from secretary to administrative assistants and allows the Supreme Court to set their salary rather than Statute. I'd ask for a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, any discussion? Senator...can we have some order, please. Senator DeAngelis. Senator DeAngelis. SENATOR DeAngeLis:

... yeah, a question of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator DeAngelis.

SENATOR DeangeLis:

Is there any cap on the increase that can be given?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

No, there is not. It's...the control we will have over it is in the appropriation from the Supreme Court. The Supreme Court will make that determination. It'll be part of their appropriation bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DEANGELIS:

Well, I...I would think this is highly unusual to not have a limit...a top limit on a salary. Do we do this for anybody else?

PRESIDING OFFICER: (SENATOR DEMUZIO) d

Senator Darrow.

SENATOR DARROW:

I don't understand why it's unusual. It's Judicial Branch of Government and the Supreme Court sets the salaries for all their...number of their employees, if not all their employees.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Can we have some order, please. Senator DeAngelis.

SENATOR DeanGELIS:

Well, maybe I'm not clear, but I don't believe it's the court...Supreme Court that's setting it. Each circuit is doing it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeangeLis:

Is that correct?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

No, I believe it's set in our Statutes...I believe it's eighteen thousand dollars set by the General Assembly.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator ... DeAngelis.

SENATOR DEANGELIS:

Well, yeah, right now it is, but if...if this bill goes through, each circuit will be able to determine what it wants to pay...well, you're shaking your head, is that incorrect? PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

It's...it's the...Supreme Court that sets the salaries and...we appropriate the funds. This is a Supreme Court recommendation.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I rise and speak in favor of the bill. The...the Supreme Court has...has asked us to look into it and these administrative assistants do an awful lot of work in our circuits. So, I...I ask for a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Darrow may close.

SENATOR DARROW:

I'd merely ask for a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Question is, shall House Bill 171 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Senator Savickas. Have all voted who wish? Take...have all voted who wish? Have all voted who wish?

Take the record. On that question, the Ayes are 25, the Nays are 24, 3 voting Present. House Bill 171 having failed to receive the required constitutional majority is declared lost. Senator Darrow requests postponed consideration. House Bill 291, Senator Lemke. On the Order of House Bills 3rd Reading is House Bill 291. Mr. Secretary, read the bill. SECRETARY:

House Bill 291.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LENKE:

What this...bill...does is amends the Criminal Code of 1961 to make it a Class I felony for someone who knowingly disarms a peace officer who's acting in the performance of...his official duty by taking his firearm from the peace officer's person or from an area when the peace officer is in immediate possession. I ask for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, any discussion? If not, the question is, shall House Bill 291 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 54, the Nays are none, none voting Present. House Bill 291 having received the required constitutional majority is declared passed. 293, Senator Coffey. On the Order of House Bills 3rd Reading is House Bill 293. Mr. Secretary, read the bill, please.

House Bill 293.

SECRETARY:

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Coffey.

SENATOR COFFEY:

Thank you, Mr. President and members of the Senate. House Bill 293 is a...really kind of a clean-up bill, but it amends the Bees and Apiaries Act in relating to the permit requirements for transportation of bees into Illinois or across county boundaries within Illinois. I'll be glad to answer any questions...and would ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Senator Dunn.

SENATOR DUNN:

Thank you, Mr. President...wonder if the Senator would yield?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Dunn.

SENATOR DUNN:

Is this requested by the Beekeepers' Association? I have some beekeeper friends who haul bees around the county and around the State, now they have to go to the Department of Agriculture to get a permit. Is that correct and why would that be?

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, can we...can we break up the caucuses. Senator Savickas. Senator Chew. Senator Coffey.

SENATOR COFFEY:

First of all, Senator Dunn, this is...really the bill came from the Beekeepers' Association and it actually...because there's some diseases that's carried in the throat of some of the bees and has created some proplems for some of the bee raisers in the State, they want this piece of legislation which allows the department to make sure that bees coming in from...from Africa or other countries will not

create a problem for them, so it's their legislation.

PRESIDING OPFICER: (SENATOR DEMUZIO)

Further discussion? Question is, shall House Bill 293 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 55, the Nays are none, none voting Present. House Bill 293 having received the required constitutional majority is declared passed. 332, Senator Smith. On the Order of House Bills 3rd Reading is House Bill 332. Mr. Secretary, read the bill, please.

House Bill 332.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and members of the Senate. House Bill 332 covers a gap. It's...amends the Criminal Code for failure to report for periodic imprisonment. Someone who has received a sentence of periodic imprisonment and if they fail to report to begin their sentence, they have committed a crime, a Class 3 if...if it was sentenced for felony and a Class B misdemeanor if it was a misdemeanor by a sentence. Nothing in the law presently makes it a crime for not showing up for the first day. I ask for a favorable vote. It's a wery simple bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Really the purpose of the bill is some minor technical clean-up language to the...the legislation that we passed here several years ago. does about four things; it makes it further...clear the intention of the Illinois Areas Agricultural Act, it provides for notification of the formation, dissolution or modification of any of these areas to the Illinois Department of Agriculture. The purpose of that being that they are involved in making recommendations on agricultural areas. There was an amendment added in committee by Senator Demuzio to protect the coal mining rights in an agricultural area, and there was an amendment added on the Floor yesterday to reduce the size of an agricultural area from five hundred acres down to three hundred and fifty acres.

House Bill 468 is a bill that amends the Egg and Egg Products Act, and simply put, this bill is a bill that was similar to the one we had here in the last General Assembly that passed the House but simply was not acted upon in the Senate. It provides that it will be unlawful for any handler or retailer to pack eggs in the consumer size containers other than those...other than during the original candling and grading operation unless the retail location has obtained written permission of the Department of Agriculture to repackage the eggs and has complied with the respective requirements. This simplistically put is, is to legalize that which is already being done by retailers in Illinois. I know of no opposition and would solicit an Aye vote.

SENATOR COFFEY:

House Bill 582 requires nonfamily or nonauthorized corporations, partnerships or trusts which acquire transfer or hold interest in agricultural land in Illinois to report such transactions and holdings to the Department of Agriculture and to the...and to direct the director to analyze this information on such reports. Really what this does is trying to find out actually if this land being acquired by other countries or by other corporations if it's taking the family farm out of the hands of those that...that are family farmers are presently. SENATOR DONAHUE:

Right now in the Statutes there is no mechanism for deestablishing these types of districts and it is in response to a problem in my area; however, it does effect all districts the same, and I would just hope for its favorable passage.

It...the only change is as...to this that applies to the family of deceased victims. Ask for your Aye vote.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall House Bill 778 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 51...53, the Nays are none, none voting Present. House Bill 778 having received the constitutional majority is declared passed. House Bill 815, Senator Carroll. Read the bill, Mr. Secretary.

SECRETARY:

House Bill 815.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This bill after agreement was reached with the Higher Ed. community and with the various school boards requires them to make reasonable accommodations for religious observation of...of the individual students as to class attendance, tests, et al and asks the school boards at the elementary and secondary level to establish reasonable criteria for parental notification well in advance of the necessity for observation of religious holidays. (Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Poshard.

SENATOR POSHARD:

Thank you, Mr. President and members of the Senate. House Bill 990 permits the disclosure of school student records for research purposes provided the person to whom the information is released signs an affidavit agreeing to comply with all the applicable Statutes and rules pertaining to student school...or school student records. Presently, under the Illinois Student Records Act, third party access to students records for statistical or research purposes, one must go through the State Board of Education in Springfield to get permission to do that. This bill would change that permission routine to the local board of education and that's all the bill does. Be happy to answer any questions. I would ask for a favorable vote on the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)
