### SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. As you know, Senator Rock and I have passed out the amendment and the explanation to the amendment to 1604. It's on your desk. It's a very complicated, sensitive issue to say the least. I want to commend Senator Rock for working and knocking out this agreement. As you know, the four leaders and some of our members have worked long and hard on

this compromise, and to say the least, it was not easy. I would like to personally commend Senator Rock...of course, he was defending the trial lawyers which, quite frankly, is not very easy to do, but he did a great job, quite frankly, and if it wasn't for Senator Rock, we probably would not have had this compromise, and it's been a compromise between the medical profession and the trial lawyers. It was not an easy...how should I say it...amendment...neither side is very happy. It's a very complicated subject. I'll be happy to answer any questions. I said both sides are in agreement and, hopefully, we will pass it and stand up and do what's right.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Senator Rock.

# SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Bill 1604 as amended is, as Senator Philip said, the result of some rather lengthy and at times heated negotiations between representatives of the medical society. the Governor's Office, the trial lawyers and those of us from the Assembly who, I think, were working in the best interest of the poor, unfortunate victims of malpractice. The fact is that we are confronted in this State with something of a crisis in terms of the affordability of malpractice insurance, and certain members of the medical profession have indicated very strongly that they were either not continue to practice in their specialty because of the insurance premium difficulty or, in addition, and mostly in addition, they have to resort to the practice of what is called defensive medicine, whereby literally more costs are assessed against the consumer, the patient, in terms of ultimate protection from liability for the doctor. I think this is a reasonable compromise. As with any compromise neither of the principals is particularly pleased, but the fact is that the effort is

to do two things; to reduce the number of frivolous lawsuits that are to be filed and this Act will become effective August 15th and will apply to all suits filed on or after that date, and that's the reason we're trying to go out of the ordinary course of business and get it to the Governor so that there will be this couple of month period of time within which your constituents and mine can truly understand what the new law will be; and in addition to the reduction of the frivolous lawsuits, we are at the same time by the virtue of the provisions of 1604 as amended truly protecting the rights of those unfortunate victims of medical malpractice. We are not, in fact, putting a cap on any recovery that they might receive because of the misfeasance or malfeasance of a medical professional; and at the same time, we are recognizing that there is an insurance crisis and so there is provision for collateral source, deductions, there is provision for a structured verdict. All in all, I think it is a result of which we can all be proud, and I would suggest that we have a...a unanimous affirmation of House Bill 1604 as amended.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

We have the following Senators that are seeking recognition in this order, Senator Lemke, Berman and Geo-Karis. Senator Lemke.

## SENATOR LEMKE:

Just a statement for the record. It's...it's my belief, as chairman of Judiciary, that this bill is unconstitutional. It takes the powers away from the Judiciary and I believe it will be set forth in the courts to determine, and any...any...any judge in the Supreme Court that had...him or any of his members of his family connected with the drafting of this legislation should excuse himself and another Supreme Court judge appointed. I also say that this bill is special legislation for a select group of individuals which is against the Illinois Constitution in this State and should

not be done. Another thing, we have not been shown there has been a...affordable...malpractice crisis in insurance 'cause the insurance company has not revealed those records yet and we have no way of getting those. The other point is on the collateral source rule, we are passing the expense of medical to the people that pay for group insurance, the common man, to exempt one of the highest paid professionals in the State of Illinois, that's the doctors. As far as the other provisions in the rule...in the bill, as far as frivolous lawsuits, the lawyers have conceded and have ... don't want frivolous lawsuits and there aren't any lawyers that are filing frivolous lawsuits, and if they are, they are under the sanctions of the Supreme Court and have been properly disciplined. That has not happened in the medical profession. There is no doctor that has ever been disciplined in the State, their license revoked. In the matter of Blickman who was...who had...practicing malpractice in the form of an abortion clinic and also absconding with public aid funds, he has never lost his license in the State of Illinois. No one has ever done that, they have gotten their licenses back. So, let it be known to this State that this is a bill we're going to pass to try to protect reputable doctors, but it's up to the medical society to get rid of the bums in the profession; and when we have doctors that come here from a foreign...land and can't speak English to the patients, are going to have malpractice, 'cause if you can't understand the person's...person's problems in English, how can they talk to them in a different language? I think this is a...I think something should be done in this realm and I don't think 1955 goes as much to remove the...the doctors in this State, the minority of them, who are poor and should be kicked out of the profession and it's up to the medical society to do that and I'd like to see them do it now. I was here in '76 when we had affordable malpractice crisis, we

gave them what they wanted and yet the premiums...the...company they control, still the premiums keep going up and the claims keep going down in the amount of money paid out. I don't know what's going on, but I hope that we can get at the real serious problem and that's the culprits that are milking the premiums in this State, the insurance industry. I will vote on this bill Aye only to...to protect the good doctors, but let the profession of the medical society get rid of the bad ones.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Berman.

#### SENATOR BERMAN:

Thank you, Mr. President. Would the... Senator Rock yield to a question? Senator, calling your attention to page 5 of the bill, lines 25 and thereafter. Would you explain in regard to the calculation of future damages how those damages will be calculated considering the affects of inflation and future payments?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rock.

### SENATOR ROCK:

Yes, thank you, Mr. President and Ladies and Gentlemen of the Senate. Senator Berman, I'm sure you're aware that this amendment was subject to a number of different provisions and drafts, particularly as it applied to...to the question of...of future damages and how we take into account what everybody acknowledges as an inflation factor. One of the earlier drafts and one of the things we talked about was tying the ultimate recovery for future damages to the T-bill rate and that was felt, frankly, at the last couple of moments to be a little unworkable. So, what we have done is that under Section 2-1707...it is the intent of this legislation that this will be done by jury instruction, so that the jury, as instructed by the court, will itself determine

how inflation and the possible increase in wages of the plaintiff would, in fact, affect future damages. It is a factor that is to be presented to the jury by virtue of an instruction.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Berman.

### SENATOR BERMAN:

Then it's my understanding that future inflation...can be taken into account in the deliberations of the jury and that's anticipated. Is that correct?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rock.

# SENATOR ROCK:

That is correct, that is the intent of this legislation.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Berman.

### SENATOR BERMAN:

Thank you, Mr. President, and thank you, Senator Rock. Just to comment on the bill. I think there's one item that I would like to bring to your attention. When the medical society came down on their lobbying day, they did a very effective job and in the closing hours of that particular day, there was the announcement of a package of legislation. House Bill 1604 before us today is an amendment to that original package that was announced two or three weeks ago. want to point out, to my knowledge and I believe I'm correct, that in the negotiations that have taken place in these past two weeks or so, the trial bar has addressed what they viewed as certain inequities that were built into the original proposal, inequities as related to the injured victim, to the plaintiff. I think it's fair to point out that one of the proposals that was in the original package and has been untouched in the negotiations is a provision that reduces and for the first time, to my knowledge, legislates attorneys.

fees, and I'm very proud to explain that point, and I'm proud because of the fact that the bar association did not jump in to try to reestablish any higher level of fees than was originally suggested. And let me give you a specific example, that under this bill, for the first time, in any type of personal injury action, there is legislation that sets forth the amount of fees allowable and the one-third...thirty-three and a third percent of the first hundred and fifty thousand dollars. Now as we all know, in many of these cases, because of the substantial uncertainty involved in these cases, a thirty-three and a third percent fee is...is not uncommon. That third...one-third fee is still built in only to the first hundred and fifty thousand dollars. Twenty-five percent is the legislated fee for the next eight hundred fifty thousand and twenty percent for anything over a million dollars. A fast calculation, ladies and gentlemen, says to you and to me that the attorney that is able to recover a million dollar judgment or a million eight hundred thousand dollar judgment has, in fact, shaved his fees by approximately a hundred and thirty-three thousand dollars. The bar associations in the negotiations did not touch that provision. I'm proud of the bar for that type of commitment to seeing to it that the plaintiffs and the injured persons get more money out of the proceeds. I would ... commend that kind of approach to the medical society when we're talking about affordability. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Geo-Karis.

# SENATOR GEO-KARIS:

Well, Mr. President and Ladies and Gentlemen of the Senate, those of us who are conscientious lawyers are a little bit tired of some of the ambulance chasing lawyers who feel they can make so much more money just prosecuting any case against any doctor they desire for anything. I feel

that this bill as amended in the House does provide the safeguards for the people and also for the conscientious doctors. I'm going to vote for this bill predicated on the fact that 1955... House Bill 1955 also has language in it which states in effect that the hospital administrators and individual health care providers who without malice and in good faith go after doctors who don't deserve to be in the medical profession or who...constantly do the wrong things for their patients. I do feel that this bill does have safeguards for the patients, also has safeguards for the doctors. In addition, this bill gets rid of punitive damages, which it should. It also has...malicious prosecution elements in favor of the doctors against people who prosecute them without good grounds, and it does have the opportunity to a doctor to go after the lawyer who sues them on a spurious case to go after them for all their expenses. All in all, I think if we are to...going to keep good doctors here, we have to do something and I think this bill is in the right direc-Hopefully, it will be considered constitutional and I will vote Aye and urge my colleaques here to vote Aye for it. PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, Senator Philip may close.

# SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. As you know, this has been a very sensitive, detailed amendment. I said nobody on either side is happy, quite frankly, but I think generally speaking, the consensus of opinion is something that we ought to do, the time is now, the time is right and I would hope that we would see a lot of green votes up there.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall House Bill 1604 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is

open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 57, the Nays are none, none voting Present. House Bill 1604 having received the constitutional majority is declared passed. Resolutions.

### SENATOR TOPINKA:

Yes, Mr. President. I would like to recommit to subcommittee status of the Health Committee, House Bill 391. It

somehow got out on Agreed Bill...List yesterday and it should not have, and it should go back to subcommittee.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator, you can't put it in subcommittee. It's an action of the committee. We can rerefer it back to committee and let them...Senator Topinka moves to rerefer House Bill...to rerefer House Bill 381 back to the Committee on Public Health. You've heard the motion. Any objection? Hearing no objection, leave is granted. House Bill 391 will be referred to the Committee on Public Health. Senator Vadalabene, for what purpose do you arise?

### SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate.
