The hour of noon having arrived, the Senate will come to order. Members will be at their desks. Our guests in the gallery will please rise. Our prayer this morning will be by the Reverend Rudolph Shoultz, Union Baptist Church, Springfield, Illinois. Reverend.

REVEREND RUDOLPH SHOULTZ:

(Prayer given by Reverend Shoultz)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Reading of the Journal.

SECRETARY:

Tuesday, June the 17th, 1986.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate.

I move that the Journal just read by the Secretary be approved unless some Senator has additions or corrections to offer.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the motion by Senator Vadalabens.

Discussion? If not, those in favor indicate by saying Ay2.

Opposed Nay. The Ayes have it. Motion carries. It is so ordered. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. I move that reading and approval of the Journals of Wednesday, June 18th; Thursday, June 19th and Friday, June 20th; Monday, June 23rd; Tuesday, June 24th; Wednesday, June 25th and Thursday, June 26th, in the year 1986, be postponed pending arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the...excuse me, you've heard the motion as posed by Senator Vadalabene. Those in favor indi-

cate by saying Aye. Opposed Nay. The Ayes have it. Motion carries and so ordered. Messages from the House.

SECRETARY:

Message from the House by Mr. O'Brien, Clerk.

Mr. President — I am directed to inform the Senate the House of Representatives has concurred with the Senate in the adoption of their amendments to the bill with the following title:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Resolutions.

SECRETARY:

Senate Resolution 1127, by Senator Vadalabene. It's congratulatory.

1128, by Senator Mahar. It's congratulatory.

And 1129, by Senators Karpiel, Friedland, Savickas and all Senators. And it is congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar.

PRESIDENT:

The Senate will please come to order. Messages from the House.

SECRETARY:

Message from the House by Mr. O'Brien, Clerk.

Mr. President — I am directed to inform the Senate the House of Representatives has adopted the following joint resolutions, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution 180 which is sponsored by Senator Donahue in the Senate and House Joint Resolution 181 which is sponsored by Senator Welch in the Senate.

PRESIDENT:

All right, with leave of the Body, we'll move those to a special order of business on a Supplemental Calendar. Those are the two resolutions that called for disapproval of the Compensation Review Board Report. Senator Philip and I have agreed that today would be the appropriate time to take up those resolutions and we will do so. So, with leave of the Body, Mr. Secretary, those two resolutions will be moved immediately to the Calendar, placed on the Order of the Secretary's Desk. Leave is granted. Resolutions.

The following resolutions are all congratulatory.

Senate Resolution 1130. by Senators Sommer and Davidson.

1131, 1132, by Senator Topinka.

PRESIDENT:

Consent Calendar. If I can have your attention, there has been some discussion between Senator Philip and I with respect to the weekend schedule and I know that it's of interest to the members. Let me just suggest that we will work this afternoon, given what's on the Calendar and the meetings that are currently...meetings that are currently going on. I had to delay the Conference Committee because the...some of the Governor's representatives indicated they wished to have another...they're meeting currently in the Governor's Office. There will be a meeting in the Governor's Office tomorrow with respect to the subject of horse racing and I've asked Senator Vadalabene and Senator Philip has asked Senator Weaver to speak on behalf of the Senate. When

we conclude our business this afternoon, which I expect will be approximately four o'clock, we will reconvene at ten o'clock tomorrow morning and handle whatever needs to be handled, and then we will reconvene on Sunday at 7:00 p.m., and then we will reconvene on Monday at ten o'clock and, hopefully, adjourn for the semester and go immediately to the Governor's House for his end of Session party. No, it's Monday. There is a party tonight, that's not the end of Session party. So, ten o'clock on Saturday and then 7:00 p.m. on Sunday and then ten o'clock on Monday. And by that time, we should have it all, hopefully, put together. Senator Vadalabene, for what purpose do you arise, sir?

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. There will be a Democratic Caucus in...in the President's Office immediately. A Democratic Caucus in the President's Office immediately and we will reconvene approximately at two o'clock.

PRESIDENT:

That request is in order. Senator Rupp. SENATOR RUPP:

Thank you, Mr. President. Republican Caucus, Senator Philip's Office immediately. We will be five minutes shorter than you.

PRESIDENT:

Terrific. All right, the Senate will stand in Recess until the hour of two o'clock. Republican and Democratic Caucus immediately. We'd ask all the members to be prompt. It shouldn't take but a...(machine cutoff)

RECESS

AFTER RECESS

PRESIDENT:

Senator Luft, for what purpose do you arise, sir?
SENATOR LUFT:

Thank you, Mr. President. I would like for the record to show that Senator Chew is absent today because of illness. Also, that Senator...Senator O'Daniel is due as a result of...or, I mean, absent as a result of a death in his family. PRESIDENT:

The record will so reflect. All right, if I can have the attention of the Body, we have a number of requests. WAND-TV Channel 17 has requested permission along with Channels 3, 7 and 20...and WCAI-TV. I guess that covers them all. If...with leave of the Body, leave is granted. Senator Welch, for what purpose do you arise, sir?

Mr. President, I would ask that we move to Senate Calendar Supplemental No. 1 Secretary's Desk Resolutions for House

PRESIDENT:

SENATOR WELCH:

That request is in order. With leave of the Body, we'll move to Supplemental Calendar No. 1. Hr. Secretary, House Joint Resolution 181. The Senator also seeks leave to consider both resolutions; as I understand it, they are identical. House Joint Resolution 180 will be considered with 181, with leave of the Body. Leave is granted. On the Order of Secretary's Desk Resolutions, Supplemental Calendar No. 1. House Joint Resolution 181, Senator Welch. I'd ask the staff to take the conferences off the Floor. Senator Welch.

Thank you, Mr. President. House Joint Resolution No. 181 and House Joint Resolution 180 are resolutions which recommend that the Legislature reject the recommendations of the Compensation Review Board. The Compensation Review Board has recommended pay raises of 9.7 million dollars over two years. Eighty...eighty-six percent of those 9.7 million dollars in raises will go to Judicial pay increases. The raises include raises of seventy-one thousand eight hundred dollars for cost

of living increases effective July 1, 1986, which end up being increases on top of salaries not even being paid to constitutional officers of the State of Illinois. Mr. President, there are basically three reasons why we should reject the recommendations of the Compensation Review Board. Number one, there is a budget shortfall in the State of Illinois of at least three hundred and four million dollars and we are scrambling to find needed revenue. Secondly, the priorities of the State of Illinois are set by the Legislature, and I don't believe this is the priority that we should set in this tight budgetary year. Third, the annualization of cost of living increases has come about by institutionalizing the Compensation Review Board. These three reasons, I believe, are sufficient enough to recommend an Aye vote on these resolutions. And I would move for an Aye vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Welch has moved the adoption of House

Joint Resolution 181. Discussion? Senator Donahue.

SENATOR DONAHUE:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. As a cosponsor or a sponsor of an identical resolution, I, too, would rise in support of this resolution. I do not think that at this time we can...we are doing this in the best interest of our constituency. I would just ask for an Aye vote on these resolutions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator...Senator Hall. Senator Hall. Senator Berman. Senator Berman. Senator Berman.

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise in opposition to these resolutions. I think it's important to note that the cost...and there have been dollar figures that have been bantered about, but the cost of the proposed pay raises, which are four and a half percent

next year and five percent the year after, as it affects the General Assembly is two hundred and forty-five thousand dollars next year and five hundred and thirty-two thousand dollars the year after. I think that in my experience of eighteen years in the General Assembly the...I have not found at any time any substantial number of my constituents who have voiced any objection to a reasonable increase for State employees or a reasonable increase for their State Legis-This falls very much so into that category. lator. total amount that we receive out of that is very, very small, each of us can form our own opinion as to the Executive and Judicial Branch, but I think it's important to note that our portion of this total cost is nominal, minimal, very, very insubstantial, a quarter of a million the first year and a half a million the second year. I urge a No vote or a non vote on these resolutions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Rock.

SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I don't really know that there's a lot of discussion that's necessary on this. When we established the Compensation Review Board, we asked them to make recommendations to this Assembly which we within thirty Session days have the opportunity to approve or disapprove. The moment of truth is with us. I frankly feel, as I have said publicly at the time the report was issued, that these raises are eminently justified, it is merely a cost of living increase. And even this morning, a national executive group said that middle management was deserving of a nine percent, this is a long way from nine percent. I urge a No vote on House Joint Resolution 181.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. One of the most difficult things we do in the General Assembly is vote for pay raises. And it's not so hard, very honestly, to vote for pay raises for other constitutional officers. The most difficult thing is to vote for our own pay raise and there's nobody else here to do it but ourselves. You're talking about a 2.5 percent...per year for four years. In my judgment, that's not a gigantic amount of money. I wish there was another way of doing it. I wish we could put our pay raises off to somebody else, to some other body, to the Executive Branch, the judges, but we can't, it's ours to do. Well, it's only seven million dollars a year in a budget of about twenty billion, not a large amount of money. I certainly would encourage everybody to vote No on this resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, Senator Welch may close. Whoop...Senator Geo-Karis.

SENATOR GEO-KARIS:

Just a...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Geo-Karis, hold it...

SENATOR GEO-KARIS:

•••point of parliamentary•••

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Geo-Karis.

SENATOR GEO-KARIS:

•••the•••the two resolutions are going to be•••considered at the same time, is that correct? 180 and 181?

PRESIDING OFFICER: (SENATOR DEMUZIO)

I...I was not on the Floor but I am told that leave of the Body was, in fact, granted to hear...to have a simultaneous vote on House Joint Resolution 180 and 181. Senator

Welch may close.

SENATOR WELCH:

Mr. President, I would urge an affirmative vote in order to reject the recommendations of the Compensation Review

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch has moved the adoption of House Joint Resolutions 180 and 181. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Senator Savickas. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 26, the Nays are 30. House Joint Resolution 181 and 182 having failed to receive the required constitutional majority or thirty affirmative votes is...has failed. All right. Senator Rock, for what purpose do you arise?

Thank you, Mr. President. I would ask you now that we move to the Order of Secretary's Desk Nonconcurrence and we'll go right through the Calendar.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, page 9 on your Calendar, Secretary's Desk Noncurrence is House Bill 2546, Mr. Secretary. Senator Watson, you're first out of the box. Secretary's Desk Nonconcurrence, House Bill 2546.

SECRETARY:

House Bill 2546 with Senate Amendments 1 and 2.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Page 9,...can we have some order, please. We are on the Order of Secretary's Desk Nonconcurrence. House Bill 2546, Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. I guess the proper motion would be to...to nonconcur...I move to nonconcur with House action and ask for a Conference Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson moves...

SENATOR WATSON:

Refuse to recede. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Watson moves to refuse to recede from House Amendments 1 and 2 to House Bill 2546 and that a Conference Committee be adopted. All in favor indicate by saying Aye. Opposed Nay. The...the Ayes have it. The motion carries and the Secretary shall so inform the House. House Bill 2573, Senator Welch. Senator Welch. Mr. Secretary...all right, Senator Welch...I.m sorry, Mr. Secretary. SECRETARY:

House Bill 2573 with Senate Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Mr. President, I would move to recede from this amendment. What happened was the Senate changed the bill to be like the Senate bill. The House sponsor prefers it to remain like the House bill as he started out. So, I would ask that...

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, discussion? Senator Welch moves that the Senate refuse to recede from the adoption of Amendment...Senate Amendment No...all right,...can we have some order, please. I can hardly hear myself think. Senator Rock.

SENATOR ROCK:

I would just ask the members when we recede from a Senate amendment or Senate amendments, this is final action. So, I'd ask you to please be a little more attentive.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator...Senator Welch, would you...Senator

Welch.

SENATOR WELCH:

After hearing from the House sponsor, I would ask that we refuse to recede from Senate Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Welch has apparently changed his mind.

Now we're refusing to recede. Senator Welch moves that the Senate refuse to receive...recede from the adoption of Senate Amendment No. 1 to Senate Bill...to House Bill 2573. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. House Bill 2642, Senator Joyce...Jerome Joyce. 2642, Mr. Secretary.

SECRETARY:

House Bill 2642 with Senate Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator Welch, could you take your conferences off the Floor, please. Senator Joyce.

SENATOR JEROME JOYCE:

Yes, thank you, Mr. President. I would refuse to recede and ask for a Conference Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Joyce moves that the Senate refuse to recede from the adoption of Senate Amendment No. 1 to House Bill 2642. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. All right, and a Conference Committee will be appointed on House Bill 2642, House Bill 2573 and House Bill 2546. House Bill 2785, Mr. Secretary.

SECRETARY:

House Bill 2785 with Senate Amendments 1 and 2.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Marovitz.

SENATOR MAROVITZ:

Thank you, very much, Mr. President and members of the Senate. I would move that the Senate refuse to recede from House Amendments No. 1 and 2...from Senate Amendments No. 1 and 2 to House Bill 2785 and that a Conference Committee be appointed.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Marovitz moves that the Senate refuse to receive...recede from the adoption of Senate Amendment Noes. I and 2 from House Bill 2785 and that a Conference Committee be appointed. All those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. House Bill 3036, Senator Welch. Senator Welch. Senator Welch on the Floor? House Bill 3043, Senator Lemke. Bottom of page 9, House Bill 3043, Mr. Secretary.

SECRETARY:

House Bill 3043 with Senate Amendments...Senate Amendment

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LEMKE:

I move to recede from Senate Amendment No. 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Ladies and gentlemen, it will go much quicker and faster if we have some order. We ask that you take your conferences off the Floor. All right, Senator...Senator Schuneman.

SENATOR SCHUNEMAN:

Well, thank you, Mr. President. Senate Amendment No. 3 was the one which removed the provision in this bill that apparently would have cost some twenty million dollars to implement, and the Senate has already spoken on that issue and I'm curious to know why the Senator is now moving to...to recede from our position.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LEMKE:

The sponsor of the bill asked me to recede from the amendment and I am going along with the House sponsor...but that's what you...you...you are accurate. Senator Schuneman. PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Schuneman.

SENATOR SCHUNEMAN:

Yeah, okay, thank you, very much. Mr. President, I'd simply like to call the attention of the Senate that this action on which we have already spoken and ask you to be alert for the Conference Committee report in case it comes back with this language back in.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Weaver has requested some order.

Ladies and gentlemen, can we have some order, please. Take

your conferences off the Floor. Senator Lemke.

SENATOR LEMKE:

I persist in my motion to recede from Amendment No. 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Schuneman. Senator Schuneman.

SENATOR SCHUNEMAN:

Well, thank you, Mr. President. I...I had my signals mixed up here. Actually, what the ...what the sponsor is doing is asking the Senate to recede from an amendment which was put on this bill the other day that would take out the objectionable provisions and that's something that we should not do. What...in effect...this is the bill, you remember, that would require the State to pick up a hundred percent of any of the...the mandates that we place upon the Criminal Justice System, and I don't think we should recede from this amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator...Senator Weaver on the Floor? All right, Senator Davidson.

SENATOR DAVIDSON:

Well, Mr. President and members of the Senate, I rise in opposition to this motion to recede 'cause it...what it was just stated by Senator Schuneman, if this would pass, if we did vote recede, this is final passage, this is going to lay upon the State to a hundred percent pay all mandates under the Criminal Justice System. Now if you want another ploy on how to send State money to the counties, this is it. I'm not saying that counties may not need some help, but with the financial crunch you're all saying that the State Treasury is in, you're opening up a bag of worms that...that's unknown for what cost could be, and I urge all of you to vote against this motion to recede.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Berman.

SENATOR BERMAN:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I participated in the debate the other day that caused us to take out this...the portion of this dealing with the mandate. I don't think we ought to back off of that position. There are things that both local government and the State should participate in; our Criminal Justice System is one of them, it's both local dollars and State dollars and by making it a hundred percent mandate program, we're picking up a...the total cost and I don't think we should be put in that position. I urge a No vote on the motion.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Lemke may close.
SENATOR LEMKE:

I ask for a favorable adoption of my motion to recede.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke...the question is, shall the Senate recede

from Senate Amendment 3 to House Bill 3043. Those in favor will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 20, the Nays are 34, none voting Present. The motion fails. Senator Lemke, do you have another motion? Senator Lemke.

SENATOR LEMKE:

•••the other motion is that we not recede and ask for a Conference Committee•

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke moves that the Senate refuse to recede from the adoption of Senate Amendment 3 to House Bill 3043 and that a Conference Committee be appointed. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. motion carries and the Secretary shall so inform the House. (Machine cutoff)...there...there have been several...several inquiries of members who have, in fact, requested roll calls of the House joint resolutions that were just acted upon. The Secretary informs me that it, in fact, did skip one, so one to you'll have to move everybody up determine their...their actual posture. SENATOR DAVIDSON:

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene.

SENATOR VADALABENE:

Thank you, Mr. President and members of the Senate...

PRESIDING OFFICER: (SENATOR DEMUZIO)

•••Senator•••Senator Vadalabene, pardon me• Ladies and gentlemen, I know the House members must•••have nothing else to do at the moment, but•••we welcome you here, but please take your conferences off the Floor• Senator Vadalabene• SENATOR VADALABENE:

Yes, at the outset, I would like to have Senator Jones be a hyphenated cosponsor of Senate Bill 2061.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Vadalabene to add Senator Jones as a hyphenated cosponsor or a cosponsor of Senate Bill 2061. Is leave granted? Leave is granted. It's so ordered. Senator Vadalabene.

SENATOR VADALABENE:

Thank you, Mr. President and members of the Senate. Amendment No. 1...House Amendment No. 1 to Senate Bill 2061 establishes the Vietnam War Veterans Day a commemorative holiday on March 29th of each year. On March 29th, 1973, was the day the U.S. troops were officially withdrawn from Vietnam. It does not change anything else, and I move to concur with the House amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Question is...is there discussion? If not, the question is, shall the Senate concur with House Amendment 1 to Senate Bill 2061. Those in favor will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Take the record. On that...take the record. On that question, the Ayes are 55, the Nays are none, none voting Present. The Senate does concur with House Amendment 1 to Senate Bill 2061 and the bill having received the required constitutional majority is declared passed. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the

Senate. I have assumed, with leave of this Body, sponsorship of Senate Bill 2200 along with Senator Philip. Senator Philip and I, after some lengthy discussion and with leave of the Body, I'd like to move to that order of business for the purpose of Tabling that bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock seeks leave of the Body to go to the Order of Senate Bills 3rd Reading, on page 3, for the purpose of Tabling the bill. Is leave granted? Leave is granted. Senator Rock now moves to...to Table Senate 3ill 2200. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Bill 2200 is Tabled. Senator Leitch, for what purpose do you arise?

SENATOR LETTCH:

Thank you, Mr. President. I would ask that House Joint Resolution 227 be considered, that we suspend the appropriate rule and adopt the resolution. These folks are leaving tomorrow and the House sponsor requests this courtesy.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, I am told that this is a congratulatory resolution...

SENATOR LEITCH:

Yes, it is.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...that it is needed today. With leave of the Body, we'll go to the...is...it's my understanding that House Joint Resolution...227, a congratulatory resolution, is on the Consent Calendar. With leave of the Body, we will go to that order of business to take up that specific resolution. Is leave granted? Leave is granted. On the Order of...of the...of the Consent Calendar is House Joint Resolution 227. Senator Leitch moves to suspend the rules for the immediate consideration and adoption of House Joint Resolution 227. Those in favor indicate by saying Aye. Opposed Nay. The



Ayes have it. The rules are suspended. Senator Leitch now moves the adoption of House Joint Resolution 227. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 227 is adopted. With leave of the Body, now we'll go to the Order of Secretary's Desk Resolutions. Secretary's Desk Resolutions. Secretary's Desk Resolutions. Start on the...at the top of page 6 and proceed right through. Senator Rock. Senator Rock. with...all right. Senate Resolution 411, Senator Kustra. Senator Kustra on the Floor? Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Thank you. I'd like to ask to be added as a cosponsor, if I may, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Of ...

SENATOR SMITH:

•••leave of the Body•••on Senate Bill 2061, please•

PRESIDING OFFICER: (SENATOR DEMUZIO)

House bill?

SENATOR SMITH:

Senate Bill 2061.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Smith seeks leave of the Body to be added as a cosponsor of Senate Bill 2061 and add Senator Demuzio. Is leave granted? Leave is granted. It's so ordered. Now, we are on the Order of Resolutions. Senator Kustra on the Floor? 514. Senate Resolution 514, Senator Lemke. All right, Senate Resolution 514, Senator Lemke...oh, I'm sorry, Mr. Secretary.

SECRETARY:

Amendment...Amendment No. 1 offered by Senator Lemke.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LEMKE:

...what this amendment does is...is what was happening in the...in the...was brought up in the...in the Executive Committee when it was heard, it deletes all reference to IDOT and directs the Tollway Authority to study the need for noise barriers between I-90 and I-94 restricting the area. I think it's a good amendment. I ask for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator DeAngelis.

SENATOR DEANGELIS:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates he will yield. Senator DeAngelis.
SENATOR DeANGELIS:

Senator Lemke, I apologize. You do not...I do not have a copy of the resolution, but did you amend this on the Floor to include the things that we had requested in committee?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke.

SENATOR LEMKE:

That's what our staff did, yes. It restricted the area from I-90 to I-94 instead of the whole tollway system.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Lemke, I'm told that it does, in fact, involve the expenditure of money; therefore, a roll call will have to be taken. The question is on the adoption of Senate Resolution 514...all right, Senator Lemke moves the adoption of Amendment No. 1 to Senate Resolution 514. Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

Amendment No. 2 offered by Senators Topinka and Zito.

PRESIDING OFFICER: (SENATOR DEMUZIO)



Senator Topinka.

SENATOR TOPINKA:

Yes, Mr. President and Ladies and Gentlemen of the Senate, this amendment would ask that the...the Highway Authority whenever it advertises any work for bid to send notices to each State Senator and Representative from the affected area or areas specifying the project's nature, location, expected cost, commencement, completion date. Basically what the Illinois Department of Transportation now does in terms of policy, we would be asking the tollway to do.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Topinka has moved the adoption of Amendment No. 2. Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further amendments? SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lemke, are you ready to proceed? All right.
Senate Resolution 514, Senator Lemke.

SENATOR LEMKE:

I ask for the adoption of Senate Resolution 514 which calls for the tollway to do a study in regards to noise along the tollway in regards to residential area.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, the question is on the adoption of Senate Resolution 514 as amended. Those...those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 35, the Nays are 15, none voting Present. Senate Resolution 514 having received the required majority vote is adopted. Senate Resolution 624, Senator Netsch. 695. 720. 804, Senator Etheredge. Senator

Etheredge, 804? Senator Etheredge. Senator Etheredge, 804? 879, Senator Joyce. 879, Senate Resolutions? All right. Senate Resolution 879, middle of page 6...middle of page 6, Mr. Secretary, 879, Senate Resolution. Senator Joyce.

SENATOR JEROME JOYCE:

Yes, thank you, Mr. President. What this says is that it directs the Department of Nuclear Safety to just make a study of the incident in Chernobyl and to make comparisons with Illinois nuclear reactors to see if they can prevent a similar nuclear accident in Illinois, also dealing with the evacuation plans we have in Seneca, a town in...in my district. The last...a couple of weeks ago, they...they were not notified of a...of an...an accident and...at the Brookfield Station for some sixteen hours after it happened, and I would like our Department of Nuclear Safety to make some comparisons and report back to us on that.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, discussion? Senator Schuneman.
SENATOR SCHUNEMAN:

Thank you, Mr. President. It's my understanding that the Department of Nuclear Safety agrees that it's probably a good idea to conduct this study, and while they may have some reservations about exactly how it ought to be done, we stand in support of the resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, the question is on the adoption of Senate Resolution 879. Those in favor will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays are none, none voting Present. Senate Resolution 879 having received the required majority vote is adopted. 881, Senator Dudycz. Senate Resolution 881, Mr....Senator Dudycz.

SENATOR DUDYCZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Resolution 881 urges the Soviet Union to make full restitution to the people of Ukrain and other countries who will suffer direct or indirect health hazardous from this nuclear accident at Chernobyl and that the United States demonstrate its compassion for the Ukrainian people by offering medical teams and medicine. The Senate Resolution 881 is an exact duplicate of a House resolution sponsored by Representative Kulas and which received unanimous support, and I ask for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Dudycz has moved the adoption of Senate Resolution 881. Those...any discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 881 is adopted. Senate Resolution 900, Senator Smith. Senator Smith, Senate Resolution 900. I beg your pardon. I'm...I am told that there is an amendment to this. Senate Resolution 900, Mr. Secretary.

SECRETARY:

Amendment No. 1, by Senator Smith.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and members of the Senate. Amendment No. 1 to...Senate Resolution 900 amends Senate Resolution...by deleting lines 13 and 14 and inserting the following "Winnie Mandela" and in line 15 by deleting "three" and inserting "two" and in line 16 by deleting "four" and inserting...deleting that...what we're eliminating in this...resolution is to recognize the African National Congress as the legitimate representative of the country's blacks. This was asked to be done in committee. The heart of the resolution is that we urge Congress and the President of the United States to encourage South Africa to. one, free

Nelson Mandela and lift the ban on his wife, Winnie Mandela; and two, which becomes...three which becomes two, is to impose stricter economic sanction as a means to speed the process of peaceful negotiations and, four...three...which is now three, establish framework for political discussions which can lead to a peaceful settlement with the black majority and be it further resolved that a suitable copy of this preamble and resolution be presented to the President of the United States, the President of the U.S. Senate, the Speaker of the U.S. House of Representatives and each member of the Illinois Congressional Delegation. I think that it is imparative that our Senate go on record as joining other legislative bodies across this country in expressing our concern for the plight of South Africa and the...and report to our...to our government and Congress...asking that...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith, we are on...

SENATOR SMITH:

...they will free them...

PRESIDING OFFICER: (SENATOR DEMUZIO)

We are on the adoption of Amendment No. 1.

SENATOR SMITH:

...are you on the adoption of that?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Yes, ma*am.

SENATOR SMITH:

Okay, thank you. Well, the adoption is that we would eliminate item two, which I first read.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Thank you, Mr. President. This resolution was approved by the minority members of the Executive Committee with the understanding that a...that an amendment would be offered and, of course, it has now been offered but we've not had an opportunity to really look at it and put it together with the resolution. I would ask Senator Smith to take this bill out...or this resolution out of the record for a few minutes until we've had an opportunity to look at it. I have no objection to adopting the amendment and then getting back to it; if...if we could proceed that way, I'd appreciate it. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Smith, the gentleman has suggested that we adopt Amendment No. 1 and he has requested that...after that adoption that you take the resolution out of the record in order that you might confer on the resolutions that's in the...in its entirety after amended. Senator Smith.

SENATOR SMITH:

I... $\mbox{Mr.}$ Speaker and members of the Senate, I agree, I'll...

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Smith has moved the adoption of Amendment No. 1 to Senate Resolution 900. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. With leave of the Body, we'll come back to that later in the...oh, I'm sorry, there...there is another amendment. Further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, it'll...it'll repose back on the Calendar.

902, Senator Keats. Senate Resolution 902, Senator Keats.

SENATOR KEATS:

The resolution urges, doesn't mandate anything, urges Illinois business and State Government not to purchase from terrorist nations, such as, Iran, Lybia, Syria. Again, it urges, does not mandate and does say that we...makes a state—

ment that we do not intend to trade with terrorist nations.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, Senator Keats has moved the adoption of Senate Resolution 902. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate...oh, I'm sorry, I didn't...Senator...Senator Joyce, I didn't see you. Senator Joyce. All right, Senator Keats has moved the adoption of Senate Resolution 902. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 902 is adopted. With leave, we'll come back to 921 in a minute. Senate Resolution 922, Senator Geo-Karis. All right, there's leave to go back to Senate Resolution 921. Leave is granted. Senate Resolution 921, Mr. Secretary.

On the Order of Secretary's Desk Resolutions, Senate Resolution 921, Senator Demuzio.

SENATOR DEMUZIO:

Thank you, Mr. President. Senate Resolution 921 makes a request of the EPA to conduct a feasibility study regarding the implementation of a waste water facilities revolving loan fund for our State to be submitted to the General Assembly by January the 1st of 1987. The Federal Clean Water Act would require communities to achieve compliance with discharge and...by July the 1st of 1988, and since the U.S. EPA and the Illinois EPA have required communities to develop municipal compliance plans which define their compliance and financial needs and since the Federal and State Grant Assistance Program is not expected to be available for many of these communities across our State that must be forced to upgrade their facilities and that the reauthorization of the Clean Water Act is expected to include a new provision for capitalization of State revolving funds to provide some relief for current and long-term community needs; therefore, this resolution, at the request of the Illinois EPA, is...is requesting a study to determine the feasibility...regarding the implementation of a waste water facilities revolving loan...program for our State and that requires that the study would be submitted to the General Assembly by January the 1st of 1987. Frankly, I think this may, in fact, be one of the most important things we do this...this Session since many of our communities are faced with these demands by both U.S. E?A and...in the Illinois EPA and I would move its adoption.

All right, Senator Demuzio has moved the adoption of Senate Resolution 921. Discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Thank you, Mr. President. He join with Senator Demuzio in urging adoption of this important resolution. It affects every district in the State of Illinois. We think it's a good idea.

PRESIDENT:

Question is the adoption of Senate Resolution 921. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, no Nays, none voting Present. Senate Resolution 921 having received the required constitutional majority is declared adopted. Senator Smith, I'm informed by the..the Chair has been informed that Senator Schuneman and others are satisfied with respect to Senate Resolution 900. If it's your wish, we'll go right back to it. On the Order of...Secretary's Desk Resolutions, Senate Resolution 900.

SENATOR SMITH:

Thank you, Mr. President. Inasmuch as I have already explained, I merely would ask for the adoption of this resoulution.

PRESIDENT:

All right, Senator Smith has moved the adoption of Senate Resolution 900. Any further discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Top of page 7, 929, Senator Lechowicz. On the Order of Secretary's Desk Resolutions, Senate Resolution 929. All right, Ar. Secretary.

Amendment No. 1 offered by the Executive Committee.

PRESIDENT:

Senator Lechowicz on Committee Amendment No. 1.
SENATOR LECHOWICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Committee Amendment No. 1 stipulates that the audit shall be a compliance audit and limits the scope of the audit to only those funds appropriated to the Department of Transportation, Commerce and Community Affairs and Revenue, deletes the requirement that the Auditor General investigate such funds, requires the audit to be submitted by April 1st, 1987 rather than December 1st, 1986. I move for its adoption.

PRESIDENT:

SECRETARY:

Senator Lechowicz has moved the adoption of Committee Amendment No. 1 to Senate Resolution 929. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments? SECRETARY:

No further amendments.

PRESIDENT:

All right, we'll have some intervening business, Senator Lechowicz, and get right back to you. Senate Resolution 939, Senator Luft. Senate Resolution 974, Senator Joyce. On the Order of Secretary's Resolution...Secretary's Desk Resolutions, Senate Resolution 974, Mr. Secretary.

SECRETARY:

No...no committee amendments.

PRESIDENT:

Senator Joyce.

SENATOR JEREMIAH JOYCE:

Thank you, Mr. President and members of the Senate. Senate Resolution 974 would send a clear message to those who would seek to impose a city income tax in the City of Chicago upon those who earn a wage or a living in the City of Chicago, the people who reside in the suburbs and the people who reside in the city. As I explained in the Executive Committee where there were no dissenting votes, this is the wrong tax, this is the wrong time, this is the wrong place; and to come at this time and say to the people who are considering locating businesses in the City of Chicago, people who are considering locating in the City of Chicago that they are going to be hit with another tax at some future date, I think, is bad mistake and I would ask that this Body adopt Senate Resolution 974 and deliver a very clear message.

All right. Senator Joyce has moved the adoption of Senate Resolution 974. Discussion? Senator Kelly.

Yes, Mr. President, I'd like to get leave to be added as a hyphenated sponsor on Senate Resolution 974.

All right, the gentleman seeks leave to be added as a hyphenated cosponsor. Is leave granted? Leave is granted. Further discussion? Senator Netsch.

SENATOR NETSCH:

SENATOR KELLY:

PRESIDENT:

I•••will the sponsor yield for one question, please?
PRESIDENT:

Sponsor indicates he*11 yield, Senator Netsch.
SENATOR NETSCH:

...I...I assume...I don't have a copy of the resolution

in front of me and I just want to make sure that in the ending provision where it usually says and that a suitable copy be sent to thus and so that it say "and a suitable copy be sent to the members of the Illinois Senate and the Illinois House," because it is only by authority of the Illinois General Assembly that the city or...or any other city can impose an income tax. So, I'm not quite clear why we are passing a resolution telling ourselves that we ought not to do something that only we can do in the first place. So, we do ask that a...a copy be sent to ourselves, right?

Senator Joyce.

SENATOR JEREMIAH JOYCE:

Well, that's the whole purpose of the resolution. The whole purpose of this resolution, Senator Netsch, is to give those...to tell those people who are suggesting that they are going to come here in six months and seek a city income that they are not going to get it. We are going on record saying we will not do that. So, those business people who are thinking of locating in Chicago, those...those people are...are...are looking at the economic situations in the City of Chicago will know that they can locate their business in Chicago, that they will not get socked with a tax; those people who are considering relocating out of the City of Chicago because of the present economic situation, because of statements such as...are coming forth from the city council and from the mayor's office that they are going to be socked with another tax, they will understand that we are on record we are not going to authorize the City of Chicago to impose a city income tax. That's what the resolution says. I clearly understand that the city cannot do it without our approval. PRESIDENT:

Further discussion? Senator Netsch.

SENATOR NETSCH:

Yeah, I...I don't think we ought to do it right now either, as a matter of fact, so I'm not arguing the merits of it. I just am not quite sure what we accomplish by doing this because at the same moment that we can adopt a resolution saying, gee whiz, we oughtn't to do this, we could change...that is any time the Legislature changed its mind, like next year or the year after or any other time, it could simply do it. I mean, the resolution...doesn't bind us and I'm not...sure that we really have accomplished anything other than to say, you know, go away and don't bother us this year. That...that is not a question, by the way.

I understand. Further discussion? Senator Lemke.

SENATOR COLLINS:

Yeah...let me...let me for real...for clarity of this resolution and I have the same basic concerns, I'm trying to find out what the sponsor is...what are we doing? You know, are we just going through the formalities here...some formalities, because there's no way that you can tell me, as a citizen and as an elected representative, that I cannot come here at any time and introduce some legislation calling for the authorization of an income tax in the City of Chicago or any other city in this State. You just can't do that with a resolution. So I don't know what you're doing.

PRESIDENT:

Further discussion? Senator Dudycz.

SENATOR DUDYCZ:

(Machine cutoff)...you, Mr. President. I ask leave to be added as a cosponsor of this resolution.

PRESIDENT:

The gentleman seeks leave to be added as a cosponsor of Senate Resolution 974. Without objection, leave is granted. Senator Geo-Karis.

SENATOR GEO-KARIS:

Well, Mr. President and Ladies and Gentlemen of the

Senate, people are getting tired of being taxed to death. I think this is a very worthwhile resolution and I think it's a very necessary resolution, and I'd like to see...in fact, I'm going to sponsor a resolution saying that no local government will be able to have an income tax, and I don't know how...far I'll get with it...if I can't do it by resolution, I'll do it by bill. I think it's a good resolution and I speak in favor of it.

PRESIDENT:

Well,...Senator Collins, for what purpose do you arise?

You cut me off and...

PRESIDENT:

I did not cut you off; you said, I don't understand what you're doing. I didn't take that to be a question.

SENATOR COLLINS:

•••but he didn*t answer my•••he didn*t my question•

PRESIDENT:

That is not the...the Chair's definition of a question. Senator Topinka.

SENATOR TOPINKA:

Yes, just a question of the sponsor, please.

PRESIDENT:

Question...or the sponsor...

SENATOR TOPINKA:

Yes, does this also affect suburban Cook County? PRESIDENT:

Senator Joyce.

SENATOR JEREMIAH JOYCE:

Well, it certainly does. The proposed...the...the proposal that...that comes from the mayor would tax anyone who is making a living or earning an income in the City of Chicago.

PRESIDENT:

Senator Topinka.

SENATOR TOPINKA:

Yes, Mr. President, it's an outstanding idea. Can...may
I have leave to be added as a cosponsor, please?
PRESIDENT:

The lady seeks leave to be added as a cosponsor as does Senator Geo-Karis. Without objection, leave is granted. Senator Jones.

SENATOR JONES:

Thank you, Mr. President...will the sponsor yield?

PRESIDENT:

Indicates he'll yield, Senator Jones.

SENATOR JONES:

•••Senator Joyce, does this resolution preclude the Village of Arlington Heights from imposing a local tax?

PRESIDENT:

Senator Joyce.

SENATOR JEREMIAH JOYCE:

No, but if you would like to prepare an amendment that would encompass that notion, I'd certainly support it.

PRESIDENT:

Senator Jones.

SENATOR JONES:

Does this resolution preclude the Village of...or the town...City of Springfield or City of Peoria or City of East St. Louis from imposing an income tax?

PRESIDENT:

Senator Joyce.

SENATOR JEREMIAH JOYCE:

I'm not aware of the mayors of those cities...proposing city income taxes. If they are...you know, and...someone wants to put an amendment on which would deal with that, I would not have any objection, Senator Jones.

PRESIDENT:

Senator Jones.

SENATOR JONES:

Well, could you read to the Body the resolve clause of the resolution?

PRESIDENT:

PRESIDENT:

Senator Jones.

SENATOR JONES:

Could you read...I don't know what the resolve clause of the resolution says, could you read that?

Senator Joyce.

SENATOR JEREMIAH JOYCE:

Well,...maybe the Secretary could read it to you, Senator Jones.

PRESIDENT:

Mr. Secretary, if you please.

SECRETARY:

(Secretary reads SR 974)

PRESIDENT:

Senator Jones.

SENATOR JONES:

Well, you know, I...I notice many persons across the...across the aisle and to all parts of the...the State jumped on...on the resolution, you know, they all jumped on the City of Chicago, but I noticed that the resolution doesn't preclude their...local units of...government from increasing where they would tax if they so desire. So this...it's a self-serving resolution, and I don't think that we...we, the members of the General Assembly, should be telling local units of government that if they need to raise revenue, then they must get the revenue. It's very self-serving, it should be defeated.

PRESIDENT:

Further discussion? Senator Lechowicz.
SENATOR LECHOWICZ:

Thank you, Hr. President and Ladies and Gentlemen of the Basically, when this matter was heard before our Senate. committee. I asked at that time to be listed as a chief cosponsor; and the reason for ... or I believe the importance of it is that the City of Chicago and its administration has proposed the idea twice now of imposing a city income tax much to the chagrin of not only to the business community but also to the people who work in the City of Chicago from all areas of the northeastern section of the State of Illinois. The mayor of Springfield nor the mayor of Arlington Heights, Rollington Park or any other mayor, to my knowledge, has not proposed a city income tax. That issue has been proposed and discussed in the City of Chicago. That was the reason of genesis of this Senate resolution, that's why at that time, I asked to be listed as a chief cosponsor because the magnitude and the impact affects not only Chicago but the surrounding residents of the...of that section of the State and the business community, and I think that this resolution should be adopted overwhelmingly. Thank you.

PRESIDENT:

Further discussion? Is there any further discussion? Senator Joyce, you wish to close?

SENATOR JEREMIAH JOYCE:

Very...very briefly. You know, this proposal does impact my community, it impacts the City of Chicago. It does have...some effect, it tells those people up in Chicago to try to find some other revenue sources. If revenue is needed, find some other revenue sources. We do have a responsibility, Senator Jones, because we have the authorization of...to...to allow this or to permit this income tax. I ask the adoption of 974.

PRESIDENT:

All right. The question is, the adoption of Senate Resolution 974. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 47 Ayes, 5 Nays, none voting Present. Senate Resolution 974 having received the required constitutional majority is declared passed. On the Order of Secretary's Desk Resolutions, Senate Resolution 929. 929, Mr. Secretary.

SECRETARY:

Senate Resolution 929 with...with...Committee Amendment
No. 1.

PRESIDENT:

Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Resolution 929 asks for a compliance audit in three areas for the City of Chicago; money that is received from the Department of Transportation, money that is received of Revenue Department and Community Affairs...Commerce and Community Affairs. Basically, as it was pointed out in committee, there was a compliance audit that's required of every other municipality in this State. The magnitude of the City of Chicago, they have one person assigned to do a compliance audit supposedly on all this money coming into the City of Chicago. Such financial audits are not intended necessarily to demonstrate compliance with State grants and they should. Grant reporting compliance with State requirements is generally audited at the discretion of the State granting agency and to the extent deemed appropriate by the agency. That's the fact of life when the City of Chicago and the Finance Committee hired Coopers and Liebrand, they hired them for the specific purpose of trying to get additional bonding authority for...from the New York bonders. Unfortunately, a compliance audit, as you and I know it, has not been conducted in the City of Chicago over the past twenty years. This situation is long overdue and that's the...purpose of 929. I strongly recommend that this Body adopt and vote on...behalf of 929.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? All right. The question is, shall the Senate adopt Senate Resolution 929. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, I voting Present. Senate Resolution 929 is adopted. 939, Senator Luft. Senate Resolution...o,...978, Senator Jerome Joyce. Senate Resolutions 978. Senator Joyce.

SENATOR JEROME JOYCE:

Yes, thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

No wait a minute...I beg your pardon. We'd better read...978.

SECRETARY:

•••Senate Resolution 978•••and no committee amendments•

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Joyce.

SENATOR JEROME JOYCE:

All right, thank you, Mr. President. Last year, we...we passed Senate Bill 1021 which...required the Commerce Commission to study the...implementation of promotional rates used by a public utility for its industrial and commercial customers. What this resolution does is call on the ICC to include in its study of promotional rates the possibility of removing the minimum take required to qualify so that such rates will be available to a greater number of small businesses. What this does is just lower the amount of kilowatt

hours they have to use to...for an incentive for small businesses to locate. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Resolution...Senator Donahue.

SENATOR DONAHUE:

Well, thank you, Mr. President. I would just like to rise in...in support of this resolution. I think the study would...would be an...excellent opportunity to help small business in Illinois.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, Senator Joyce moves the adoption of Senate Resolution 978. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 978 is adopted. Senate Resolution 1009. Mr. Secretary.

SECRETARY:

Senate Resolution 1009 with...Executive Committee offers one amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Committee Amendment No. 1, the adoption of which I will move, changes the numbers to reflect the fact that the lottery is now in excess of one billion dollars annual, it's 1.3 billion their estimate is, and it made a couple of other word changes in the text after consultation with the lottery officials. I know of no objection, I would move the adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Rock moves the adoption of Committee

Amendment No. 1 to Senate Resolution 1009. Those in favor

indicate by saying Aye. Opposed Nay. The Ayes have it.

Committee Amendment No. 1 is adopted. Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Resolution...I'm sorry, amendments from the Floor?

SECRETARY:

No...no further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

•••We'll come right back to it with some intervening business. Senator...Senate Resolution 1045, Senator Rock. 1046, Senator Lechowicz. Senate Resolution 1046, Nr. Secretary.

SECRETARY:

With...no amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All 'right, Senator Lechowicz.

SENATOR LECHONICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Resolution 1046 urges President George Dunn and the County Board of Commissioners, Richard J. Daley and the State's Attorney's Office of Cook County and Judge Harry Comerford, the Circuit Court of the 1st District of the State of Illinois to study and report a night court to be estaolished in Cook County for cases involving acts of vandalism by juvenile offenders. This is an area that's been discussed quite candidly and openly in the northwest section of the City of Chicago and the southwest section, and both communities have strongly recommended an urge that a juvenile night court be established who's tried to...stop the act of vandalism and juvenile delinquency that's unfortunately occurring in those communities. That's the purpose of 1046. I know of no objection, came out of committee 17 to nothing and I think it merits your support.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Dudycz.

SENATOR DUDYCZ:

•••thank you, Are President. I ask leave to be added as a cosponsor of Senate...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Dudycz seeks leave of the Body to be added as a cosponsor. Is leave granted? Leave is granted. Further discussion? Senator Lechowicz moves...Senator DeAngelis.

SENATOR DEANGELIS:

Question of the sponsor, please.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator DeAngelis.

SENATOR DEANGELIS:

When do this...is there any reporting requirement...back to us on...on this, Senator Lechowicz?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

No, sir, just urging them to establish this court in Cook County. \cdot

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DEANGELIS:

Well, okay, I thought if it took it after November, you might want to include Joe Matthewson's name under...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

Maybe ten years from now that may be possible but not in 1986.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Lechowicz has moved the adoption of Senate Resolution 1046. Those in favor indicate

by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 1046 is adopted. All right, with leave of the Body, we'll return to Senate Resolution 1009. Senator Rock.

SENATOR ROCK:

Thank you. Mr. President and Ladies and Gentlemen of the Senate. I would also ask leave of those members who have asked me to...for leave to be cosponsors, Senators Jones and Smith. This is a resolution concerning itself with the State lottery. And specifically what we are asking the Economic and Fiscal Commission to determine and to report back to us is the impact of the lottery on the poor and the working poor. There were some allegations that the poor who purchase tickets are not aware really of what impact there will be in the event that they win with respect to their general assistance or public assistance and food stamps and other benefits. There was some concern about the advertising and marketing with respect to the lottery. There is some concern about future practice. I have met with the lottery officials, I have met with the ... director of the Department of Public Aid, all of whom, I might say, are willing to cooperate and provide the information necessary so that this General Assembly will have a thorough study of the advertising and marketing practices, the practices and policies of other states that have lotteries so that we can get a pretty good overview of what happens and, hopefully, put a lot of these concerns and...and worries to rest. We've asked the Economic and Fiscal to do it expressing that we expect the full cooperation of the State lottery and the Department of Public Aid and all departments of...of State Government. I don't think there is any objection to this. He've asked that the report be submitted to the Assembly by December 1,...1986, and I would seek a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Kelly.

SENATOR KELLY:

Mr. President, I'd like to get leave to be added as a co-

PRESIDING OFFICER: (SENATOR DEMUZIO)

You've heard the request of Senator Kelly to be added as a cosponsor. Is leave granted? Leave is granted. Further discussion? Senator Dunn.

SENATOR DUNN:

Thank you, Mr. President. I, too, would like to be added as a cosponsor, if...if I could.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Dunn to be added as a cosponsor of Senate Resolution 1009. Senator Collins has made a similar request. Senator Poshard, Senator Smith and if you will just give the Secretary your name down here, he will automatically just add it to you. With leave granted...and Senator Netsch. We will...

SENATOR NETSCH:

Yeah, thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

•••just a moment, we•••those individuals that I°ve just read into the record will be afforded the opportunity to be cosponsors. Senator Netsch, on this question.

SENATOR NETSCH:

Thank you. I just wanted to make a point for the record. I'm strongly in support of the objective of this study and, as I indicated to Senator Rock in the committee and subsequently. I hope that...I know that he has now requested that we have the full cooperation of the lottery and the Department of Public Aid which the Economic and Fiscal Commission, which I cochair, will certainly need. There are still some parts of the study that are going to be a little bit difficult for us to do in terms of our resources and I hope that everyone will be reasonably patient and understanding about

that, but we will do our very best to produce the information that is requested because I think we all agree that it is very important information. It's just that some of it is a little hard to come by and we may need a little extra help from other parts of State Government.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, Senator Rock has moved the adoption of Senate Resolution 1009. Those in favor will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 54, the Nays are none, none voting Present. Senate Resolution 1009 having received the...the required majority vote is declared passed. Senate Resolution 1004, Senator Lechowicz. I'm sorry, Senate Resolution 1047.

SECRETARY:

•••Senate Resolution 1047, no committee amendments.

SENATOR LECHONICZ:

Thank you, Ar. President, Ladies and Gentlemen of Senate Resolution 1047 is the recommendation that Senate. was given to us by the Auditor General the early part of this month when he gave us a summary and report Digest on the feasibility study of the State toxology laboratory. In that summary of a very detailed report, the recommendation...that's contained in 1047 was contained on page 8, and it's asking...the Auditor General requested that in order to really complete the first overview, it would be necessary to conduct a program and management audit of all the State's laboratory services. That was the recommendation and the report we all received. I thought it was an excellent idea. It came out of committee 17 to nothing and I move for its concurrence...adoption.

PRESIDENT:

Senator Lechowicz has moved the adoption of Senate Reso-

lution 1047. Any discussion? If not, those in favor of the adoption will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 Ayes, no Nays, none voting Present. Senate Resolution 1047 having received the required constitutional majority is declared adopted. If I can have your attention, Representative Panayotovich has...accompanied by a very special guest that I would like the opportunity to introduce. Sam, will you...it is my pleasure to introduce to you the Consul General of Yugoslavia who is visiting the General Assembly today, Hr. Bahrudin Bijedic.

MR. BAHRUDIN BIJEDIC:

(Remarks by Mr. Bijedic)

PRESIDENT:

House Joint Resolution 104, Senator Luft. HJR 183, Senator DeAngelis. HJR 184, Senator D*Arco. HJR 189, Senator Karpiel. You got to pay attention in this business, Aldo. HJR 189, Senator Karpiel. On the Order of Secretary*s Desk Resolutions, House Joint Resolution 189, Mr. Secretary.

SECRETARY:

House Joint Resolution...189 with no amendments.

PRESIDENT:

Senator Karpiel.

SENATOR KARPIEL:

Thank you, Mr. President. House Joint Resolution 189 petitions the President and the Congress of the United States not to limit the eligibility of the nation's veterans to VA health care benefits and to provide adequate funding to the Veterans' Administration to enable it to continue to offer state of the art medical care to those veterans who are eligible for and need and apply for such care, and I ask for your support.

PRESIDENT:

Any discussion? There any discussion? If not, Senator Karpiel has moved the adoption of House Joint Resolution 189. All in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Senator Poshard on 197. On the Order of Secretary's Desk...Resolutions is House Joint Resolution 197. Mr. Secretary.

SECRETARY:

With no committee amendments.

PRESIDENT:

Senator Poshard.

SENATOR POSHARD:

Yes, thank you, Mr. President and Ladies and Gentlemen of the Senate. House Joint Resolution 197 urges the Governor and the Illinois congressional delegation to oppose Congressional House Resolution 4567 which would impose severe nomic hardships on the coal production of the State of Illinois. The U.S. House of Representatives is currently considering House Resolution 4567 which attempts to solve the acid problem. This could cut Illinois coal production by up to two-thirds of the 1985 production levels, costing the State about four thousand mining jobs and could cause a six hundred million dollar loss to the State's economy. Illinois in the past few years has significantly reduced air pollution from coal at a cost of hundreds of millions of dollars to electric utility customers, and the State of Illinois has invested over fifty million dollars in research and development projects designed to reduce this kind of pollution. He think this is the path to go down to develop new clean coal technology so that we do reduce whatever sulfur content escapes into the air. The Governor has made a trip to Washington in regard to this task already, and we would urge you to support this resolution.

PRESIDENT:

Any discussion? Is there any discussion? If not, the

question is the adoption of House Joint Resolution 197.
Those in favor indicate by saying Aye. All opposed. The
Ayes have it. The resolution is adopted. Senator DeAngelis,
183. On the Order of Secretary's Desk Resolutions, House
Joint Resolution 183, Mr. Secretary.

SECRETARY:

•••House Joint Resolution 183 and no committee amendments•

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

Thank you, Mr. President. House Joint Resolution 183 urges the House and the Senate to oppose...the U.S. House and Senate to oppose the contracting out of positions such as guards, elevator operators, messengers and custodians which are restricted to veterans, preference eligibles in Federal agencies.

PRESIDENT:

Senator DeAngelis has moved the adoption of House Joint Resolution 183. Discussion? Senator Netsch.

SENATOR NETSCH:

Thank you. A question to the sponsor.

PRESIDENT:

Indicates he'll yield, Senator Netsch.
SENATOR NETSCH:

I have the...the strange feeling, Senator DeAngelis, that the...your resolution really flies in the face of what I thought was one of your major commitments and, that is, to the privitization of government services because this would, in effect, say that the United States Government should not do that which you have been a strong advocate in this General Assembly. Could you just explain that to me?

Senator DeAngelis.

PRESIDENT:

SENATOR DEANGELIS:

I intend to vote No.

PRESIDENT:

Senator Netsch.

SENATOR NETSCH:

That explains it.

PRESIDENT:

All right. Senator DeAngelis has moved the adoption of House Joint Resolution 183. Any further discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Top of page 8,...(machine cutoff)...Joint Resolution 150, Senator Watson. Mr. Secretary, on the Order of Secretary's Desk Resolutions is Senate Joint Resolution 1-5-0.

SECRETARY:

Senate Joint Resolution 150 with no committee amendments. PRESIDENT:

All right, Senators Watson and Poshard. Senator Watson.
SENATOR WATSON:

SECRETARY:

PRESIDENT:

SENATOR JONES:

I talked to the minority spokesperson and the chairman of the committee and the minority leader as it relate to this motion, and the bill was voted on, not based on the resolution but on...a procedural matter and I was not there at the time, so I ask for a...a favorable consideration of this motion.

SENATOR JONES:

PRESIDENT:

Yes, thank you, Mr. President. I...I do have an amendment...one amendment to the resolution and what the amendment does is allow the superintendent of education to appoint a designee for the committee to make other...make other nonsubstantive changes. I move for the adoption of the amendment.

PRESIDENT:

Senator Jones has moved the adoption of Amendment No. 1 to Senate Joint Resolution 166. All in favor of the...any discussion? Senator Barkhausen on Amendment No. 1. All in favor of the adoption of the amendment indicate by saying Aye. All opposed. The Ayes have it...Amendment No. 1 is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDENT:

Senator Jones on Senate Joint Resolution 166. He'll give them just a minute to look at the amendment; in the meantime, we'll go back, with leave of the Body, to Senate Joint Resolution 155. Senator Woodyard has rejoined us.

SENATOR WOODYARD:

SENATOR JONES:

PRESIDENT:
