SENATOR VADALABENE:

Thank you, Mr. President and members of the Senate. SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. (Machine cutoff)...get some more Pages down here to pass out the supplemental Calendar, we might be able to proceed. When the Pages finish passing out Supplemental Calendar No. 1, we will start at the top and go straight down. Senator Carroll will be the first...the first Conference Committee report. Senator Carroll on the Floor? All right. All right....Supplemental Calendar No. 1, we'll start on the Conference Committee reports. Senator Carroll on the Floor? All right, with leave of the Body, we'll come back to 2688. Leave granted? Leave is granted. On the Order of Conference Committee Reports is House Bill 2986, Ar. Secretary.

SECRETARY:

House Bill 2986 first Conference Committee report with...on House...Senate Amendments 1 and 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Channel 20 has requested permission to tape the proceedings. Is leave granted? Leave is granted. Senator Leitch. No? Senator Sommer.

SENATOR SOMMER:

Begging your pardon, Mr. President, would it be possible to hold...just for a few minutes till we get all our paper out here on the Floor for our members? It won't take very long.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer, just on...on this bill or on the entire...on the entire Calendar, all right. Well, with leave of the Body, let's just...take it out of the record. Senator Sommer. All right. All right, Supplemental Calendar No. 1, Conference Committee reports is House Bill 2688, Mr. Secretary.

SECRETARY:

First Conference Committee report on House Bill 2688.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Well, thank you, Mr. President and Ladies and Gentlemen of the Senate. First Conference Committee report on Senate...on House Bill 2688 would reinstore the statutory amount necessary for the funding of McCormick Place, the debt service appropriation et al, and I would move adoption of Conference Committee Report No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator DeAngelis.

SENATOR DEANGELIS:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

I said it fast enough where you wouldn't have probably caught it if you weren't walking around. This is the statutory appropriation for McCormick Place including the debt service on the bond issue and the 4.8 as required.

PRESIDING OFFICER: (SENATOR DEBUZIO)

Further discussion? If not, the question is, shall the Senate adopt the first Conference Committee report on House Bill 2688. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 34, the Nays are 16, 4 voting Present. The Senate does adopt the first Conference Committee report on House Bill 2688 and the bill having...received the required constitutional majority is declared passed. House Bill 2986, Senator Leitch. You ready? All right. House Bill 2986, Mr. Secretary.

SECRETARY:

First Conference Committee report on House Bill 2986.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Leitch.

SENATOR LEITCH:

Thank you, Mr. President. This is the ordinary appropriation for the Illinois Farm Development Authority and it also includes the agreement for the Exxon oil overcharge settlement expenditure and I'd move for its approval.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Discussion? Senator Sommer.

SENATOR SOMMER:

Mr. President, you'll note that the Conference Committee report does not include the Senate Republican signatures, that's because we asked that the Governor's Office review this report and determine whether it correlated with the agreement they made. It does, but in the meantime, the thing went to the printers and we simply were unable to sign. We do agree with it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, the question is, shall the Senate adopt the first Conference Committee report on House Bill 2986. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are none, 1 voting Present. The Senate does adopt the first Conference Committee report on...on House Bill 2986 and the bill having received the required constitutional majority is declared passed. House Bill 2988, Mr. Secretary.

SECRETARY:

First Conference Committee report on House Bill 2988.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is the ordinary and contingent expenses of the Department of Conservation and it is at the level of one hundred and twenty—one million five hundred and eighty—eight thousand four hundred dollars, and I would move the Senate adopt the first Conference Committee report.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Lechowicz.

SENATOR LECHOMICZ:

Thank you, Mr. President. I have a...will the sponsor yield to a question?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates she will. Senator Lechowicz

SENATOR LECHOWICZ:

I notice in the Conference Committee report you've provided seventy-five thousand dollars for renovating the Gaylord Building in Lockport under House Bill 2988. Also in Senate Bill 1752, which we haven't addressed yet, we have a hundred and fifty-two thousand seven hundred and forty-seven dollars out of GRF for operating the Gaylord Art Gallery at the Gaylord Building in Lockport. Is that building presently owned by the Department of Conservation?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Thank you, Mr. President. I would ask if Senator Sangmeister could respond to your questions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sangmeister.

SENATOR SANGMEISTER:

My understanding is, I'm not sure, Senator Lechowicz, whether it is right now, but it...it's owned by a not-for-profit corporation if it isn't. Okay? And I think their

intent is to transfer that building to the Department of Conservation or to that...what's that other, Historic Site Preservation Council? One or the other it's going to go to, that was what I was told.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Lechowicz.

SENATOR LECHOWICZ:

That answers one question. My second question is the one million dollars added to the 1.4 million appropriation for the Illinois Conservation Corps, does that mean that we're going to give them 2.4 million dollars then for the Illinois Conservation Corps and to what area does the corps address itself to?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

•••Senator Carroll, are you wanting to respond to that?

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Donahue yields to Senator Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Yes, that's part of the teen program we had established as the Senate initiative and that is, in fact, a million added for teen gang crime prevention, et cetera, et cetera, et cetera,

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

SENATOR LECHOWICZ:

This money is for the Illinois Conservation Corps. Now, I know the one that I'm familiar with is...covers the...the southern Illinois counties and that was for the hiring of people during the summer in the State parks, and I'm just wondering if...either the analysis is wrong or the explana-

tion is wrong, one of the two.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

If he can hold a second, I'll try and get him the exact reference.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Both items are correct, Senator Lechowicz. It is, in fact, the conservation corps and it is part of the teens in trouble initiative of the Senate Democratic Caucus and was put on in the House, but it does go, in fact, to the conservation corps for teens-in-trouble hirings.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Darrow.

SENATOR DARROW:

Will the sponsor yield?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates she will yield. Senator Darrow.

SENATOR DARROW:

Are all the funds appropriated out of general revenue?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Could you repeat that? I'm sorry.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator Darrow.

SENATOR DARROW:

Are the funds for these projects from the General Revenue Fund?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Not totally, no, sir.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

Is the five million dollars for the Shed Aquarium in Chicago general revenue funds?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue. Senator Donahue.

SENATOR DONAHUE:

Capital development funds, Senator Darrow.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Darrow.

SENATOR DARROW:

Has the Governor signed off on this?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

I...don't speak for him. I don't know. Senator Carroll is holding his hands up.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

I've been accused of speaking for him on occasion on this Senate Floor of late. In this case I believe I can, it was in his budget. So that, therefore, I would assume that he has signed off on it since he introduced it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, the question is, shall the Senate adopt the first Conference Committee report on House Bill 2988. Those in favor will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 55, the Nays are none, none voting Present. The Senate does adopt the first Conference

Committee report on House Bill 2988 and the bill having received the required constitutional majority is declared passed. House Bill 2991, Mr. Secretary.

SECRETARY:

House Bill...Conference...first Conference Committee report on House Bill 2991.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, this is the annual budget for the Historical Preservation Department. It has twelve million two hundred and forty-three thousand two hundred and ninety-one dollars. I'd appreciate a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Lechowicz.

SENATOR LECHOWICZ:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President. The two staff people at Jubilee College in Peoria County...the two staff people in Peoria College, Jubilee County, do we normally do that for any other college in this State...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...

SENATOR LECHOWICZ:

•••so we can keep the facility open seven days a week?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson.

SENATOR DAVIDSON:

It's not a college, Senator Lechowicz, this is a historical site that goes back to 1800's. It's been given to the Department of Conservation and in the split between Conservation and Historical Preservation Department, the Jubilee College was put in under the historical part. It was also...was in that same transfer was to be open seven days a week, and this is for two staff people so it can be open seven days a week. It is not an operating college whatsoever.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Keats.

SENATOR KEATS:

Just a...a question of the sponsor. On the Illinois Humanities Council, who are they and what do they do and why are we paying them with State funds to do something?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson.

SENATOR DAVIDSON:

Well, the Illinois Humanities Council is a council created by the act of legislation and it has to do with encouraging those individuals who have ability...in the artistic fields to be encouraged to develop and develop more artists and artistic individuals from the State of Illinois.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, the question is, shall the Senate adopt the first Conference Committee report on House Bill 2991. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are 2, none voting Present. House Bill 2991 having received the required constitutional majority is declared passed. House Bill 3165, Mr. Secretary.

SECRETARY:

First Conference Committee report on House Bill 3165.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is, in fact, the supplemental appropriation. We added certain other supplemental appropriations to it, five hundred thousand for...as agreed for the Chicago Convention and Visitors Bureau FY '86 monies which we had pulled out of the bill originally as well as some other specific funds for the Industrial Commission so they can meet their payroll of a few weeks ago and a transfer in the Human Rights Commission so they can meet their payroll and five thousand dollars for the Department of Corrections to correct an error of omission in their FY '86 budget. I would move adoption of Conference Committee Report No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Fawell.

SENATOR FAWELL:

Thank you, very much. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Fawell.

SENATOR FAWELL:

When we add this five hundred thousand dollars to the Tourism Promotion Fund, how much will that give them altogether now, do you know?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Senator Fawell, to my recall, that is their appropriation in total for FY *86. This is the supplemental for *86 that we had deleted from the bill earlier in the process and are now putting back. It's my recall, and I will check it, that this is the total of their appropriation for FY *86.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Fawell.

SENATOR FAWELL:

And does that come out of the General Revenue Fund or is that part of the...the tax or is that...is the tax...hotel tax additional money?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

That's the Tourism Promotion Fund funded by the hotel/motel tax.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Watson. Senator Keats.
SENATOR KEATS:

Question of the sponsor or ... maybe in this case Senator Carroll. Now the...Chicago Convention and Tourism Bureau, is it true the reason they're out of money is 'cause they've got so many guys on the payroll that they re no longer meeting the obligations that we gave them the money for? When we set up that fund....when we set up that Tourism/Convention Fund...convention...and that money to go there, the money came from hotel tax and it was agreed the money would be used for tourism enhancement. I think anyone who's ever read a newspaper would be well aware that the...and, Senator Carroll, you could probably give me the percentage...it's like fifty or seventy percent of the money now goes simply to pad payrolls of people who have nothing whatsoever to do with bringing in convention. Have I hit the wrong budget on that or...I'm just knee-jerking on the wrong budget then. Okay? But let me know when we get to the one where we're padding a payroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

•••Senator Carroll, you wish to close? Senator Carroll.

SENATOR CARROLL:

Yes, Senator Keats, you just voted for all those that the

Governor put in where you're padding the payroll. In this case, I believe we have solved that problem by putting the money where the legislature had intented it to be and that is the Convention and Tourism Bureau...Chicago Convention and Tourism Operation as opposed to the one that was getting the funds. That was not the one where the people were going out and getting conventions and tourism and so on. There were two competing groups. This is the correct one that I think you would want it to go to.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The question is, shall the Senate adopt the first Conference Committee report on House Bill 3165. Those in favor will...will vote Aye. Those opposed Nay. The...the voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are 3, none voting Present. The Senate does adopt the first Conference Committee report on House Bill 3165 and the bill having received the required constitutional majority is declared passed. House Bill 3257, Hr. Secretary.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is the ordinary and contingent expenses of the operations of the court system including the Supreme Court. This went to conference in order to make some corrections to the...what we thought had been an agreed amendment and we had created some problems in some of the different little division offices, then that impact of this add to the hundred and forty-two million dollar budget is two hundred seventy-four thousand. House Bill 1945 with Senate Amendments 1, 2 and 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DEANGELIS:

Thank you, Ar. President. I move that the Senate does not concur...does not recede from Senate Amendments No. 1, 2 and 3 and ask for a Committee on Conference.

House Bill 3162 with Senate Amendment No. 2.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate.

I refuse to recede and will ask for a Conference Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Vadalabene has moved that the Senate refuse to recede from the adoption of...Senate Amendment 2 to House Bill 3162 and that a Conference Committee be appointed.
