PRESIDENT:

The hour of ten having arrived, the Senate will please come to order. Will the members be at their desks. Will our guests in the gallery please rise. Prayer this morning by Senator Kenneth Hall. Senator Hall.

SENATOR KENNETH HALL:

(Prayer given by Senator Hall)

PRESIDENT:

Thank you, Senator. Reading of the Journal. Senator Vadalabene.

SENATOR VADALABENE:

Thank you, Mr. President and members of the Senate. I move that reading and approval of the Journals of Wednesday, October 30th; Thursday, October 31st; Friday, November 1st; Monday, November 4th; Tuesday, November 5th; Wednesday, November 6th and Thursday, November 7th, in the year 1985, be postponed pending arrival of the printed Journals.

SECRETARY:

A Message from the House by Mr. O'Brien, Clerk.

Mr. President - I am directed to inform the Senate the House of Representatives adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution 123.

(Secretary reads HJR 123)

PRESIDENT:

All right. Senator Luft moves for the suspension of the rules for the immediate consideration and adoption of House Joint Resolution 123, which is the adjournment resolution calling for us to return to Springfield on Tuesday, at the hour of noon. I am happy to report that the leadership will meet with the Governor on Monday at noon, and we have asked the...conferees on the supplemental appropriation to meet at Monday at three o'clock with the hope that on Tuesday we can take final action. SECRETARY:

PRESIDENT:

Without objection, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolutions are adopted. Any further business to come before the Senate? Any announcements? SENATOR SCHAFFER:

Mr. President, somehow it seems appropriate that the last thing we should do this week is my requesting a Republican Caucus immediately in Senator Philip's office. All right.
