#### PRESIDENT:

All right, Senator Netsch seeks leave of the Body to be added as a cosponsor on Senate Bills 130 and 216, asked that Senator Welch be shown as the hyphenated sponsor on Senate Bill 172 and 216, and that Senator Jerome Joyce be shown as the cosponsor on 130, 172 and 216 and that Senator Rock be added as a cosponsor on 205. Hithout objection, leave is granted. Senator Raica, for what purpose do you arise?

Mr. President, I request leave of the Senate at this time to be removed from Senate Bill 199 as a joint sponsor. I had no idea the bill was introduced and that I was sponsoring that bill.

#### SENATOR MAHAR:

Mr. President, I seek leave of the Body to discharge the Committee on Labor and Commerce of Senate Bill 199 for the purpose of Tabling.
