PRESIDENT:

The Senate will please come to order. Will the members be at their desks and will our guests in the gallery please rise. Prayer this afternoon by the...Reverend Robert Erickson, Griffin High School, Springfield, Illinois. Father.

REVEREND ROBERT ERICKSON:

(Prayer given by Reverend Erickson)

PRESIDENT:

Thank you, Father. Reading of the Journal.

ACTING SECRETARY: (MR. HARRY)

Reading of the Senate Journals for Tuesday, March 24th, 1987 and Wednesday, March the 25th, 1987.

PRESIDENT:

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I move that the Journals just read by the Secretary be approved unless some Senator has additions or corrections to offer. Mr...move that reading and approval of the Journals on Thursday, March 26th and Tuesday, March 31st, in the year 1987, be postponed pending arrival of the printed Journals.

PRESIDENT:

(Machine cutoff)...the motion as place by Senator Vadalabene. Any discussion? If not, all in favor indicate by saying Aye...I beg your pardon, Senator Hawkinson, for what purpose do you arise?

SENATOR HAWKINSON:

Thank you, Mr. President. On a point of personal privilege.

PRESIDENT:

Yes, sir.

SENATOR HAWKINSON:

I was absent on March 24 and for some reason the Journal

for that date reflects that I voted Present on Senate Joint Resolution No. 17, and I would like the record to reflect that I was absent on that occasion.

PRESIDENT:

With that correction, the record will so reflect...any other corrections or additions? All right, if not, you've heard the motion again as placed by Senator Vadalabene. If there's no further discussion, all in favor indicate...saying Aye. All opposed. The Ayes have it. The motion carries and it's so ordered. Senator Keats, for what purpose do you arise?

SENATOR KEATS:

Thank you, Mr. President. With the leave of the Senate, a group of us who are going to be cosponsoring a piece of legislation, rather than ten of us stand up as individuals, on Senate Bill 1 we would like you to add as cosponsors myself, Senator Keats; Senator Woodyard, Senator Topinka, Senator Friedland, Senator Macdonald, Senator Maitland, Senator Donahue, Senator Rigney, Senator Dunn and Senator Madigan.

PRESIDENT:

All right, with leave of the Body, Senator Keats seeks leave to show himself and nine additional members of the Senate as cosponsors of Senate Bill 1. Senator Keats, if you'll be kind enough to provide that list to the Secretary that would be helpful. Without objection, leave is granted. Committee reports, Mr. Secretary.

PRESIDENT:

Will our guests in the gallery please rise and be recognized. Welcome to Springfield. Senator Raica, for what purpose do you arise, sir?

SENATOR RAICA:

Thank you, Mr...thank you, Mr. President. With permission, I would like to be added...with the permission of the chief sponsor, I'd like to be added as a cosponsor on Senate Bill 152, please.

PRESIDENT:

All right, the gentleman seeks leave of the Body to be added as a cosponsor on Senate Bill 152. Without objection, leave is granted. Senator Collins, for what purpose do you arise?

SENATOR COLLINS:

Yes, thank you, Mr. President. I move to...move that the committee...suspend further consideration of Senate Bill 477 from the Revenue Committee for the purpose of Tabling that bill. That bill is highly defective and I will be filing a new bill tomorrow morning.

PRESIDENT:

In the Revenue Committee at the moment?

SENATOR COLLINS:

Apparently so. It was just read out from...reported out

from the assignment of bill and it was assigned to the Revenue Committee, so it...I guess it's not in there yet.

PRESIDENT:

All right, Senator Collins seeks leave of the Body...and moves to discharge the Committee on Revenue from further consideration of Senate Bill 477 for the purpose of Tabling. All in favor of the motion to discharge indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Senate Bill 477 is discharged. Senator Collins now moves to Table Senate Bill 477. All in favor of the motion to Table Indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it is so ordered. Senator Karpel, for what purpose do you arise?

SENATOR KARPIEL:

Thank you, Mr. President. I would like leave of the Body to be added as a hyphenated cosponsor on Senate Bill 177 and also Senate Bill 74.

PRESIDENT:

I'm sorry, Senator Karpel, I missed the two numbers.

SENATOR KARPIEL:

Senate Bill 177 and...and Senate Bill 74.

PRESIDENT:

Okay. Senator Karpel seeks leave of the Body to be added as a cosponsor of Senate Bills 177 and Senate Bill 74. Without objection, leave is granted. Senator Geo-Karis, for what purpose do you again arise?

SENATOR GEO-KARIS:

Mr. President, with leave of the sponsor, I would like to be added as a cosponsor on Senate Bill 1. Thank you.

PRESIDENT:

All right, the lady seeks leave of the Body to be added as a cosponsor of Senate Bill 1. Without objection, leave is granted.

PRESIDING OFFICER: (SENATOR DEHUZIO)

Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Senator Jones.

SENATOR JONES:

Yes, thank you, Mr. President and members of the Senate...

PRESIDING OFFICER: (SENATOR DEMUZZIO)

Pardon me, Senator...

SENATOR JONES:

...first, I must have leave for immediate consideration of the resolution.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

All right, Senator...Senator Jones on...on Senate Joint Resolution 34 is asking leave of the Body to have that

considered now rather than going to committee. Senator Davidson, for what purpose do you arise?

SENATOR DAVIDSON:

Is the resolution congratulatory or something such to that order?

PRESIDING OFFICER: (SENATOR DEWUZIO)

It...it's my understanding that it simply extends the reporting date of the Sport's Commission or whatever it is. I...I don't know the proper name. Senator Maitland.

SENATOR MAITLAND:

No, on another...another issue.

PRESIDING OFFICER: (SENATOR DEWUZIO)

All right, Senator Jones has asked leave of the Body to consider...Senate Joint Resolution 34. Ask leave to suspend the rules for the immediate consideration. Is...is leave granted? Leave is granted. The rules are suspended. Senator Jones is now recognized on Senate Joint Resolution 34. Senator Jones.

SENATOR JONES:

SENATOR WATSON:

Thank you, Mr. President. We have a group of high school students here from my area from Belleville and from Collinsville, Fairview Heights, who are on the German-American Partnership Program and they are a...a group from West Germany, and I hope I get this correct, but it's from Gemeinde, Weyhe. How was that? Was that all right? From West Germany and I'd like to welcome them to Springfield.

PRESIDING OFFICER: (SENATOR DEHUZIO)

All right, if our guests in the gallery would please rise and be recognized by the Senate. Welcome to Springfield. Senator Maitland, for what purpose do you arise?

SENATOR MAITLAND:

Thank you, Mr. President. I, too, rise on a point of personal privilege. In the gallery on the...on the right side of...is the seventh grade grade school class from Trinity Lutheran Grade School in Bloomington, Illinois. I'd like them to rise and be recognized, please.

PRESIDING OFFICER: (SENATOR DEHUZIO)

If our guests will rise and please...be recognized by the Senate. And I'm sure that, Senator Maitland, at some point you will provide us with an explanation of what the right side is. Resolutions.

ACTING SECRETARY: (MR. HARRY)

Senate Resolution 35 offered by Senator Keats.

PRESIDING OFFICER: (SENATOR DEHUZIO)

Executive.

ACTING SECRETARY: (MR. HARRY)

Senate Resolution...Senate Joint Resolution 36 offered by Senator Degnan. It's congratulatory.

PRESIDING OFFICER: (SENATOR DEHUZIO)

Consent Calendar. All right, introduction of bills.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 537, by Senator Watson.

(Secretary reads title of bill)

1st reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Poshard, for what purpose do you arise?

SENATOR POSHARD:

Yes, Mr. President, I'd like to seek leave of the Body to be added as a hyphenated cosponsor on Senate Bill 21 and 22 and Senate Bill 398. I have permission of the sponsors.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Poshard has...seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 21, 22 and 398. Is there objection? No objection, leave is granted. It's so ordered. Senator Rock, for what purpose do you arise? Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Before we adjourn, and we will adjourn shortly until eleven o'clock tomorrow morning, Senator Philip and I met earlier today and in an attempt to accommodate the membership, we have made a....we have a recommended change in the schedule for next week. As I'm sure everyone is aware, April 10th...Friday, April 10th is the last day to introduce bills in both the House and the Senate. The House, I am told after meeting with the Speaker, will be in...literally be in perfunctory session for the purpose of introduction only. So, Senator Philip and I have discussed the...the change in our schedule and we are suggesting that we will meet on the ninth and the tenth, which is Thursday and Friday, and that those four committees that were scheduled to meet Wednesday and Thursday would now meet on Thursday. So that at ten o'clock in the morning the Committee on Transportation would meet as would the Committee on Energy, and at two o'clock in

the afternoon the Committee on Revenue and the Committee on Finance would meet and that Friday we would be in...we would be in session but only for the purpose of introduction of bills. We will open the Session at nine o'clock on Friday morning and keep it open for the entire business day for the purpose of introduction of bills only, and the membership would be required to be here only on Thursday for the purpose of those committee meetings and Floor Session, so that we would effectively...what we're doing is effectively canceling Wednesday and making our Session responsibility next week literally one day which is Thursday only. So, I would hope that everybody would make note of that change and...particularly the...the members...the chairmen and the members of those committees would make their plans accordingly. Ten o'clock on Thursday for Transportation and Energy Committees, two o'clock on Thursday for Revenue and Finance and a Session on Friday which will commence at nine in the morning for the purpose of introduction only. There will not be any roll calls of any kind on Friday.

PRESIDING OFFICER: (SENATOR DEWUZIO)

Senator Karpiel.

SENATOR KARPIEL:

Thank you, Mr. President. I'd just like to announce that there will be a premeeting of...of the Republican members of the Executive Committee immediately following Session in Room 309G.

PRESIDING OFFICER: (SENATOR DEWUZIO)

Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I have a question of President Rock. What about those bills that are still going to be in the Reference Bureau that will not be ready by the last day of introduction? I'm assuming if they're not introduced by a week from

this coming Friday, no matter where they are, that's the end of the ball game.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you. We are in constant communication with our friends in the Reference Bureau and, hopefully, all the work product. There are a number of requests that are still there. They tell me they are doing their darndest to get them all out and get all of us accommodated. The fact of the matter is, the last day to introduce bills is April the 10th and if there are bills that come in after that, you and I will have to sit down and make the appropriate ruling.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

Thank you, Mr. President. The AIDS Subcommittee of the Judiciary Committee and the Public Health Committee will meet at three-thirty promptly in Room 400 of the Capitol. All bills of those two subcommittees of Judiciary and Public Health will be heard and we'll be out by four-thirty, votes will be taken. We have witnesses who have come a long way. Please be prompt. Three-thirty, AIDS Subcommittee, both Public Health and Judiciary.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Collins, for what purpose do you arise?

SENATOR COLLINS:

Yeah, for the purpose of an announcement.
