SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. The adjournment resolution is before us know, Senate Joint Resolution 37. The reason it is is the House is kind

of in a hurry to get it over there. I am told they may adjourn peremptorily once they finish their business. Just an observation from this side of the aisle. In any event, all that rhetoric notwithstanding, it calls for us to be back here, per our agreement with Senator Philip and myself, Thursday at the hour of noon for Session. Now, there are two committees that are meeting at ten o'clock in the morning. So. I'd ask the members to please observe that. We will be in and out of here on Thursday. And the last day for introduction of bills, of course, is Friday. So Friday will be a day...of Session but for the purpose of introduction of bills only. The House is in perfunct all next week for the purpose of introduction and that's why all those dates were recited. I would move, Mr. President, for the suspension of the rules and the immediate consideration and adoption; and let me just add, I know a number of the members are anxious to get back to their district, we have only, in my judgment, three resolutions that members have asked me to consider this afternoon. Senator Newhouse has one. Senator Smith has Senator del Valle has one. And I understand that Senator Fawell has a bill from the Department of Public Aid that of an emergency nature and she would like to offer an amendment to a bill on 2nd reading. Other than that, we...so if can handle that we can be out of here in less than thirty minutes. In the meantime, I would move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 37.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the motion. Any discussion? Senator Rock has moved for the immediate...suspension of the rules for the immediate consideration and adoption of Senate Joint Resolution 37. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator Rock now moves the adoption of Senate Joint Resolu-

tion 37. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 37 is adopted. Senator Savickas, for what purpose do you arise?

SENATOR SAVICKAS:

For three points, Mr. President. One, I would like to announce that Senator Marovitz is not here...here due to his father's illness. Second point is that I would like to recognize that the Ball-Chatham Elementary School Fifth Grade Class of Mrs. Peggy Goodwin is in the gallery and Bruce Moaten, one of the young fellows that I know.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Will our guests in the gallery please rise and be welcomed by the Senate. The record will reflect Senator Marovitz's absence. Senator Savickas.

SENATOR SAVICKAS:

And the last is...I had sent a note to Senator Weaver. We'd like to...discharge the Committee on Education from further consideration of Senate Bill 485, it's an appropriation bill for asbestos funding, and move it into Appropriations I. Senator Weaver, I sent a note over to you...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Which education committee, Higher Ed. or Elementary and Secondary?

SENATOR SAVICKAS:

It was probably in Elementary Ed.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Savickas moves to discharge the Committee on Education from further consideration of Senate Bill 485 and that the bill be referred to the Committee on Appropriations I. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. And is so ordered. Resolutions.

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR NEWHOUSE:

SENATOR NEWHOUSE:

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Newhouse has moved to...has moved to suspend the rules for the immediate consideration and adoption of Senate Joint...Resolution 38 which I am told is congratulatory in nature. Is there discussion? There are...a couple of lights on. Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator Newhouse on Senate Joint Resolution 38.

SENATOR NEWHOUSE:

Congratulatory resolution. I move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Newhouse has moved the adoption of Senate Joint Resolution 38. It is congratulatory in nature. Those in favor will...discussion? If not...if not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 38 is adopted. Further resolutions.

Consent Calendar. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, Mr. President. In order to move us along here, I would ask leave of the Body to go to the Order of the And on page 3 on the Calendar on the Order of Senate Bills 2nd Reading is Senate Bill 141. There is an amendment that Senator Fawell is prepared to offer...that is of an emergency nature. We are to conform with Federal law so that we can receive some Federal reimbursement and if we do not do this by the first of Nay, I am informed by the Department of Public Aid that we can ... we stand to lose about twenty million dollars. So it seems to me opportune that we do it. The House, in its typical fashion, has fouled it up, so we're going to amend it here and send it back to them and give them another crack at it. I would ask leave of the Body to go to the Order of Senate Bills 2nd Reading for the purpose of taking up Senate Bill 141.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. With leave of the Body, we will go to the Order of Senate Bills 2nd Reading. Page 3 on your Calendar, Senate Bill 141. Is leave granted? Leave is granted. On the Order of Senate Bills 2nd Reading is Senate Bill 141. All right. Senate Bill 141,...Madam Secretary.

Senate 3ill 141.

SECRETARY:

(Secretary reads title of bill)

2nd reading of the bill. The Committee on Judiciary offers one committee amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Fawell.

SENATOR FAWELL:

Thank you, very much. The committee amendment in effect became the original bill, and...and what it does...when someone...some...a couple in...DuPage County, for instance, goes to Cook County for purposes of a divorce, the judge may send the post decree motions back to the original court for such things as child support. And the Illinois Bar Association supports the bill under that form, and I would ask for your...affirmative vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Fawell has moved the adoption of Committee Amendment No. 1 to Senate Bill 141. Is there discussion? Senator...Dunn, not on this, right? Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Further committee amendments.

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

SECRETARY:

Yes. Senator Fawell offers one Floor amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Fawell.

SENATOR FAWELL:

Thank you, very much. This is the amendment that Senator Rock was talking about. It makes all child supportments orders of judgment. And it is necessary to pass this to put us in conformancy as far as the Federal Government is concerned because, indeed, we will lose twenty million dollars. And I would ask for your affirmative vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Fawell has moved the adoption of Amendment No. 2 to Senate Bill 141. Is there discussion?

Senator Dunn, do you wish...Senator Dunn. All right. Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further amendments?

No further Floor amendments.

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. All right. With leave of the Body, we will now go to page...6 on your Calendar, page 6 on your Calendar, Secretary's Desk Resolutions. All right. With leave of the Body, page 6, Senate Resolution 110. Senator Smith.

Thank...thank you, Mr. President and members...of the Senate Resolution No. 110 is very important. Senate. Τt imposes the IRS new ruling on lobbying activities. On November the 5th, 1936, the IRS proposed new lobbying regulations which seriously restricts communications between legislators and nonprofit 501 C3 corporations. Nonprofit corporations involvement and participation in the legislative process benefits both the nation and the state and is legally recognized pursuant to PL 94455. The proposed rules adversely affect private foundations and other donors by placing unreasonable administrative burdens on them which restrict their activities and discourage their support for public policy research to advocacy services. We, therefore, through Senate Bill 110 request that the IRS to withdraw its proposed rules by lobbying for public charities and request that a committee composed of IRS public charities and congresspersons be established to assist in drafting regulations. I pray that we here will be considerate of this and let this go through so that we can get it to Washington by tomorrow.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Smith has moved the adoption of Senate Resolution 110. Is there discussion? Senator

Karpiel.

SENATOR KARPIEL:

Thank you, Mr. Chairman. Well, I...I understand...or I realize that we discharged committee...or suspended the rules to hear it today...as of yesterday. But I don't think anyone on our side knew what...the resolution was about. I have no objection to the resolution or the intent of the resolution. I think it's a very important subject matter. However, I do have some problems with the resolution the way it is written. We're asking...or we're telling the Federal Government to form a committee made up of the IRS, congressmen, Department of...Public Charities...we should have...we're telling that they have to form a committee to study this issue. already been requested...the turning back of these rules and regs. have already been requested by both...ooth sides of the aisle of the House and ways...House Ways and Means Committee and the Senate Finance Committee, and there's going to be a hearing on this May 11th, 1987. All I am saying is that, yes, this is an important issue but I wish this resolution would go to committee where we could perhaps work on it a little bit and make sure that we pass out the very best resolution that we can.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith. Senator Smith, you want to give...Senator Smith.

SENATOR SMITH

Thank you,...Mr. President, and to Senator Karpiel. This is an emergency and it's going to affect a lot of our non-profit organizations that are dependent upon the RRS...IRS reverting, because they will go back to 1977 and these people will...nonorganizations... profit organizations will have to pay all this back—money which is very, very serious. Now if you...Senator Karpiel, I'm addressing you. If it's all right with you, we'll be delighted to take out the part where the

Illinois Senate petitions to the United States Congress, but we would like to get something today to Washington in regard...to let them know that we are really hurting and many of our nonprofit organizations and charities will certainly be grateful to you...for your consideration.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Karpiel.

SENATOR KARPIEL:

Well, I would...I would like to know, because I'm not aware that there is an emergency...on this that it couldn't wait until...you know, a committee meeting to be held on this. We had other resolutions heard in committee yesterday, we even passed out one of Senator Smith's, why couldn't we have done it yesterday? You know, if there is an emergency, I'd like to know what that emergency is. I mean, is there a deadline that this would have to be in by?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith.

SENATOR SMITH:

Yes, it has to be in Washington by tomorrow. The House has already passed their's out and we would like for our's to go along with it. If I can meet with you at the close of this Session and we can reword or something so that we can get something out from...from the...from the Senate, because this is a deadline. We are in sympathy with them. This is saying...if we do not pass this, this is saying to our non-profit organizations, League of Women Voters and...and the Junior League and the Chicago Urban League and the Community Action Agency and other foundations, we are saying to them that we're not in sympathy with them and what they are trying to do...and I think it's...I think it's incumbent upon us that if we would try to make some type of restitution here. I'd be happy to work with you, take out whatever you say so that we can get this going today.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Karpiel.

SENATOR KARPIEL:

Well, thank you, Mr. Chairman. I hate to be intransigent on this, but we were...we did have a committee meeting yesterday of the Executive Committee, we did handle resolutions, even one of Senator Smith's, we could have done it then. I...and I still don't hear the reason for an emergency. If the only emergency is that we can send it out at the same time as the House because the House has passed their's; frankly, with what the House is doing today, I'm not so sure we should want to do anything along with them.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Smith.

SENATOR SMITH:

(Machine cutoff)...Senator Karpiel,...this is very important and...and I'm not concerned about the actions over in the House, this is the Senate, this is the House of Lords over here, and we want to conduct ourselves as such. The only thing I want to say, it is an...an emergency on this in that it should be submitted...we have to meet the deadline of the Executive Committee...no, here...in order to meet the deadline of April 3rd for public commitment...comment.

PRESIDING OFFICER: (SENATOR DEAUZIO)

Senator Karpiel.

SENATOR KARPIEL:

Well, I just want to say one more thing. If we're talking about amending this resolution, we can't amend it after Session today, after we've passed the resolution and still send it out so it's in Washington by tomorrow. I think it's written badly. I don't think we should be or we can be telling the Federal Government what kind of a committee to set up and who should be on it and what members, et cetera. I just think this is an important issue, but if there is no

deadline...Federal deadline emergency, I don't know why we have to do it now and without any committee hearings and without any work on the resolution. I think if we send this out to Washington today so it gets there tomorrow, we are sending a flawed resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator...Senator Rock.
SENATOR ROCK:

Well, frankly, I disagree. And if Senator Karpiel will take the time, please, to read Senate Resolution 110, it very simply says, and those of us that have been active in the National Conference of State Legislators have been beating up or attempting to beat up the IRS for sometime about their proposed rules with respect to lobbying activities by notfor-profit organizations. And that's what this is about. And what they have said is, if you're going to have comment on these proposed rules, get it in by April 1. That's what we're trying to do. And we are urging our gressional delegation to say to the IRS, hey, take another look at this will you, please? This is not right. We too many public interest bodies in this state that are going to be affected, badly, by this proposed rule, and that's what we want to tell them. Now the fact of the matter is, I've already spoken with Congressman Rostenkowski on the telephone about this matter. All right? This just puts us on record as saying, please, take another look at this, IRS. Now if you want to stand there and defend the IRS, you may wind up standing there alone, because I don't know anybody that wants to defend the IRS.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Senator...Senator Geo-Karis...Senator...Senator Schunzman.

SENATOR SCHUNEMAN:

Thank you, Mr. President. Ladies and Gentlemen of the

Senate, we ought to take a look at...at the way we handle resolutions. Now if...if this...this matter that Senator Rock just addressed and that Senator Smith addresses is...is not new. There's nothing new about this, it's been around. If it's a problem today, it's been a problem for a long time. The Executive Committee has been meeting, Senator Karpiel has been available for discussions on this matter and others. And to come here at the last minute and ask us to waive the rules and give immediate consideration to this resolution the same time when many...many others of us have resolutions that we would like to have heard today is just the wrong way to operate this...this Chamber. And we did a little too much of this last year and now we're beginning early in this Session to do it, and we really shouldnot approve these resolutions without a decent committee hearing, that's all we're And...and certainly Senator Rock's point about getting a message to them on April 1, April 1 was yesterday, I And so it's not going to make any difference whether passes today or next week. He ought to have a hearing on this.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? If not, Senator Smith may close.

SENATOR SMITH:

I would like to correct one statement, that in order for this to have public comment it has to be in Washington by April 3rd, not the 1st but April the 3rd. Senator Karpiel, is it that that you do not like a portion of this analysis that we have in the bill? We'd be delighted to take it out. But the thing about it is is that the Illinois State Senate would have a voice in saying that we are in sympathy with these non-for-profit organizations and it affects many people that live in your district, people who come down to help us to vote and to pass bills and et cetera. We are trying to

help them, they cannot come into these halls but we are here.

And all of these little idiosyncrasies and...and technical—
ities and all, the bottom line is that we want to be heard in
Washington that the Senate is in sympathy. Now we can take
out whatever you want us to take out, but the thing about it
is, let us get something on some paper and send it to
Washington that we are heard and they know that we are concerned.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right.

SENATOR SMITH:

These are our constituents that live in the State of Illinois, across this state. These are people who are functioning and coming down here, nonprofit organizations seeking to help us to help our people, and the least that we can do is to show our concern. Whatever you want us to take out, we'd be delighted to take out, but let us have something that we can send to Washington.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The...Senator Smith moves the adoption of Senate Resolution 110. Those in favor will indicate by saying Aye. Opposed Nay. Senator Karpiel, for what purpose do you arise?

SENATOR KARPIEL:

I'd like a roll call vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Karpiel has requested a...a roll call. Senator Karpiel, do you persist...in your motion? Senator Karpiel, do you persist in your motion?

SENATOR KARPIEL:

Yes, sir.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Smith has moved the adoption of Senate Resolution 110. Those in favor of the resolution

will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 30, the Nays are 4, 16 voting Present. Senate Resolution 110 is adopted. All right. We have some special guests that are visiting the Chamber. Senator Woodyard. Senator Woodyard is recognized. SENATOR WOODYARD:

Thank you, very much, Mr. President and members of the I do have my Chrisman basketball team over here this afternoon. I had purposely...scheduled them for April 2nd so as not to have them here on April Fools Day, but the way the Session is going on the other side of the Rotunda today, I kind of wondered if...if I made the correct choice. But anywave this is more interesting to have a...a basketball here than it is in the debate going on across the...across the...way. These young people are members of the Chrisman basketball team who finished third in the state in the Class Tournament a couple of weeks back and also the cheerleaders. And I have Coach Beals and his wife here today And we have...and you did pass a resolution day also. before yesterday congratulating them and I did want to present them to you. Now if you would digress with me just...or allow me to digress just a moment. The...the record this year for Chrisman was twenty-seven wins and five losses. Two years ago we finished twenty-eight and five and were second in the state. So, we have quite a tradition of basketball in my small hometown of Chrisman which is thirteen hundred population. And I think we have less than a hundred and fifty kids in our high school. So it shows you what can be done. A lot of that is attributed to our coach. Coach Roger Beals. And at this time he has a total record of five hundred and twenty-three wins against a hundred and fifty-four losses. Since he came to Chrisman, believe this, his record is four hundred and twenty-six wins against seventy-five losses. I wish I could pass my bills with that kind of percentage record for sure. But in this case, Coach Beals, would you join me up here. By the way, Roger was inducted into the Illinois Basketball Hall of Fame in 1985, so please join me in welcoming him here today.

COACH ROGER BEALS:

(Remarks by Coach Beals)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Weaver, for what purpose do you arise?

Thank you, Mr. President. I think Senate Bill 443, sponsored by Senator Kustra was mistakenly assigned to Higher Education, it should be Financial Institutions. I think all involved recognize this, and in the absence of Senator Savickas, I would ask that that we reassigned to Financial Institutions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Weaver asks that Senate Bill 443 be discharged from the Committee on Higher Education and that it be referred to the Committee on Finance and Credit Regulations. Those in favor of that motion will indicate by saying Aye. Opposed Nay. The Ayes have it. The...Senate Bill 443 will repose in the Committee on...Finance and Credit Regulations. Senator Karpiel, for what purpose do you arise? All right. Committee reports.

SECRETARY:

Senator Jerome J. Joyce, chairman of the Committee on Executive, reports Senate Bills Noed. 154, 162, 22, 256, 282

And Senate Bill 385 Do Pass as Amended.

Senate Joint Resolution 22 do adopt as amended.

House Joint Resolution No. 1 do adopt.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle on...Senator del Valle, for

what purpose do you arise?

SENATOR DEL VALLE:

Thank you, Mr. President. I move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 22.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...del Valle has moved to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 22. Is there discussion? If not, those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator del Valle, on Senate Joint Resolution 22.

SENATOR DEL VALLE:

Senate Joint Resolution 22 establishes a joint committee on immigration reform which is very much needed given that May 5th will begin the legalization process. We want to make sure that there's a broad approach to determining the impact of...of the new Federal immigration law and what can be done by State Government to ensure that it is implemented in a fair and just manner.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senate Joint Resolution 22 will, in fact, require a roll call. Senator Karpiel.

SENATOR KARPIEL:

Thank you, Mr. Chairman. Senator del Valle,...is the amendment putting an effective date in this bill on the bill? PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...

SENATOR KARPIEL:

•••and also changing the membership as we discussed yesterday?

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator...Senator del Valle...wait a minute...wait a minute. In fact, there...there is a committee amendment

which in fact has not yet been adopted. Frankly, I was there yesterday but I...I...I forgot it myself. So, Senator...del Valle seeks...leave of the Body to...amend Senate Joint Resolution 22. Senator del Valle on...on Committee Amendment No.

SENATOR DEL VALLE:

Committee...Amendment No. 1 increases the membership from twenty-three to twenty-eight.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle moves the adoption of Committee Amendment No. 1 to Senate Joint Resolution 22. Discussion? If not, those in favor indicate by saying Ay2. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Amendments from the Floor?

SECRETARY:

One Floor amendment offered by Senator del Valle.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR DEL VALLE:

The...the amendment sets...6-1-88 as the final date...reporting date...final reporting date.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle, has moved the adoption of Amendment No. 2 to Senate Joint Resolution 22. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle, on Senate Joint Resolution 22, you're recognized.

SENATOR DEL VALLE:

Yes, I move for the adoption of the resolution...Senate

Joint Resolution 22 as amended.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle moves the adoption of Senate Joint Resolution 22. Those in favor of the adoption will vote Aye. Those opposed Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate does adopt Senate Joint Resolution 22. PRESIDING OFFICER: (SENATOR DEMUZIO)

Will our guests in the gallery please rise. Welcome to Springfield. All right. Senator Keats, for what purpose do you arise?

SENATOR KEATS:

I would ask leave of the Senate to join with Senator Zito on his Senate Bill 213...

PRESIDING OFFICER: (SENATOR DEMUZIO)

...well, wait a minute...

SENATOR KEATS:

All right. Senator Keats...Senator Keats. for what purpose do you arise? Let's...let's take it now.

Do I have to follow this? I...I would request permission of the Senate to join with Senator Zito as a hyphenated co-sponsor of Senate Bill 213 which goes into our Financial Institutions Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Keats seeks leave of the Body be added as a hyphenated cosponsor of Senate Bill 213. Is leave granted? No objection, leave is granted. Senator Brookins, for what purpose do you arise?

SENATOR BROOKINS:

Thank you, Mr. President. Seated in the gallery is the winningest coach from Chicago, Julian High School, Walter Smith. And I'd like...on the Democratic side.

PRESIDING OFFICER: (SENATOR DEMUZIO)

•••Walter Smith• Walter, would you please rise and be recognized by the Senate• All right• Senator Jacobs• for what purpose do you arise?

SENATOR JACOBS:

Thank you, Mr. President. With...with leave of the Body, I would like to be added as a hyphenated cosponsor to Senate Resolution No. 156.

PRESIDING OFFICER: (SENATOR DEMUZIO)

I'm sorry, Senator Jacobs, I....[didn't hear you.

SENATOR JACOBS:

That's all right, you're being rude to me again, that's all right, Vince. Senate...I would like to be added as a hyphenated cosponsor to Senate Resolution No. 156.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the request of Senator Jacobs to be added as a hyphenated cosponsor of Senate Resolution 156. Is leave granted? Leave is granted. Senator Karpiel, for what purpose do you arise?

SENATOR KARPIEL:

Yes, thank you, Mr. President. With leave of the Body, I would like to be added as a cosponsor on Senate Bill 339..379, I'm sorry.

PRESIDING OFFICER: (SENATOR DEMUZIO)

(Machine cutoff)...Karpiel, that was...what was the number again?

SENATOR KARPIEL:

All right. Senator Karpiel seeks leave of the 3ody to be added as a hyphenated cosponsor to Senate Resolution 379. Is leave granted? Leave is granted. Senate Bill...379. Resolutions.

SECRETARY:

Senate Resolution 160 offered by Senator Ralph Dunn.

It's a death resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senate Resolution 161 offered by Senators Zito and Keats.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. All right. Consent Calendar. Senate...Madam

Secretary, has there been any...corrections or additions to the Senate...

SECRETARY:

There have not.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Resolutions Consent Calendar?

SECRETARY:

There have not.

PRESIDING OFFICER: (SENATOR DEAUZIO)

All right. The Resolutions Consent Calendar has been passed out, and we...with leave of the Body, we will add Senate Resolutions 1-5-7...through 1-6-0. (Machine cut-off)...Joint Resolution 49 and Senate Joint Resolution 39. Is leave granted to add those? Leave...leave is granted. So ordered. Senator Rock now moves the adoption of the Resolutions Consent Calendar. Those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. The Resolutions Consent Calendar is adopted. Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, it's my understanding that a bill was discharged from one committee and put in another, and I know nothing about it. I...we...have instituted a procedure that if a bill should be changed that I should be notified and the Minority Spokesman on the Committee on Assignment of Bills. This was not done. This is to prevent everybody just getting up without anybody knowing anything and just changing bills from committee to committee. I would ask that whoever made that motion that that bill be brought back to its original committee and let those committee members hear the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Savickas, I was under the...the...operating under the impression that that was cleared with you; apparently, it wasn't. Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen...of the Senate. I certainly agree with Senator Savickas and, quite frankly, we just had an example of that today on this resolution. I was not notified about that resolution. I haven't got any big problem with that resolution. But number one, wa didn't know what it did or does or is going to do. came over and talked to me about it, and we've done it. Now we always used to have the courtesy when we were going to switch committees or do some things at the last minute that at least somebody came over to this side of the aisle and talked to us about it, because, quite frankly, most of the stuff we agree to do. But here of lately we have no idea till somebody on the other side of the aisle stands up and makes some kind of request that we don't know anything about or don't understand. And you couldn't get that resolution to Washington D. C. tomorrow if your life depended on it. And we all know you probably couldn't find a Congressman or United States Senate that ever looked at our resolutions. And most of them aren't worth the paper they're written on, quite frankly. But I think we ought to take a little more time, and when we've got something, I should or one of my leaders ought to walk over and talk to Senator Rock and explain what we're trying to do, and it should work the same way on the other side of the aisle. And Senator Savickas is absolutely, one hundred percent correct.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, I want to reiterate again that I was under the impression that it had been cleared with Senator Savickas. He was not on the Floor. The...the motion was made by the...on the Republican side. If there is an objection, and I think that, quite frankly, the process ought to be reversed. Senator Keats, for what purpose do you arise?

Senator Kustra called on the phone. If Senator Kustra hears any of our voices, if you've cleared this, come over here and will you tell us what you cleared up? If you aren't hearing it on the thing, then fine, Senator Savickas is correct, put the thing back. If it's not cleared, it shouldn't be done. And if Senator Kustra can hear us, will somebody come over here and clear this up?

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Savickas has moved that Senate Bill 443 be discharged from the Committee on Finance and Credit Regulations and that it be returned to the Committee on Higher Education. Is there objection? Hearing none, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it and Senate Senate Bill 443 will be reposed back in the Committee on Higher Education. Further...Senator Geo-Karis. SENATOR GEO-KARIS:

I'd like to be added as an immediate cosponsor to Senate Bill 379. It's Senator Jacobs bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senate Bill 379, it's the request of Senator Geo-Karis to be added as a hyphenated cosponsor. Is there leave? Leave is granted. So ordered...Senator del Valle.

SENATOR DEL VALLE:

Yes. I'd like to be added as a hyphenated cosponsor to Senate Bill 253 and Senate Bill 257.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle asks leave of the Body to be added as a hyphenated cosponsor of Senate Bills 253 and 257. Is leave granted? Leave is granted. So ordered, without objection. Further business to come before the Senate? All right. Further business? Senator Rock moves that the Senate stand adjourned until the hour of noon, April the 9th. Thursday, April the 9th. Is that it? All right. The Senate stands adjourned until April the 9th.
