PRESIDENT:

The hour of one having arrived, the Senate will please come to order. Will the members be at their desks and will our guests in the gallery please rise. Prayer this afternoon by Reverend Rudolph Shoultz, Union Baptist Church, Springfield, Illinois. Reverend.

REVEREND RUDOLPH SHOULTZ:

(Prayer given by Reverend Rudolph Shoultz)

PRESIDENT:

Reading of the Journal, Madam Secretary.

SECRETARY:

Senate Journal of Thursday, April 7, 1988.

PRESIDENT:

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I move that the Journal just read by the Secretary be approved unless some Senator has additional or corrections to offer.

PRESIDENT:

All right, you've heard the motion as placed by Senator Vadalabene. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries. It's so ordered. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. I move that reading the...approval of the Journals of Friday, April 8th; Tuesday, April 12th; Wednesday, April 13th and Thursday, April 14th, in the year 1988, be postponed pending arrival of the printed Journals.

PRESIDENT:

You've heard the motion as placed by Senator Vadalabene. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and

it is so ordered. Messages from the House.

SECRETARY:

A Message from the House by Mr. O'Brien, Clerk.

Mr. President - I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I'm instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution 171. It is congratulatory.

PRESIDENT:

Consent Calendar, Madam Secretary. Resolutions.

SECRETARY:

Senate Resolution 973 offered by Senators Brookins and Smith.

Senate Resolution 974 offered by Senator DeAngelis.

Senate Resolution 975 offered by Senator Newhouse.

Senate Resolution 976 offered by Senator Thomas Dunn and all members.

Those are all congratulatory.

Senate Resolution 977 offered by Senators Smith and Brookins.

Senate Resolution 978 offered by Senator Newhouse.

It is a...those are both...death resolutions.

PRESIDENT:

Consent Calendar.

SECRETARY:

Senate Joint Resolution 117 offered by Senator Vadalabene. It is substantive.

PRESIDENT:

Executive.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, on the Order of Resolutions, Senator Dunn. Leave of the Body, we'll go to the Order of Resolutions for the specific purpose of a congratulatory resolution which I understand is of...some of urgency. Senator Dunn.

SENATOR TOM DUNN:

Thank you, Mr. President. I move to suspend the rules for immediate consideration and adoption of Senate Resolution 976 which is congratulatory in nature. This is a young lady who was awarded the third annual Illinois consumer awareness poster contest winner and I would move for the adoption of the resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the motion as posed by Senator Dunn. Senator Dunn moves the...to suspend the rules for the immediate consideration and adoption of Senate Resolution 976 which is congratulatory. Those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. Senator Dunn now moves the adoption of Senate Resolution 976. Discussion? If not, those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 976 is adopted. All right. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I know that Senator Carroll has an announcement about his committee and Senator Davidson has a couple of announcements that he's interested in, but while I have the Floor, Mr. President, I'd like the attention of the members. I have discussed with Senator Philip a schedule...couple of schedule changes for this week and next week. There's a memorandum on the desks of all members concerning the accommodation for the Education Committee which will meet on Tuesday, April the 26th, on the Senate Floor to consider a great number of proposals with respect to school reform. So, the Judiciary Committee will meet on Wednesday instead of

Tuesday of next week. In addition, for this week, the Rules Committee will meet tomorrow at the hour of noon and the Session will commence at one o'clock so that we will accommodate the morning committee and have the Rules Committee meet at noon and then on Thursday morning, which is get-away-day, in an attempt to accommodate the members' travel schedule, we will convene the Session at 9:00 a.m. and the committees will meet as scheduled at ten o'clock and two o'clock respectively, but the Session will commence at nine and we will be concluded by committee time. So, I'd ask the members to make a note of that. Thursday, the Session will begin at 9:00 a.m. in the morning and we will conclude our business pretty rapidly.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further announcements? Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. The Appropriations I Committee meeting will be promptly at two o'clock. We have a very extensive schedule. We will start with the Bureau of the Budget and then what appears to be the Bureau of the Budget's suggestions for supplemental appropriations that would be within Appropriations I and then go back to the Fiscal '89 OCE's that have been scheduled. So, it will be quite extensive. We would ask the members to please be prompt and please be brief and at two o'clock we'll meet in 212.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further announcements? Senator Davidson.

SENATOR DAVIDSON:

Hello. Mr. President and members of the Senate, I would like to bring to your attention...can I have their attention, please, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, ladies and gentlemen, we're about to conclude

our business. Senator Davidson has an announcement. Senator Davidson.

SENATOR DAVIDSON:

Tomorrow is Legislative Fitness Day, a joint effort between the Governor's Council on Health and Fitness and IAPEHI, which is the Illinois Association of Physical Ed. and Health Instructors. This is for your benefit. It's at 7:30 a.m. to one-thirty in Room 114. Many of you participated in it last year and we'd like to see all of you there. Whether you think you're good, bad or indifferent, the only way to find out is be there. Secondly, Mr. President, due to the...this is some importance to you people from northern Illinois. Due to the illness of my secretary's mother last week, we were unable to lay this on the desk, but Thursday morning, May the 12th...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator Davidson, all of the noise is coming from your side of the aisle, I think.

SENATOR DAVIDSON:

That's impossible, we're not that hot air, but...they're both guilty, but Thursday morning, May the 12th, is the Governor's Prayer Breakfast. For those of you who are sport fans and those of you who are from Chicago area, the speaker...hold it please, Doris. The speaker is Mike Ditka. Now for those of you and the members of the Legislature, if you'll get your request to me before Thursday, May the 5th, we have reserved seats in the center part for members of the Legislature. The tickets are eight dollars and a half, and we need your money with your reservation. We will have seats for you to be present. Thank you, I'll keep the tip. Those of you who are going to participate, please, come and see me and get your order in so we can have you at the reserved section. President Rock is one of the members of the Podium Committee and who will open the...open prayer and he's going

to keep attendance and I'm going to double-check to make sure whether he was correct. So, we'll look forward...see all of you there. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further announcements? Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President, I would at this time seek suspension of the rules to reassign three bills. On the motion to reassign Senate Bill 1672 from the Committee on Elementary and Secondary Education to the Committee on Executive. This bill deals with the Freedom of Information Act and not with education matters. Senate Bill 2197, from the Committee on Insurance to the Committee on Public Health. This is a bill that deals with path. tests and not insurance matters.. And Senate Bill 1966 from Judiciary to Executive. It deals with...at the request of the Auditor General with separate funds to be deposited into an audit...an audit account. So at this time, I would seek leave of the Body to reassign these three bills.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Savickas seeks leave of the Body to discharge the Committee on Elementary and Secondary Education from Senate Bill 1672 further consideration and that it be reassigned to the Committee on Executive. Is leave granted? Leave is granted. It's so ordered. All right, the...all right, on the motion to suspend, those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. Elementary and Secondary Education is discharged from further consideration and the bill, 1672, is assigned to Executive. Senator Savickas has also moved Senate Bill 2197 to be discharged from the Committee on Insurance and rereferred to the...reassigned to the Committee on Public Health, and also Senate Bill 1966 to be discharged from Judiciary and to be reassigned to the Committee on Executive. Those in favor

indicate by saying Aye. Opposed Nay. The Ayes have it. Insurance...2197 is...is...now reposes in Public Health, Senate Bill 1966 in Executive and Senate Bill 1672 also in Executive. Further announcements? Senator Schuneman.

SENATOR SCHUNEMAN:

Not a...not an announcement, Mr. President. I seek leave to be added as a cosponsor on a bill. Senate Bill 2063.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, with leave of the Body, Senator Schuneman has sought leave to be added as a hyphenated cosponsor of...or a cosponsor...a cosponsor of Senate Bill 2063. Is leave granted? Leave is granted. It's so ordered. Senator Berman.

SENATOR BERMAN:

For purpose of announcement, Mr. President. Ladies and gentlemen,...every year the...every year there is a service which takes place at the Old State Capitol to memorialize the Holocaust. Tomorrow is the date of that event. It will take place at 11:00 a.m. at the Old State Capitol and there will be a bus...ladies and gentlemen, there will be a bus that will leave...that will leave from the north drive at ten forty-five, and I cordially invite all of us to attend the Holocaust Memorial Service which, of course, is in memory of the millions of people, Jews and non-Jews, who perished in the Holocaust and to pay tribute particularly to the non-Jews who assisted victims of the Holocaust, and I think it is a fitting and very sobering experience. I commend all of you to join us tomorrow at eleven o'clock. The bus will take off at ten forty-five from the north door to the Old State Capitol tomorrow morning. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further...Senator Davidson.

SENATOR DAVIDSON:

Permission to become a hyphenated cosponsor of Senate

Bill...1922.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Davidson to be added as a cosponsor of Senate Bill 1922. Is leave granted? Leave is granted. It's so ordered. Senator Collins, for what purpose do you arise?

SENATOR COLLINS:

Purpose of announcement. I would request leave to move the Transportation Committee hearing on Tuesday which is scheduled on the Calendar for 2:00 p.m. for immediately after adjournment. Whenever we adjourn, we will immediately go to the Transportation Committee. We shouldn't be there very long.

PRESIDING OFFICER: (SENATOR DEMUZIO)

That is on Thursday. Is that correct, Senator Collins? On Thursday. All right. Further announcements? Senator Welch.

SENATOR WELCH:

Mr...Mr. President, I would also advise the Senate that the Committee on Energy and Environment scheduled to meet at 2:00 p.m. this Thursday will now meet at noon in Room 400.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right.

SENATOR WELCH:

Energy and Environment at high noon on Thursday.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further announcements? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I've had the okay from the sponsor of Senate Bill 1622 and I would like to be added on as a cosponsor of Senate Bill 1622.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Geo-Karis to be added as a hyphenated...as a cosponsor, I beg your

pardon, of Senate Bill 1622. Is leave granted? Leave is granted. It's so ordered. Senator Mahar, what purpose do you arise?

SENATOR MAHAR:

Thank you, Mr. President. I seek leave of the Body to be added as a hyphenated sponsor of Senate Bill 1850. 1-8-5-0.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Mahar seeks leave of the Body to be added as a...cosponsor of...of Senate Bill 1850. Is leave granted? Leave is granted. It's so ordered. Further business to come before the Senate? Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like to request that Senator Hall be added as a hyphenated sponsor to Senate Bills 1584 and 1587.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Smith that Senator Hall be added as a hyphenated cosponsor of Senate Bills 1584 and Senate Bill 1587. Is leave granted? Leave is granted. It's so ordered. Senator Macdonald, for what purpose do you arise?

SENATOR MACDONALD:

Thank you, Mr. President. I would like to add Senator Kustra as the third hyphenated cosponsor, then Senator Dunn and Senator Rigney as hyphenated cosponsors of SJR CA 94.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the request of Senator Macdonald to add hyphenated cosponsors Kustra, Dunn and Rigney. Which Dunn? Senator Macdonald, what...Ralph Dunn as hyphenated cosponsors of SJR Constitutional Amendment 94. Is leave granted? Leave is granted. It's so ordered. Senator Hall. Senator Hall, are they here?

SENATOR HALL:

They're filing in right now, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall, for what purpose do you arise?

SENATOR HALL:

Point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

State your point.

SENATOR HALL:

Thank you, Mr. President and members of the Senate. I'm very proud today to introduce to the Senate the gifted program Operation Uplift of District 189. They're accompanied today by Doctor Edna Allen, director of gifted program guide and service; Mr. Frank Blackshear, mathematician, project specialist; Miss Janey Snowden, career operating specialist; Mrs. Lorena Green of the gifted program, Miss Elizabeth Jackson, program coordinator; Doctor Edson Nyamapfene, teacher/consultant, gifted instructor; Mrs. Myrtle Harris, gifted teacher, District...and Mrs. Irene Oglesby, gifted...program aide. Would you please rise and be greeted by the Senate, District 189.
