PRESIDENT:

The Senate will please come to order. Will the members be at their desks and will our guests in the gallery please rise. Our prayer this afternoon by the Reverend William Ellis, People's Church of God, Decatur, Illinois. Reverend. REVEREND WILLIAM ELLIS:

(Prayer given by Reverend Ellis)

PRESIDENT:

Thank you, Reverend. Reading of the Journal. Senator

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Wednesday, April the 1st, 1987; Thursday, April 2nd, 1987. Mr. President, I move that the Journals just read by the Secretary be approved unless some Senator has additions or corrections to offer.

PRESIDENT:

You've heard the motion as placed by Senator Smith. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it is so ordered. Senator Smith.

SENATOR SMITH:

Thank you, Hr. President. I move that the reading and the approval of the Journals of Thursday, April 9th and Friday, April 10th, in the year 1987, be postponed pending arrival of the printed Journals.

PRESIDENT:

You've heard the motion as placed by Senator Smith. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries. It's so ordered. Committee reports.

SECRETARY:

Senator Jones, chairman of the Committee on Insurance,
Pensions and Licensed Activities, reports Senate Bills Noed.

265, 465, 1115 and ... 1172 Do Pass.

And Senate Bills Noed. 454 and 601 Do Pass as Amended.

PRESIDENT:

Senator Friedland, for what purpose do you arise? SENATOR FRIEDLAND:

Thank you, Mr. President. Request leave to be added as a cosponsor of two Senate bills. They are 1152 and 1516, and this is with the sponsor's approval. Thank you.

PRESIDENT:

All right. Gentleman seeks leave to be added as a cosponsor on Senate Bills 1152 and 1516. Without objection, leave is granted. Senator Vadalabene, for what purpose do you arise, sir?

SENATOR VADALABENE:

Yes, for the same reason, Mr. President. I have two bills that I want to be...I'm asking...for permission to be a cosponsor. Senate Bills 1458, the sportsmen's bill, and Senate Bill 1421, the bed...bed and breakfast bill.

Mr. President, I ask leave of the Body and...and with permission of the sponsor, I would like to be shown as principal sponsor of Senate Bill 1454, and I also have a point of personal privilege.

All right. Gentleman seeks leave to be added as a cosponsor on Senate Bill 1454. Without objection, leave is granted. State your point, sir.

SENATOR MADIGAN:

Executive. Senator Woodyard, for what purpose do you arise?

SENATOR WOODYARD:

Thank you, Mr. President. With leave of the Body and permission of the sponsor, I would like to be...added as a hyphenated cosponsor of Senate Bill 1227 and Senate Bill 1229.

PRESIDENT:

All right. The gentleman seeks leave of the Body to be added as a cosponsor on Senate Bills 1227 and 1229. Without objection, leave is granted. Senator O'Daniel, for what purpose do you arise, sir?

SENATOR O'DANIEL:

Mr. President, point of personal privilege.

PRESIDENT:

State your point, sir.

SENATOR O'DANIEL:

I would like to introduce in the...in the President's Gallery the Hamilton County Junior High Beta Club, eighth grade, and their...their teachers.

PRESIDENT:

Will our guests in the gallery please rise and be recognized. Welcome to Springfield. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you, Mr. President. If I might, I would like to make an announcement. The Illinois Economic and Fiscal Commission is meeting at five o'clock today. This will be the meeting at which we will review and adopt our revenue estimate for the biennium, so that it is an extremely important meeting of the commission. I would also urge any of you, particularly the new members, to attend if you are able to do so, because it is an opportunity to get a great deal of

background information on where we are fiscally and where we are likely to be going. The meeting is in the Capital Development Board Board Room which is on the 3rd Floor of the Stratton Building. That was the only room that was available to us. It is possible to find it. Five o'clock today. Thank you, very much.

PRESIDENT:

All right. Economic and Fiscal at five o°clock today. Senator DeAngelis, for what purpose do you seek recognition? No purpose. Senator Zito, for what purpose do you seek recognition?

SENATOR ZITO:

Thank you, Mr. President. To ask leave of the Body to be added as a hyphenated chief sponsor of Senate Bill 227. I have talked with the Senate sponsor.

PRESIDENT:

The gentleman seeks leave of the Body to be added as a cosponsor on Senate Bill 227. Without objection, leave is granted. Senator Hudson, for what purpose do you arise, sir?

Thank you, Mr. President. To seek leave of the Body to have my name deleted as the principal sponsor of Senate Bill 1457, if I may. And not only deleted but sponsor of any kind. In other words, struck from that bill. Okay? Is that overkill?

PRESIDENT:

Why don't you Table it? Is it yours? Table it.
SENATOR HUDSON:

...no.

PRESIDENT:

All right. The gentleman seeks leave to be removed as the chief or any sponsor in any capacity from Senate Bill 1457, with leave of the Body. No objection, leave is granted. So ordered, Senator. Senator DeAngelis, for what

purpose do you arise?

SENATOR DEANGELIS:

Thank you, Mr. President. I would like to be shown as a hyphenated sponsor on Senate Bill 8-3-4, 834.

PRESIDENT:

The gentleman seeks leave to be shown as the hyphenated cosponsor on Senate Bill 834. Without objection, leave is granted. Senator Demuzio, for what purpose do you arise, sir?

SENATOR DEMUZIO:

Yes. With leave of the Body, I°d like to be removed as a hyphenated cosponsor of Senate Bill 426.

PRESIDENT:

All right. Gentleman seeks leave to be removed as the cosponsor on Senate Bill 4-2-6, 426. Without objection, leave is granted. Channel 20 has requested permission to shoot some tape. Without objection, leave is granted. Senator Davidson, for what purpose do you arise, sir?

SENATOR DAVIDSON:

To ask for the suspension of the rules and the immediate consideration of Senate Resolution 172, congratulatory resolution for the Auburn Fifth...Rotary Club 50th Anniversary so I can present it this evening.

PRESIDENT:

That request appears to be in order. Madam Secretary, you want to put that on the board. Senator Davidson has moved to suspend the appropriate rules for the immediate consideration and adoption of Senate Resolution 172. It is...he represents a congratulatory resolution. All in favor of the motion to suspend indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Senator Davidson now moves the adoption of Senate Resolution 172. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted.

Senator Marovitz, for what purpose do you arise?

SENATOR MAROVIT7:

Thank you, very much Mr. President. With leave of the sponsor, I'd like to be added as a hyphenated principal sponsor to Senate Bill 808.

PRESIDENT:

The gentleman seeks leave of the Body to be added as the hyphenated cosponsor on Senate 3ill 8-0-8, 808. Without objection, leave is granted. Senator Welch, for what purpose do you arise?

SENATOR WELCH:

Thank you, Mr. President. I'd like to change the sponsorship on Senate 3ill 1425 from Holmberg-Welch to Welch-Holmberg.

PRESIDENT:

All right. The gentleman seeks leave to change the chief sponsor on Senate Bill 1425 to...from Senator Holmberg to Senator Welch. Without objection, leave is granted. Resolutions.

PRESIDENT:
