All right. Senator Philip, for what purpose do you arise? Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I'd like the record to indicate that Senator Macdonald is back at home. Her daughter is having a serious operation so I'd like the record to indicate that. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The record will so indicate. Senator Kustra. for what purpose do you arise?

SENATOR KUSTRA:

Thank you, Mr. President. With leave of the Senate, I would like to add Senator O'Daniel as a hyphenated cosponsor of Senate Bill 1491.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Kustra seeks leave of the Body to add Senator O'Daniel as a hyphenated cosponsor of Senate Bill 149. Is leave granted? Leave is granted. I'm sorry, 1491, 1-4-9-1. Senator Davidson, for what purpose do you arise? SENATOR DAVIDSON:

Mr. President — I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution 59, and it's congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar. Senator Luft, for what purpose do you arise?

SENATOR LUFT:

Thank you, Mr. President, if we'll in a lull I'd like to ask to be added as a hyphenated cosponsor of Senate Bill 1304.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Luft seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 1304. Is leave granted? No objections, leave is granted. So ordered. Senator Jones, for what purpose do you arise? SENATOR JONES:

Yes, thank you...Mr. President. I ask leave...for Senate Bill 938, 1005, 1009, 1184, 1191 and 1419, leave so that...suspend the posting requirements so those bills can be heard in the Senate Insurance Committee on Tuesday...on Tues-

day at 10:00 a. m....Tuesday the 28th at 10:00 a. m. I talked with the leaders on both sides of the aisle and I ask for leave to suspend the posting requirements.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Jones, would you...would you repeat the numbers?

SENATOR JONES:

You got them there.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Jones seeks...moves to suspend the rules for the purpose of waiving the posting notice so that Senate Bills 938, Senate Bill 1005, Senate Bill 1009, Senate Bill 1184, Senate Bill 1191 and Senate Bill 1419 can be heard in the Insurance Committee on Tuesday, April the 28th, at ten o'clock. Is there discussion? If not, all those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Posting requirements are waived for the bills that were read into the record that were journalized. Senator Hall, for what purpose do you arise?

#### SENATOR HALL:

Thank you, Mr. President. I move to suspend the six-day posting requirement so that the Appropriation I Committee...will meet at 9:00 a. m. next Tuesday, April 23th, in Room 212. It was posted for ten. All right. Senator Hall has sought...he moves to suspend the rules in order that...the posting rules on the Six-Day Notice in order that the bills that Senator Hall read into

the record which has been furnished a copy to the Secretary, 689, 778, 783, 837, 833, 839, 840, 847, 890, 974, 987, 1044, 1045, 1083, 1199, 1200 and 1348, in order that they may be heard in the Appropriations II...I'm sorry, the Appropriations I Committee at 9:00 a. m. next Tuesday, April the 28th, at the hour of nine o'clock. All right. Is there discussion? If...if not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries. The rules are suspended. Senator Davidson, for what purpose do you arise?

## SENATOR DAVIDSON:

Leave of the Body to add Senator Raica as a cosponsor on Senate Bill 247.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Davidson seeks leave of the Body to add Senator Raica as a hyphenated cosponsor of Senate Bill 247. Is leave granted? Leave is granted. So ordered. All right, leave of the Body, we'll go to the order of ...all right, with leave of the Body, we'll go to the Order of Resolutions. Resolutions, Madam Secretary.

#### SECRETARY:

Senate Resolution 196 offered by Senator del Valle. It's a death resolution.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Consent Calendar. Senator Etheredge, for what purpose do you arise?

# SENATOR ETHEREDGE:

Mr...Mr. President, I seek leave to be added as a hyphenated cosponsor on Senate Bill 117.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the request of Senator Etheredge. Senator Etheredge...has sought leave to be added as a hyphenated cosponsor of Senate Bill 117. And the bill will read Demuzio-Etheredge-Welch. Is leave granted? Leave

is granted. So ordered. Senator O\*Daniel, for what purpose do you arise?

#### SENATOR O'DANIEL:

Mr. President, I'd like...would like leave of the Body to be added as a hyphenated cosponsor of Senate Bill 1333, have permission from the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...O\*Daniel seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 1333. Is there objection? No objection, leave is granted. So ordered. Senator...Senator Severns, for what purpose do you arise?

# SENATOR SEVERNS:

Mr. President, I'd like to ask for leave of the Body to be added as...hyphenated cosponsor to Senate Bills 62, 394 and 687. Thanks.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the request of Senator Severns to be added as a cosponsor. Is that a hyphenated cosponsor? A hyphenated cosponsor of Senate Bills 62, 394, 687. Is there objection? Leave granted? Leave is granted. So ordered. Senator...Senator Savickas, for what purpose do you arise?

# SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, I rise on a motion to reassign two bills at both the request of the sponsors and with the agreement of the chairman and with Senator Weaver, our minority spokesman. The first is Senate Bill 687 and I would move that it be discharged from the Elementary and Secondary Education Committee and be reassigned to the Labor and Commerce Committee. And...Senate...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well let's...let's do them one at a time. Senator Savickas moves to...to discharge the Committee on Elementary and Secondary Education from further consideration of Senate Bill 687, that it be reassigned to the Committee on Elementary...I°m sorry, Committee on Labor and Commerce. Is leave granted? Leave is granted. So ordered. Senator Savickas. SENATOR SAVICKAS:

And the second bill is Senate Bill 1511. I would move to discharge Senate Bill 1511 from the Public Health Committee and reassign to the Judiciary Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Savickas moves that...to discharge the Committee on Public Health from further consideration of Senate Bill 1511 and that it be reassigned to the committee on Judiciary. Is...those in favor of the motion indicate by saying Aye. Opposed Nay. The Ayes have it. It is so ordered. Senator Schuneman, for what purpose do you arise?

Thank you, Mr. President. To request leave to add Senator Kustra as a hyphenated cosponsor on Senate Bill 597.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Schuneman seeks leave to add Senator...Kustra as a hyphenated cosponsor on Senate Bill 597.

Is leave granted? Leave is granted. So ordered. Senator D'Arco, for what purpose do you arise?

SENATOR D'ARCO:

Mr. President, I ask leave to Table Senate Bill 656 which is presently residing in the Committee on Public Health.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...Senator D\*Arco has moved to...to
Table...Senator D\*Arco has moved to discharge the Committee
on Public Health from...further consideration of Senate Bill
656 with the purpose of Tabling. All those in favor indicate
by saying Aye. Opposed Nay. The Ayes have it. The Committee on...Public Health is discharged. Senator D\*Arco now

moves to Table Senate Bill 656. Discussion? If not, those

in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. The motion is carried and Senate Bill 656 is Tabled. All right. Madam Secretary, have there been any additions or subtractions to the Resolutions Consent Calendar? Have there been any objections filed to the Resolutions Consent Calendar?

All right. Senator Madigan seeks leave of the Body to be added as a cosponsor...hyphenated cosponsor of Senate Bill 9-2-4. 924. Senator Madigan, 9-2-4? 9-2-4?
