Ladies and Gentlemen of the Senate, I have some very important guests with me here today that I'd like the Senate to take the time to recognize and, perhaps, listen to for a couple of moments. I think all of us are very proud when industry or business moves into our district especially industry that stays there. This year in Herrin, Illinois, which is one of the leading industrial

In the meantime, Senators Berman and Schaffer have indicated that the Senate bill that was yesterday moved from 2nd to 3rd, Senate Bill 485, the middle of page 32, is obviously of an emergency nature. Thank you. Mr. President. Senate Bill 485 is the bill

that we debated on 2nd reading yesterday. As it is presented to you today, the bill appropriates a little bit less than one million dollars to cover the state's portion of the contracts ready to be let for three schools districts for asbestos abatement, and those three school districts are Richmond School District for four hundred...for two hundred and seventy thousand dollars, the Central Community District in Iroquois County for a hundred and five thousand and Morton High School District for six hundred thousand dollars. This appropriation is to Capital Development Board. If there are additional funds or rather substitute funds that will come to this...to these school districts as a result of any state or Federal appropriation of any permanent funding mechanism,...these monies would be returned under that funding mechanism. We debated the issue as to whether Morton should be in or out, they are in. I think the bill should move forward to address the needs of these three school districts so that they can go to contract and do the work immediately. I ask for a favorable vote.

### PRESIDENT:

Any discussion? Is there any discussion? If not, the question is, shall Senate Bill 485 pass. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 59 Ayes, no Nays, none voting Present. Senate Bill 485 having received the required constitutional majority is declared passed. All right. Ladies and gentlemen, for the remaining fifteen or twenty minutes, we're going to try Senate bills 2nd reading. We would hope that anything with controversy would not be called. We are all, obviously, under a little bit of stress and strain and there are committee meetings again starting at two o'clock, but in order to move the process and afford our clerical help some much needed relief,
