PRESIDENT:

The hour of eleven-thirty having arrived, the Senate will please come to order. Will the members be at their desks and will our guests in the gallery please rise. Our prayer this morning by the Reverend Rudolph S. Shoultz, Union Baptist Church, Springfield, Illinois. Reverend.

REVEREND RUDOLPH SHOULTZ:

(Prayer given by Reverend Shoultz)

PRESIDENT:

Thank you, Reverend. Reading of the Journal. Senator

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I move that reading and approval of the Journals of Wednesday, April 29th and Thursday, April 30th and Friday, May 1st and Monday, May 4th and Tuesday, May 5th and Wednesday, May 6th and Thursday, May 7th, in the year 1907, be postponed pending arrival of the printed Journals.

PRESIDENT:

Will our guests please stand and be recognized. Welcome to Springfield. Senator Mahar, for what purpose do you arise, sir?

SENATOR MAHAR:

Mr. President, I seek leave of the Body to be added as a hyphenated cosponsor on the following three bills, if this the appropriate time.

PRESIDENT:

Sure.

PRESIDENT:

Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you, Mr. President. I have a couple of housekeeping matters. Would this be an appropriate time to take care of them? Sponsorship and one other.

PRESIDENT:

Indeed, it would, yes.

SENATOR NETSCH:

Thank you. I wanted to have the record show that one of the...Senator Rigney, if you would just be alerted to this. One of the bills, Senator Rigney, that we held in committee, Senate Bill 748, was not on the list to go to subcommittee and I think appropriately it should have, to the Tax Relief Subcommittee. So, I would just simply ask that the record reflect the fact that Senate Bill 748, which is Senator Zito's bill, will be for our purposes referred to the Tax Relief Subcommittee with all of the other bills. So, its status basically will not change except it will go to subcommittee rather than just be held.

PRESIDENT:

All right, the record...record will so reflect.

SENATOR NETSCH:

All right, and...then two other matters, if...I would also ask leave of the Body to be shown as a hyphenated co-sponsor, with the original sponsor's permission, who is Senator Rigney, on Senate Bill 1050.

PRESIDENT:

All right, the lady seeks leave of the Body to be added as the hyphenated cosponsor on Senate Bill 1050. Without objection, leave is granted. Senator Netsch.

SENATOR NETSCH:

And one other piece of housekeeping business, Mr. President. Senate Bill 102 of which I was the original sponsor, I

would ask leave of the Body to change that sponsorship to Committee on Revenue so that the...the bill will be shown as a committee bill, Senate Bill 102.

PRESIDENT:

All right, Madam Secretary, that's on page 3 on the Calendar. You may want to make a note. Senator Netsch seeks leave of the Body to have the sponsorship on Senate Bill 102 shown as the Senate Committee on Revenue. Without objection...or is there objection? Senator Davidson, for what purpose do you arise?

SENATOR DAVIDSON:

Just a question. She said the Senate Revenue Committee and I did not hear the minority spokesman on Revenue concur with that recommendation. I would like to know if the minority spokesman on Revenue concurs that this should become a committee bill.

PRESIDENT:

You are correct. Take it out of the record. Senator Zito, for what purpose do you arise? Senator Zito, for what purpose do you arise?

SENATOR ZITO:

Not to red flag one of my bills, Mr. President, but Senate Bill 749 has picked up four...three Republican cosponsors. I'd like to ask leave to add them, Senator Schaffer, Senator Friedland and Senator Karpiel, Senate Bill 749.

PRESIDENT:

All right, gentleman seeks leave of the Body to add Senators Friedland, Karpiel and Schaffer to...as cosponsors...749...749, thank you. Without objection, leave is granted. Senator Severns, for what purpose do you arise?

Thank you, Mr. President. I'd like to seek leave of the Body to add Senator Woodyard as a hyphenated cosponsor to Senate Bill 892.

PRESIDENT:

All right, the lady seeks leave of the Body to add Senator Woodyard as the hyphenated cosponsor on Senate Bill 892. Without objection, leave is granted. Senator Jones, for what purpose do you arise, sir?

SENATOR JONES:

Thank you, Mr. President. I'd like to seek leave of the Body to add Senator Schaffer as a joint sponsor on Senate Bill 243.

PRESIDENT:

All right, the gentleman seeks leave of the Body to add Senator Schaffer as a cosponsor on Senate Bill 243. Without objection, leave is granted. Senator Davidson, for what purpose do you arise?

SENATOR DAVIDSON:

Mr...excuse me, Mr. Chairman, I have checked with the minority speak...spokesman on Revenue and I withdraw my objection on the request by Senator Netsch for the Revenue Committee to become the sponsor instead of her...Senate Bill 102.

PRESIDENT:

All right, Senator Netsch has sought leave of the Body to show Senate Bill 102, which is on page 3 on the Calendar, under the sponsorship of the Senate Revenue Committee. The objections have now been withdrawn. Without objection, leave is granted. It's so ordered. Committee reports.

SECRETARY:

Senator Savickas, chairman of the Committee on Assignment of Bills, reports the assignment of the following House bills to committees:

Judiciary - House Bill 615; Local Government - House Bill 803; Public Health, Welfare and Corrections - House Bill 674; and Transportation - House Bill 390.

PRESIDENT:

Senator Watson, for what purpose do you arise? SENATOR WATSON:

Thank you, Mr. President. Recalling your statement from yesterday concerning 2nd reading and noncontroversial bills, when will we be going to that order of business?

PRESIDENT:

Soon as you're ready. You got a bill?

SENATOR WATSON:
Yes, sir.

PRESIDENT:

Give me the number.

SENATOR WATSON:

129.

PRESIDENT:

All right, with leave of the Body, we'll move to the Order of Senate Bills 2nd Reading. On the top of page 4 is Senate Bill 129. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 129.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDENT:

3rd reading. Senator Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, Mr. President, yesterday inadvertently I took Senate Bill 710 and gave it to Senator Fawell. Inadvertently it was a bill that I had made a mistake...is Senator Fawell on the Floor?

PRESIDENT:

She's on the Floor, Senator Sam.

SENATOR VADALABENE:

And I was wondering if I could have that bill back. It was an honest mistake and I would like to maintain the sponsorship of that bill; however, it's in the posture of...of Senator Fawell's ownership now and I wonder how I handle that with such a loving person as Senator Fawell.

PRESIDENT:

Senator Fawell.

SENATOR FAWELL:

Sam, you can have anything you want.

PRESTDENT:

Senator Sam.

SENATOR VADALABENE:

Wait till I get well.

PRESIDENT:

All right, the gentleman...

SENATOR VADALABENE:

...what's the procedure for that?

PRESIDENT:

...the gentleman seeks leave of the Body to be shown as the chief sponsor on Senate Bill 710...hyphenated cosponsor with Senator Fawell. Without objection, leave is granted. Senator Alexander, for what purpose do you arise?

SENATOR ALEXANDER:

Thank you, Mr. President. I would be...like to be...entered as a hyphen cosponsor...to...Senate Bill 843.

PRESIDENT:

All right, the gentleman seeks...the lady seeks leave of the Body...to be added as the hyphenated cosponsor on Senate Bill 843. Without objection, leave is granted. Senator Madigan, for what purpose do you arise?

SENATOR MADIGAN:

Mr. President, I have a similar request as Senator

Watson...on 2nd reading.

PRESIDENT:

Sure,...whatever Senator Watson wants, that's what we're going to do today.

SENATOR MADIGAN:

On Senate Bill 929. Page 22.

PRESIDENT:

All right, top of page 22, with leave of the Body, we'll move to the Order of Senate Bills 2nd Reading, Senate Bill 922. Read the bill...929, I guess. Read the bill, Madam Secretary. Read the bill, Madam... beg your pardon, we can't find it. Too many bills.

SECRETARY:

Senate Bill 929.

(Secretary reads title of bill)

2nd reading of the...bill. No committee amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDENT:

3rd reading. All right, with leave of the Body, we'll move to the Order of Resolutions. Any objections been filed to the Resolutions Consent Calendar, Madam Chairman?

SECRETARY:

No objections.

PRESIDENT:

All right, Senator Vadalabene moves that the Senate resolutions shown on the Resolutions Consent Calendar, 224, 226, 227, 228, 229, 230, 232, 234, 235, 236, 237, 238, 240; Senate Joint Resolution 48, House Joint Resolution 69, House Joint Resolution 70 and Senate Resolution 241 be adopted. All in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and the Resolutions Consent Calendar

is adopted. Senator Karpiel, for what purpose do you arise?
SENATOR KARPIEL:

Thank you, Mr. President. I'd just like leave to be added as a cosponsor on Senate Bill 483.

PRESIDENT:

All right, the lady seeks leave to be added as a cosponsor on Senate Bill 483. Without objection, leave is granted.

Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President and...Ladies and Gentlemen of the Senate, with your leave, I would like to be added as an...as a. hyphenated cosponsor to Senate Bill 990.

PRESIDENT:

All right, the lady seeks leave to be added as a cosponsor on Senate Bill 990. Without objection, leave is granted. Senator Welch, for what purpose do you arise, sir?

Mr. President, I'd ask leave to be added as a cosponsor to Senate Bill 275 and 276.

PRESIDENT:

All right, the gentleman seeks leave of the Body to be added as a cosponsor on Senate Bills 275 and 276. Without objection, leave is granted. Senator Smith, for what purpose do you arise?

SENATOR SMITH:

Thank you, Mr. President. I'd ask leave to be added as a hyphenated sponsor to Senate Bill 100.

PRESIDENT:

All right, the lady seeks leave of the Body to be added as the hyphenated cosponsor on Senate Bill 100. Without objection, leave is granted.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Resolutions.

SECRETARY:

Senate Joint Resolution 50 offered by Senator Rock.

(Secretary reads SJR 50)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

I would move that we suspend the appropriate rule for the purpose of the immediate consideration and adoption of this joint resolution. It is the adjournment resolution. Senator Davidson, would you check with your leader?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock moves to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 50.
