Consent Calendar. If I can have your attention, I discussed with Senator Philip a little earlier, today we will be on the Order of 2nd Reading and go right through the Calendar in order. Tomorrow morning at nine we have the Executive Committee, so it's been suggested that we start at eleven o'clock tomorrow morning. At noon, of course, we have the Joint Session for the purpose of receiving and listening to

Secretary of Education Bennett and then we will reconvene in Session immediately after that joint session and joint address. Thursday morning is the Prayer Breakfast so we will start Session at nine-thirty hoping to accommodate the...I beg your pardon...all right, it's been suggested that ten might be more appropriate, that's fine, to accommodate those who will be in attendance at the Prayer Breakfast and I have requested of the appropriations' people that we hold the appropriation amendments until Thursday. The House is scheduled to be in on Friday and Monday, it is my judgment that we have...we...we do not have to be in. So that what we will do on Thursday, I hope, is amend the appropriation bills or discuss the amendments and adopt them or not adopt them and then...at the conclusion of that order of business, just go home until next Tuesday. SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Amendment No. 1, the committee amendment, becomes

the bill and it makes five changes with respect to the Illinois Tax Increment Financing Law. It establishes a special fund in the State Treasury for the repository of this money. It calls for a one-time review of existing and future TIF districts by the Department of Commerce and Community Affairs. It attempts to place a cap on the amount that will be available for these municipalities by virtue of limitations on the area and the sales tax percentage that's generated within that area. It reduces the state's contribution over a number of years and it adjusts the calendar year so that the Department of Revenue can better estimate and the municipalities will have more certainty as to the amount they are to receive. This amendment is a...the result of literally weeks of negotiations between the Office of the Governor and the Department of Revenue and the members of the Illinois Tax Increment Association. I am aware of the fact that those negotiations are still continuing, but I would ask that the amendment be adopted and I am prepared to call it back at some future date if necessary to again reflect the negotiations that are ongoing, and I would move the adoption of Amendment No. 1.

SENATOR JACOBS:

Amendment No. 1 was requested by the Illinois Credit Union League. The material being deleted was proposed in the bill and there's no existed law being changed in the amendment. What it does it removes the proposed limited liability for directors and offices,ask for your support.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Jacobs has moved the adoption of Committee Amendment No. 1 to Senate Bill 1603. Discussion? If not, those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Further committee amendments?

SENATOR HAWKINSON:

Thank you, Mr. President. Senate Bill 1611 deals with the rights of grandparents and visitation. The amendment was a restricting amendment offered at the behest of the Illinois State Bar Association, was adopted in committee, and I'm in support of the amendment and would urge its adoption. The...the amendment...the original bill would have prohibited visitation outside the home and I struck that language "without the consent of the...the parents," and so it limits the scope of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR SAVICKAS:

What was the drafting error?

The drafting error was that it referred to two Acts instead of one. The amendment was intended for...only for the clinical social workers and the...and the committee amendment addressed the social workers as well as clinical social workers, and that reason why I'm Tabling that amendment.

SENATOR DeANGELIS:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR DeANGELIS:

Senator Jones, that committee amendment was the bill. Are you going to offer another amendment now to replace it?

SENATOR WOODYARD:

Thank you, Mr. President. Committee Amendment No.
1...the bills deals with some clean-up language as far...it's
part of a package...JCAR, it deals with definition of domi-
cile of a serviceman in the State of Illinois. It's purely a
technical cleanup. Evidently, we left some language out of
the Revenue Act of 1987, this simply codifies what we're
doing presently. There is no change whatsoever...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Thank you, Mr. President. 1707, another JCAR bill, and it's a JCAR amendment which eliminates language in the bill that...that mandates the Department of Public Aid to devise standards governing reimbursements, and I move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)
