he's Tabling.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. We have now...all right. Senator Marovitz has moved to rerefer Senate Bill 1343 from the Order of 2nd Reading and have that bill...returned to the Order of...Committee on Transportation. Those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. 1343 will be returned to the Order of the Transportation Committee. All right. Senate Bill 1346 and Senate Bill 1347, let's take them one and...Senate Bill 1346, Senator Marovitz has moved to rerefer that bill off the Agreed Bill List on the Calendar to the Committee on Judiciary. Is leave granted? Leave is granted. So ordered. And Senate Bill 1347...Senate Bill...is on...on the Order of 3rd Reading in the Senate and Senator Marovitz has moved that that bill be referred to the Committee on Judiciary. On the Order of Senate Bills 3rd Reading is Senate Bill 434. All right, Senate...take it out of the record. Senate Bill 453, Senator Etheredge. Oh, that's a recall. Senate Bill 453. Okay, on the...Senator Etheredge seeks leave of the Body to return Senate Bill 453 to the Order of 2nd Reading for the purpose of...an amendment. Is leave granted? Leave is granted. On the Order of Senate Bills 2nd Reading is Senate Bill 453, Mr...Madam Secretary.

SECRETARY:

Senator Hall offers Amendment No. 5.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge...all right, Senator Hall. I beg your pardon, Senator Hall.

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is just a technical amendment. It did not do what we thought it was and that's the reason that we have to take the action we're taking right now, and we've discussed it with Senator Etheredge and the others on the other side.

All right, discussion? If not, the question is, shall Senate Bill 580 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 580 having received the required constitutional majority is declared passed. All right, with leave of the Body, we will jump back and pick up...with intervening business having occurred, we'll pick up 453. Is leave granted? Leave is granted. On the Order of Senate Bills 3rd Reading is Senate Bill 453, Madam Secretary.

SECRETARY:

Senate Bill 453.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President and members. This is the supplemental appropriations bill. It would appropriate a total of a hundred and fifty-three million a hundred and forty-four thousands of dollars for FY '87. Of that figure, approximately a hundred million six hundred thousand is GRF and fifty-two million five hundred thousand is in other funds.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Bill 453 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Senator Schaffer.

SENATOR SCHAFFER:

This is a good bill for all of us balanced budget people. This is the General Obligation Bond Act as introduced at eight hundred and twenty-seven million and eight hundred thousand dollars. The Senate reduces it to nine dollars, a budget reduction of eight hundred and twenty-seven million nine hundred and ninety-nine thousand nine hundred and ninety-one dollars. How's that for fiscally conservative?

Don't put the press release out, it may change later in the game. We're just sending it over to the House and an agreed figure will be arrived at in the latter stages of this Session.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, discussion? If not, the question is, shall Senate Bill 778 pass. Those in favor will...will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll...I'm sorry, Senator Hall.

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen of the...the next nine bills that we have before us are bills that Senator Maitland and Etheredge and Carroll and Hall have...they're simply vehicle bills since we have no way of knowing what action the House may take. So, it's necessary for us to have these available. So, I'll start out with 783, as you say,...Mr. President,...you want to talk with me? Oh, okay. And I move that 783, an Act making appropriation to Department of Commerce and Community Affairs to the...I move for the...for the passage of this bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, the question is, shall Senate Bill 783 pass. Those in favor will vote Aye. Those opposed will vote Nay.

Discussion? Question is, shall Senate Bill 784 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Discussion? I'm sorry. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays are none, none voting Present. 784...Senate Bill 784 having received the required constitutional majority is declared passed. Senator Raica, for what purpose do you arise?

SENATOR RAICA:

A point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

State your point.

SENATOR RAICA:

Mr. President and members of the Senate, with us in the gallery we have an individual who's the director of Research and Development for the Chicago Fire Department, Mr. Frank Gagliardi and his family. Frank, would you please rise and be recognized by the Senate.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...welcome to Springfield. On the Order of Senate Bills 3rd Reading is Senate Bill 785, Madam Secretary. Read the bill.

SECRETARY:

Senate Bill 785.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Hall.

SENATOR HALL:

I would ask for the same roll call for Senate Bill 785. It's a vehicle bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Question is, shall Senate Bill 785 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53...all right, let's...have all voted who wish? Have all voted who wish? Have all voted who wish? Senator Luft. Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are none, none voting Present. Senate Bill 785 having received the required constitutional majority is declared passed. Page 29, Senate Bill 835. On the Order of Senate Bills 3rd Reading is Senate Bill 835, Madam Secretary.

SECRETARY:

Senate Bill 835.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Maitland.

SENATOR MAITLAND:

Thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 835 appropriates a hun-

PRESIDING OFFICER: (SENATOR DEMUZIO)

Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 45, the Nays are 3, 1 voting Present. Senate Bill 835 having received the required constitutional majority is declared passed. On the Order of Senate Bills 3rd Reading is Senate Bill 836, Madam Secretary.

SECRETARY:

Senate Bill 836.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Maitland.

SENATOR MAITLAND:

Thank you, very much, Mr. President. Senate Bill 836 appropriates one hundred dollars to the Department of Corrections.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Bill 836 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 34, the Nays are 17, none voting Present. Senate Bill 836 having received the required constitutional majority is declared passed. On the Order of Senate Bills 3rd Reading is Senate Bill 837, Madam Secretary.

SECRETARY:

Senate Bill 837.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is a General Obligation Bond Act vehicle. I would ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Bill 837 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 32, the Nays are 14, 5 voting Present. All right, Senate Bill 837 having...all right, Senate Bill 837 having failed to receive the required constitutional majority of thirty-six is declared lost. Senator Maitland...or Senator Etheredge.

SENATOR ETHEREDGE:

Mr. President, I would ask that this put on postponed consideration.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Etheredge has requested postponed consideration...postponed consideration. On the Order of...of Senate Bills 3rd Reading is Senate Bill 838, Madam Secretary. Read the bill. Oh, Senator Maitland, I beg your pardon. Senator Maitland, for what purpose do you arise?

SENATOR MAITLAND:

Thank you, very much, Mr. President. Just a...just a comment, if you would. I think Senator Hall clearly articulated what these bills were supposed to do and the purpose of their introduction. Now we supported on this side of the aisle totally those vehicle bills that bore the name of

Democratic sponsors, and I guess we would have appreciated the same thing from this side of the aisle, and I'm somewhat taken back by the fact that the last three bills have...have received a number of...of negative Democratic votes.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall.

SENATOR HALL:

Well, Senator Maitland is absolutely correct. We...the only reason that we had...this was an agreement that we did. As I told you that we could not be sure of what's coming over to us from the House, so this is the reason that we have these, and I would ask for a favorable support for these bills.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right,...Senator...Senator Jacobs, for what purpose do you arise?

SENATOR JACOBS:

Well, if I could, just a statement to the sponsor. I don't think it's a Democrat and Republican situation, but I know I would be hard pressed as an example to go...back to my district and explain to my people where I have a prison that I am discussing the possibility of a...putting the female prisoners in with male prisoners. I just have a problem with the terminology. It's not so much the...the fact that it's a vehicle bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, the...the bill is on the Order of Postponed Consideration...further discussion? Senator Lechowicz, for what purpose do you arise?

SENATOR LECHOWICZ:

Well, just to add to the discussion, Mr. President. Maybe we have too many vehicle bills. I...we...you know, we all know the process. We're all going be in the Conference Committee Report and the question is, how many Conference

Committee Reports do we really need in order to pass the appropriation process. A number of states only have one or...one bill, other states have two or three. Now we have more vehicles...than states having putting in...through the entire appropriation process, California and New York specifically, much larger states. So, I just think that maybe it's time that we look at the...look at our own House and say that maybe we should look at the appropriation process. I mean, you're going back and you're just...going to say well you passed a vehicle bill for a dollar or two dollars so you can, you know, have something to work along the way. It doesn't go over too well.

PRESIDING OFFICER: (SENATOR DEMUZIO)

On the Order of Senate Bills 3rd Reading is Senate Bill 838. Madam Secretary, read the bill.

SECRETARY:

Senate Bill 838.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is another one of the vehicle bills which I would ask everyone to support. I would remind you of the...the fact that there is a...there...is a bipartisan agreement to support the...vehicle. Senator Hall has referred to this agreement twice. I would ask for your favorable consideration.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Bill 838 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted

who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 27, the Nays are 16, 5 voting Present. Senate Bill 838 having failed to receive the required constitutional majority is declared lost. Senator Etheredge.

SENATOR ETHEREDGE:

I would request postponed consideration, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, postponed consideration is in order. Senator Etheredge has requested, leave is granted, postponed consideration. Senator Luft, for what purpose do you arise?

SENATOR LUFT:

I suppose as a point of observation, if that's permissible. The problem that I think that everybody is having with these vehicle bills, and I think that I am maybe second to none in having vehicle bills dealing maybe with income tax or the sales tax, but if you read the analysis of Senate Bill 838 on this Calendar, it's to the Department of Conservation for the study of the migratory habits of the Side Hill Dodger. My suggestion would be that if you're going to use a vehicle bill, try to find something that makes it more available for us to vote for, and I don't know whether these can be pulled back off of 2nd reading and make some change in the terminology or whatever, but I'd be more than willing to support you on any...kind of vehicle you want as long as it isn't something of this nature.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Hall, for what purpose do you arise?

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen. I assure you that Senator Carroll and I and with Senator Etheredge and Senator Maitland, we operated in good faith. It was...since we're all on the same appropriation committees and that's the only reason that we've done that. Now if you

notice, they have gone down the line and that was the reason. We will...after this, it may be...as said, that we ought to have some different names maybe that were given this, but the only reason that I explained is we certainly do not know what's coming to us from over there and we just called ourself working together. This was just an agreement and I think we ought to live up to our agreement.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, on the Order of Senate Bills 3rd Reading, top of page 30, is Senate Bill 839, Madam Secretary.

SECRETARY:

Senate Bill 839.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

This is a...is another one of the vehicles on which we have prior agreement. I would ask for your favorable consideration.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? All right, discussion? If not, the question is, shall Senate Bill 839 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 33, the Nays are 7, 8 voting Present. Senate Bill 839 having received the required constitutional majority is declared passed. On the Order of Senate Bills 3rd Reading is Senate Bill 840, Madam Secretary. Read the bill.

SECRETARY:

Senate Bill 840.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is another bill just like the...the others prior, another vehicle. I would request your favorable support.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall Senate Bill 840 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record.

On that question, the Ayes are 23, the Nays are 19, 6 voting Present. Senate Bill 840 having received the...having failed to receive the required constitutional majority is declared lost. Senator Etheredge.

SENATOR ETHEREDGE:

Would request postponed consideration, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge has requested postponed consideration with respect to Senate Bill 840. Postponed consideration is granted. All right, Senate Bill...the last appropriation bill on the Calendar, Senate Bill 1464, Madam Secretary. Is on...it is on page 41, Senate Bill 1464.

SECRETARY:

Senate Bill 1464.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Oh, I beg your pardon, I...I...I skipped a bill. We...we have 1464 in the record. We'll come back and pick up 1348. Okay? On the Order of 1464, Senator Hall. 1464.

SENATOR HALL:

...hold it just a minute, Mr. President. We want to confer here just a second.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Hall.

SENATOR HALL:

Would you be so kind as to hold that one, please?

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, take it out of the record. All right, with leave of the Body, we will return to Senate Bill 1348 which the Chair inadvertently skipped over. It's on the bottom of page 38, Senate Bill 1348, Madam Secretary.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 1348 is a transfer. It transfers eighty-five thousand from Personal Services and Travel...to Contractual Services and Equipment and Telephone Communications. So...I would move for its favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, the question is, shall...shall Senate Bill 1348 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays are none, none voting Present. Senate Bill 1348 having received the required constitutional majority is declared passed. All right, with leave of the Body, we have successfully or unsuccessfully, depending

upon...how you want to look at it, completed the appropriations bills on 3rd reading and we will now return to the Order of...of Senate Bills 3rd Reading from whence we left off on Friday. The first bill is on page 20. On the Order of...page...page 20 is Senate Bill 365, Senator Zito. 370, Senator Welch. On the Order of Senate Bills 3rd Reading is Senate Bill 370, Madam Secretary.

SECRETARY:

Senate Bill 370.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Thank you, Mr. President. This bill amends the Liquor Control Act in that it eliminates the prohibition against issuing liquor licenses to aldermen, members of city councils or commissions, members of the village board of trustees or members of a county board. It was felt that these individuals be...were being denied rights to have liquor licenses and participate in that particular type of a business.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, is there discussion? Discussion? If not, the question is, shall Senate Bill 370 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 38, the Nays are 11, none voting Present. Senate Bill 370 having received the required constitutional majority is declared passed.

PRESIDING OFFICER: (SENATOR SAVICKAS)

On the Order of Senate Bills 3rd Reading is Senate Bill 371, Senator Maitland. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 371.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President. Senate Bill 371 as amended I believe has the...has the approval of the opposition that we had in committee, and it does require the...the...the Citizens Utility Board...to make its report available and to report...their...activities with respect to lobbying, intervention and salaries and reimbursements. I...I think we've met all of the opposition. I would appreciate your support.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 371 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 50, the Nays are none, none voting Present. Senate Bill 371 having received the constitutional majority is declared passed. Senate Bill 377, Senator Demuzio. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 377.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

SENATOR DEMUZIO:

Yes, thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 377 is a bill that concerns itself with the Illinois Farm Development Authority which deals with the interest rates on the authority's loans and the payment of interest costs on selling loans in the

secondary market. The Farm Development Authority is in support of...of this legislation and there was an amendment that was placed on that indicated that the Governor was...required to direct the continuing appropriation. It deleted the discretionary authority required amounts in the Illinois Ag. Loan Guarantee Fund to be held to guarantee loan payments. It made other technical changes. It also required the sufficient funds be held in the Agricultural Loan Guarantee Fund which was consistent with the Act. It makes other technical changes. I would ask for your support. I know of no...no known opposition.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 377 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays are none, none voting Present. Senate Bill 377 having received the constitutional majority is declared passed. Senate Bill 378, Senator Netsch. Senator Netsch. Senate Bill 380, Senator Luft. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 380.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Luft.

SENATOR LUFT:

Thank you, Mr. President. Senate Bill 380 was introduced at the request of the township officials. It addresses a problem that exists in many downstate counties where the sheriff's department is so small that it neither has the manpower nor the time to enforce township ordinances. Senate Bill 380 allows the township to appoint an enforcement offi-

cer to serve for a period of a one-year term. The county sheriff can reject or disapprove of the appointment. It also set...sets forth other...provisions in compensation on a per diem basis that a township may offer. The enforcement officer, he or she, may not carry firearms and must undergo certain trainings as set forth in the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Senator Fawell.

SENATOR FAWELL:

Thank you, very much. May the...will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR SAVICKAS)

He indicates he will.

SENATOR FAWELL:

Does this apply to all of the counties except for Cook County?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Luft.

SENATOR LUFT:

Yes, ma'am.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Fawell.

SENATOR FAWELL:

...thank you, then to the bill. This bill does allow a...a township to hire a...an enforcement police officer. I would suggest that all of you take a good look at this bill as minority spokesman of the Local Government.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, Senator Luft may close.

SENATOR LUFT:

Thank you, Mr. President. I would just ask for a favorable roll call. This pertains only to township ordinances and it doesn't imply to any state, county or local laws, as I said, other than the township ordinances, and I would ask for

a favorable roll call.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Question is, shall Senate Bill 380 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 41, the Nays are 9, none voting Present. Senate Bill 380 having received the constitutional majority is declared passed. Senate Bill 385, Senator Poshard. Senate Bill 388, Senator Dunn. Senate Bill 398, Senator Smith. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 398.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and Ladies...Gentlemen of the...Senate. Senate Bill 398 allows school authorities to withhold information regarding the whereabouts of any victim of child abuse that is in protective...custody. It specifies that the school is to direct the person inquiring to the Department of Children and Family Services or to a local enforcement agency. The difference in the amendment and the original bill is that in the original bill information could only be dispersed to...from the parent that is suspected, but in the amendment version information can be withheld from anyone who inquires about the child in protective custody. And as I stated before, the committee was concerned about this and they aided me in correcting this bill. As I said, the original bill did not specify where to refer the person making the inquiry, but the amendment does refer the person to the Department of Children and...Services or either the local police.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 398 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are none, none voting Present. Senate Bill 398 having received the constitutional majority is declared passed. Senate Bill 399, Senator Smith. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 399.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 399 creates the Chicago Board of Education Different Tax in the Building Fund that will increase the Building Fund tax rate by the difference between the 1986 tax rate for the Chicago Board of Education bonds' principle plus interest and the tax rate that the Chicago Board of Education will use in the future to pay for the debt service on the Chicago Board of...Education bonds outstanding as of the end of 1986. The Chicago Board of Education has not sold any bonds since 1978. As time goes on, the property tax rate that is needed for the debt service on bonds that the Chicago board sold up through...1978 is declining. This decline in the tax rate needed for the debt service on the Chicago Board of Education Bond means that the total taxing power for elementary and secondary education in Chicago will decline; however, elementary and secondary education in the Chicago need at least as much total taxing power as it has now if it is to improve the education of Chicago children; thus, there

is a need for something that would allow the Chicago Board of Education to preserve its total taxing power as its debt service requirement declines and to reallocate excess taxing power from debt service to the rate limited in operation fund. The board of education debt service difference tax would do just that. This tax would increase the tax rate limit in the Chicago Board of Education Building Fund by the difference between the '86 tax needed for the debt service on all Chicago Board of Education Bonds sold before '79. The Chicago Board of Education Difference Tax would not increase the total tax rate but it does place the funds in the difference areas to be used. I...I move for a favorable vote.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Let's start with Senator Fawell.

SENATOR FAWELL:

Thank you, very much. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR SAVICKAS)

She indicates she will.

SENATOR FAWELL:

In effect, isn't this a...a...a raise of the taxes without referendum?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Smith.

SENATOR SMITH:

No, it is not.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Fawell.

SENATOR FAWELL:

Well, last week I tried to explain that, in effect, I was not going to raise the DuPage taxes and...and for some reason or other your side seemed to think that I was putting a...a...taxation without a referendum. I was doing just exactly the same thing you are doing. Your side insisted that

I was doing a taxation without a referendum. I don't understand what the difference...perhaps Senator Netsch could explain the difference to me?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Netsch doesn't feel it's her responsibility to explain it. She's seeking recognition on her own to speak to the bill. Senator Smith, do you wish to explain it?

SENATOR SMITH:

I merely would like to say to Senator Fawell that I am not discussing nothing but this one particular piece of legislation.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Further...Senator Fawell.

SENATOR FAWELL:

I notice the Taxpayers' Federation is also against this bill. So, I would suggest my colleagues take a good, long look at this before they vote for it.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Netsch.

SENATOR NETSCH:

I...I had not really...thank you, Mr. President. I had not really expected to respond to Senator Fawell. I think there is a difference though. If I understand this bill and that is certainly the way we understood it in the Revenue Committee, there is no increase in the total authorized taxation to the Chicago Board of Education. It has to do with a lessening of the amount that would be extended for one purpose, and in a sense, a...just picking up of that gap in order to...that it would not be lost. In a sense, without this, there would actually be a decrease in the available property tax authorization for the Chicago Board of Education. So, I think it is fair and accurate to say, and I believe this is what Senator Smith said, that there is, in fact, no increase in authorized taxation with or without

referendum that is provided by this bill. In that sense, I think it is different from that which Senator Fawell had proposed last week...and we supported it on that basis in the Revenue Committee.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Does that conclude your remarks? Senator Schaffer.

SENATOR SCHAFFER:

I...I think only second to Senator Berman, that was nicely done. The bottom line is that if the bill passes and is signed into law, thirteen million dollars more will be taken out of the pockets of the property taxpayers in the City of Chicago. Now I don't happen to live in the City of Chicago. I don't happen to represent the City of Chicago. If there's no one here who does represent the City of Chicago who is concerned about that, I'll vote for it, but if there is concern in the City of Chicago about a thirteen million dollar increase in property taxes, if someone from Chicago would say so, I'll think about not voting for it. It's your city. We want to help you and if you guys want thirteen million more in property taxes and no one...not one word is raised in opposition, I don't see how we can't help but go along with you.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Fawell, for a second time.

SENATOR FAWELL:

Thank...thank you, very much, and I apologize for raising...for a second time, but I would like to tell my colleagues that exactly...exactly what is happening now was exactly what DuPage wanted. We had paid for our jail. It was not going to cost one cent more to put that levy on...you saw fit not to vote for that. I would ask my colleagues not to vote for this. What's good for the goose is good for the gander.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Dudycz.

SENATOR DUDYCYZ:

Thank you, Mr. President. Since Senator Schaffer was looking for someone from Chicago to speak out against it..or speak for it, well, I, for one, would like to look forward to my taxpayers in my district receiving a property tax rebate and I'm going to vote No and I'm going to urge everybody, at least on this side, to join me voting No and let some of my property tax owners get some relief.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, Senator Smith may close.

SENATOR SMITH:

Thank you, Mr. President and members of the Senate. I think they have got the wrong idea. This is merely a fund that is already available, but if we do not use this fund, it will decline in its value. It will help the...Board of Education to preserve the taxing power it has for debt service requirements and reallocate the excess taxing power to the operating funds which is Education and Building Fund where there is a tremendous need. Our schools in the City of Chicago, the children need it and because of somebody's...something about a jail or something like that, I don't see why we should deny our children in the...City of Chicago or anywhere from being able to help themselves in their school buildings, the repairs and...and materials and things that they need. We cannot get enough money from the state. The state is cutting down. Here's an opportunity for the Board of...Education to help themselves by preserving a tax fund that is declining and I ask your...favorable vote and support in this. Let us not think in terms of...what's good for the goose, what's good for the gander. I'm thinking in terms of the betterment of our young people who are dependent upon us for their future. So, I'm asking for a

SENATOR SMITH:

Put it in...

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Smith seeks leave to put it on postponed consideration. Hearing no objection, leave is granted. Senate Bill 400, Senator Luft. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 400.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Luft.

SENATOR LUFT:

Thank you,...thank you, Mr. President. Senate Bill 400 is a credit card interest rate disclosure bill. It's designed to provide the consumer in the state with the...available information to, hopefully, allow them to find a better rate on their credit cards. There are three major parts of the bill. The first...that requires the Attorney General to collect from credit card issuers and retail sellers the annual percentage rate of interest, membership fees and grace period length that such...and disseminate such information to the public upon request. In other words, he is a depository for all information to be so supplied. It also demands that the insurer...issuers are required to disclose on applications or on accompanying literature, an account solicitation and/or periodic billing statements, the

APR and whether the APR is variable, annualized membership fees or participation fees, the length of the grace periods, transaction fees assessed and late payment charges. It further requires insurers to file with the AG their...or Attorney General their APR membership or participation fees and the length of any grace period which are then being generally offered. Impose a business offense for failure to comply and such information must be sent to the AG within sixty days of the effective date of this Act. The language is specified in the bill which has to be on all applications and all billings.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Senator Keats.

SENATOR KEATS:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Having worked with Senator Luft and Senator Zito on this bill, if you really do believe in the informed consumer making an intelligent decision, this makes the information available. Rather than government mandating programs, this says to someone, here is any information you might need, you may be informed by reading it and then you may make whatever intelligent choice you decide. This is classic consumer legislation to benefit those consumers who are concerned enough to take the time to make an intelligent decision.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? Senator Zito.

SENATOR ZITO:

Thank you, Mr. President and members. Senate Bill 400, as a cosponsor, I can tell you is a product of a great deal of meetings and input to the subject not only of capping interest rates on credit cards but the immediate urgency to provide the consumers in Illinois an opportunity to compare...or comparatively shop, I should say, for credit cards to find the best rate and the best card suited to their

needs. Senate Bill 400 provides several provisions which will, I think, adequately address the urgency of the issue. Senate Bill 400 will provide that anybody doing business with credit cards in the State of Illinois disclose not only on their applications but on your monthly billing statement that this information will be available at the Attorney General's Office. To pass Senate Bill 400 successfully, I can tell you, my colleagues, that we will be the first state in the union to have disclosure measures in law in Illinois. No other state in the union has this type of legislation. I think it's a great step forward for the consumers in this state and I strongly urge the adoption of Senate Bill 400.

Senate Bill 407, Senator...for what purpose Senator Smith rise?

SENATOR SMITH:

Thank you, would you please register me for voting for Senate Bill...what was that..

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Smith indicates...

SENATOR SMITH:

...400, please...I wasn't at my desk.

PRESIDING OFFICER: (SENATOR SAVICKAS)

...if she pressed the right button, she would have voted for Senate Bill 400. Let the record so show. Senate Bill 407, Senator Woodyard. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 407.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Woodyard.

SENATOR WOODYARD:

Thank you, Mr. President and members of the Assembly. Senate Bill 407 is in...was in response to some of the problems that...have evolved because of the day-care centers particularly in rural areas, and in working with Department of Child Family Services who drafted the amendment, we now define a group day-care home as a home that receives more than three but up to a maximum of twelve children...that includes the family's natural or adopted children under the age of twelve, and this does seem to somewhat alleviate the problems that...that we find in the rural areas particularly in the small communities in which there may only be one day-care home in that entire town, and I would encourage your support for Senate Bill 407 or be glad to answer any questions.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 407 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 407 having received the constitutional majority is declared passed. Senate Bill 408, Senator Demuzio. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 408.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio wishes to take it out of the record. Senate Bill 412, Senator Kustra. Senate Bill 413, Senator

Jones. Senate Bill 418, Senator Zito. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 418.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Zito.

SENATOR ZITO:

Yes, thank you, Mr. President and members. Senate Bill 418 as amended is the rewrite of the Illinois Pharmacy Practice Act. I understand that there are still negotiations going on, but in the spirit of time, we'd like to move Senate Bill 418 and address those concerns in the House...the amendment that we adopted last week, the Floor amendment, was pretty close to a compromise position. I understand that they're still working, and rather than delay the process, I would ask that Senate Bill 418 be sent to the House, and if any further input is needed, they can address it through the amendment form at that Chamber. I'd ask for its adoption.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. I'd like to acknowledge the fact that I may have a conflict of interest but this would be a great green vote. Thank you.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, the question is, shall Senate Bill 418 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 50, the Nays are none, 1 voting Present. Senate Bill 418 having received the constitutional majority is declared passed. With leave of the Body, we'll return back to Senate

Bill 412 for Senator Kustra. Hearing no objection, leave is granted. On the Order of Senate Bills 3rd Reading, Senate Bill 412. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 412.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. President and members of the Senate. Senate Bill 412 is an attempt to deal with the interest which is assessed for the underpayment of sales taxes. There have been numerous attempts to do this in the past; in fact, we passed a bill last year or the year before which provided for an interest rate penalty of 1.25 percent per month or fifteen percent per year. The problem with that is that we always have to come back in and adjust the interest rate to whatever the current market rate is. What this bill does is change that system so that the interest rate is pegged to what the IRS has identified the current market rate to be. That will eliminate the need for us to come back here year after year and do this. This is a proposal of the Illinois State Chamber of Commerce and I would urge your favorable consideration.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Let's start with Senator Rigney.

SENATOR RIGNEY:

Yes, a question of the sponsor.

PRESIDING OFFICER: (SENATOR SAVICKAS)

He indicates he'll yield.

SENATOR RIGNEY:

Where would that put the interest rate at the present time?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

The...the prime is eight and a quarter, Senator Rigney.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rigney.

SENATOR RIGNEY:

Does this give some late payer the prime rate?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

No...no, it does not give them the prime rate, it...it's...it's a rate established for each calendar quarter under Section 6621 of the...Internal Revenue Code and the...the Internal Revenue Code has identified an underpayment rate.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rigney.

SENATOR RIGNEY:

Well, I'm...I'm just wondering how then it relates to the prime...my problem is,...the present rate was reduced from twenty-four down to fifteen last year, and I had the understanding that maybe this was going to bring it down around nine percent. Is that correct?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

Nine percent or the adjusted rate and I think that right now is about twelve percent.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rigney. No further questions? Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President. Will the sponsor yield to a

question?

PRESIDING OFFICER: (SENATOR SAVICKAS)

He indicates he will.

SENATOR LECHOWICZ:

What's the revenue loss for the state with the passage of this bill?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

The Department of Revenue has never indicated what the revenue loss is.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Lechowicz.

SENATOR LECHOWICZ:

My second question, does this apply to counties as well?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

It's the state sales tax.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator...Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. I would point out a couple of things. One is that there is another bill on the Calendar which addresses the problem of equalizing the interest rates but does it at a...a different level and at a flat rate. That bill, as I recall, was voted out of the Revenue Committee unanimously, this one was not in part because the Department of Revenue did register opposition to this bill, and my recollection is that their concern was not just the nine percent but also the floating rate which they found to be probably a fairly difficult thing to live with and creating a little bit of chaos. So, I think the...the best judgment...although, admittedly, this bill was voted out also by

the committee, I think the best judgment of many of us was that it ought not to be a floating rate, at least not for this particular provision and that it made just as much sense to equalize it at something above nine percent. That would be consistent with the action that was taken during the last Session as well. So, while I agree with the principle of trying to find a way to resolve this problem, it is my feeling that this is not the best way, and I, for one, will oppose the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Further discussion? If not, Senator Kustra may close.

SENATOR KUSTRA:

Thank you, Mr. President. To answer Senator Netsch, it looks like the rates are going up again, so we're just going to be back in here doing this all over again. I think the Illinois State Chamber of Commerce has come up with a reasonable approach to dealing with a problem that is going to come back at us every year, at least every other year. The Department of Revenue's objection seems to be based only on the fact that in previous years we've pegged it at a certain rate, but, as I said, if we can come up with a solution that pegs it to the Internal Revenue Code, I mean, it's not like we're creating our own formula here, all we're doing is playing off the Federal Government's evaluation of what should be the underpayment rate. I would ask for your favorable consideration.

PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall Senate Bill 412 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 47, the Nays are 4, 1 voting Present. Senate Bill 412 having received the constitutional majority is declared passed. Senate Bill 421, Senator Demuzio. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 421.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

SENATOR DEMUZIO:

Thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. 421 is a...another bill that deals with the Illinois Farm Development Authority Act and makes various changes; one, clarification was at the recommendation of the Auditor General. The Illinois Farm Development Authority pays salaries to its employees through fees that's generated by the authority and there is a need for clarification at the recommendation, as I've indicated, of the Auditor General. The financial industry in Illinois has recommended the clarification as to the length of time for the payment schedule on the...what's...that the current law did not stipulate as a cap on the length of time for payment. I don't know of any opposition. It's supported by the Illinois Farm Development Authority, the Farm Bureau and I'd be glad to answer any questions if anyone has any.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 421 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 421 having received the constitutional majority is declared passed. Senate Bill 422, Senator Karpiel. Senate Bill 423, Senator Marovitz. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 423.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Marovitz.

SENATOR MAROVITZ:

Thank you, very much, Mr. President and members of the Senate. Senate Bill 423 modernizes the...process for small estate affidavits. It was recommended by both bar associations and the chief charge of the probate division of...of Cook County. The affiant of a small estate affidavit will be considered to be transacting business in Illinois. The affiant would include a statement that by mailing the affidavit, the fine is transacting business in Illinois and, in effect, this would...this would make it easier to get a long arm jurisdiction over a nonresident...affiant. There was some concern expressed in the committee regarding an indemnification provision that was taken out. Because of the committee's concern, we put that back in, so there is indemnification. I would ask for a...I know of no opposition to the bill and I would ask for an affirmative roll call.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 423 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 52, the Nays are none, none voting Present. Senate Bill 423 having received the constitutional majority is declared passed. Senate Bill 426, Senator Maitland. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 426.

{Secretary reads title of bill}

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Maitland.

SENATOR MAITLAND:

Thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 426 introduced by Senator Demuzio and myself was a bill introduced originally to deal with...with reorganization in some small rural school districts and we found that we weren't going to need that bill for that purpose and so we chose to use it to...to accommodate the needs of the Blue Ribbon...the Blue Ribbon Committee on the Improvement of Teaching as a Profession, a committee that I served on and Senator Berman served on from this Body. It was a committee that dealt with the...with the studies of the Carnegie Report and the Holmes Report that dealt with the future of teaching, and some of those recommendations were...from that committee needed to be legislative items and we have amended into Senate Bill 426 three different components of that legislation. Let me describe them for you very briefly. The first part allowed the State Board of Education to establish pilot programs for teachers relating to clinical schools, restructuring the teaching work place and providing support and assistance for beginning teachers. Secondly, it...it extends for two years the program...a pilot program that's already in place to study teacher career compensation. That's an issue that's been debated in this Body from time to time and this merely extends that pilot program. And finally, it consolidates all the consolidated...the consolidation...the...it consolidates all scholarship programs that we've enacted the last two or three years with respect to teaching, involving...minorities in the shortage areas and a number of other areas, and I would appreciate your support of Senate Bill 426.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 426 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Woodyard.

SENATOR WOODYARD:

Thank you, Mr. President and members of the Senate. Senate Bill 432 deals with the designation of historic sites and basically the bill says that a site cannot be designated by the council if the owner of that site is in opposition to that. Under present law, we find that...that those sites can be designated without the owner's permission. So, this bill was introduced in response to some of the problems evolving from that...those sites owned by people who did not wish to have them designated. Be glad to answer any questions.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 432 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 432 having received the constitutional majority is declared passed. Senate Bill 438, Senator Fawell. Senate Bill 443, Senator Kustra. Read the bill, Madam Secretary...Mr. Secretary.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. President and members of the Senate. This is a bill which has been requested by the Illinois State Scholarship Commission regarding the Illinois Guaranteed Loan Program. Basically that program involves loans made by private lending institutions which are guaranteed by the state but they are...reinsured and sometimes reimbursed by the Federal Government. A recent Federal law requires the Illinois State Scholarship Commission and, for that matter, all other loan guarantors to permit the participation of out-of-state lenders in its loan program. Were we not to change our laws thus allowing these out-of-state lenders to participate in the program, Illinois would be at a competitive disadvantage. About twenty other states have already taken the action that I would ask us to take today, and I'd ask for your favorable consideration.

Is there discussion? If not, the question is, shall Senate Bill 443 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 443 having received the constitutional majority is declared passed. Senate Bill 451, Senator O'Arco. Senate Bill 454, Senator

Senator Dunn.

SENATOR TOM DUNN:

...thank you, Mr. President. This bill would create theft by deception when an offender obtains at least five thousand dollars from a victim who is at least sixty years of age, and it becomes a nonprobational Class 2 Felony.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 469 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 47, the Nays are 2, none voting Present. Senate Bill 469 having received the constitutional majority is declared passed. Senate Bill 470, Senator Dunn. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 470.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Dunn.

SENATOR TOM DUNN:

Thank...thank you, Mr. President. This bill would provide that the PTAB would be prohibited from acting on any petition until a local board of review has filed proof of service of the petition on affected taxing districts.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall

Senate Bill...Senator Netsch.

SENATOR NETSCH:

Well...thank you, Mr. President...I was just going to say that I think that in the form in which it is, the bill achieves Senator Dunn's purpose very adequately and will not at the same time cause havoc in the assessment process. So I think it is more than adequate as it is.

PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall Senate Bill 470 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are 1, none voting Present. Senate Bill 470 having received the constitutional majority is declared passed. Senate Bill 473, Senator Karpel. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 473.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Karpel.

SENATOR KARPIEL:

Thank you, Mr. President. 473 simply puts back into place the levy for municipalities for their ESDA programs. When we passed the county sales tax bill, what was it two years ago, I believe, inadvertently the language which took away their levy for ESDA also took away the municipality's levy and this simply...puts it back into the Statute.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? Senator Demuzio.

SENATOR DEMUZIO:

Senator Karpel, I'm sorry I didn't hear the explanation. This would authorize the municipality to levy a five-cent property tax for emergency services and disaster operations

and would limit the amount collectible no more than twenty-five percent per capita...is this a Municipal League legislation and is this another tax increase without referendum?
PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Karpiel.

SENATOR KARPIEL:

No, this is not another tax increase without legislation. The municipalities had this all along and when Public Act...84-163 passed, which was the county sales tax, legislation passed a couple of years ago, inadvertently...this levy which was taken away from the counties, inadvertently they also took it away from the municipalities. That was not the intention of the legislation and this is simply putting it back into the Statute. I have a letter here from the Taxpayers' Federation, they are supporting this legislation because it was a mistake and, you know, there was no intention to take it away from the municipalities.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Demuzio.

SENATOR DEMUZIO:

Well, I don't disagree with what you're...what you're saying and that is that the...it's my understanding also that this legislation was introduced at the request of the Taxpayers' Federation but, nevertheless, the reinstatement of the...of the power is a nonreferendum power which affords the corporate authority the ultimate responsibility and obligation to levy...to levy the tax. So, theoretically, I suspect my answer has been...the question to my answer is...is...the answer to my question is, in fact, it is. Thank you.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. I was going to add simply that

I...I rise in support of Senator Karpel's bill. I think it is absolutely correct that was accidentally removed and this is literally...correcting an error that was made and not adequately corrected last Session.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, the question is, shall Senate Bill 473 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 40, the Nays are 8, 1 voting Present. Senate Bill 473 having received the constitutional majority is declared passed. Senate Bill 478, Senator Etheredge. Senate Bill 480, Senator Fawell. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 480.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Fawell.

SENATOR FAWELL:

Thank you, very much, Mr. President. This is an agreed bill between the Supreme Court and the clerk of my county and all it does is puts us in the same position as Cook County, and it allows us to get rid of some of these old traffic tickets at the end of three years rather than seven and a few other records that they agreed to.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 480 pass. Those in favor...Senator Kelly.

SENATOR KELLY:

Yes, Mr. President, I'd like to, with leave of the Body, ask a question about the...what type of records...you're saying you're changing it from seven to three years. What

records are these...if you'd go over that again, please.

PRESIDING OFFICER: (SENATOR SAVICKAS)

...Senator Fawell.

SENATOR FAWELL:

Yes, that particular record that I'm speaking of is traffic tickets. We just...like Cook County destroys them at the end of three years...this allows my clerk to do the same. And there are other...certain other records that can be...can be destroyed after they have been photographed.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Kelly.

SENATOR KELLY:

Yes, Senator Fawell, that second part of your statement is the one that interests me when you say other..what other thing besides these violations are we talking about? What are these documents that we're lowering the period from seven years to three years on? I'd like to know what they are.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Fawell.

SENATOR FAWELL:

All right. If you'd...want me to read them. Forceable entry in detainer cases; all records of forceable entry in detainer cases may be destroyed three years after final judgment or disposition of the case; nonrecord materials, handwritten or computerized daily court sheets which are five years old or older may be destroyed; minute books may be...destroyed five years after last entry of the book, contract cases whenever judgments are entered by confession or otherwise in cases of arbitration, cases in tort and plevin...distress for rent, habeas corpus records, criminal items E through I may be destroyed three years after judgment or disposition of the case whenever in common law has been preserved on photogenic...microphotogenic or electronic process, inheritance tax proceedings may be destroyed seven years

after final judgment or disposition of the case, felony records may be destroyed six years after final judgment or disposition of the case or five years after a finding of not guilty or dismissal, juvenile records may be destroyed twenty-one years after final disposition...you want me to go on...of the case. All this...misdemeanor records and those preliminary hearing records which have not been made part of the felony file may be destroyed...

PRESIDING OFFICER: (SENATOR LUFT)

...Senator...Senator, would you excuse me one moment, please? Senator Kelly, for what purpose do you seek recognition?

SENATOR KELLY:

Senator, it's too early in the week to be harassing you. I don't intend to do that but I just wanted a couple of brief statements. You don't have to go on, I'll...I'll support your proposal.

PRESIDING OFFICER: (SENATOR LUFT)

Further discussion? Further discussion? Senator Fawell to close.

SENATOR FAWELL:

I just ask for a favorable vote.

PRESIDING OFFICER: (SENATOR LUFT)

All right. The question is, shall Senate Bill 480 pass. Those in favor vote Aye. Those opposed...vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, Mr. Secretary. On that question, the Ayes are 52, the Nays are none and none voting Present, and Senate Bill 480 having received the required constitutional majority is declared passed. On the Order of 3rd Reading, Senate Bill 483, Senator Etheredge. Read the bill, Mr. Secretary, please.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 483.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR LUFT)

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. What Senate Bill 483 does is to authorize counties and municipalities to work together to plan for the disposal of solid waste. I would be very happy to respond to any questions.

PRESIDING OFFICER: (SENATOR LUFT)

Discussion? Discussion? Senator Welch.

SENATOR WELCH:

Thank you. I'd like to ask a question of the sponsor.

PRESIDING OFFICER: (SENATOR LUFT)

He indicates he will yield.

SENATOR WELCH:

Senator Etheredge, this bill...does this allow for eminent domain by counties or their commission that are going to be enacted?

PRESIDING OFFICER: (SENATOR LUFT)

Senator Etheredge.

SENATOR ETHEREDGE:

No, it doesn't deal with the issues of eminent...domain or siting. That's...there are no changes from the existing law that in...in regard to those matters incorporated in this bill.

PRESIDING OFFICER: (SENATOR LUFT)

Senator Welch.

SENATOR WELCH:

Well, the bill does allow for a tax to be imposed, is that correct? Is it a backdoor referendum? No?

PRESIDING OFFICER: (SENATOR LUFT)

Senator Etheredge.

SENATOR ETHEREDGE:

No. There is no tax proposals in here at all. Now, the original bill did relate to stream clearing and a tax for that purpose, but all of that is stricken, Senator.

PRESIDING OFFICER: (SENATOR LUFT)

Further discussion, Senator Welch?

SENATOR WELCH:

Well, the...this bill allows for the county to create a group that could compete with private industry, is that correct? Because what you're doing is allowing for a waste system to be created which energy created thereby could be sold to private industry. Is that correct?

PRESIDING OFFICER: (SENATOR LUFT)

Senator Etheredge.

SENATOR ETHEREDGE:

It does say that the counties could sell the products...the waste products that are created by the decay of the materials in a landfill. That is true.

PRESIDING OFFICER: (SENATOR LUFT)

Further discussion, Senator Welch?

SENATOR WELCH:

Yes. Well, since this apparently was an amendment put on...on the Floor, who is...this was in...

PRESIDING OFFICER: (SENATOR LUFT)

Senator Etheredge.

SENATOR ETHEREDGE:

...no, Senator, the amendment that is now the bill was put on in committee. There was some discussion here later on because for some reason or another the committee records did not show that this was, in fact, a committee amendment but...but, indeed, it is, Senator.

PRESIDING OFFICER: (SENATOR LUFT)

Senator Welch, you through? Further discussion? Senator Keats.

Thank you, Mr. President. I have a very definite conflict of interest in this bill and will be voting Present.

PRESIDING OFFICER: (SENATOR LUFT)

Further discussion? Further discussion? Senator Etheredge to close.

As I have indicated in response to the questions, I...I hope that the...all the concerns that had been raised about a tax without referendum have been alleviated. There is no tax increase without referendum incorporated in this legislation. It relates solely to the cooperative planning for the disposal of solid waste by counties and municipalities. I would ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR LUFT)

The question is, shall Senate Bill 483 pass. Those in favor vote Aye. Those...opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, Mr. Secretary. On that question, the Ayes are 46, none voting Nay and 4 voting Present. Senate Bill 483 having received the required constitutional majority is declared passed. On the Order of 3rd Reading is Senate Bill 497, Senator Alexander. Read the bill, please, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

Senate Bill 497.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR LUFT)

Senator Alexander.

SENATOR ALEXANDER:

Thank you, Mr. President. Senate Bill 497 amends the Marriage and Dissolution of Marriage Act. In essence, it...amends the delinquency of child support money. This

bill has the support of the Department of Public Aid after the amendment was placed on it. The amendment merely placed the essence of the bill into the other various sections of the law relating to child support money. It does increase the minimum amount that may be withheld for child support money from ten percent to twenty percent on court order. It does change that the obligor can no longer remain delinquent even up to a dollar before he is required to be brought back in before the court for a hearing so that our system of child support money and families who will be receiving these monies will not have the problems that they've had in the past. I would ask your sincere support in passing Senate Bill 497.

PRESIDING OFFICER: (SENATOR LUFT)

Discussion? Is there any discussion? If not, the question is, shall Senate Bill 497 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, please, Mr. Secretary. On that question, the Ayes are 53, none voting Nay and none voting Present. Senate Bill 497 having received the required constitutional majority is declared passed. On the top...Senator Demuzio, for what purpose do you arise?

SENATOR DEMUZIO:

Thank you, Mr. President. It just seems to me that we have done an extraordinary amount of work today with all of the...appropriation bills and everything and so, therefore, it seems to me we ought to...without the housekeeping duties there, perhaps adjourn till ten...ten o'clock tomorrow.

PRESIDING OFFICER: (SENATOR LUFT)

(Machine cutoff)...the motion to adjourn. All...

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. The...do we have any housekeeping...Senator Brookins, for what purpose do you arise?

SENATOR BROOKINS:

Yeah, with...with...with...with leave of the House, I'd like to add Senator Raica and Senator Dudycz to Senate Bill...which one, oh, 39.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Brookins has sought leave of the Body to add Senators Raica and Senator Dudycz to Senate Bill 39 as hyphenated cosponsors. Is leave granted? Leave is granted. Senator Dudycz, for what purpose do you arise?

SENATOR DUDYCHZ:

Yes, thank you, Mr. President. In addition, I would like to be added as a hyphenated cosponsor to House Bill 332 with permission of the main sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Dudycz, would you repeat that...I was...

SENATOR DUDYCHZ:

(Machine cutoff)...would like to be added as a hyphenated cosponsor to House Bill 332 with permission of the chief sponsor, Senator Poshard.

PRESIDING OFFICER: (SENATOR DEMUZIO)

...332, all right. Senator Dudycz seeks leave of the Body to be added as a hyphenated cosponsor of 332, House Bill. Leave granted? Leave is granted. It's so ordered. Resolutions.

ACTING SECRETARY: (MR. HARRY)

Senate Resolution No. 272 offered by Senator Raica.
Senate Resolution 273 offered by Senator DeAngelis.
Both congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar.

ACTING SECRETARY: (MR. HARRY)

Senate Resolution 274 offered by Senator Geo-Karis.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive. Now before anyone gets away as...it's my understanding that...if I could have your attention, it is my

understanding that tomorrow morning when we begin by prior agreement, that we will begin on the Order of Recalls. We'll be on...on the Order of Recalls in the morning when we begin. All right. Senator Jacobs, for what purpose do you arise?

SENATOR JACOBS:

With leave of the Body, I found that bill. I would like to have Senator Hawkinson added as a hyphenated cosponsor of House Bill 2406.

PRESIDING OFFICER: (SENATOR DEMUZIO)

2406? You've heard the request of Senator Jacobs to be added as the hyphenated cosponsor of House Bill 2406. Is leave granted? Leave is granted. So ordered. Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

By agreement to both parties, I'd like to be added as the principal hyphenated sponsor to Senate Bill 28.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Marovitz seeks leave of the Body to be added as the principal hyphenated cosponsor to Senate Bill 28. Is leave granted? Leave is granted. All right. Is there further...Senator Davidson, for what purpose do you arise?

SENATOR DAVIDSON:

He asked to be a hyphenated cosponsor, not the principal sponsor, correct?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well,...it's my understanding he asked to be the...principal hyphenated cosponsor. That's the...

SENATOR DAVIDSON:

It'd be Davidson-Marovitz, right? Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Davidson-Marovitz. All right, leave is granted. So ordered. Further business to come before the Senate? Senator Netsch moves that the Senate stand adjourned till tomor-
