PRESIDENT:

the Order of House Bills 1st Reading. It makes it easier on the Secretary's Office if these bills are assigned and taken off the Calendar. Senator DeAngelis, for what purpose do you seek recognition?

SENATOR DEANGELIS:

Thank you, Mr. President. I would like to have leave of the Body to discharge the Committee on Rules...to discharge Senate Joint Resolution 6 and have the resolution moved to the Executive Committee. I have talked to the chairman of Executive. I don't know why this bill...it's the only bill that I know of that got stuck in Rules this Session. Is this part of the continuing saga of the fiscal notes?

I, frankly, don't even know what you're talking about. Why don't we wait a minute to just explain to me, at least, what you're talking about. I don't have a clue as to what you're talking about. All right, Senator Berman, for what purpose do you arise?

SENATOR BERMAN:

Thank you...thank you, Mr. President. I would ask for leave to add Senator DeAngelis as a hyphenated cosponsor on House Bill 934.

PRESIDENT:

All right, gentleman seeks leave to add Senator DeAngelis as a...hyphenated cosponsor on House Bill 934. Without objection, leave is granted. Wait...before we start all this sponsor-cosponsor, let's get...Senator DeAngelis.

SENATOR DEANGELIS:

Thank you, Mr. President. I will withdraw my request and I will wait for a meeting of the Rules Committee...

PRESIDENT:

Thank you.

SENATOR DEANGELIS:

...so that this can be discussed.

PRESIDENT:

Thank you. Senator Luft.

SENATOR LUFT:

Thank you, Mr. President. I'd ask to have my name removed as the chief sponsor of House Bill 2012 and have myself replaced with Senator del Valle.

PRESIDENT:

All right, the gentleman seeks leave to have himself removed as chief sponsor of House Bill 2012 and substitute instead Senator del Valle. Without objection, leave is granted. Senator Marovitz, for what purpose do you arise?

Thank you, Mr. President. For two purposes. I'd like the sponsorship on...House Bill 507, which I am the principal sponsor, to be changed to read Berman-Marovitz instead of Marovitz...

PRESIDENT:

All right, gentleman seeks leave to add...to change the sponsorship on House Bill 507 to read Senators Berman-Marovitz. Without objection, leave is granted. Senator Marovitz.

SENATOR MAROVITZ:

Also, Mr. President, having checked with both sides, I would move that...to discharge the Executive Committee from consideration of Senate Resolution 252. This is a reporting requirement...

PRESIDENT:

Well, that...that motion will be in order but not at this time. We're trying to handle all these requests for sponsor, cosponsor, change and unchange. Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. Same request. I'd like to change the sponsorship of House Bill 824 from Emil Jones to Frank Watson-Jones and I've talked to Emil and he's agreed.

PRESIDENT:

824. The gentleman seeks leave to be shown as the chief sponsor of Senate Bill...House Bill 824 hyphenated with Senator Jones. Without objection, leave is granted. All right, now we have fifteen lights lit up to do exactly the same thing. If everybody will just...we'll get to it. Senator Macdonald.

SENATOR MACDONALD:

Thank you, Hr. President. I'd like to have Senator Smith's name added as a hyphenated cosponsor of...House Bill 2013 of which I am the chief sponsor and also House Bill 2670 of which I am the chief sponsor. I would also like to have my name added as her hyphenated cosponsor on House Bill 2559 and 2560.

PRESIDENT:

All right, the lady seeks leave to have Senator Smith shown as the cosponsor on House Bills 2013 and 2670 and have her name added as a sponsor on House Bills 2559 and 2560. Without objection, leave is granted. Senator Dunn.

Thank you, Mr. President. I ask leave that House Bill 2034...strike that, House Bill 2410 read Dunn-Rock. PRESIDENT:

All right, gentleman seeks leave to show House...House Bill 2410...2410, Madam Secretary, I think is still on the Calendar. Gentleman seeks leave to show it Dunn-Rock. Without objection, leave is granted. Senator Alexander. SENATOR ALEXANDER:

Thank you, Mr. President. I would like to be removed as the chief cosponsor of 294 and become a hyphenated cosponsor. Senator Collins will become the chief sponsor of 294.

PRESIDENT:

All right, the lady seeks leave to show Senator Collins as the chief sponsor on 294 with herself as the cosponsor.

Without objection, leave is granted. All right, if I can have the attention of the membership. Senator Philip and I discussed earlier the possibility of not being in Session tomorrow, and Senator Collins has agreed to postpone her meeting and all those bills that were posted for tomorrow until the following week so that the Senate will not be Session tomorrow. We will conclude our business, I hope, this afternoon. There are committee meetings, Appropriations will meet. Public Health will meet. We will this afternoon deal with resolutions on the Secretary's Desk and Lechowicz has asked that we go to the...the Order of Executive for the purpose of considering gubernatorial appointments, and we will not be here tomorrow. There will be an adjournment resolution which will call for us to return to Springfield next Tuesday at the hour of noon when we conclude our business today. Senator Dunn, for what purpose do you arise?

SENATOR RALPH DUNN:

Thank you, Mr. President. I...I'd like to be added as hyphenated cosponsor of House Bill 1954. Senator Poshard is the principal sponsor.

PRESIDENT:

All right, the gentleman seeks leave to be added as the hyphenated cosponsor on House Bill 1954. Without objection, leave is granted. Senator Hahar.

SENATOR MAHAR:

Thank you, Ar. President. I would seek leave of the Body to change the sponsorship of House Bill 2839 and that should read Mahar-Collins.

PRESIDENT:

All right, the gentleman seeks leave to show Senator Mahar-Collins as the sponsors on House 3111 2839. Without objection, leave is granted. Senator Topinka.

SENATOR TOPINKA:

Yes, Mr. President, if I might, I would like to show as a hyphenated joint sponsor Senator Emil Jones to House Bills 404, 405 and 407.

PRESIDENT:

All right, the lady seeks leave to show Senator Jones as the hyphenated cosponsor on House 3ills 404, 405 and 407. Without objection, leave is granted. Senator Woodyard. SENATOR WOODYARD:

Thank you, Mr. President. With permission of the sponsor, I would...like to have leave of the 3ody to be shown as the...the sponsor...the only sponsor of House Bill 2826. PRESIDENT:

House Bill 2826. The gentleman seeks leave to be shown as the Senate sponsor. 2826? All right, without objection, leave is granted. Senator Raica.

SENATOR RAICA:

Thank you, Mr. President. I ask leave of the Body, with permission of the chief sponsor, to be added to the following House bills as a hyphenated sponsor: House Bill 89, 1349, 1087 and 765.

PRESIDENT:

All right, the gentleman seeks leave to pe added as a cosponsor on House Bills 89, 765, 1087 and 1349. Without objection, leave is granted. Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen. I...I seek leave of the Body to add as a hyphenated sponsor Senator Virginia Macdonald to Senate Bills 25, 60 and 2559.

PRESIDENT:

Thank you. That motion has already been taken care of.

SENATOR SMITH:

That has ... thank you.

PRESIDENT:

Senator Jones.

SENATOR JONES:

Yes, thank you, Mr. President. I'd like to waive the...the posting requirements so that House Bill 1836 and 1434 can be heard in the Insurance Committee on Tuesday, June 2nd.

PRESIDENT:

1836 and what else?

SENATOR JONES:

1434.

PRESIDENT:

1434. The gentleman seeks to suspend the rules for the purpose of waiving the posting requirement so that House Bills 1836 and 1434 can be heard in the Insurance Committee next week. Without objection, leave is granted. It's so ordered. Senator Dudycz.

SENATOR DUDYCZ:

Thank you, Mr. President. I seek leave to be added as a cosponsor of House Bill 332 and hyphenated cosponsor of House Bill 2207.

PRESIDENT:

All right, gentleman seeks leave to be added as the cosponsor on House Bill 332 and the hyphenated cosponsor on House Bill 2207. Without objection, leave is granted. Senator Topinka.

SENATOR TOPINKA:

Yes, sorry, Mr. President, I forgot one and that was to add Senator Emil Jones also as a hyphenated joint sponsor to House Bill 409.

PRESIDENT:

All right, the lady seeks leave to show Senator Jones as the hyphenated sponsor on House Bill 409. Without objection, leave is granted. Madam Secretary, while I'm here, 1433, I seek to remove myself as the sponsor. I did not...that must be an error somewhere. 1433 was read in with me as the

sponsor. I do not know anything about it. Senator Etheredge.
SENATOR ETHEREDGE:

Thank you, Mr. President. I seek leave to have Senator Marovitz shown as hyphenated cosponsor on House Bill 310.

PRESIDENT:

All right, the gentleman seeks leave to show Senator Marovitz as the hyphenated cosponsor on House Bill 310. Without objection, leave is granted. Senator Harovitz, for what purpose do you arise?

SENATOR MAROVITZ:

Thank you, very much, Hr. President. I would move to discharge the Executive Committee from further consideration of Senate Resolution 252. I've checked with all parties on both sides of the aisle and there is no objection. It merely extends the reporting deadline.

PRESIDENT:

All right, the gentleman seeks leave to discharge the Committee on Executive from further consideration of Senate Resolution 252 for the purpose of its immediate consideration and adoption. Any discussion on the motion to discharge? All in favor of the motion to discharge indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Now before the Body is the question of the adoption of Senate Resolution 252. Senator Marovitz.

SENATOR MAROVITZ:

Thank you, very much, Mr. President and members of the Senate. This has to do with the Senate Select Committee on Sports and Meetings Facilities and extends the reporting deadline from June 1st to June 30th. We are going to be holding a hearing on June 8th. I am reliably informed that there may be some movement regarding a...proposal for a Chicago Bears Stadium, and in order to hear testimony about that and how it may affect the State of Illinois, we have scheduled a June 8th hearing at the State of Illinois Building, and I

would ask for adoption of Senate Resolution 252.

PRESIDENT:

All right. Senator Marovitz has moved the adoption of Senate Resolution 252. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Senator Brookins, for what purpose do you arise?

SENATOR BROOKINS:

Yes, Mr. President, I'd like to...with leave of the Body, have Senate Bill...I'm sorry, House Bill 237 removed...me in that...me as chief sponsor making Senator Hall chief sponsor and me hyphenated cosponsor.

PRESIDENT:

All right, the gentleman seeks leave to show Senator Hall as the chief Senate sponsor of House Bill 237 and Senator Brookins as the hyphenated cosponsor. Without objection, leave is granted. Senator Brookins.

SENATOR BROOKINS:

Mr. President, House Bill 810, I'd like to have myself removed as chief sponsor, making Senator Poshard chief sponsor, showing me as hyphenated cosponsor and Senator del Valle as hyphenated cosponsor.

PRESIDENT:

All right, the gentleman seeks leave to show Senator Poshard as the hyphenated...as the chief sponsor of Senate Bill 810...House Bill 810 with himself and Senator del Valle as the hyphenated cosponsor. Without objection, leave is granted. Senator Hall, for what purpose do you arise? Senator Dunn, for what purpose do you arise, sir?

SENATOR RALPH DUNN:

Thank you, Mr. President. I'd like leave to be added as a hyphenated cosponsor on House Bill 237 also.

PRESIDENT:

All right, the gentleman seeks leave to be added as the

hyphenated cosponsor on House Sill 237. Without objection, leave is granted. Senator Lechowicz, for what purpose do you arise, sir?

SENATOR LECHOWICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like to...remove my name from House 5:11 1836 as the principal sponsor and...and ask that Senator Pat Welch be the principal sponsor.

PRESIDENT:

All right, the gentleman seeks to show Senator Welch as the chief Senate sponsor of House Bill 1836. Without objection, leave is granted. Senator Smith...I'm sorry, Senator Lechowicz.

SENATOR LECHOWICZ:

Another request, Mr. President. On House Bill 187 would you add...Senator D.Arco as a cosponsor with me on that bill. PRESIDENT:

All right. Gentleman seeks leave to show Senator John D'Arco as the hyphenated cosponsor on Senate Bill...House Bill 187. Without objection, leave is granted. Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I ask leave, with the approval of the sponsor, to be added as a hyphenated cosponsor on House Bills 93, 97 and 99. PRESIDENT:

All right, the lady seeks leave to be added as the hyphenated cosponsor on House Bills 93, 97 and 99. Without objection, leave is granted. All right, Madam Secretary, we'll go to the Order of Committee Reports.

SECRETARY:

Senator Marovitz, chairman of the Committee on Judiciary, reports House Bills Noed. 67, 90, 121, 175, 310, 388, 523, 535, 615 and 2062 Do Pass.

And House Bill 2167 Do Pass as Amended.

PRESIDENT:

Wait a minute...wait a minute. Senator Collins, for what purpose do you arise? Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you. Mr. President. With the permission of the chief sponsor to be added as a hyphenated cosponsor on House Bill 1473.

PRESIDENT:

All right, the lady seeks leave to be added as the hyphenated cosponsor on House Bill 1473. Without objection, leave is granted. Senator Collins.

SENATOR COLLINS:

Yes, thank you, Mr. President. To remove myself as the sponsor from House Bill 1988 and to add...Senator Topinka will be the sponsor. I do not wish to be on the bill at all. PRESIDENT:

The lady seeks leave to substitute Senator Topinka as the Senate sponsor on Senate Bill...House Bill 1988. Without objection, leave is granted. All right, with leave of the Body, we'll move to the Order of Secretary's Desk Resolutions. Senator Joyce. Page 33 on the Calendar. We will go through the Order of Secretary's Desks...Desk Resolutions and then we will go to the...Committee on Executive Appointments for its report. On the Order of Secretary's Desk Resolutions, Senate Resolution 102, Madam Secretary.

SECRETARY:

Senate Resolution 102 offered by...the Executive Committee. No committee amendments.

PRESIDENT:

All right, Senator Joyce.

SENATOR JEROME JOYCE:

Thank you. Mr. President. Senate Resolution 102 is a

voluntary clean indoor air program. This urges groups that participate in voluntary clean indoor air programs to study and monitor the...progress of such programs and report their findings to the General Assembly by 5-1-88. Be happy to answer any questions.

PRESIDENT:

Any discussion? Any discussion? If not, the question is, shall Senate Resolution 102 be adopted. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 56 Ayes, no Nays, none voting Present. Senate Resolution 102 having received the required constitutional majority is declared adopted. 134, Senator Kustra. 151, with leave of the Body, we'll get back to that when I get off here. 161, Senator Zito. On the Order of...Secretary's Desk Resolutions is Senate Resolution 161, Madam Secretary.

SECRETARY:

Senate Resolution 161. No committee amendments.

PRESIDENT:

Senator Zito.

SENATOR ZITO:

Yes, thank you, Mr. President and members. Senate Resolution 161 is a resolution that was identical to Senate Resolution 576 offered by Senator Rock in the last Session; however, there wasn't any action taken by the Executive Committee. The resolution requested a special Senate committee to be known as the Senate Special Committee on Consumer Banks is created to study consumer banks in Illinois. The Special Committee on Consumer Banks would conduct hearings and report its recommendations to the Illinois Senate by March the 15th, 1988. We think it would greatly enhance our opportunity to understand these issues and would move for its passage.

PRESIDENT:

Any discussion? Is there any discussion? If not, the question is the adoption of Senate Resolution 161. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 56 Ayes, no Nays, none voting Present. Senate Resolution 161 having received the required constitutional majority is declared adopted. Senator Dunn, Senate Resolution 169. Madam Secretary, on the Order of Secretary's Desk, page 33 on the Calendar, Senate Resolution 169.

SECRETARY:

Senate Resolution 169. No committee amendments. $\mbox{PRESIDENT:}$

Senator Ralph Dunn.

SENATOR RALPH DUNN:

Thank you, Mr. President and members of the Senate. Senate Resolution 169 directs the various institutions under the jurisdiction of the boards of higher education, including the community colleges, to identify and to report to the Board of Higher Education the amount of asbestos material used throughout their facilities as a health hazard it may create and the estimated cost of containment or removal...to report to the Higher Education Board by January 1st, 1988 and they in turn are to report to the General Assembly by March the 1st of *88. I'd move its adoption.

PRESIDENT:

All right, Senator Dunn has moved the adoption of Senate Resolution 169. Discussion? Senator Schaffer.

SENATOR SCHAFFER:

The resolution doesn't imply that we're going to do anything about it once we're told, does it? We certainly have a track record of doing nothing. I just wanted to make sure we weren't promising anything we weren't going to deliver on.

PRESIDENT:

Further discussion? If not, the question is the adoption of Senate Resolution 169. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 Ayes, no Nays, none voting Present. Senate Resolution 169 having received the required constitutional majority vote is declared adopted. 180, Senator Keats. On the Order of Senate Resolutions...Secretary's Desk Resolutions, Senate Resolution 180. Madam Secretary.

SECRETARY:

Senate Resolution 180. The Committee on Executive offers one committee amendment.

PRESIDENT:

Senator Keats on Committee Amendment No. 1.

SENATOR KEATS:

I've never seen the amendment in my life.

PRESIDENT:

Senator Keats.

SENATOR KEATS:

No...no one checked with the sponsor. It says, "Committee Amendment 1 corrects technical errors," little discussion, "Do Adopt as Amended." Never heard of it.

PRESIDENT:

Well, it is a technical correction.

SENATOR KEATS:

Could we please have it put on, I guess.

PRESIDENT:

I guess. All right, Senator Keats has moved to adopt Committee Amendment No. 1 to Senate Resolution 180. All in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDENT:

All right, Senate Resolution 180, Senator Keats.
SENATOR KEATS:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This just asks the RTA in DuPage and the Toll Highway Authority and all these people to talk about whether there's a need for mass transit in the eastern edge of the county. There are existing railroad tracks there right now. We've got right of ways down the middle of some of those expressways. No money. There's no requirement they do anything. We'd just like them to talk to each other and this is all that we ask them to do.

PRESIDENT:

Question is the adoption of Senate Resolution 180. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 56 Ayes, no Nays, none voting Present. Senate Resolution 180 having received the required constitutional majority is declared adopted. Top of page 34, 181, Senator Smith. On the Order of Secretary's Desk Resolutions is Senate Resolution 181, Madam Secretary.

SECRETARY:

Senate Resolution 181. No committee amendments.

PRESIDENT:

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen...Senate Resolution 181 deals that the...by the General Assembly, the administrative office of the Illinois...courts be directed to undertake an alternative sentencing feasibility study for...female offenders. The county jail and work release programs have evened up in fewer

resources to deal with the special needs of the children of an incarcerated mother. This Senate resolution merely directs the administrative office of the Illinois courts, the agency mandated by Illinois law to supervise nonincarceration sentencing, to complete a feasibility study of alternative sentencing programs for incarcerated mothers and their children and pregnant inmates. I ask that we have a favorable vote on this...

PRESIDENT:

Any discussion? Is there any discussion? If not, the question is the adoption of Senate Resolution 181. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 48 Ayes, 4 Nays, 1 voting Present. Senate Resolution 181 having received the required constitutional majority is declared adopted. 222, Senator Demuzio. On the Order of Secretary. Besk Resolutions is Senate Resolution 222, Madam Secretary.

SECRETARY:

Senate Resolution 222...one committee amendment offered by the Executive Committee.

PRESIDENT:

Senator Demuzio on Committee Amendment No. 1.
SENATOR DEMUZIO:

Well, Committee Amendment No. 1 is the amendment that was...requested by the Illinois Department of Transportation. It removes the administrative determination on the...on the speed limit. They simply wanted the resolution to rest with the decision being made by the Federal Department of Transportation. We've agreed with it. I would move adoption of Amendment No. 1.

PRESIDENT:

All right, Senator Demuzio has moved the adoption of

Committee Amendment No. 1 to Senate Resolution 222. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDENT:

Wrong button. I tell you. Senator Demuzio, you're...you're more than halfway home. Just call for a roll call and we're right there. All right, Senator Demuzio...no, this is just...that was a mistake. We have to from time to time prove that we're human up here. Senator Demuzio on Senate Resolution 222.

SENATOR DEMUZIO:

Well, the...the only question I have on the last vote, Mr. Secretary, since nobody pushed their green buttons, how did I get 31? Nevertheless...that can go unanswered. House...Senate Resolution 222...it calls for the Illinois Department of Transportation to make an extraordinary effort to convince the Federal Highway Administration to name that part...portion of...of Route 36 between Springfield and Route 100 that has been designated as...as Interstate 72 so that it...it, in fact, can have the sixty-five mile an hour speed limit...attached to it. There is some dispute now since it is not a completed interstate that the Feds have apparently by rule allowed them...forbidden them to leave the speed limit at fifty-five. It's rather confusing. The Department of Transportation, as I understand it, has already made effort toward trying to resolve this...issue with the Federal Government. This simply would request that they make every effort to see to it that the sixty-five is applied to that portion between Route 36 and Route 100.

PRESIDENT:

Discussion? Is there any discussion? If not, the ques-

tion is the adoption of Senate Resolution 222. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 52 Ayes, no Nays, 2 voting Present. Senate Resolution 222 having received the required constitutional majority vote is declared adopted. 225, Senator Dunn. On the Order of Secretary's Desk Resolutions, top of page 34, is Senate Resolution 225, Madam Secretary.

SECRETARY:

Senate Resolution 225. No committee amendments.

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

Thank you, Mr. President. This would direct the Auditor General to conduct an investigation into a building that was purchased in secrecy for the sum of eighty—six thousand dollars and then the state was given the marvelous opportunity to rent this building and they do so at the sum of one hundred and six thousand dollars per year and this will call for an investigation as to how those monies are spent.

Discussion? Any discussion? Senator DeAngelis.
SENATOR DeANGELIS:

Here we go again with Will County. I believe...question of the sponsor.

PRESIDENT:

Indicates he will yield, Senator DeAngelis.
SENATOR DeANGELIS:

I believe last year Senator Sangmeister had a...and I don't have the resolution, of a similar sort and the Auditor General indicated that he had neither the...the authority or the inclination to get involved. What's the difference between this resolution and Senator Sangmeister's resolution?

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

He agrees with this one.

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

(Machine cutoff)...I think I can clear that up, Senator DeAngelis. The...the...the resolution that was passed by Senator Sangmeister required the Auditor General to audit all of the funds of the particular agency involved. I don't know the name of it. This particular resolution only applies itself to that portion of state or Federal dollars that it gets that the State of Illinois, in fact, does have some responsibility to it and, therefore, he is, in fact, empowered to make the proper audit, and that's...that's the difference in the resolutions.

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

Well, another question of the sponsor though.

PRESIDENT:

Indicates he'll yield, Senator DeAngelis.

SENATOR DeANGELIS:

You are asking for an audit of the entire Will County PIC Council funds...the public funds of the Will County PIC Council, correct?

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

That's correct.

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

So, what you stated to begin with wasn't essentially what the thrust of this resolution is.

PRESIDENT:

Senator Dunn.

SENATOR TOX DUNN:

I beg your pardon, would you repeat that?

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

If I heard you correctly, your initial explanation is that you wanted the Auditor General to look into the use of state funds for leasing purposes on a building that was purchased in Will County, but now you're asking for an entire audit of the public funds of the PIC Council in Will County. PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

No, that is not correct. I'm asking for an investigation.

PRESIDENT:

Senator DeAngelis.

SENATOR DeANGELIS:

An investigation of what?

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

Well, for instance, if it's a good deal for the State of Illinois and for its citizens to pay a hundred and six thousand dollars a year for a building that was purchased for eighty-six thousand dollars.

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

Well, that's not what your resolution says, Senator Dunn.

Let me read if...if...if I'm reading correctly and I'm doing it rather quickly. You want to "Conduct an investigation into the obligation expenditure receipt or use of public funds of the state by the Will County Private Industry Council," and I want to get to...to that council eventually "cause that's what your resolution is calling for the investigation of. Now you may want to dispute the fact that they lease the building and that's fine, but that's not what your resolution is doing.

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

I'll stand on what the resolution requests and it requests an investigation as to the propriety of the expenditure of state money for a building that was purchased for eighty-six thousand dollars and is now being leased to the people of Illinois for one hundred and six thousand dollars per year.

PRESIDENT:

All right, further discussion? Is there any further discussion? Senator DeAngelis, I°m sorry.

SENATOR DEANGELIS:

Well, you know, I like Senator Dunn, but I...I think his response there a little flippant because that's not what the resolution calls for. Now, I do want to get to one point of the resolution. May I address the way your resolution is currently presented rather than what you think you want it to do...and, by the way, the Auditor General does what's directed in the resolution, not a wish list of any legislator. Okay? May I direct a question at that?

You are in order, sir.

SENATOR DEANGELIS:

Okay. What is the total budget of the PIC Council?

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

I don't know the answer to that.

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

How much are the public funds involved in the PIC Council?

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

If I don't know the...the former one, I certainly can't state what percentage it would be.

PRESIDENT:

Senator DeAngelis.

SENATOR DEANGELIS:

Well. I don't know the answer to either one, but I will tell you this, that the amount of public funds of the State of Illinois used by the PIC Council is either zero or extremely negligible, so what wa're setting about here is a chase by the Auditor General on something that if there is a problem would be a very small part of the problem for the state, and I went along with Senator Sangmeister's resolution last year. We went through a tremendous amount of...and...as cochairman of the Legislative Audit Commission, the Auditor General went through hoops to try to find a way of doing it. He found out that he couldn't do it and here we go again, and I...I really think that this resolution is inappropriate. If you want to go after that particular item, I would suggest you draft a resolution of that...that type, but not to call for an investigation of a council which is basically funded by Federal money in which the state has very little money; in fact, I'm not so certain they have any money at all...a full-blown investigation, I think it's a waste of the Auditor General's time and money. If you want to do the other resolution, I'll support it but not this one.

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Well, I...I don't know what we're talking about here. This resolution is very similar...to the one that Senator Sangmeister had with the exception of the fact that it only limits itself to the...audit of...of those public funds that are being utilized by this particular...particular group and we do it all the time. There may be some problems that, Senator DeAngelis, you might have with the wording of the resolution, but I don't think it's anything different than we normally, customarily and usually have done in the thirteen years that I have been here and I would simply suggest to you that...he probably already has the authority to do this.

Senator DeAngelis.

SENATOR DEANGELIS:

Well, I...I...I know we do a lot of things, Vince, but I have to tell you, one of the relevant factors is what the percentage of state money is in a project. Now if he wants to investigate that part of it, I have no problem because he's focused the investigation, but the resolution forces the Auditor General to look into this Will County Private Industry Council in search of where the state funds are spent which may not be anyplace at all. I...I think the thing ought to be targeted to what he's trying to do rather than using a shotgun to blast an organization.

PRESIDENT:

All right, further discussion? Further discussion? Senator Dunn may close.

SENATOR TOM DUNN:

I...I would urge you to vote for this for the reason that this was a building conceived in secrecy that was...the ownership was denied to the public until the heat became too hot, and I would urge you that a vote for this would be a rejection of this kind of expenditure of state funds. I don't think that we need to split hairs nor do we need an economics lesson to show that when someone buys a building for eighty—six thousand dollars and then...and then has a wonderful deal of renting it for a hundred and six thousand dollars a year, I think that says it all.

PRESIDENT:

Question is the adoption of Senate Resolution 225. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 31 Ayes, no Nays, 25 voting Present. Senate Resolution 225 having received the required constitutional majority is declared adopted...I beg your pardon, Senator DeAngelis.

SENATOR DEANGELIS:

Request a verification.

PRESIDENT:

That request is in order. Senator DeAngelis has requested a verification. Will the members please be in their seats. Madam Secretary, please read the affirmative vote.

Alexander, Berman, Brookins, Carroll, Collins, D*Arco, del Valle, Demuzio, Thomas Dunn, Hall, Hawkinson, Holmberg, Jacobs, Jones, Jeremiah Joyce, Jerome Joyce, Kelly, Lechowicz, Luft, Marovitz, Netsch, Newhouse, O*Daniel, Poshard, Savickas, Severns, Smith, Vadalabene, Welch, Zito and Mr. President.

PRESIDENT:

Senator DeAngelis, do you question the presence of any

member?

SENATOR DEANGELIS:

Yeah, Senator Emil Jones.

PRESIDENT:

Senator Jones is in the back of the Chamber.

SENATOR DEANGELIS:

Senator Collins.

PRESIDENT:

Senator Collins on the Floor? Senator Collins on the Floor? Strike her name, Madam Secretary.

SENATOR DEANGELIS:

That's it...no...no, I'm sorry. Senator Jeremiah

Joyce...that light went up to 31 all of a sudden.

PRESIDENT:

Senator Joyce...Senator Joyce on the Floor? Senator Joyce on the Floor? Strike his name. Question the presence of any other member, Senator DeAngelis?

SENATOR DeANGELIS:

No. that's it.

PRESIDENT:

All right, the roll has been verified. On that question, there are 29 Ayes, no Nays, 25 voting Present. Senate Resolution...225 having failed to receive the required constitutional majority is declared lost. 271, Senator Demuzio, I'm told there's an amendment. All right, on the Order of Senate...Secretary's Desk Resolutions is Senate Resolution 271, Madam Secretary.

SECRETARY:

Senate Resolution 271. No committee amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

Senator Demuzio offers Amendment No. 1.

PRESIDENT:

Senator Demuzio on Amendment No. 1.
SENATOR DEMUZIO:

Yes, it was suggested in committee that in the...evaluation of the State Health Insurance Program that the...the Department of Insurance be made a...aware of and have a copy of the findings as well as the Department of Central Management Services. The amendment adds Central Management Services as a part of the...of the resolution and also suggests that in looking into the program that there would be cooperation between Central Management Services and the Department of Insurance. It's requested by the committee. I would move its adoption.

PRESIDENT:

Senator...Demuzio has moved the adoption of Amendment No.

1 to Senate Resolution 271. All in...any discussion? Senator Karpiel.

SENATOR KARPIEL:

Thank you, Mr. President. Senator, did...did you say that the amendment would say that this...that CMS has to do this study instead of Department of Insurance?

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

•••no, in•••in committee it was suggested that since the Central Management Services is the primary responsible agency for this, that they should be made a party too. So, in the amendment it says•••that in cooperation with the Department of Central Management Services•••if I can find it in the resolution, so it indicates that both•••both the Central Management Services and the Department of Insurance would cooperatively and jointly work on this problem•

PRESIDENT:

Senator Karpiel.

SENATOR KARPIEL:

Thank you, I see that now. Don't you find it a little bit unusual though to have CMS more or less investigating itself?

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Well, I wouldn't call it an investigation. There are several hundred of complaints. As I recall and I think you recall being in committee that there was some unanimity in the fact that Central Management Services ought to be made a party to this resolution and that is the specific reason that I have put it forth. I'm not on a witch hunt here. I'm just simply trying to get to the point of the program where we can get a good evaluation of this administration of the...of the health program in the State of Illinois and if there are problems, to work them out and that's simply and specifically all this resolution calls for. It doesn't call for any of those inflamatory adjectives as we had in the previous resolution.

PRESIDENT:

Discussion? Senator Netsch.

SENATOR NETSCH:

Thank you. I was going to add that it seems to me, Mr. President and Senator Demuzio, that it is essential to have CMS involved. They are the...it is the state agency which has oversight as well as the authority initially to enter into these agreements, and whether they did or did not fully know of the complaints that we were told about, they certainly should be made aware of them and it's just absolutely critical that they be a part of the process so that anything that is a problem can, in fact, be resolved on the spot.

PRESIDENT:

Further discussion? Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, I rise in support of this resolution as amended, if the amendment has been adopted; if not, I rise in support of the amendment. Many of you have state employees, I'm sure, in your district same as I have, but I happen to have probably more than anyone and we have had numerous complaints in...in relation to the payment of legitimate claims and I think we just need to have someone lift the cover and let's look at it and the two agents responsible, CMS and Insurance and let's do it.

SENATOR SCHAFFER:

Senator, some of us are aware of the amendment and I'm just wondering, there is some welfare reform legislation currently moving through the General Assembly, I...I assume that this committee's moving its date passed is not an indication that we don't wish to act upon welfare reform legislation this Session. That's the only concern that I'd heard voiced about moving the reporting date.

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

Well, no, Senator Schaffer,...the reporting date of 7-1-87 is really not feasible since we will probably still be in Session 7-1-87 and the members would not have been appointed to the commission. The reporting date is moved

I think that by creating the committee to study this...I mean for meaningful reform not just some of the proposals that are entered in here that are just short gap positions to try to answer individual questions. I think we have to look at a whole totally meaningful revamping of the whole system to bring it down and to its proper prospective. I would move its adoption.

PRESIDENT:

All right. Senator Savickas has moved the adoption of

House Joint Resolution 56. Discussion? Senator Karpiel.

SENATOR KARPIEL:

Thank you, Mr. President. Well, in committee I brought up the partisan nature of this committee...of this committee that's being formed and I just want to mention it again that if we're truly...interested in studying the issue and it's...and it has nothing to do with politics, then we should change the makeup of this committee. Right now, it's...it would be seven...seven Democrats in the House and Senate and four Republicans in the House and Senate, I believe, and as I say, if we're truly interested in the subject matter, it doesn't have to be a political patronage haven and I think we should have a bipartisan committee.
