Executive. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

This...thank you, Mr. President. Is this an appropriate time to just make some sponsorship adjustments, if I might? Would you add Senator Maitland as a hyphenated sponsor on House Bill 3524.

PRESIDENT:

3524, the lady seeks leave to add Senator Maitland as the hyphenated cosponsor. Without objection, leave is granted. Senator Netsch.

SENATOR NETSCH:

And Senator DeAngelis as a hyphenated cosponsor on House Bill 2918.

PRESIDENT:

All right, the lady seeks leave to show Senator DeAngelis...and by the way, Senator DeAngelis, we are happy to see you back with us...as the cosponsor of 2918. Without objection, leave is granted. Senator Netsch.

SENATOR NETSCH:

One more. With the permission of the principal sponsor, would you add me as a hyphenated cosponsor on House Bill

3338.

PRESIDENT:

3338, the lady seeks leave to be added as the hyphenated cosponsor. Without objection, House Bill 3338, leave is granted. Senator Luft, for what purpose do you arise?

SENATOR LUFT:

Thank you, Mr. President. I'd ask leave to be added as a hyphenated cosponsor of House Bill 3462.

PRESIDENT:

House Bill 3462, the gentleman seeks leave to be added as the cosponsor. Without objection, leave is granted. Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President and members of the Senate. I ask leave to have Senator Rock shown as a cosponsor on House Bill 3930 and 3931. Those, Senator Rock, are the same bills that we passed out of this Chamber a couple of weeks ago.

PRESIDENT:

All right, 3930 and 3931? Gentleman seeks leave to show Senator Rock as the hyphenated cosponsor. Without objection, leave is granted. Senator Watson, for what purpose do you arise?

SENATOR WATSON:

Thank you, Mr. President. I'd like to have leave to be...added as a hyphenated cosponsor of House Bill 3395, with...consent of the sponsor.

PRESIDENT:

...3395.

SENATOR WATSON:

Yes, sir.

PRESIDENT:

Senator Watson seeks leave of the Body to be shown as the hyphenated cosponsor. Without objection, leave is granted. Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

Thank you, very much, Mr. President and members of the Senate. On House Bill 3437...sponsorship should read Marovitz-Collins, with permission of Senator Collins.

PRESIDENT:

All right, 3437, the gentleman seeks leave to be shown as the chief sponsor with Senator Collins as the hyphenated co-sponsor. Without objection, leave is granted. Senator Collins.

SENATOR COLLINS:

Yes, a motion to transfer House Bill 3900 to the insurance...to its proper committee which is the Insurance Committee from the Transportation Committee. I have consulted with the chair of...of the Insurance Committee.

PRESIDENT:

Well,...

SENATOR COLLINS:

We'd like to have that bill transfer.

PRESIDENT:

We'll...we'll get to the order of motions a little later. Senator Vadalabene.

SENATOR VADALABENE:

Thank you, Mr. President. There'll be a Democratic Caucus immediately in the President's Office.

PRESIDENT:

All right, request for a Democratic Caucus immediately in the President's Office. Senator Watson.

SENATOR WATSON:

Yes, sir, just a clarification. The previous speaker, Senator Collins, asked for leave to move House Bill 3900 to...from one committee to another committee. What was the Chair's action in regard to that request?

PRESIDENT:

We said we'd get to that motion later.

SENATOR WATSON:

Thank you.

PRESIDENT:

Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, there will be a Republican Caucus immediately after this morning Session.

PRESIDENT:

All right.

SENATOR GEO-KARIS:

In Senator Pate Philip's Office.

PRESIDENT:

Well, we...we're not concluding the Session now. So there's no misunderstanding, we...we will...at...at the conclusion of the caucus, which I expect will be about a half an hour, we will move immediately to the Order of Senate Bills 2nd Reading for action on Senator Berman's bills and then we will go to the Order of Secretary's Desk Resolutions to handle, among others, the resolution concerning the Compensation Review Board. So, we're...we're not...we're not through for the day. Caucus immediately in Senator Rock's Office and Senator Philip's Office. Any member can pick...any caucus they want. Senate stands in Recess for thirty minutes.

PRESIDENT:

The Senate will please come to order. Senator Woodyard, for what purpose do you arise, sir?

SENATOR WOODYARD:

Thank you, Mr. President and members of the Senate. In the balcony, to the rear, are a group of young people in a group study exchange program sponsored by the Rotary from

Australia, and I know that most of you know we do have some Russians in town today, but on the opposite of the world, we also have a group from Australia. Would you please welcome them to Illinois.

PRESIDENT:

Will our guests please rise and be recognized. Welcome to Springfield. (Machine cutoff)...Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, I would like to have leave to have Senator Weaver shown as a hyphenated sponsor on House Bill 3544.

PRESIDENT:

All right, gentleman seeks leave to have Senator Weaver shown as the hyphenated cosponsor on House Bill 3544. Without objection, leave is granted. Messages from the House.

SECRETARY:

A Message from the House by Mr. O'Brien, Clerk.

Mr. President - I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I'm instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution 199. It is substantive.

PRESIDENT:

Executive. Senator Macdonald, for what purpose do you arise?

SENATOR MACDONALD:

Thank you, Mr. President. I would like to have a bill changed, please, House Bill 3668 and I would like to be removed as the lead sponsor and have it read Karpier-Macdonald.

PRESIDENT:

All right, the lady seeks leave to have Senator Karpier shown as the chief Senate sponsor on House Bill 3668 and asked that she be a hyphenated cosponsor. Without objection,

leave is granted. Senator Topinka.

SENATOR TOPINKA:

Yes, Mr. President, do you think it would be possible to add me as a hyphenated joint sponsor on House Bill 2525 and also as a cosponsor on House Bill 4075?

PRESIDENT:

All right, the lady seeks leave to be added as the cosponsor on House Bills 2525 and 4075, 4-0-7-5. Without objection, leave is granted. Senator Severns.

SENATOR SEVERNS:

Thank you, Mr. President. I'd like to seek leave of the Body to be added, with the permission of the sponsor, as a hyphenated cosponsor on House Bills 2925, 3103 and 3913 and also to have the sponsorship on House bill changed from Woodyard...House Bill 4286 changed from Woodyard-Severns to Severns-Woodyard.

PRESIDENT:

All right, the lady seeks leave to be shown as the chief Senate sponsor on House Bill 4286 with Senator Woodyard as the hyphenated cosponsor. Without objection, leave is granted. She further seeks leave to be shown as a cosponsor on House Bills 2925, 3103 and 3913. Without objection, leave is granted. (Machine cutoff)...turn to page 7 on the Calendar, on the Order of Secretary's Desks...Secretary's Desk Resolutions, Senate Resolution 233, Senator Mahar. 461, Senator Degnan. 755, Senator Kelly. 846, Senator Raica. 848, Senator Topinka. 907, Senator Luft. 949, Senator Raica. SECRETARY:

Senate Joint Resolution 120 offered by Senators Thomas

Dunn, Severns, Holmberg, Savickas, del Valle and others.

PRESIDENT:

Senator Dunn.

SENATOR TOM DUNN:

Thank you, Mr. President. This is, in fact, the Senate resolution...joint resolution that will reject and request to disapprove in whole the Compensation Review Board's recommendation for a pay increase. Without starting an avalanche of discussion, I think it's obvious this is not the time nor are the resources here for it. I urge an Aye vote.

PRESIDENT:

Discussion? Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I would ask leave that all the Republicans become cosponsor of his resolution. I would also ask when he intends on calling the House joint resolution on the same subject.

PRESIDENT:

Gentleman seeks leave to have the Republican members shown as cosponsors. Without objection, leave is granted. Further discussion? Further discussion? Question is the adoption of Senate Joint Resolution 120. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 Ayes, 1 Nay, 2 voting Present. Senate Joint Resolution 120 having received the required constitutional majority is declared passed. Senator Berman. Senator Philip, I'm sorry, for what purpose do you arise?

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I asked a second question, when the sponsor intends to go to House Joint Resolution 186, and for some reason, I

didn't get any kind of a response. I was just wondering why.

PRESIDENT:

I can't answer that. Senator Dunn. Okay. Page 2 on the Calendar, Senate bills 2nd reading. Senator Berman, what's your pleasure? Senator Berman.

SENATOR BERMAN:

Thank you, Mr. President. What...what I would ask is that we move Senate Bills 1839 and 1840 to the Order of 3rd Reading and bring it back tomorrow for purpose of an amendment.

PRESIDENT:

All right, the gentleman seeks leave of the Body to have the bills read a second time and moved with the understanding they'll be called back for amendment tomorrow. On the Order of Senate Bills 2nd Reading, Senate Bill 1839. Read the bill, Madam Secretary, please.

SECRETARY:

Senate Bill 1839.

(Secretary reads title of bill)

3rd reading of the bill...2nd reading of the bill.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDENT:

3rd reading. On the Order of Senate Bills 2nd Reading, Senate Bill 1840. Read the bill, Madam Secretary.

SECRETARY:

Senate Bill 1840.

(Secretary reads title of bill)

2nd reading of the bill. No...no amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDENT:

3rd reading. Senator Carroll, announcements? Senator Jones, announcements? Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. The Appropriations Committee meeting will be immediately after adjournment but please observe that we will be in Room A-1 instead of 212. We will be using Room A-1 in the Stratton Office Building as soon after adjournment as possible. Thank you.

PRESIDENT:

Senator Jones.

SENATOR JONES:

Are you taking motions?

PRESIDENT:

Yes.

SENATOR JONES:

Okay. The Senate Insurance Committee will be meeting in Room 400 at approximately ten minutes to three and I wish all members would get there on time because we have a very short schedule and we should get out of there within a half an hour. Ten minutes to three, Room 400, Insurance Committee.

PRESIDENT:

Senator Hall.

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen. I'd like to call it to your attention a special announcement on a time change for Appropriation II. Appropriation II will meet at 10:00 a.m. tomorrow in Room 212 instead of 2:00 p.m. Like to repeat, Appropriation II will meet in Room 212 at 10:00 a.m. tomorrow morning instead of two in the afternoon. Thank you, Mr. President.

PRESIDENT:

All right. Further business? Senator Topinka.

SENATOR TOPINKA:

Yes, Mr. President, in trying to change sponsorships of bills in the past, this apparently has not taken, so once again, House Bill 4037 which currently reads Smith-Topinka should be Topinka-Smith.

PRESIDENT:

All right, the lady seeks leave to be shown as the chief Senate sponsor of House Bill 4037 with Senator Smith as the hyphenated cosponsor. Without objection, leave is granted. Any further business to come before the Senate? Any further business? If not, Senator...Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senator Maitland has a motion on 781, I believe...761. If we could move that today to 3rd reading and bring it back would make it more convenient for everybody, if that's reasonable.

PRESIDENT:

I agree. I didn't...I didn't realize the motion had been filed. I beg your pardon. Senator Maitland, I didn't...I didn't get a copy of it. Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President and members of the Senate. I move to suspend Senate Rule 5C that the Committee on Rules be discharged from further consideration of House Bill 761 and that it be placed on the Senate Calendar on the Order of 3rd Reading.

PRESIDENT:

To be called back tomorrow for amendment. Senator Carroll.

SENATOR CARROLL:

Just for purpose of information. That's a bill that's been read before, not a fresh bill coming over, so it's been

read a second time. Is it the intent of the sponsor to bring it back tomorrow? We may have amendments. With that understanding, I would have no objection; otherwise, we would like it to be on 2nd, but if it will be brought back tomorrow, that's...that's fine.

PRESIDENT:

Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President. Yes, Senator Carroll, it will be.

PRESIDENT:

All right, Senator Maitland has moved that the Rules Committee be discharged from further consideration of House Bill 761 and it be returned to the Calendar on the order from whence it came, namely, 3rd reading. All in favor of the motion indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it is so ordered. It'll be shown on the Order of 3rd Reading tomorrow. Senator Berman.

SENATOR BERMAN:

...thank you, Mr. President. We have called a meeting of the Senate Committee on Elementary and Secondary Education for 10:00 a.m. tomorrow, the purpose of which is not to hear bills but to allow the Chicago Board of Education to make its presentation regarding suggested reforms. So, any of you who wish to attend are cordially invited, 10:00 a.m., Room 400.

PRESIDENT:

Further discussion? Further business? Senator O'Daniel.

SENATOR O'DANIEL:

Mr. President, I ask leave of the Body to be added as a hyphenated cosponsor of House Bill 3395. I have permission of the sponsor.

PRESIDENT:

All right, the gentleman seeks leave to be added as the hyphenated cosponsor on House Bill 3395. Without objection,

leave is granted. Madam Secretary, any...first...first reading bills been picked up? All right, with leave of the Body, we'll move to the Order of House Bills 1st Reading for the purpose of reading those in. House bills 1st reading, Madam Secretary.
