PRESIDENT:

The hour of twelve-thirty having arrived, the Senate will please come to order. (Machine cutoff)...members be at their desks and will our guests in the gallery please rise. Prayer this afternoon by Doctor Rudolph Shoultz, Union Baptist Church, Springfield, Illinois. Reverend.

REVEREND RUDOLPH SHOULTZ:

PRESIDENT:

(Machine cutoff)...the Journal, Madam Secretary. Senator Hall.

SENATOR HALL:

Thank you, Mr. President. May I be added as the hyphenated cosponsor of House Bill 4091?

PRESIDENT:

4091, the gentleman seeks leave to be added as an additional sponsor. Without objection, leave is granted. 4091. Madam Secretary...we have only the Resolutions Consent Calendar and the adjournment resolution, ladies and gentlemen. Have any objections been filed to the Resolutions Consent Calendar, Madam Secretary?

SECRETARY:

There have been no objections filed.

PRESIDENT:

All right, Senator Zito will then move the adoption of the Resolutions Consent Calendar, Senate Resolution 1169, 1170, 1174, 1175, 1176, 1177, 1178, Senate Resolution 1179, 1180, 1181, 1182, 1183, 1184, 1185, 1186, 1187, 1189, House Joint Resolution 202 and Senate Resolutions...1190, 1191, 1192. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and the Resolutions Consent Calendar is adopted. Sena-

tor Joyce.

SENATOR JEROME JOYCE:

Thank you, Mr. President. I would ask leave to be added as a cosponsor...Senator Joyce and Senator Welch be added as cosponsors to House Bill 3429.

PRESIDENT:

3429, Senators Joyce...show Senators Joyce and Welch as additional cosponsors. With leave of the Body, leave is granted. Resolutions, Madam Secretary...or Messages from the House, I guess.

SECRETARY:

Mr. President - I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I'm instructed to ask the concurrence of the Senate, to-wit:

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Thank you, Mr. President. House Joint Resolution 203 is the adjournment resolution that calls for us upon our conclusion of our business today to come back next Tuesday, June the 14th, at the hour of twelve noon. I would move for the suspension of the rules for immediate consideration and adoption of House Joint Resolution 203.

PRESIDENT:

All right, Senator Demuzio has moved to suspend the rules for the immediate consideration and adoption of House Joint Resolution 203. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Senator Demuzio now moves the adoption

SENATOR MAITLAND:

Thank you, Mr. President and members of the Senate. To ask leave of the Body to be shown as a hyphenated cosponsor of House Bill 3462, and the sponsor is aware of it.

PRESIDENT:

All right, gentleman seeks leave to be added as a...hyphenated cosponsor on House Bill 3462. Without objection, leave is granted. Senator Jacobs.

SENATOR JACOBS:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. A point of personal privilege.

PRESIDENT:

State your point, sir.

SENATOR JACOBS:

I would like to introduce on the Democratic side of the aisle my former chief of police, Nick Cooperson, and his wife, and a coach...a line coach for Augustana College, Don Davis, and his wife, Nancy. Please stand.

PRESIDENT:

Will our guests please stand and be recognized. Welcome to Springfield. All right, any further business to come before the Senate? Any announcements? If not, Senator Demuzio has moved that the Senate stand adjourned until next Tuesday, Tuesday the 14th, at the hour of noon. Senate stands adjourned. Have a nice weekend.
