PRESIDENT:

The hour of twelve having arrived, the Senate will please come to order. Will the members be at their desks and will our guests in the gallery kindly rise. Prayer this afternoon by Pastor James Johnson, Monroe Street Christian Church, Springfield, Illinois. Reverend.

(Prayer given by Pastor Johnson)

PRESIDENT:

Thank you, Reverend. Reading of the Journal, Madam Secretary. Senator Hall.

SENATOR HALL:

Thank you. Mr. President, I move that reading and approval of the Journals of Friday, May the 20th; Tuesday, May 24th; Wednesday, May 25th; Wednesday, June the 1st; Thursday, June the 2nd; Tuesday, June 7th; Wednesday, June 8th; Thursday, June 9th and Friday, June 10th, in the year 1988, be postponed pending arrival of the printed Journals.

PRESIDENT:

You've heard the motion as placed by Senator Hall. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it is so ordered. Ladies and gentlemen, just to...for those still in their offices or on their way to the Floor, we will begin on page 2 on the Order of House Bills 2nd Reading and proceed through the Calendar until it's time to proceed to the Appropriations I Committee. We'll begin, with leave of the Body, on the Order of House Bills 2nd Reading and we will attempt to move through the Calendar, understanding that the Appropriations I Committee meets a little later this afternoon. Senator Poshard, for what purpose do you arise, sir?

SENATOR POSHARD:

Yes, thank you, Mr. President. Mr. President, would like permission to change the sponsorship of House Bill 3387 from

Poshard to Senator Berman.

PRESIDENT:

And what it does, it requires that a drilling operator planning to drill a new oil well notify the surface owner in writing prior to the commencement of operations and provides for reasonable compensation to be paid to the surface owner for damages and property losses caused by...by the drilling operation. Oil and Gas Association has signed off on it and the petroleum industry, and, as far as I know, there's no opposition. I'd move...

SENATOR KEATS:

This...this is an administration bill from the Department of...or the Commissioner of Banks. What this amendment really does is...is rework the entire bill. It passed...committee unanimously. The amendment was requested by the commissioner, and, again, just a reworking of the bill. I'd appreciate your support.

PRESIDENT:

All right. Senator Keats has moved the adoption of Committee Amendment No. 1 to House Bill 2794. Discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SENATOR NETSCH:

Thank you, Mr. President. Committee Amendment No. 1...this deals with the Truth in Taxation Act, by the way. Committee Amendment No. 1 allows the time period for the notice of public hearing to be expanded from fourteen to twenty-one days. My understanding is that that's something that had been agreed upon between the Press Association and the House sponsor but they forgot to put it on in the House. So, I would move the adoption of Committee Amendment No. 1 to House Bill 2913.

PRESIDENT:

All right. Senator Netsch has moved the adoption of Committee Amendment No. 1 to House Bill 2913. Discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

Amendment...Committee Amendment No. 2.

PRESIDENT:

Senator Netsch on Amendment No. 2.

SENATOR NETSCH:

Thank you, Mr. President. Committee Amendment No. 2 is essentially technical. In the House by amendment we restored the reference to the one hundred and five percent trigger at which the truth in taxation procedures become operative, and there were several references to it that were unintentionally left out. So that plus one additional citation to the new

term "final aggregate levy" are inserted by Committee Amendment No. 2. I would move its adoption.

PRESIDENT:

Senator Netsch has moved the adoption of Amendment No. 2 to House Bill 2913. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

SENATOR NETSCH:

Thank you, Mr. President. House Bill 2918 is the House version of the bill that deals with an income tax refund fund. It is the same as...as Senate Bill 1562 which the Senate has already passed and we're trying to get this one in identical form. This amendment, to the best of our knowledge, does put 2918 in the same form as Senate Bill 1562. And as most of you know, basically what it does is to create a special fund in the State Treasury into which would be

transferred automatically every month a set percentage of the personal and corporate income tax receipts so that the money would accumulate and be available for the payment of income tax refunds. This amendment is the one that tracks 1562. I would move its adoption.

PRESIDENT:

All right. Senator Netsch has moved the adoption of Committee Amendment No. 1 to House Bill 2918. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

SECRETARY:

SENATOR NETSCH:

Thank you, Mr. President. Senator Rigney, this is the amendment I just spoke to you about. We have talked about this before and had not had a chance to show it to you. Amendment No. 2 which tracks the first amendment does two things which will be of enormous interest to local governments. The amendment was really suggested by us and strongly approved by the Bureau of the Budget; in fact, they have been encouraging us to do it. What it does is to make the appropriations from the Local Government Distributive Fund a continuing appropriation so that we will...it's our formula...they...we can't do anything else with the money but sometimes the local governments have had to wait because the appropriation authority was not adequate to cover the amount due them. So this makes that, the Local Government Distribu-

tive Fund, a continuing appropriation and it also makes the corporate personal property tax distribution a continuing appropriation. Again, something that is by formula we cannot control the funds but...because our appropriation authority is not always adequate there are local governments which occasionally have had to wait for that money. We think all of this fits in beautifully with the idea that we are going to have...a special income tax refund. It will help the local governments to get their money on time and it is a marvelous idea and I strongly urge its adoption.

3rd reading. (Machine cutoff)...of page 6. Top of page 6, on the Order of House Bills 2nd Reading. 3055, Senator Poshard. On the Order of House Bills 2nd Reading is House Bill 3055. Read the bill, Madam Secretary, please.

SECRETARY:

House Bill 3055.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDENT:

3rd reading. 3083, Senator Jerome Joyce. On the Order of House Bills 2nd Reading is House Bill 3083. Read the bill, Madam Secretary.

SECRETARY:

House Bill 3083.

(Secretary reads title of bill)

2nd reading of the bill. The Committee on Agriculture offers one committee amendment.

PRESIDENT:

Senator Joyce on Committee Amendment No. 1.

SENATOR JEROME JOYCE:

Thank you, Mr. President. This amendment was offered by the Illinois Bankers' Association. It limits the farmers who are covered by the Act and makes various changes regarding the mediation meetings and clarifies the deadline extensions and shortens the life of the Act. It's a farm debt mediation bill. I'd move for the adoption of the amendment.

PRESIDENT:

All right. Senator Joyce has moved the adoption of Committee Amendment No. 1 to House Bill 3083. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

No further committee amendments.

PRESIDENT:

Any amendments from the Floor?

SECRETARY:

PRESIDENT:

Senator Savickas on Committee Amendment No. 1.

SENATOR SAVICKAS:

Yes, basically it's a...a clean-up amendment, technical. It addresses the state Statute in regard to civil service

system that applies only to Chicago...because that...there is two sections of the Park District Act, one is the statewide section and one applies to the...just to Chicago Park District. It addresses the Chicago problem in the state section and some other technical changes, and I would move its adoption.

PRESIDENT:

Senator Savickas has moved the adoption of Committee Amendment No. 1 to House Bill 3085. Discussion? Senator Marovitz.

SENATOR MAROVITZ:

Senator Savickas, are there any substantive changes in this amendment at all?

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

About the only substantive one would be that it requires the general superintendent appoint...to appoint a superintendent of employment. That...if...if that's substantive, that would be about the only one.

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

And that superintendent of employment would be in charge of all the jobs in the park district?

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

I would imagine so. Not...I guess...I guess with the ability of handling the examinations and testing and...the hiring still goes through as...I would imagine as it has in the past through the general superintendent because of visibility on the budget to either put the positions in or take them out.

SENATOR MAROVITZ:

Well, the civil service examinations were always handled by the board...members of the board. Is this going to be a change so that the...the members of the board will not handle those examinations?

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

...it's...well, all I can read is...the language of law which say, "The general superintendent shall appoint a superintendent of employment to serve at the pleasure and under the direction and supervision of the general superintendent."

SENATOR MAROVITZ:

Well, I guess...I'm sorry...one of...one of the things I want to understand, it seems to me we're...we're...you're allowing someone to...we're...we're creating a new position of head of employment, I guess...is what it is. Why do we need this? I mean, the...the employment has always been handled by the board, by the superintendent of...of parks within the bureau itself. Why do we need a new position? How long is the position for? How much does it pay? Is it a contractual position? Why do we need this?

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

Well, I would imagine that the...the board of commissioners felt that the employment practices and procedures are...there's enough work there that we can and...should use a superintendent of employment to handle all of that.

SENATOR MAROVITZ:

So is this something that the...that the board of commissioners wants? Is it going to take the power away from Jesse Madison to hire and fire? And is this being done at the request of the...of the...of the commission...the board?

SENATOR SAVICKAS:

This amendment was put in at the request of John Cullerton...Representative Cullerton, who introduced the original legislation with the approval of the lobbyists of Cook and Woodard that are lobbying for the Chicago Park District with their approval to be adopted in committee. This amendment does not take power away from the general superintendent. I would think the way it is written it would give him a little more power.

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

I'm not trying to be difficult, I'm really not, I just want to understand. How would this give him more power? If he's got the power to hire right now, and now we're putting on a new head of employment, how would this give him more power?

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

He would serve at the pleasure of the general superintendent.

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

The...can't they hire somebody now? I mean, there...I know that there are positions in the park district, the head of employment, within the park district now, the people who are in charge of personnel. They have those positions right now,...individuals in charge of personnel. I...I...I just don't understand why we're creating this new position when it really exists right now.

PRESIDENT:

All right. Further discussion? Any further discussion?

Senator Savickas has moved the adoption of Committee Amendment No. 1 to House Bill 3085. Further discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

SECRETARY:

Thank you, Mr. President. Committee Amendment No. 1 takes out the immediate effective date.

There is no emergency, certainly, because this calls for an election to happen in 1990, so we have, frankly, plenty of time to consider this and I would ask if the lady would be kind enough to withdraw it or I would certainly urge opposition.

I think it is an emergency and we really do have to kind of set something into place for the future so that we can get some relief from the situation.
