All right. Ladies and gentlemen, as we indicated yesterday, we will begin on the Order of Recalls. All of you have received that sheet that's dated Thursday, June 16. We'll try to go through these and then we'll begin again on 3rd reading, and as I indicated, we will attempt to conclude our business promptly at the hour of noon so that those who have travel arrangements can be accommodated. Madam Secretary, then with leave of the Body, we'll move to the Order of House Bills 3rd Reading. Bottom of page 2, on the Order of House Bills 3rd Reading is House Bill 589. Senator Luft seeks leave of this Body to return that bill to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd Reading is House Bill 589, Madam Secretary.

Amendment No. 2 offered by Senator Luft. PRESIDENT:

Senator Luft on Amendment No. 2.

SENATOR LUFT:

Thank you, Mr. President. Amendment No. 2 is a...an amendment to satisfy concerns that were expressed by the EPA. There are four parts to the amendment. The first deletes the requirement that EPA train and certify solid waste technicians. They did not have the money nor the time nor personnel to satisfy this requirement, so we deleted it. We also state that the operation of a solid waste disposal facility without certified technicians is not a violation of the EPA Act. We...a...we...a qualified solid waste energy facility is also any facility using any amount of methane gas; now that states that it has to be the primary. And we direct the Illinois Commerce Commission to regulate the price of electricity from facilities fueled by landfilled generated That is the same formula that we used in last methane gas. year's bill that we passed on the purchase of electricity from a waste to energy facility. And I would move for the adoption of Amendment No. 2 to House Bill 589.

PRESIDENT:

Senator Luft has moved the adoption of Amendment No. 2 to House Bill 589. Discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

PRESIDENT:

Yes, it looks that way on the Calendar. 2793. Bottom of page 3 on the Calendar, Senator D'Arco. All right. Ladies and gentleman, bottom of page 3, on the Order of House Bills 3rd Reading is House Bill 2793. Senators D'Arco and Hudson seek leave of the Body to return that bill to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd Reading is House Bill 2793, Madam Secretary.

SECRETARY:

The Committee on Finance and Credit Regulations offers
Committee Amendment No. 1.

PRESIDENT:

Senator D'Arco.

SENATOR D'ARCO:

Thank you, Mr. President. Committee Amendment No. 1 provides that corporate trustees may enter into agreements with affiliated banks of the trustee and to pay reasonable compensation for those services rendered by such banks. But nothing in this section...shall be construed as removing any depositary arrangements from the requirements of the prudent person rule. So, everybody has to meet the prudent person rule which is required by law. And I would move to adopt Amendment No. 1.

PRESIDENT:

Senator D'Arco has moved the adoption of Amendment No. 1 to House Bill 2793. Discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

SENATOR NETSCH:

Thank you, Mr. President. The amendment was requested by the County Assessment Officers' Association and it is designed to clarify what is now believed to be a...an ambiguity in the law having to do with the assessment of coal. The Legislature passed a bill effective January 1, '87 which dealt with the assessment of coal. There is another paragraph which seems not to be consistent with that having to do with...the difference between developed and nondeveloped coal. This is intended to put them both in the same synk and to clarify that. And I would move the adoption of Amendment No. 1 to 2909.

SENATOR O'DANIEL:

Mr. President and members of the Senate, Floor Amendment No. 1 to House Bill 3415 allows the Department of Agriculture and the University of Illinois to develop measurements of grain quality and make those measures available to the grain industry. The Department of Agriculture does support this amendment because the amended version makes use of the grain grading system permissive rather than mandatory. The reason for this is, it seems that foreign buyers complain that...they never get what they pay for as far as foreign material and moisture content, and I think this will address that issue and probably improve our export grain trade. And I would move for its adoption.

PRESIDENT:

Senator O'Daniel has moved the adoption of Amendment No. 1 to House Bill 3415. Discussion? If not, all in favor

Amendment No. 3 to House Bill 3408, simply clean—up language to enable the Department of Transportation and other state agencies to comply with the Uniform Relocation Assistance Act of the federal government. The reason for this is that there is mechanisms now by which the departments can reimburse individuals for fair market value for their house and property but there's no assistance in regard to relocation. This would enable them to do so and I move for its adoption.

The question as to whether a transfer has ever conducted operations involving the handling of hazardous substances will not apply to consumer goods stored or hauled by a retailer in the same form as they were sold to the customer. And the second change is any person or transfer who with actual knowledge who makes any false statement, representation or certification in the...disclosure document is in violation of the Act. This amendment has been agreed to by industry, business organizations, the EPA and the Illinois Environmental Council. And I'd ask for its adoption.

It's been supported by the Treasurer, by Chicago

Title and Trust and even the tax buyers have been willing to go along with it. I would appreciate your support of its adoption.

This is a DORS amendment and it provides that all public safety agencies will provide for the requests for emergency assistance for handicapped people who are deaf via a telecommunications device for the deaf, a TDD, within their...service area at a public safety answering point.

PRESIDENT:

All right. Senator Topinka has moved the adoption of Amendment No. 1 to House Bill 4028. Discussion? Senator Demuzio.

SENATOR DEMUZIO:

Well, thank you, Mr. President. I...I don't have any problem, Senator Topinka,...with what you are doing but I...I would question the germaneness of...of your amendment with respect to the bill, because it talks about the rehabilitation services, advisory council and independent living advisory councils, and I was wondering we...we have other legislation around here that deals with the subject that you are attempting to deal with on this amendment. I would just question whether or not this is, in fact, germane.

I am carrying out the wishes of the House sponsor in a package of bills for the deaf, and this is where he wanted it.

3rd reading. 4096, Senator Woodyard. Bottom of page 16, on the Order of House Bills 3rd Reading is House Bill 4096. Senator Woodyard seeks leave of the Body to return that bill to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd Reading is House Bill 4096, Madam Secretary.

SENATOR WOODYARD:

Thank you, Mr. President and members of the Senate. House Bill 4096 deals with community college student trustees. The amendment was felt to be needed by the community college system and it would allow the flexibility to

change the formula if there should be a tax increase. The original formula bill was inadvertently passed out of the House two days ago on 3rd Reading and it was felt by the community college people to allow that...flexibility in case there should be additional revenues that this amendment was needed. And I would move for its adoption.

Senator Woodyard has moved the adoption of Amendment No. 1 to House Bill 4096. Discussion? If not, all in favor indicate by saying Aye. Opposed. The Ayes have it. The amendment is adopted. Further amendments?

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Amendment No. 1 takes the power from zoning regard to floodways away from the municipalities and give it to the county. You might wonder why I have come to that conclusion. As you know, we've had tremendous flooding in DuPage County. We thought we had everything squared away. A week ago with the Department of Transportation, Department of Waterways, we took a little survey of Salt Creek which was the flooding

area. The Village of Addison in the flood plain have allowed eight to ten new houses to be built. I couldn't believe it. The Village of Elmhurst has allowed the Comfort Inn, an eight—story motel, to be built and I've come to this conclusion, that municipal government, generally speaking, could care less about flooding as long as there's some tax incentive for them. I've come to the conclusion it's got to be taken away from those municipalities and put it in county government control. That's exactly what this does. It only applies to DuPage County, no other county.

Thank you, Mr. President, members of the Senate. The underlying bill on 4282 involves allowing two pilot projects at county fairs for parimutuel wagering. Amendment No. 1 contains language that was in about five different bills it looks like. Number one, Senate Bill 2256, by Senator Weaver, that was primarily clean—up language for the Illinois Racing Board. Then there's a bill, 3268, by Representative DeJaegher, another by Representative Cullerton, another one by Representative DeJaegher. And I had been...I have been assured that there is nothing of a controversial nature within this particular amendment. Be glad to answer any questions that you might have on this.

Yes, Mr. President and members of the Senate, I rise in opposition to these amendments. These bills...all these House bills were held in committee in the Rules Committee. Now, in the last days of the Session they're coming out, not out of Rules and through the committee process but coming out as amendment form to be put on. I object to this type of

procedure and would hope that any type of legislation whether it deals with racing or anything else of this magnitude would have the committee process. And I would oppose the adoption of these...of these bills in the amendment form.

PRESIDENT:

Further discussion? Senator Jones.

SENATOR JONES:

Yes, thank you, Mr. President and members of the Senate. I, too, rise in opposition to the procedure and to the adoption of these amendments. We did pass Senator Weaver's bill over to the House. I understand they...held that bill in Rules Committee, they wouldn't let it out. Several of these amendments were in the Rules Committee and they were held in Rules Committee; as a result, there was no time for any committee hearing whatsoever on these...on these bills. So, I think the Body should defeat this amendment and let this...let this...let these bills go through the normal process and be heard as they should be.

PRESIDENT:

Senator Jacobs.

SENATOR JACOBS:

Thank you...thank you, Mr. President, Ladies and Gentlemen of the...Senate. In deference to my colleagues that were talking about getting out of Rules, I know that there's a couple of bills on there that Senator...I mean, Representative DeJaegher had that I was to sponsor over here, and I would agree with Senator Woodyard that...Woodyard, that they are not controversial. I have no idea why they didn't get out of the House...out of Rules, and I...I think that they're good amendments and should be supported.

PRESIDENT:

Further discussion?: Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. I can't speak to the total

amendments, but one of the bills that I sponsored was to clean up some language to implement the parimutual situation at the DuQuoin State Fair and also the Illinois State Fair. It's important that we address that issue in order to really accommodate those two fairs and their parimutual wagering. So,...I...I see nothing wrong with the amendment and I would stand in support.

PRESIDENT:

Further discussion? Senator Savickas.

SENATOR SAVICKAS:

Well, Mr. President, I do think there are some controversial aspects to some of them. Senate Bill 1878 would change and relocate funds from the Chicago host tracks to the Quad-City Downs tracks. I think that's important, I think that should be discussed. I think when we deal with any of these bills that changes the formula and changes relocation of funds from one area to another, it's important and should not be just added on as amendment form and rushed through the Legislature.

PRESIDENT:

Further discussion? Senator Jacobs.

SENATOR JACOBS:

Thank you, Mr. President. I'm sorry to speak for a second time, but I think that Senator Savickas mentioned our track in the Quad-Cities and...and that there may be some controversy with that. This provision has been approved by the Horsemen's Association and the Chicago horsemen have no objections to...to this change in the funding. It...it helps the track, it keeps the track in the business and that's what that amendment is all about.

PRESIDENT:

(Machine cutoff)...Woodyard, do you wish to close? Question is adoption of Amendment No. 1.

SENATOR WOODYARD:

Thank you, Mr. President. I certainly have an empathy with the objection raised by Senator Jones and Senator Savickas, I cannot help that. I certainly agreed to sponsor this amendment as an accommodation to several people who had interest in these particular bills and, as I say,...I've been assured that there is not a controversial issue within the bills themselves. It's simply a matter of procedure and I can do nothing about that. And so I would move for adoption of the amendment.

PRESIDENT:

It basically includes three downstate park districts in the definition of museums to which four—sevenths of the monies paid into the Horse Racing Tax Allocation Fund shall be allocated and passed...passed the Senate 45 to 10. And I'd ask for your favorable consideration.

All right. Senator Holmberg has moved the adoption of Amendment No. 2 to House Bill 4282. Discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Further amendments?

It prohibits the Health...Facilities Planning Board from delegating authority to grant permits and exemptions, authorizes the Department of Health to automatically renew waivers of physical plant requirements when renewing nursing home licenses. These three proposals came out of JCAR, had the support of the Department of Public Health. And I ask for a favorable vote.

House Bill 3255 amends the Telecommunications Excise Tax Act to exempt from the state tax receipts from the sale of telecommunication services and equipment when the...transactions take place between a parent corporation and the subsidiaries or between subsidiaries of the same company. These receipts are currently included under the definition of gross charges subject to taxation. Under current law, for example, the telecommunications

company which sells telecommunications services to a subsidiary within the same corporation must pay a five percent state tax and charge for those services. This bill simply exempts that operation.

PRESIDENT:

Discussion? Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. Just a brief note that the...the bill was amended to take care of a concern that the Department of Revenue had, and at that point, it was not opposed by them and...and it did pass unanimously out of the Revenue Committee. I think in its present form it does effectively avoid what would otherwise be double taxation. So I think it is a fair bill.

So, I...I know of no opposition. I would ask for favorable support.

So, now it'll cost us twice according to Economic and Fiscal for every employee; once for their salary and once for the interest on the bond funds. That's crazy. It's bad enough as it is but maybe that explains to us why we have a hundred million dollar overrun at the State of Illinois Center, possibly as high an overrun at McCormick Place because of the way CDB is operated. If they cannot control the costs of what they tell us a building is going to cost and now we would give them bond funds to pay employees and it'll cost us at least twice, that's crazy. I think this is a terrible idea.

Mr. President and members of the Senate, does exact...does exactly what it says on the Calendar. We amended it so that the director cannot remove nonsworn personnel as head of divisions. It also adds State Police Academy as one of the divisions and I'd appreciate a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Jacobs.

SENATOR JACOBS:

Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates he will yield. Senator Jacobs.

SENATOR JACOBS:

Are these mandated programs that we're going to charge the cities for or are these programs that are not mandated? PRESIDING OFFICER: (SENATOR DEMUZIO)

I can't answer that. This was an administration bill. It came from the State Police and it was to correct a problem which they had perceived in relation to being paid for training local government employees and I can't tell you.

Well, in my experience, Senator, most of the training that is requested by the State Police from municipalities are usually due to mandates from this Legislature to...to ensure that there's adequate training. I'm not sure whether we are in violation of the Mandate's Act here or not.

Senator Davidson.

SENATOR DAVIDSON:

My discussion with the representatives from the State Police...it's not a violation. The only thing they're doing about this was to remove the cap on the fifteen hundred limit on State Police, also removed the place, I think it was District 4 which is south Cook County, where the commander of the State Police was appointing deputy state policemen now in the hands of the director, and then removes that part where they were trying to make a sworn officer had to be head of a

division and I objected to that as did many of the rest of you and we removed that language with the amendment we adopted. I'd appreciate a favorable vote.

Under current law, as I understand it, a person who is employed by the fire marshal to determine cause, origin or circumstances of fires may carry weapons during the time that they are actually investigating. The change proposed here is that an employee of the fire marshal would be classified as a peace officer and therefore would be able to carry weapons whenever they are on duty.

PRESIDENT:

Discussion? Senator Dudycz.

SENATOR DUDYCZ:

Question of the sponsor.

PRESIDENT:

Indicates he'll yield, Senator Dudycz.

SENATOR DUDYCZ:

Senator Rigney, what duties do the employees of the State Fire Marshal perform that would require them to specifically carry weapons? I don't understand.

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

Well, as I understand it, the current limitation is, and it's kind of a fine point and it only affects, I think, less than twenty people, but under current law, they are allowed to carry weapons during the time that they are actually making an investigation...and it...it deals only in...in arson type of situations. Now, under the...this particular proposal, it slightly expands that power because apparently some other times when they might not technically be, you know, engaged in the actual investigation, they still could find themselves in some kind of a hazardous position and this is why that they were seeking this additional classification as peace officers.

PRESIDENT:

Senator Dudycz.

SENATOR DUDYCZ:

I'm sorry, Senator, but I cannot understand what type of hazardous positions other than the time that they are investigating arson would the employees of the fire marshal come across where they would need to carry weapons.

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

Well, realize, this is an arson investigation and apparently when they go out, they maybe don't always technically know whether there's arson involved. I guess that's probably, you know, what they're...what they are determining.

PRESIDENT:

Senator Dudycz.

SENATOR DUDYCZ:

Well, I think it's setting a bad precedent. I think it's a very bad idea and I'm opposed to it.

PRESIDENT:

Further discussion? Senator Raica.

SENATOR RAICA:

Thank you, Mr. President. A question of the sponsor. PRESIDENT:

Sponsor indicates he'll yield, Senator Raica.

SENATOR RAICA:

Senator Rigney, you mentioned that this encompasses about twenty individuals from the State Fire Marshal. My question is, there are other departments that employ arson investigators. Does this also encompass arson investigators with various other agencies such as, either the Chicago Fire Department or...or other cities or towns which my have arson investigators?

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

No, on it's present form, it's fire marshal only.

PRESIDENT:

Senator Raica.

SENATOR RAICA:

Another question, Mr. President, if I may. Senator Rigney, the...when...when the arson investigation is going on, obviously, it's after the fact, so I'm...I'm trying to...to get a...the answer clarified that Senator...the question clarified that Senator Dudycz asked and that's if...if the arson has been committed or supposed arson has been committed already, you have a building for...for...for one reason or another that is...is destroyed. Well, if that's the case, why would that investigator need the weapon and be classified as a peace officer?

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

I understand some of these folks that might be involved in something like this...are not necessarily friendly type of people. I can understand where there might be a certain time that they might suddenly confront a situation where they might be in need of this type of a defense.

PRESIDENT:

Further discussion? Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. A question of the sponsor. PRESIDENT:

Indicates he'll yield, Senator Watson.

SENATOR WATSON:

When you say peace officer status, what does this do as far as their arrest authority? Are we going to have more people out there on the highways now...

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

That certainly is not the intent of the bill. PRESIDENT:

Senator Watson.

SENATOR WATSON:

Well, that may not be the intent but what does it do? PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

I...the way the...the Fire Marshal's Office explained it to me, it was simply, you know, well, they were concerned about the arson type of situation and they're not interested in going out and playing cop on the highway.

PRESIDENT:

Further discussion? Senator Hawkinson.

SENATOR HAWKINSON:

Thank you, Mr. President. I think Senator Watson's question has...has hit the crux of the...the opposition on the head. The concern isn't that they're going to be going out writing traffic tickets, but this will...in addition to the...the weapons protection that I have no quarrel with and which they already have during an investigation, the conferring of the peace officer status would allow them to bypass local police agencies in making determinations of probable cause and...and otherwise causing a situation where you could have conflict in a local jurisdiction, in a county or municipality, between the State Fire Marshal's new peace officers and the law enforcement officers and I believe this is the reason why the Order of Police...I'm assuming is the reason why the Order of Police stand in opposition and why I, too, stand in opposition to this bill.

PRESIDENT:

Further discussion? Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President and members of...Senate.

listened to this bill closely in committee and Tom Bestudik, the State Fire Marshal, testified on its behalf and basically explaining he has eighteen arson investigators presently employed in the State Fire Marshal's Office and the problem has been with arson, doesn't really happen in the best of neighborhoods even after the fire has occurred, and they ask for the peace officers status be granted for...for the additional protection that it gives his employees and it also gives them additional protection as you would call on their pension plan; and I don't see anything wrong with this bill, and I know there's been a few whistles been going around on the Floor already, but if you really take a look at the bill, all you're doing is...is offering these people additional protection in a very hazardous occupation. I will be...supporting this bill at the present time.

PRESIDENT:

Further discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, before these employees could carry the weapons, they have to complete the Law Enforcement Officer's Training Board program. There's only about nineteen or twenty altogether and I think it's a step in the right direction. The fact that they'd have arresting powers, I think they might need them. If they go to some of these jungles where...gangs all over the place, I think they're entitled to have some protection and I speak in favor of the bill.

PRESIDENT:

Further discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Yes, a question of the sponsor, $\operatorname{Mr.}$ President. PRESIDENT:

Sponsor indicates he'll yield, Senator Schuneman. SENATOR SCHUNEMAN:

Is this...is this whole argument really more about making sure that the employees of the Fire Marshal's Office get an alternate pension benefit than it is anything else?

PRESIDENT:

Senator Rigney.

SENATOR RIGNEY:

You know, one of the nice things about working around here is you learn something every day. Frankly,...frankly, Senator Schuneman, I had never heard that issue raised, maybe you can enlighten me on it. I...I had not heard that. It didn't become a part of the record during the...the committee process.

PRESIDENT:

Senator Schuneman.

SENATOR SCHUNEMAN:

Well, that was not a facetious question, Senator. I...I...increasingly what we're seeing around here is a change in classification of people who want to come under the alternate pension benefits and that...those alternates were allowed primarily for people who are engaged in...in prison activities, actual police activities, but more and more, we're seeing changes so that if you've ever seen a gun, then you're going to be eligible for these benefits; and...and I don't know whether that's what's behind this bill or not, I'm only asking you if you...if you know about it.

Secondly, it provides protection for health care providers who do not want to follow the power of attorney directions and provides that they do...they do not have to follow...violate their own conscience, all they have to do is see that it's transferred to another health care provider. It passed the House by a vote of 115 to nothing. I'd be happy to answer any questions.

PRESIDENT:

Discussion? Any discussion? If not, the question is, shall House Bill 3598 pass. Those in favor will vote Aye. Opposed vote Nay. The voting is open. All voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, no Nays, none voting Present. House Bill 3598 having received the required constitutional majority is declared passed. 3600, Senator Etheredge. On the Order of House Bills 3rd Reading is House Bill 3600. Read the bill.

ACTING SECRETARY: (MR. HARRY)

House Bill 3600.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Etheredge.

SENATOR ETHEREDGE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is permissive legislation. It would permit those...the...the authority responsible for the...a...a housing authority to pay per diems to the commissioners of that authority. We've reduced by amendment the population threshold from sixty thousand to ten thousand, and I'd be happy to respond to any questions.

PRESIDENT:

Discussion? Any discussion? If not, the question is, shall House Bill 3600 pass. Those in favor will vote Aye. Opposed vote Nay. The voting is open. All voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, 2 Nays, none voting Present. House Bill 3600 having received the required constitutional majority is declared passed. 3607, Senator Schuneman. On the Order of House Bills 3rd Reading is House Bill 3607. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

House Bill 3607.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Schuneman.

SENATOR SCHUNEMAN:

Thank you, Mr. President. House Bill 3607 changes the registration required for canoes and kayaks in Illinois. There are other bills that would completely eliminate the need to register canoes and kayaks. This bill is more

narrowly drawn. This one only applies to those that are owned by nonprofit organizations in the state and is introduced specifically to help organizations like the Boy Scouts and Girl Scouts. I would be happy to respond to any questions, but I would ask for a favorable vote.

PRESIDENT:

Discussion? Senator Holmberg.
SENATOR HOLMBERG:

Let me just reaffirm for our side what Senator Schuneman has said. This is just a small piece of the reason why we need to deal with the canoe and kayak registration issue this year. There is another bill, House Bill 2925, which you will have an opportunity to vote on later, which takes the whole comprehensive picture of titling and registration, whether or not rafts and float devices, water skis, all of that thing would fall under this definition. The whole area of water craft legislation is being carefully negotiated with the department in hopes that we can come up with a very comprehensive view. I agree with Senator Schuneman that this part of it does need to be handled, but I want to caution you that it doesn't take care of the whole issue that your constituents are corresponding with you about.

PRESIDENT:

Question is, shall House Bill 3607 pass. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 56 Ayes, no Nays, none voting Present. House Bill 3607 having received the required constitutional majority is declared passed. 3612, Senator Poshard. On the Order of House Bills 3rd Reading is House Bill 3612. Read the bill.

ACTING SECRETARY: (MR. HARRY)

House Bill 3612.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Poshard.

SENATOR POSHARD:

Yes, thank you, Mr. President, Ladies and Gentlemen of the Senate. This bill would provide Medicaid coverage to pregnant women and children up to one year of age who are at a hundred percent of the poverty level or below. In addition, the bill allows for a demonstration project in at least one county to implement a Medicaid program for pregnant women and children up to a hundred and eighty—five percent of the federal poverty level. The bill costs no money that is already not included in the budget. I would move for passage of the bill.

PRESIDENT:

Discussion? Any discussion? If not, the question is, shall House Bill 3612 pass. Those in favor vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 57 Ayes, no Nays, none voting Present. House Bill 3612 having received the required constitutional majority is declared passed. Senator Geo-Karis, for what purpose do you arise?

Mr. President, a point of personal privilege.
PRESIDENT:

State your point.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the...the...this astute Body, it's my pleasure to introduce to you a lady who has been the helpmate and soul mate of my congressman, Katherine Porter, wife of Congressman John Porter, who has...distinguished herself by leading a thousand women across the Turkish lines in...in Cypress, rather, with

great risk to her life. I'd like you to welcome Katherine Porter here today.

PRESIDENT:

Mrs. Porter, welcome to Springfield. Senator Welch. On the Order of House Bills 3rd Reading, bottom of page 10, is House Bill 3620. Read the bill.

ACTING SECRETARY: (MR. HARRY)

House Bill 3620.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Welch.

SENATOR WELCH:

Thank you, Mr. President. What this bill will do is require the Office of the State Fire Marshal to adopt rules and regulations regarding aboveground storage tanks and associated piping. Last year, we passed the underground storage tank bill. This law tightens that up due to federal requirements and recommendations. I'd be glad answer any questions. PRESIDENT:

(Machine cutoff)...Senator Dunn.

SENATOR RALPH DUNN:

Thank...thank you, Mr. President. Wonder if the Senator would give the explanation again. We couldn't hear it. There's a lot of noise over here and...tell us again, please. PRESIDENT:

All right, well, let...let me ask...we have a very few moments left to be together today. So, why don't we all try to keep the noise level down. Senator Welch.

SENATOR WELCH:

Yes, to repeat what I said, what this bill does is require the Office of the State Fire Marshal to adopt rules and regulations regarding aboveground storage tanks and associated piping. Last year what we did was we passed the

underground storage tank bill. That bill required fees. This bill does not require fees for your aboveground storage tanks. Now, these are tanks over one thousand gallons in capacity. In addition, this bill makes some amendments to the Underground Storage Tank Act that are basically technical that have been recommended to us by the federal government and in...and in enforing the existing law. I'd also point out that an amendment takes the City of Chicago out of both the Underground Tank Act last year which they requested, and this year to be uniform, they requested to be taken out of the aboveground storage tank law.

PRESIDENT:

Senator Dunn.

SENATOR RALPH DUNN:

Thank you. Does this also apply to agriculture above the ground tanks? The underground tank thing that we passed...I guess we passed it last year, didn't apply to agriculture...to farmers.

PRESIDENT:

Senator Welch.

SENATOR WELCH:

Sir, it will not apply to farmers.

PRESIDENT:

Further discussion? Senator Schaffer.

SENATOR SCHAFFER:

Why are we doing it? Is there a problem? I haven't had any...anybody tell me we have a problem. Are we solving something that isn't a problem? What is the justification for this further infringement of the government on the rights of the citizens of this state?

PRESIDENT:

Senator Welch.

SENATOR WELCH:

Well, there is no constitutional right to have

a...leaking gasoline tank that I know of and, basically, we're trying to register all tanks, number one; provide rules and regulations so that safe tanks are in existence and make sure that the fire marshal has the authority to regulate those tanks and know where they are.

PRESIDENT:

Further...

SENATOR WELCH:

The same philosophy for the Underground Storage Tank Act. PRESIDENT:

Further discussion? Senator Watson.

SENATOR WATSON:

Well, thank you, Mr. President. Well, it seems like that constitutional right is going to be available in Chicago. Why are they being exempted?

PRESIDENT:

Senator Welch.

SENATOR WELCH:

Well, I...hesitant to defend the...I will. The Office of Streets and Sanitations, as I understand, that particular government has authority over tanks in the city and they are entering into a delegation agreement directly with the federal government and with the State Fire Marshal as well concerning aboveground and underground storage tanks.

Senator Watson.

SENATOR WATSON:

PRESIDENT:

This is the same letter that just went out from the department...from the Fire Marshal's Office to the people in our area just within the last month asking them for a hundred dollars for every...underground storage tank. Is this the same legislation? Now we're going to do this for aboveground?

PRESIDENT:

Senator Welch.

SENATOR WELCH:

No, sir, there's no fee for the aboveground tanks. We're just promulgating rules and regulations.

PRESIDENT:

Further discussion? Senator Macdonald.

SENATOR MACDONALD:

Thank you, Mr. President. It may be helpful to clarify the fact that there were no witnesses that signed in opposing this bill and it passed out of Energy and Environment unani—mously. So, at least at the time that it appeared before the committee, we did not perceive this to be a highly controver—sial bill and I would move its passage.

PRESIDENT:

All right, any further discussion? Further discussion? Senator Rigney.

SENATOR RIGNEY:

Well, Mr. President, it may be fire marshal legislation, we must read the fine print. What...what are we doing about residential heating oil? You said farmers were exempt. Are all residential heating oils also exempt aboveground?

PRESIDENT:

Senator Welch.

SENATOR WELCH:

Well, Senator Rigney, we're not really directly regulating them. What we're doing is telling the fire marshal to develop rules and regulations for the possibility of regulating them. I'm not sure how many homes have five...have a thousand gallon tanks for heating oil though, off the top of my head.

PRESIDENT:

Further discussion? Is there any further discussion? Senator Welch, you may close.

SENATOR WELCH:

Thank you, Mr. President. I think we should not confuse this aboveground bill with the belowground bill, but I'll be glad to send a letter to all the members to explain that from last year, but this is basically a bill that the State Fire Marshal wanted to...produce rules and regulations and give him the specific authority over tanks so that we have it clarified who has the authority and what may be done in the future. I would ask for a favorable vote.

PRESIDENT:

Question is, shall House Bill 3620 pass. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 31 Ayes, 21 Nays, 3 voting Present. House Bill 3620 having received the required constitutional majority is declared passed. Senator Schaffer, for what purpose do you arise?

SENATOR SCHAFFER:

I realize the hour is late, but let's have a verification on that.

PRESIDENT:

(Machine cutoff)...request is in order. Senator Schaffer has requested a verification. Will the members be in the seats. Mr. Secretary, read the affirmative roll.

ACTING SECRETARY: (MR. HARRY)

Yes, he's in the phone booth.

SENATOR SCHAFFER:

Senator Brookins.

PRESIDENT:

Senator Brookins is also in the same vicinity there there somewhere.

Senator Jones.

PRESIDENT:

Senator Jones is to my left, as usual.

No comment. Senator...is Senator Collins even further of your left?

PRESIDENT:

No, I don't...I think Senator Collins is also on the phone.

SENATOR SCHAFFER:

Senator Barkhausen.

PRESIDENT:

Senator Barkhausen. Senator Barkhausen is not on the Floor. Strike his name, Mr. Secretary.

Senator Donahue.

PRESIDENT:

Senator Donahue does not appear to be in her chair. Strike her name, Mr. Secretary. All right, on that...the roll has been verified. On that question, there are 29 Ayes,

Your timing is superb. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

House Bill 3626.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Barkhausen.

SENATOR BARKHAUSEN:

I don't know what all the laughter is about. I...I a sure you, the timing of that last urgent phone call was purely coincidental. House Bill 3626, Mr. President and Ladies and Gentlemen of the Senate, authorizes law enforcement officers who make a DUI arrest to impound a vehicle for up to six hours where in their judgment the offender is incapable of...of safely driving the vehicle from the scene of the offense. The bill has passed almost unanimously in the House and was kindly handled by Senators Lechowicz and Hawkinson who were hyphenated cosponsors in the Senate Transportation Committee. Be happy to answer any questions and would otherwise urge a favorable roll call.

PRESIDENT:

Discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Question of the sponsor, Mr. President.

PRESIDENT:

Sponsor indicates he will yield, Senator Schuneman.

SENATOR SCHUNEMAN:

Do I understand that...that if a motorist is found to be intoxicated or accused of being intoxicated to the extent that the police officer feels that it would be unsafe and...and unlawful for them to operate the vehicle that under this legislation, the police would impound the car? Is...is that what you're telling us?

PRESIDENT:

Senator Barkhausen.

SENATOR BARKHAUSEN:

Yes, Senator Schuneman, they could...they could keep the car if there is no other means such as a friend or relative of the offender taking the car safely home or...or away from the scene, they can...they can keep the car from up to six hours. Frankly, I'm...I'm handling this bill for the House sponsor. I'm...I'm not entirely sure how, if it's the case, they're without the authority to do that right now, but anyway, that's the reason for the legislation.

PRESIDENT:

Further discussion? Senator Jacobs.

SENATOR JACOBS:

Thank you, Mr...thank you, Mr. President. Will the Senator yield for a question?

PRESIDENT:

Indicates he will yield, Senator Jacobs.

SENATOR JACOBS:

Is there a clarification...to that point or is it at the discretion of the police officer whether they will consider that there's someone available or how...how is that written into the law? I...I personally think if you give the police officers this right, you're going to have every car confiscated where this happens regardless of whether you have some-

one there or not.

PRESIDENT:

Senator Barkhausen.

SENATOR BARKHAUSEN:

Yeah, my understanding, Senator Jacobs, is that it is discretionary with the police officer as to whether they impound a vehicle for this...for up to six hours or less. The...the bill provides that when a...peace officer reasonably believes that the...the person may...commit a subsequent DUI offense if...if they were to drive their vehicle away from the scene that...that under those circumstances they...they may impound the vehicle, so it...it is discretionary in that sense.

PRESIDENT:

Senator Jacobs.

SENATOR JACOBS:

Just one...one closing comment. Was this bill requested by the tow truck operators?

PRESIDENT:

Further discussion? Senator Welch.

SENATOR WELCH:

Well, I had a question of the sponsor.

PRESIDENT:

Sponsor indicates he'll yield, Senator Welch.

SENATOR WELCH:

My question, Senator, is...is...how is this a constitutional provision? It seems to me to be taking property without any due process. The person...there's an allegation of a ticket, there's no...there may be probable cause but there's no proof. I'm sure...if you would... explain that to me, I would appreciate it.

PRESIDENT:

Senator Barkhausen.

SENATOR BARKHAUSEN:

Senator Welch, I guess my...my answer would...to that would be that it's not a...a taking in a constitutional sense and that it is in...in no way a permanent deprivation. That is why there is this six—hour limitation on the...on the period during which the police department could keep the vehicle.

PRESIDENT:

Further discussion? Senator Kelly.

SENATOR KELLY:

Now, I've got my question answered. Thank you.

Any further discussion? Senator Hawkinson.

But there's no authority in this bill to...to impound and keep that vehicle if there's any alternative that the...the accused has available to removing the vehicle.

Further discussion? Any further discussion? Senator Barkhausen, you wish to call...close?

SENATOR BARKHAUSEN:

Just to make the...the point that, you know, there is I...I believe real...real urgency to this measure. Apparently, there was testimony on the...on the part of the...hyphenated cosponsor, Senator Lechowicz, who was kind enough to handle this bill in committee that he was aware in his district of a...of an instance in which an offender drove his vehicle away after...after being processed for a DUI offense and actually...actually killed an individual. So I think it is essential that we give our law enforcement officers the authority that this bill would grant and...and I ask for a favorable roll call.

PRESIDENT:

The question is, shall House Bill 3626 pass. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 Ayes, 4 Nays, none voting Present. House Bill 3626 having received the required constitutional majority is declared passed. All right. We have...Senator Schaffer, for what purpose do you arise?

SENATOR SCHAFFER:

Mr. President, on a point of personal privilege.
PRESIDENT:

State your point, sir.

SENATOR SCHAFFER:

I would like the opportunity to introduce the Lake County chairman, Mr. Bob Neal, who's a member of the county board and a township supervisor, and the first time in sixteen years, I've beaten Senator Geo-Karis to an introduction.

Mr. President and...members of the Senate, this bill was heard in...committee and was defeated. 4107 was defeated and the sponsor of both 4107 and the next bill, 4108, chose not to call 4108, got up and stalked out of the committee hearing. We all lose, we all win around here. This bill had its hearing in committee and I object to this bill being discharged.

PRESIDENT:

All right. Any further discussion? Senator Collins, you wish to close? All right. If not, the question is, the motion...Senator Collins has moved to discharge the Committee on Executive from further consideration of House Bill 4107 and asked that it be placed on the Calendar on the Order of 2nd Reading. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all

voted who wish? Have all voted who wish? Take the record. On that question, there are 21 Ayes, 31 Nays, 1 Present. The motion fails. 4108, Senator Collins. Read the motion, Mr. Secretary.

ACTING SECRETARY: (MR. HARRY)

I move to discharge the Committee on Executive from further consideration of House Bill 4108 and the bill be placed on the Calendar on the Order of 2nd Reading.

PRESIDENT:

Senator Collins.

SENATOR COLLINS:

Yes, 4108 is the Medical Center Commission bill and there were still some problems to be worked out when the bill was in committee and I didn't call it. The problems has been worked out at this time and I'm moving to discharge the committee and the bill be placed on the Order of 2nd Reading. PRESIDENT:

Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, I rise in opposition to this motion. This bill was posted in committee. The sponsor of both 4107 and 4108 after losing 4107 in the committee chose not to call it, left the committee and said leave it. Let's leave it.

PRESIDENT:

Further discussion? Senator D'Arco.

SENATOR D'ARCO:

You know, Mr. President, the Medical Center Commission is in my district and I've talked to the executive director of that commission, and to indicate to this Body that the problems in this bill have been worked out is a totally inaccurate representation. And I don't know who you talked to about this bill, but you sure didn't talk to anybody at the Medical Center Commission, because they indicated to me that

the problems have not been worked out.

PRESIDENT:

All right. Any further discussion? Further discussion?

Senator Collins, you wish to close?

SENATOR COLLINS:

To Senator...D'Arco, I said that the problems with the amendment had been worked out. I did not suggest that I talked with the Medical Center Commission about this...about this amendment. We were working on an amendment, the commissioners of...Commissioner Still, Commissioner Roselove and others in the City of Chicago was working out an amendment and that amendment was not worked out at the time the bill was in committee. As to Senator Davidson, I did not know that you were a mind reader. Now, you cannot say that I didn't call the bill because the other bill failed, that is not the case. I said leave it...leave the other bill. I was going to leave it whether or not that had...bill had passed or failed. So you...you're not a mind reader I don't think around here, now you may be a lot of other things, but I don't think you're a mind reader. I move for...for the adoption.

PRESIDENT:

All right. Senator Collins has moved to discharged the Committee on Executive from further consideration of House Bill 4108 and asked that it be placed on the Calendar on the Order of 2nd Reading. Those in favor of that motion will vote Aye. Opposed will vote Nay and the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 19 Ayes, 34 Nays, none voting Present and the motion fails. 4125, Senator Jones. Read the motion, Mr. Secretary. ACTING SECRETARY: (MR. HARRY)

I move to discharge the Committee on Judiciary from further consideration of House Bill 4125 and the bill be placed

on the Calendar on the Order of 2nd Reading. PRESIDENT:

Senator Jones.

SENATOR JONES:

Thank you, Mr. President and members of the Senate. Senate Bill 4125 creates the offense for drug induced homicide. The bill had a thorough hearing in committee and there was two motions made to...for a do pass motion but the chairman chose not to recognize that motion...those motions and everything and wouldn't let the bill out. As...it's a bill dealing with drugs and narcotics for those persons who are trafficking drugs. It had a very good hearing and so I ask for a favorable vote on this motion to place this bill on 2nd reading.

PRESIDENT:

Discussion? Senator Barkhausen.

SENATOR BARKHAUSEN:

Mr. President and members, I...I just wanted to point out that I...I thought this bill should have had a more adequate hearing in the Judiciary Committee and...and I, in fact, was the one that made the...the do pass motion. I think it's worthy of consideration by the full Body and would urge your favorable vote on the motion.

PRESIDENT:

Further discussion? Any further discussion? If not, Senator Jones has moved to discharge the Committee on Judiciary from further consideration of House Bill 4125 and asked that it be placed on the Calendar on the Order of 2nd Reading. Those in favor of that motion will vote Aye. Opposed will vote Nay and the voting is open. Have all voted who wish? Have all voted who wish? All voted who wish? Take the record. On that question, there are 48 Ayes, 3 Nays, none voting Present. The motion carries and it's so ordered. 1844, Senator Marovitz. Read the motion, Mr.

Secretary.

ACTING SECRETARY: (MR. HARRY)

(Machine cutoff)...move to discharge the Committee on Insurance, Pensions and Licensed Activities from further consideration of House Bill 1844 and that the bill be placed on the Calendar on the Order of 2nd Reading.

PRESIDENT:

Senator Marovitz.

SENATOR MAROVITZ:

Thank you, very much, Mr. President. This motion has to do with a bill dealing with child...child care workers in the State of Illinois and seeing that these...these workers who deal with abused and sexually abused and neglected children and handicapped and retarded children are...are adequately schooled and trained and there was substantial support in the committee. There was never a roll call taken in committee and I think it's an important issue dealing with the children of the State of Illinois and should be dealt with on the Floor.

PRESIDENT:

Discussion? Senator Jones.

SENATOR JONES:

Thank you, Mr. President and members of the Senate. I rise in opposition to the motion. There was adequate...discussion on the bill and there...there was quite a bit of debate as to whether or not the person should be licensed under the Department of Professional Regulation or should it go under DCFS. I...after discussion, we asked that the bill be placed in...in...working subcommittee to deal with the issue this fall because there was quite a bit of bickering as to where the licensure should take place and the bill did have a roll call, Senator Marovitz. We did ask leave to place the bill in subcommittee, leave was given. So those persons who do support the process of the committee

working, then they will vote against this motion.

PRESIDENT:

Senator Schuneman.

SENATOR SCHUNEMAN:

Thank you, Mr. President. Well, I...I join in...with the chairman of the committee in opposition to the motion. This is an issue which the committee felt was not ready to be sent to the Floor and, therefore, suggested that it go to subcommittee. It was...a vote was taken in committee and I think the motion should be opposed.

PRESIDENT:

Senator Topinka.

SENATOR TOPINKA:

If I might, Mr. President, will the sponsor...could you give me a little more information about the bill, what it does, what it's supposed to do?

PRESIDENT:

No, I'm afraid that question is not in order. All right. Any further discussion? Senator Marovitz may close.

SENATOR MAROVITZ:

Well, this...this is an issue that deals with abused, neglected, retarded and handicapped children and making sure that the...that there's training for those people who are counselors for those kids and who care for those kids in institutions. That's what the issue is and you can vote against it, but the fact is, it deserves to be debated on the Floor and the people who run the homes feel that it's important to have the...the...the proper people in the homes dealing with these kids on a daily basis. That's what this issue is and I think it deserves to be debated.

PRESIDENT:

All right. Senator...

SENATOR MAROVITZ:

It didn't have a roll call.

PRESIDENT:

...Senator Marovitz has moved to discharge the Committee on Insurance and Pensions and Licensed Activities from further consideration of House Bill 1844 and asked that it be placed on the Calendar on the Order of 2nd Reading. Those in favor will vote Aye. Opposed vote Nay. The voting is open. All voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 15 Ayes, 35 Nays, 1 voting Present. The motion fails. Any other motions in writing that have been filed? Senator Carroll on House Bill 3542. Read the motion, Mr. Secretary. ACTING SECRETARY: (MR. HARRY)

I move to discharge the Committee on Appropriations I from further consideration of House Bill 3542 and the bill be placed on the Calendar on the Order of 2nd Reading.

PRESIDENT:

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. As I had filed on 3403, and I apologize for having been off the Floor, but the Secretary of State had asked to talk to me about that motion, I'm glad Senator Davidson moved ahead. In our haste to get done with committee we left a few bills on the Calendar, forgot to call them and, therefore, they were not on the report. This one and the one to follow were to be vehicle bills to be used in the fall if necessary. I would move, therefore, that the Committee on Appropriations I be discharged from...further consideration of House Bill 3542 so it may be placed on the Calendar on 2nd reading. PRESIDENT:

All right. Any discussion? With leave of the Body, can we do them both on one roll call...or one motion? 3542 and 43 to be vehicles to be utilized in the fall. Senator Carroll has moved to discharge those bills from the Committee

on Appropriations I and asked that it be placed on the Calendar on the Order of 2nd Reading. All in favor indicate by saying Aye. All opposed. The Ayes have it. The motions carry and it is so ordered with respect to both bills. Any other motions to be filed will be placed on the Calendar. Resolutions, Mr...Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. President. With leave of the Senate, as the chief sponsor of House Bill 3900, I'd like to add Senators Marovitz, Carroll, Raica and Watson.

PRESIDENT:

SENATOR SMITH:

The gentleman seeks leave to add those Senators as cosponsors. If you...Senator Kustra, if you'd give the list to the Secretary, it would facilitate their record keeping. Without objection, leave is granted. Senator Smith.

Yes, Mr. President and Ladies and Gentlemen of the Senate, I'd like to take leave and request, with the approval of the sponsors, to serve as the...hyphenated sponsor on Senate Bill 2260 and House Bill 3615.

PRESIDENT:

3615. The lady seeks leave to be added as a cosponsor on House Bill 3615 and Senate Bill 2260. Without objection, leave is granted. Resolutions, Madam Secretary.

SECRETARY:

Senate Resolution 1227 offered by Senator Demuzio, President Rock and all members.

Senate Resolution 1228 offered by Senator Fawell.

Senate Resolution 1229 offered by Senator...Senators

Demuzio, Weaver, President Rock and all members.

Senate Resolution 1230 offered by Senator Kelly.

Senate Resolution 1231 and 1232 offered by Senator DeAngelis.

They're all congratulatory.

Senate Resolution 1233 offered by Senator Jones, it's a death resolution.

PRESIDENT:

With leave of the Body, we add those to the Consent Calendar. Resolutions.

SECRETARY:

Senate Joint Resolution 144 offered by Senator Jerome Joyce, it is substantive.

PRESIDENT:

Executive. (Machine cutoff)...yeah. Resolutions. SECRETARY:

Senate Joint Resolution 145.

(Secretary reads SJR 145)

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is the adjournment resolution. It calls for us to come back next Tuesday, June 21st, at the hour of noon. I would move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 145.

PRESIDENT:
