That...that's one area of the bill that the Governor addressed and the...the reason for it was that this land was received from the Federal Government and cannot under the restrictions imposed be leased to other entities. Maybe we can...next session if you want to address it or clear it up, I'd be happy to help.

#### SENATOR TOM DUNN:

Well, thank you, Mr. President. My recollection on...on that issue was that when...when the lease occurs, they take it under the same conditions as given by the lessor and they may not come in and essentially change the purpose for which the land exists now. I will tell you that the residents who...who live adjacent to that property are against that and were against it last fall.

I move to accept the specific recommendations of the Governor as to Senate Bill 1286 in manner and form as follows. Amendment to Senate Bill 1286 in acceptance of Governor's recommendations. Filed by Senator Demuzio.

Senator Demuzio.

#### SENATOR DEMUZIO:

Well, the Governor changed the effective date to July the 1st of 1988. It was the bill that amended the Trust and Trustee Act. Apparently is just provides some additional time for the trustee to enter into agreement with the bank. I would move that the Senate accept the Governor's amendatory veto with respect to Senate 3ill 1286.

## PRESIDENT:

Discussion? Any discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1286 in the manner and form just stated by Senator Demuzio. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 58 Ayes, no Nays, none voting Present. The specific recommendations of the Governor as to Senate Bill 1286 having received the required constitutional majority vote of Senators elected are declared accepted. Senator Berman. On the Order of Motions in Writing to Accept the Specific Recommendations for Change, there's a motion with respect to Senate Bill 1335. Madam Secretary, read the motion, please.

#### SECRETARY:

I move to accept the specific recommendations of the Governor as to Senate Bill 1335 in manner and form as follows. Amendment to Senate Bill 1335 in acceptance of Governor's recommendations. Filed by Senator Berman. PRESIDENT:

Senator Berman.

#### SENATOR BERMAN:

Thank you, Mr. President. This is the computer crime bill and the Governor made two changes which I think improved the bill and I would move their acceptance. The first change...main change was that he...defined vital services in a more specific manner and also addressed the question of due process as to prima facie evidence. Move the adoption of the amendatory veto.

## PRESIDENT:

Discussion? Is there any discussion? Senator Hawkinson.
SENATOR HAWKINSON:

Thank you, Mr. President. Hill the sponsor yield for a question?

## PRESIDENT:

Indicates he'll yield. Senator Hawkinson.

## SENATOR HAWKINSON:

Senator, our analysis indicates that a second change is that the language in the bill originally which protected innocent third parties and...by that I assume he means bona fide purchasers...good faith purchasers from forfeiture is changed to protect bona fide owners only at the time that the offense is committed and that the change is intended to prevent a fraudulent transfer after the fact from insulating the computer from forfeiture, and my question is...does this mean that a good faith purchaser after an offense is no longer protected...what we know in the law as a bona fide purchaser? PRESIDENT:

Senator Berman.

#### SENATOR BERMAN:

I don't have that answer. If you wish, I'll take it out and get you an answer tomorrow.

#### PRESIDENT:

All right, take it out of the record, Madam Secretary. Bottom of page 25, motions in writing to override specific recommendations, Senator Dunn. Madam Secretary, on the Order of Motions in Writing to Override Specific Recommendations, there's a motion with respect to Senate Bill 226. Read the motion, please.

#### SECRETARY:

I move that Senate Bill 226 Do Pass, the specific recommendations of the Governor to the contrary notwithstanding.

Filed by Senator Thomas Dunn.

#### PRESIDENT:

Senator Dunn.

### SENATOR TON DUNN:

Thank you, Mr. President. The first part of...of this bill passed this Body 54 to nothing, and what that required was to have Department of Revenue provide technical assistance to a county assessor in incidents where the EAV was greater than three hundred and fifty thousand. In the House...the bill was amended to have and mandate that DOR at the request of a local assessing official assess an sanitary landfill in a downstate county with a population of less than two hundred and seventy-five thousand. That technically only affected one county, Sinclair County, and it was sponsored by Monroe Flinn. I urge the override of the Governor's veto.

Any discussion? Is there any discussion? Senator Rigney.

#### SENATOR RIGNEY:

Well, Mr. President, the way I understand the reason the

Governor struck out two of these sections is that in a year when we simply do not have the dollars to meet our commitments in a lot of other areas, here we go creating some new commitments for State Government. To provide the technical assistance to any assessor that requests it he felt was certainly was not wise in a...in a tight budget year and that furthermore to involve the state in assessing of landfills to the extent that this is going to require, here, again, a new mandate upon government, upon State Government, no idea, really, about what the cost is going to he of...of administrating these two programs. So, I think I would have to respectfully ask that we hold the line with the Governor on this and I wish that later on that the sponsor would file a motion to simply to concur in the amendatory veto.

#### PRESIDENT:

Further discussion? Any further discussion? Senator

#### SENATOR TOM DUNN:

Yes, thank you, Mr. President. Well, the bill as put before you in the Senate when it passed 54 to 0 was not predicated on a tax increase. There's not one sitting there today. What it merely does is ask that technical assistance be given in those situations as outlined in the bill. I urge for an overrule.

#### PRESIDENT:

Question is, shall Senate Bill 226 pass, the specific recommendations of the Governor to the contrary notwithstanding. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 33 Ayes, 24 Nays, 1 voting Present. The motion fails. 537, Senator Watson. 1009, Senator Savickas, and 1314, Senator Dunn. All right, ladies and gentlemen, we have

effectively been through the Calendar. As I understand the wishes of the Senate, Madam Secretary, you have...resolutions.

#### SECRETARY:

Senate Resolution 595 offered by Senators Rock, Poshard,
Collins, Severns, Thomas Dunn and Holmberg,

Senate Resolution 596 offered by Senator Savickas.

Senate Resolution 597 offered by Senator Brookins.

And they're all congratulatory.

#### PRESIDENT:

Consent Calendar.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock wishes, with leave of the Body, to go to the order of his motion. Is leave granted? Leave is granted. On the order of Senator Rock's motion, Madam Secretary.

## SECRETARY:

I move that temporary Senate Rule 5C be waived and that the Committee on Rules be discharged for consideration of Senate Bill 1520 and that the bill be placed on the Senate Calendar on the Order of Senate Bills on 2nd Reading. Filed by Senator Philip J. Rock.

## PRESIDENT:

Senator Rock.

#### SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 1520 as introduced is a supplemental appropriation in the amount currently of eighteen million dollars. It was discussed at some length, I am told, this morning in the Committee on Appropriations. It currently resides in the Rules Committee and I think in an attempt to expedite our business this Session, we are better served to have that bill out on the Calendar where it is subject to...amendment and will, in fact, be offered for amend—

ment...the amendment stage tomorrow so that members will have an opportunity to react to the pleas of their constituents, many of whom were here today and have appeared in the Appropriations Committee. I...I fully recognize that we are under a limited time schedule, but I think it's fair to say that negotiations with the administration, with the Governor's Office, have begun. We would hope that we would fine...finally wind up with an agreed amount...and an agreed bill, but in the meantime, this is a vehicle that I think will serve us all well and I would ask that Senate Bill 1520...that the rules be suspended and that Senate Bill 1520 be brought out to the Calendar on the Order of 2nd Reading.

All right, discussion? All right, Senator...if not, Senator Rock has moved that temporary Senate Rule 5C be waived and the Committee on Rules be discharged from consideration of Senate Bill 1520 and that the bill be placed on the...on the Calendar on the Order of 2nd Reading. Those in favor of the motion will indicate by saying Aye. Opposed Nay. The Ayes have it. Hotion carries. Senate Bill 1520 will repose on the Calendar on the Order of 2nd Reading. Further business to come before the Senate? Senator Welch.

## SENATOR WELCH:

Thank you, Mr. President. The Committee on Energy and Environment will be meeting immediately in Room 400 for purposes of considering House Bill 911. It should be a very short meeting.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further announcements? Senator...Senator Netsch. Senator Netsch.

#### SENATOR NETSCH:

Thank you, Mr. President. A reminder that the Economic and Fiscal Commission will meet at 8:00 a.m. tomorrow morning in Room 212. We will be updating the revenue estimate and

hearing some additional fiscal analysis. I would certainly urge the members of the commission to be there and any other members are invited.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Netsch, will that be a positive announcement?

Further business to come before the Senate? Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. I would move that the Senate stand adjourned until eleven o'clock, eleven o'clock tomorrow morning.

PRESIDING OFFICER: (SENATOR DEMUZIO)
