The Governor amendatorily vetoed that provision, I liked the provision. I think it made sense 'cause it cuts down on the number of lawsuits, but the House decided to accept the amendatory veto. The other things are important. So I would move to accept the Governor's amendatory veto as to House Bill 474.
