PRESIDENT:

SECRETARY:

To the Honorable members of the Senate, 85th General Assembly. Pursuant to Article IV, Section 9B of the Illinois Constitution of 1970, I veto Senate Bill 566 entitled "An Act Concerning the Regulation of the Practice of Respiratory Care." Senate Bill 566 would require the Department of Professional Regulation to license respiratory therapists. Evidence of actual and systematic harm has not been presented to the...establish that the practice of respiratory therapy poses a significant danger to the public health, safety or welfare. National accreditation and credentialling mechanisms already exist for respiratory therapy practice in addition to hospital accreditation standards...utilization reviews and quality control efforts. Respiratory therapists work under the...supervision of the physicians and are employed by physicians or hospitals who can be expected to properly assess their qualifications. Finally, there is no appropriation to fund a new licensing program which will be effective January 1, 1989, if signed into law. For these reasons, I veto Senate Bill 566. Sincerely, James R. Thompson, Governor.
