A Message for the Governor by Zack Stamp, director of Legislative Affairs. November 15, 1988.

Mr. President — The Governor directs me to lay before the Senate the following Message.

To the Honorable members of the Senate, 85th General Assembly, I have nominated and appointed the following named persons in the offices enumerated below and respectfully ask concurrence in and confirmation of these appointments of your Honorable Body.

# SENATOR NETSCH:

Thank...thank you, Mr. President. Senate Bill...excuse me, Senate Bill 1470 is the bill dealing with a long-term commitment for the funding of the state five pension systems that we in the Senate passed, as I recall, unanimously in 1987, and then was subsequently passed in...this year, 1988, by the House. The...the only change that the Governor has made in the bill is to delay the effective date for one year, and, indeed, that is a recommendation that some of us made to him after we went home. Our plea was this is a major, major piece of legislation, one of the first times the Legislature has ever really grappled with the pension commitments. We do not want to lose the substance of the bill. The extra funding that is required in the first few years is not in the budget. We understand it may have to be delayed for a year but do no



more than that, and that is exactly what the Governor did, he delayed it for effectively one year. It is still an important piece of legislation and I would certainly recommend that we accept the Governor's amendatory veto. It is a proper use of the amendatory veto in this case.

PRESIDENT:

All right, Senator Netsch has moved the acceptance of the Governor's specific recommendations as to Senate Bill 1470. Is there any discussion? Discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1470 in the manner and form just stated by Senator Netsch. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. # SENATOR D'ARCO:

Thank you, Mr. President. This bill was amendatorily vetoed by the Governor, and what it does is change the

all-year program for IRAP into a winter program which was the original intent of the bill. It also provides that...instead of the funds running out in 1989, when it was originally proposed, the funds would run out, when the Exxon Oil over...oil refund money runs out whenever that occurs. This is acceptable to everybody. A task force has been appointed and we are looking into ways and means to keep IRAP viable in the State of Illinois; therefore, I would accept the Governor's amendatory veto.

### PRESIDENT:

All right, Senator D'Arco has moved to accept the specific recommendations of the Governor as to Senate Bill 1626. Is there any discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1626 in the manner and form just stated by Senator D'Arco. Those in favor will vote Aye. Opposed vote Nay. The voting is open. All voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 Ayes, no Nays, none voting Present. The specific recommendations of the Governor as to Senate Bill 1626 having received the required constitutional majority vote of Senators elected are declared accepted. Same order, motions in writing to accept specific recommendations for change, on Supplemental No. 1 there's a motion filed with respect to Senate Bill 2124, Senator Poshard. Madam Secretary.

# SENATOR POSHARD:

Yes, thank you, Mr. President. This bill originally dealt with the relation to security interest in crops. In brief, the...the bill allows either the mortgagee or the operational lender to claim the crops depending upon which lender first files a lien under the UCC. The Governor's amendatory veto here simply clarifies that the seed lender's priority lien is retroactive to the effective date of this Act and that was left out of the original bill. I'd move that we accept the Governor's change.

### PRESIDENT:

All right, Senator Poshard has moved the acceptance of the specific recommendations of the Governor as to Senate Bill 2124. Discussion? Senator Hawkinson.

# SENATOR HAWKINSON:

Thank you, Mr. President. Will the sponsor yield for a question?

### PRESIDENT:

Sponsor indicates he will yield, Senator Hawkinson.

### SENATOR HAWKINSON:

Senator, as I understood the bill as it passed the General Assembly it had the support of both farm groups as well as the banking groups. Is this still true with this change? PRESIDENT:

Senator Poshard.

# SENATOR POSHARD:

It is still true. This change is agreed upon by all the interests that are concerned about this bill.

## PRESIDENT:

Further discussion? Any further discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 2124 in the manner and form just stated by Senator Poshard. Those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have

all voted who wish? All voted who wish? Have all voted who wish? Take the record. On that question, there are 53 Ayes, no Nays, none voting Present. The specific recommendations of the Governor as to Senate Bill 2124 having received the required constitutional majority vote of Senators elected are declared accepted. The bottom of Supplemental No. 1 there's a motion in writing to override the specific recommendations of the Governor with respect to Senate Bill 1562, Senator Netsch. No. All right. # SENATOR Zito:

Yes, thank you, Mr. President and members. I have spoken to the minority spokesperson, Senator Keats, and all committee members on this legislation. We would like to discharge our Committee of Finance from further consideration, to move to 2nd reading on this legislation for the purpose of an amendment. I can explain the amendment now or take care of the discharge and would ask the Chair to recognize the fact that we would like to adopt...at least attempt to adopt the

# PRESIDENT:

All right, Senator Zito has moved to discharge the Committee on Senate Finance from further consideration of House Bill 2533 and asked that the bill be placed on the Order of 2nd Reading and, in fact, read a second time. Any discussion on the motion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it's so ordered. We will now move, with leave of the Body, to the Order of House Bills on 2nd Reading, Madam Secretary.

Senator Zito offers Amendment No. 1.

### PRESIDENT:

Senator Zito on Amendment No. 1.

### SENATOR ZITO:

Yes, thank...thank you, Mr. President and members. You have all received an...a copy of Amendment No. 1 to House Bill 2533. This amendment in the bill would then create the Illinois Financial Services Development Act. The purpose of the legislation is to permit financial institutions to issue credit cards with adjustable interest rates. The Act will permit a lender to increase the interest rate on existing and future debt if agreed to by the borrower in the initial application for credit. The plan is modeled after the concept of adjustable rate home mortgages. With this proposal financial institutions can issue revolving credit under

either existing law or this proposed amendment and Act. purpose of the Act is to strengthen the economic development of the financial institutions of this state. Illinois based financial institutions are losing existing jobs and future job opportunities due to the adverse regulatory climate involving customer revolving credit laws. In order to secure these jobs, the restrictions on such credit laws need to be modernized to enhance the competitive advantage permitted financial institutions located in other states. I think the legislation will put Illinois on par with several states, most notably Delaware and South Dakota that are quite unrestrictive in their credit card laws. While Illinois does not have an interest rate ceiling, restrictions against adjustable rates for interest costs and the twenty dollar maximum...annual fee do exist. This has prohibited Illinois to be able to grow with the credit card industry and has, in ladies and gentlemen, lost Illinois fact, lost...Illinois economic development; and I think by the passage of this legislation we can immediately be the beneficiaries of approximately two thousand jobs in Illinois and Illinois can compete with expand this operation 50 South...South Dakota, Delaware and some of the other states. I'll be happy to answer any questions on the amendment and would move for the adoption of Amendment No. 1 to House Bill 2533.

# PRESIDENT:

All right, Senator Zito has moved the adoption of Amendment No. 1 to House Bill 2533. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The amendment is adopted. Are there further amendments?

# SECRETARY:

# SENATOR KELLY:

Thank you, Mr. President and members of the Senate. This motion would place Senate Bill 1700...or take it from committee and place it on 2nd reading. This legislation would reestablish the one thousand dollar exemption for senior citizens and the...the blind which was taken away by the federal tax revisions. I've talked with, and I'm sure you have too, a number of senior citizens that felt that the Senate let them down during the last year by not passing such legislation, and I would at least like to have the opportunity to have it on the Floor and say we're aware of it, we know it's very important and when the money is there, we're going to go ahead and put this back into place and, therefore, I...I move for this motion.
