PRESIDENT ROCK:

Yeah, but I gotta discharge to Table. All right. If you'll turn to Senate Supplemental Calendar No. 1 there is a Motion in Writing with respect to Senate Bill 801. Madam Secretary, read the motion, please.

PRESIDENT ROCK:

Senator Dunn.

SENATOR T. DUNN:

Thank you, Mr. President. Last spring this bill passed 55 for, and 2 against, here in this Body, and what it does, it allows local option for taxing districts to abate property taxes up to ten years on only newly constructed residences, up to a period of no more than ten years. I urge that the Governor's veto be overridden, and we vote favorably for this bill.

PRESIDENT ROCK:

All right. Senator Dunn has moved that Senate Bill 801 pass, the veto of the Governor to the contrary notwithstanding. Discussion? Senator Karpiel.

SENATOR KARPIEL:

Thank you -- thank you, Mr. President. I have questions. Will the sponsor yield?

PRESIDENT ROCK:

Sponsor indicates he will yield. Senator Karpiel.

SENATOR KARPIEL:

Senator Dunn, do I -- I understand that this bill was passed 55 to 2 last spring and, frankly, if I understand it correctly, I don't know how that happened. My questions are; are you saying in this bill that a local option, meaning, I suppose, a mayor or a local council, can designate any new construction and say that that new construction will have the property taxed abated for up to ten years?

PRESIDENT ROCK:

Senator Dunn.

SENATOR T. DUNN:

They could choose to do that up to ten years. They could make it for one year, or one month, or two years, whatever they sought. But it would have to be done by the elected officials.

PRESIDENT ROCK:

Senator Karpiel.

SENATOR KARPIEL:

Is that on an individual parcel-by-parcel basis or is that a development or -- or an area?

PRESIDENT ROCK:

Senator Dunn.

SENATOR T. DUNN:

There's no restriction on it. If it were to bring in a subdivision, they could do it for a subdivision. As long as it's a newly constructed home, but it must be newly constructed.

PRESIDENT ROCK:

Senator Karpiel.

SENATOR KARPIEL:

Well, thank you, Mr. President. I rise in strong opposition to this bill, for a lot of reasons. If, in fact, there are areas in the State, perhaps in Senator Dunn's district and other districts, where this is used as an economic development tool, suggest limiting it, or changing the legislation to rewrite it to some type of a -- kind of like a TIF district, or enterprise zone, or some kind of a area where this might be needed. But in my district, and other districts like mine that are high growth areas, we have developments popping up every day. You just can't keep up with the growth. The local taxing bodies, like the schools, could possibly be educating all these hundreds and hundreds of new kids, for up to ten years, with no tax revenue stream coming with them. I think it also puts in the hands of some local governments, some local mayors, or boards, or councils, or trustees, or whoever is going to do this designation, I think it

puts in their hands a great deal of power to -- I don't know, play off one developer against another, or do all kinds of damage. But frankly, I'm not as concerned about that, as I am concerned about the lack of revenue for the -- the school districts. I can't see, frankly, in my district that anybody would do that knowing the loss of revenue it would mean, but just on the chance that someone might, I think this is a bad idea. I really would suggest that if you could change the bill to amend it to make it some type of economical -- economic tool for an economically depressed area, it would be a lot more palatable.

PRESIDENT ROCK:

Further discussion? Senator Rigney.

SENATOR RIGNEY:

Well, Mr. President, I think, probably, Senator Karpiel made some excellent agruments against this legislation. I think perhaps it's not well thought out. And I'm kind of embarrassed to think that it went all the way to the Governor's desk before the were found with the bill. This is not limited legislation. This could, you know, the mayor and the council willing, in any town you'd be able to give this type of a reduction. Realize who's filling up our schools, it's the people that are living in these houses and all of this -- the potential here is just absolutely mind-boggling, as to how much could be given away in tax money, if you started, willy-nilly, granting this type of tax relief back home. It seems to me, if you're going to make everybody else in this State pay some rather high taxes, and believe me, they are paying high taxes, what is the justification of allowing these homeowners in these new homes to pay their fair share. And to think you could go up to ten years on this is just incredible, to say the least. ... (machine cutoff)...

Senator Rigney, was that a question or -- all right. Further discussion? Senator Schaffer.

SENATOR SCHAFFER:

Mr. President, I, too, arise in opposition to this. Frankly, I have been a little disconcerted about the lack of sympathy I've many of my municipalities, in terms of developer contributions for school districts. Some of them do not seem to feel that they have any real responsibility for the schools. Most of my municipalities live, almost exclusively, off the sales tax and other State and federal sources. They aren't particularly dependent on the property tax, so when they abate the property tax, it doesn't particularly impact on them, but it is absolutely devastating to a school district. And I know, from time to time, all of us have school districts that have to pass referendums, and my reaction would be that if the taxpayers found out that there was a whole new housing area that had gotten some sort of abatement, you would have one heck of a time passing a tax referendum. I -- I can see some use for abatements for development, in terms of industrial parks, and perhaps even some commercial ventures, but for residential housing, boy -- I think we're really opening the door here.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Maitland.

SENATOR MAITLAND:

Thank you very much, Mr. President and Members of the Senate. Senator Dunn, I think most of us know what -- what we're trying to do here, and I -- I applaud you for the efforts, but I - and I was one who was asleep at the switch last spring, as well. This State has spent a lot of time and resources on activities such as TIFs and enterprise zones, to attempt to -- to improve the economic stability of -- of certain communities. This -- this issue here though, I see -- I believe gives -- gives mayors, if you will, a

lot of power over school districts, and perhaps there might even be a lack of communication and I -- I really fear, as other speakers have suggested before me, that -- that these large subdivisions that have just a tremendous amount of boys and girls going to school, simply won't for ten year period be -- be paying their fair share, plus, plus we can't ignore, once again, the impact that the resource equalizers going to have on this kind of activity. So I would just -- I would urge the Body to -- to reject the measure today, and encourage the sponsor to pursue matters like the TIF or enterprise zones. Something like that to -- for economic development.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Further discussion? Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates he will yield. Senator DeAngelis.

SENATOR DeANGELIS:

Senator Dunn, does this abate the property tax, or abate the assessment?

SENATOR T. DUNN:

The tax.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

I think what's going to happen here is -- and I'm for lowering property taxes, but I got to tell you, if you abate the property taxes, you leave the assessed valuation in there, they're going to lose not only the property tax, but they're also going to lose the State Aid. So, you're whamming them twice, and they're going to have an increase in enrollment, as well, and so I don't know how the heck they're going take care of their particular problems with

education.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Dunn.

SENATOR T. DUNN:

To close?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis, was that a question? Senator DeAngelis.

SENATOR DeANGELIS:

No, that was a statement, but I would like to know which Democrat sawed of my microphone? I've got to be the humpback of Notre Dame to talk into this sucker.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, times have changed since we left here. Further discussion? Senator Dunn may close.

SENATOR T. DUNN:

Thank you, Mr. President. Well, I think you've -- you've raised some issues that maybe do not necessarily address the bill. First of all, this is permissive, and it seems to me around here we make a lot of decisions wherein we trust the local officials that are elected to do things. And it seems to me the argument was last spring on the tax package if we were going to give these people money, that we ought to trust the local officials, who are elected, to fairly distribute it. It seems to me that I heard that discussion? When you raised the question, Senator Karpiel, about you don't have a problem with housing in your area, that may be true; but what about areas that have blighted areas? And what about areas that have homeless people? What about -- what about placing the trust in the already elected officials, who are there to answer to the public, to properly administer this? because there is an opportunity for abuse, necessarily, that our elected officials are going to go out and abuse this process. And what's wrong with attracting to a

blighted area, new housing, and housing for the homeless. So, what I'm suggesting to you is that if there are any abuses in this system, it's something we can come back next year and address, if we have to, or we can look to the locally elected people; and we can have them answer the abuses that they decided. It won't be a mayor's decision, it will be a council's decision. It will be a voluntary decision on their part for them to place no taxes on something in their district. So I urge adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

The question is, shall Senate Bill 801 pass, the veto of the Governor to the contrary notwithstanding. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 16, the Nays are 28, none voting Present. Okay. On the Supplemental Calendar No. 1. Senate Bill 1096. It was Senator Luft's bill originally. Senator -- Senator Berman wishes to -- read the motion, Madam Secretary. ... (machine cutoff)... It's a Luft motion. All right.

SENATOR LUFT:

I'm going to vote No, but I know it's not -- it's a useless effort. Thank you, Mr. President.

You're right. Further discussion? If not, the question is, shall the Senate -- I beg your pardon. Senator Rea.

SENATOR REA:

Thank you, Mr. President. On Senate -- I have a question I'd like to ask of the sponsor.

Senator Luft.

SENATOR LUFT:

That's correct. The Governor amendatorily vetoed that provision out of Senate Bill 1096.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Further discussion? Senator Luft, you wish to close? Question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1096 in the manner and form as just stated by Senator Luft. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 48, the Nays are 2, none voting Present. Senator Smith, are we ready on 745? Has that been worked out with the Governor's Office? All right. Thank you. Page 5 on the Calendar, Ladies and Gentlemen. On the Order of House Bills 3rd Reading. Senator Smith seeks leave of the Body to return that bill to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd Reading, House Bill 745. Madam Secretary.

SECRETARY HAWKER:

Amendment No. 4 offered by Senator Smith.

PRESIDENT ROCK:

SENATOR SMITH:

Thank you, Senator -- Mr. President. This deletes all. It extends Medicaid eligibility for pregnant women, and children up to age six, currently one years of age. It increase an income eligibility standards for pregnant women seeking Medicaid from one hundred percent, to one hundred and thirty-three percent of the nonfarm income official poverty line, as defined by the Federal Office of Management and Budget. This amendment, which becomes the bill, is the compromise between the Department of Public Aid and the Citizens Assembly on Children. This amendment is in line with the federal guidelines and I ask for its approval...(machine cutoff)...

PRESIDENT ROCK:

3rd Reading. Senator Smith, we'll get to that bill tomorrow. Senator Jacobs. 731. Top of Page 9. ...(machine cutoff)...Top of Page 9 on the Calendar. On the Order of Consideration Postponed, Concurrence, is Senate Bill 731. Senator -- Madam Secretary.

SECRETARY HAWKER:

House Amendments 1, 5, 6 and 7.

PRESIDENT ROCK:

Senator Jacobs.

SENATOR JACOBS:

Thank you, Mr. President, Ladies and Gentlemen of the Senate.

I ask that we non-concur in Senate Bill amendments -- all the amendments to Senate Bill 731, and we ask for another conference committee.

PRESIDENT ROCK:

All right. Senator Jacobs has moved to non-concur in House Amendments 1, 5, 6 and 7 to Senate Bill 731. All in favor, indicate by saying Aye. All opposed. The Ayes have it. The motion carries, and the Secretary shall so inform the House. All right. Ladies and Gentlemen, again on Page 6 on the Calendar. Thank you, Mr. President and Members. The amendment to House Bill 2431, which I propose, is necessary because of the enactment Session of Senate Bill 952. If you remember, legislation, among a number of other things, amended Chapter 85 to limit the investment authority of public treasurers. The bill reduced the types of classifications of short-term obligation of corporations' commercial paper in which public treasurers may invest, from the three highest-rated papers, to the highest-rated paper as determined by at least two major rating agencies. The bill further limited the treasurers' investment authority by capping the percentage of public agencies' funds which may be invested in such short-term obligations at twenty-five percent. Previously, as you recall, there were no caps - no such caps existed. This proposal would now revert to the three highest classifications, and would increase the cap on investment of commercial paper to one-third of the public agencies' funds. This proposal is sponsored by both sides of the aisle. Supported by both -- the State Treasurer's Office is on board. The Illinois Bankers Association. Continental Bank. I know of no objections. I'd be happy to answer any questions, and would move for its adoption.

PRESIDENT ROCK:

All right. Senator Zito has moved the adoption of Amendment No. 1 to House Bill 2431. Discussion? Senator Keats.

SENATOR KEATS:

Thank you, Mr. President. I just rise in support of this amendment. It reads Senator Zito, Senator Keats. Really it does

several things, and Senator Zito explained them well. I'll merely say that it does expand investment opportunities, but maintains the consumer protection factors. It doesn't allow investments in non-graded papers and stuff. It really is a pretty decent idea. I would ask for your support.

Rules Committee. All right. Any further business to come before the Senate? Senator Kelly.

SENATOR KELLY:

Thank you, Mr. President. The Committee of Executive Appointments, Veteran Affairs and Administration has listed on the Calendar that there's a ten o'clock meeting in Room 212. It should have been nine o'clock and I'd ask leave that the Committee - and also request that all members of the Executive Appointments be there are nine o'clock tomorrow morning.

PRESIDENT ROCK:

All right. The Gentleman seeks leave to announce the committee meeting at nine o'clock tomorrow morning of the Committee on Executive Appointments. Further business to come before the Senate? Is there any further business? If not, Senator Vadalabene moves that the Senate stand adjourned till eleven o'clock on Thursday, January 11th. We should be in a position to finish relatively early.
