Mr. President, if I could first very quickly on a matter...on a matter of personal privilege introduce the sixth grade class from my alma mater, the Lake Forest Country Day School in Lake Forest, Illinois. There are approximately forty-three students here today from that class...with their teacher, Terry Hate, and I just wanted to make them welcome.

Will our guests please stand and be recognized. Welcome to Springfield. Now, Senator Barkhausen, Amendment No. 2 to Senate Bill 28.

SENATOR BARKHAUSEN:

Amendment No. 2 to Senate Bill 28, Mr. President and members, is the first in a series of...of bills and amendments that we have that have come to us from the Governor's Office's recommendations following up his State of the State...statements, and urging that we take a variety of steps to try to remedy the very serious drug problem in Illinois. This is an amendment to the School Code provisions enacted here four years ago dealing with school report cards. It provides that the report card shall also include student performance data by district on the outcomes under alcohol and drug use and abuse curricula which are developed as required part of the education in the area of physical development and health. And I would move its adoption.

SENATOR DAVIDSON:

Question of the Chair...the statement you just said that the amendment was out of order 'cause some bill was in front of the committee or not, but my understanding whenever a bill is on second floor any member of this Senate has constitutional right to offer an amendment long as it is germane to the same section. How could you rule such an amendment out of order if that's been for...procedure for as many years as I've been around here that a member of the Senate duly elected who has an amendment that deals with the same section has a right to have it voted up or down?

Mr. President and Ladies and Gentlemen of the Senate, we have had numerous bills on the same subject. The fact that they were in committee or not doesn't make any difference. There is Senate Bill 28 on the Floor now and there's been an amendment offered to it, and I think it's only right and proper under all your good rules that that motion be taken up. If you don't like the amendment, vote it down, but I think you're...out of order when you're telling us that because there's another bill in committee we can't go into it. This is wrong, wrong, wrong, and it's not like you to be that wrong.

PRESIDENT ROCK:

Well, I can refer you if...to Robert's Rules of Order, Section 35, says specifically so long as a question is in the hands of a committee, the Assembly cannot consider another motion involving practically the same question. Senate Bill 43, Senator Marovitz. 68, Senator D'Arco. 79, Senator Maitland. 104, Senator Hawkinson. On the Order of Senate Bills 2nd Reading is Senate Bill 104. Read the bill, Madam Secretary, please.

provides for the recognition of drug free schools in communities and sets up a system for providing grants for drug free schools. It further provides that the State Board of Education shall make grants available to qualifying school districts for a variety of related purposes. It provides that school boards are empowered to adopt a policy authorizing school officials to request assistance of law enforcement...officials for the purpose of conducting reasonable searches of school grounds and lockers for illegal drugs and it has some related provisions. I would be happy to answer any questions. I would...I would initially though, Mr. President, say that if...if for any reason you were to make a ruling on this amendment as you did to my Amendment No. 2. on Senate Bill 28 that I ask for a roll call. And if you make that ruling that I would ask that your ruling be appealed and...and ask for a roll call on such an appeal.

PRESIDENT ROCK:

Well, in response, Senator Barkhausen, your prescience is obvious. Yes, it is out of order since it is identical to a bill that is again pending in committee. Senator Barkhausen requests a roll call. And the question is, shall the ruling of the Chair be sustained. Those in favor of sustaining the ruling will vote Aye and those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 27 Ayes, 30 Nays. The motion having failed to receive the necessary three-fifths negative vote the appeal fails and the ruling of the Chair is sustained. Further amendments?
