Yes. Thank you, Mr. President and Members of the Senate. Committee Amendment No. 1 primarily addresses a serious problem -- overcrowded problems that the Department of Corrections have -- has with parole violators. It is my understanding that they receive back into the prisons approximately two hundred and fifty parole violators per month. In addition to that, those persons who violates their -- Work Release Program. And what the bill -- the amendment does, it -- it creates a diversion center -- detention center, so that those persons will not have to go back into the prison and add to the overcrowding problems; and most certainly, it is a cost-saving measure. I think everybody agree that it is far less costly to have these people in the diversion centers rather than back into the prison population. It also makes several technical changes, and confirms <sic> to some of the -- the few differences in the Shock Program that the Governor has, so it bring those two provisions identical, and I would move for the adoption.
