That is language that was suggested by the other side that was taken verbatim, and changed in Rule 43 part A, if my memory serves me correct. Also, a rules change would require that all conference committee reports will sit one full legislative day on a Member's desk before consideration, and would require a conference committee report to have the requisite number of signatures which would, in this particular instance, by rule would be six of the conferees. Another provision is that Appropriations Conference Committee Reports shall be considered by the applicable Appropriations Committee before consideration by the entire Body, and there will be a hearing held in a hearing room with notice to the public and to Members of the Senate.
