Committee Amendment 1 increases, from two to five business days, the length of the period in which a vehicle transferer must apply for a new title following receipt of the vehicle and the title. It changes reference from what is currently called a hazardous motor vehicle to a hazardous, dilapidated motor vehicle. Permits a law enforcement agency to authorize a towing service to impound a hazardous, dilapidated motor vehicle, and adds a statement of finding by the General Assembly. Makes certain other technical corrections. We worked with the State Police and the City of Chicago and the States — the Secretary of State's Office on this bill and this amendment. And I know of no opposition.

Senate -- Senate Bill 32, Amendment No. 1, is thus: it adopts the same minimum wage rate, increases that have been agreed by the Congressional conferees on minimum wage. These same increases were approved by the U.S. House on May 11th. The amendment establishes State minimum wage rate increases on October 1st of each of the next three years, resulting in a four dollars and fifty-five cents per hour State rate on October 1st, 1991. The

first year would be fifty cents. The second year would be forty cents. And the third year would be thirty cents. This amendment reduces the original highest rate in Senate Bill 32 by ten cents an hour, and also pushes back all three dates for increases. The State Chamber of Commerce calls this a responsible amendment. And I urge its adoption.

### SENATOR MAROVITZ:

I would oppose this amendment. I find it hard to believe that anybody would want to take this, the syphilis test, out of our current law. We find syphilis is a disease that is curable with penicillin. There are many cases that are — of syphilis and gonorrhea that are found through these tests, prior to marriage. The disease is eminently curable. The — there is no real expense involved. And I find it hard to believe that you'd want to remove a test like this, where there is a cure for the disease. And many people are — are — many, many cases are found during premarital testing. Both of those things are not true regarding the AIDS test.

## SENATOR ZITO:

Thank you, Mr. President. I don't believe this amendment has been distributed. Can I ask the sponsor if it has? There is not one on my desk.

You found twenty-eight cases of AIDS. It is just the exact same expense as the AIDS. You are saying the AIDS test is

Floor Amendment No. 1 is in response to a request by members of the committee to have the Comptroller, rather than the Illinois Economic and Fiscal Commission, report annually to the General Assembly on the fiscal impact of bid-exempt contracts. Senator Berman. Top of Page 19. Senate Bill 17. Senator de1 Senate Bill 20. Senator Jones. On the Order of Senate Valle. Bills 3rd Reading, top of Page 19, is Senate Bill 20. Read the bill, Madam Secretary, please.

#### SECRETARY HAWKER:

Senate Bill 20.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDENT ROCK:

Senator Jones.

# SENATOR JONES:

Yeah. Thank you, Mr. President and Members of the Senate. Senate Bill 20 comes at the request of the Director of the Department of Children and Family Services. What it does is include homeless youth and youth emergency shelters under the Child Care Act. The Director of the Department and many other social service agencies have been working on this serious problem in the State of Illinois as relate to our runaway youth and teenage homeless youth in the State of Illinois. And by placing this amendment in the Child Care Act, it gives the Director the discretion of setting up the demonstration product -- the demonstration home for these homeless teenage youth in the State of Illinois. And I know of no opposition, and ask for a favorable vote.

# PRESIDENT ROCK:

Is there any discussion? Senator Hawkinson.

## SENATOR HAWKINSON:

Thank you, Mr. President. Will the sponsor yield for a question?

## PRESIDENT ROCK:

Sponsor indicates he will yield, Senator Hawkinson.

## SENATOR HAWKINSON:

The runaway situation, Senator, has been a dilemma for law enforcement and parents and everybody else because, essentially, over the course of the last decade, because of some federal requirements and everything else, law enforcement and parents have been unable to do anything other than to sort of hold the runaway for a few hours and try and urge them to go back home or into a program. And there are some — crisis intervention services that are offered now to them. What will this bill do to the runaway in a practical situation that the crisis intervention people do not currently do?

# PRESIDENT ROCK:

Senator Jones.

# SENATOR JONES:

Well, one of the things the bill would do is set up a temporary shelter to deal with, not only the runaways, Senator, runaway youth - you got different categories. You got the runaway youth that may be just a temporary runaway for one day. You have runaway youth that's been on the street for maybe three or four months. Then you got that hard core youth that's out there. And what this bill would do is give the Department of Children and Family Services the discretion of setting up a teen-age shelter that would network with other agencies to attempt to get those youngsters back to their original home. We -- we looked at this -- this problem, not only here, but we went to California, Los Angeles, San Diego, and looked at some of the types of homes that they have in trying to deal with the homeless youth. And

currently, right now, when we talk about shelters, there is no such thing for homeless teenagers. And you can't mix them with the adults. And then you can't mix some hard core youngsters with the first-time runaways. So this bill is designed to -- for the Department to set the home up, to network with other social service agencies, and attempt to get those children back to their original home.

PRESIDENT ROCK:

Senator Hawkinson.

SENATOR HAWKINSON:

But there's nothing in -- in the bill that would allow DCFS or the these pilot projects to - I don't want to choose a poor word, but coerce or force these people. It would just be an opportunity that would be offered?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Jones.

SENATOR JONES:

Yes. It is more or less permissive legislation to -- to give the Department the authority to do what they want to do, and that is to deal with shelters for homeless youth.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Fawell.

SENATOR FAWELL:

Thank you very much. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

SENATOR FAWELL:

Senator, my county is talking about putting up one of these shelters. And I notice in Section 10-6, harboring a runaway, it's got: Any person, other than an agency or association providing crisis intervention services as defined in the Juvenile Court Act, or an operator of a youth emergency shelter, as defined in the

Child Care Act, who, without knowledge or consent of the parents — minor's parents or guardian knowingly gives shelter, to a minor, and so on and so forth, is going to be guilty of a Class A misdemeanor. Now, what you're saying that these shelters do not necessarily have to notify the law enforcement or parents? Is that the idea?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Jones.

#### SENATOR JONES:

No. That is not what I'm -- I'm saying. When I mentioned runaway youth, that is just part of the problem. We have -- this legislation is designed to deal with the homeless youth, the homeless teenagers. And in some instances you do get that runaway youth for the first time. And currently, right now, if someone were to take them into custody, they could be -- they could run into problems themselves. What this legislation is designed to do is give the -- the Department the discretion of setting up demonstration projects in the State of Illinois, where in if they did get a runaway youth, they would not be in violation of the law.

# PRESIDING OFFICER: (SENATOR D'ARCO)

Any further discussion? If not, the question is, shall Senate Bill 20 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. On that question, there are 56 voting Yes, none voting Nay, none voting Present. And Senate Bill 20, having received the required constitutional majority, is hereby declared passed. Senate Bill 23. Senator Netsch. Read the bill, Madam Secretary.

# SECRETARY HAWKER:

Senate Bill 23.

(Secretary reads title of bill)

Senator Netsch.

#### SENATOR NETSCH:

Thank you, Mr. President. Senate Bill 23 provides for joint nomination of Governor and Lieutenant Governor. As everyone I think, the Constitution of Illinois requires that Governor and Lieutenant Governor run as a team in the general and then provides that the General Assembly may, if it chooses, provide for joint nomination. I don't think I have to remind some Members here of a rather unfortunate thing that happened in my party a couple of years ago. It could happen to anyone. I think the main thing, though, is that the whole idea of that office really was to be a helpmate to the Governor, whoever the Governor might be. And I think this helps to confirm that that will, in fact, be the case. I might mention that this Body, the Senate, passed the identical bill last Session by a vote of 52 to 4. I think there was widespread support for it then. believe the widespread support still exists. I would be happy to answer any questions.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any questions? If not -- Senator Philip.

#### SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senator Netsch, I might -- I must commend you on -- on your -- your idea and your thought, for a change. Normally, I don't find too much in agreement with you, particularly political things. But I always thought the Governor or the President of the United States ought to pick his running mate. There should be no reasons why they shouldn't circulate one petition for Governor and Lieutenant Governor. It's an excellent idea. And we all ought to support it.

I want to ask a question on the last bill, that's all. PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Brookins. Senate Bill 33. Read the bill, Madam Secretary.

SECRETARY HAWKER:

Senate Bill 33.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Brookins.

# SENATOR BROOKINS:

Hello. Thank you, Mr. President. This will permit banking corporations who operate in the Chicago to hold their security against liabilities and obligations in the African Development Bank. The African Development Bank is a franchise mechanism for the development of various nations in Africa. And today, in the front page of the WALL STREET JOURNAL, this bill made front page. And they say it's a very good bill and a very good bank.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? Senator Keats.

# SENATOR KEATS:

Just -- just rising in support of the legislation. Since it

looks like there isn't going to be any opposition, I'll just quickly sit down again then. Thank you.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any further discussion? If not, the question is, shall Senate Bill 33 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. On that question, there are 54 voting Yes, none voting -- none voting Nay, none voting Present. And Senate Bill 33, having received the required constitutional majority, is hereby declared passed. Senate Bill 34. Read the bill, Madam Secretary.

SECRETARY HAWKER:

Senate Bill 34.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

Thank you, Mr. President and Members of the Senate. Senate Bill 34 requests the Department of Public Aid shall reimburse counties for the entire cost of medical assistance for those persons detained in county jails who have previously been determined eligible for medical assistance on the Illinois Public Aid Code.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? Any discussion? Senator Fawell.

SENATOR FAWELL:

Thank you very much. Senator, will you yield for a question? PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

SENATOR FAWELL:

Could you tell us what the fiscal note on Senate Bill 34 says?

Senator O'Daniel.

SENATOR O'DANIEL:

Thank you, Mr. President. Actually, the request for the -no, the fiscal note, when it was -- for counties less than eighty
thousand was eight hundred and twelve thousand dollars. But now
we've added all counties, and I -- I don't have a fiscal note on
that. It would probably -- probably double the cost of it.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Geo-Karis. Wait a minute.

SENATOR GEO-KARIS:

Wait a minute. I believe Senator Fawell wasn't finished. And I'm ready to go --

PRESIDING OFFICER: (SENATOR D'ARCO)

Oh, I thought she was finished. Senator Fawell.

SENATOR FAWELL:

I will be glad to share the fiscal note with you. The Department estimates that the cost, as amended, will be 4.7 million dollars annually. And these funds will not include in the Department's Fiscal Year 1990 budget request. Can you tell me where we're going to get 4.7 million dollars to do this? I mean, my county would love it, but we haven't got the money.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

Senator Fawell, I think the State would be more of capable of furnishing this money than would the local counties. And the thing about the bill - the reason I think this is a fair bill - they're picking up the cost to these people prior to them coming into -- being placed in jail. If they're already eligible for this medical assistance, I don't see why they should be cut off and the county would have to pick -- pick this cost up. And --

And I realize it is some cost, but I think the State would --would be more capable of coming up with the cost of this than the counties can. So - and this does include all counties now in the State of Illinois. And this legislation was given to me by the County Board Association.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Demuzio.

#### SENATOR DEMUZIO:

Thank you, Mr. President. I, too, rise in support of this measure. I think Senator O'Daniel has hit the nail right on the head. There's a lot of these small communities - small counties - that have to pick up enormous medical costs of those individuals who are detained or incarcerated in their county jail. And this -- it's my understanding -- it only applies to those individuals who have been previously determined to be eligible for medical assistance under the Public Aid Code. So, in fact, we would be paying it anyway. And I don't know why we just don't afford us -- why the State doesn't afford us the opportunity, at the local county level, to -- to take advantage of that. And I -- I rise in support of this measure.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Watson.

#### SENATOR WATSON:

Thank you. Question of the sponsor.

PRESIDING OFFICER: (SENATOR D'ARCO)

Indicates he will yield.

#### SENATOR WATSON:

Senator O'Daniel, why is it now that an individual who's incarcerated is not eligible for reimbursement under Public Aid benefits. Why is that now?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

## SENATOR O'DANIEL:

I don't know why they aren't now. I know they -- this is the ones that -- deals with the ones that are already eligible, prior to being placed in jail. What this says, that they will continue to be -- the cost for medical assistance will continue to be picked up by the Department of Public Aid, instead of the local county governments having to pick this charge up.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Watson.

## SENATOR WATSON:

Thank you. That's my question. Is -- isn't that current policy of the Department, that even though an individual is incarcerated, can't they be eligible for Public Aid benefits while they're in the county jail, especially medical?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

#### SENATOR O'DANIEL:

As the -- as the present law, they -- they pick up, all above twenty-five hundred dollars. Now they'll pick it all up.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Kustra.

# SENATOR KUSTRA:

Thank you, Mr. President and Members of the Senate. You know, we here in Illinois, who have a balanced budget, oftentimes scoff at our colleagues in Washington at the imbalanced budget that they have, and here we go right down the same path as Washington. I mean I — I don't know how we can sit here today, very early in our Session, and add millions of dollars to a budget which has already been planned out. Senator Watson asked a very good question, and as Senator O'Daniel said, under current law, the Department reimburses the jail only if the cost of medical expenses exceeds twenty-five hundred dollars. When you open this

thing up, and then you add Cook County, and, again, it's my understanding that, by amendment, Cook County is now included in this bill. Boy, I mean you're into real big bucks. And I just don't see how you can -- you can obliterate an existing policy now, drive up the cost of the budget, when we can't figure out a way to get to June 30th. This is a bad idea, especially now. And I would urge a No vote.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel, to close.

#### SENATOR O'DANIEL:

Thank you, Mr. President and Members of the Senate. I think this -- this is a very fair bill. You know, it's got where the Department of Corrections tells us the type of facility we have, and they're always telling us what we have to do out there. And -- and the counties don't have money enough to upgrade their jails and provide medical care and -- and retain the prisoners for months at a time. And I think, you know, if they're going to put all these requirements on counties, they should pick up the cost of it. And I'd appreciate an affirmative vote.

## PRESIDING OFFICER: (SENATOR D'ARCO)

All right. The question is, shall Senate Bill 34 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Is your light working, Ethel?

#### SENATOR ALEXANDER:

Mr. President -- oh, thank you -- Senate Bill 33, which I am a co-sponsor, I pressed my button for Yes. It did not light up. I've been recorded as not voting. Would you -- the record reflect that I did vote? thank you.

# PRESIDING OFFICER: (SENATOR D'ARCO)

All right. Well, right now we're on 34. We'll get back to it. Thank you. All right. Have all voted who wish? Take the

record. On that question, there are 34 voting Yes, 22 voting Nay, none voting Present. And Senate Bill 34, having received the required constitutional majority, is hereby declared passed. Ethel, the record will so reflect on Senate Bill 33. Senator Watson. Read the bill, Madam Secretary.

# SECRETARY HAWKER:

Senate Bill 36.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Watson.

# SENATOR WATSON:

Thank you, Mr. President. This increases the minimum salary that would trigger the need for an economic interest statement from thirty-five thousand to forty-five thousand. This is for State, local government, and school district employees. This does not affect the General Assembly. It does not affect the -- any local elected official. We're told that by 1990 there's going to be some hundred and fifty-five thousand people that are going to have to comply with the Act under current salary structure of thirty-five thousand. All we're doing is raising that from thirty-five thousand to forty-five thousand. We've done this over the years. It started out at fifteen thousand. We raised it twenty thousand, then to twenty-five. A couple of years ago, in 1983, we raised it to thirty-five. So I think that it's raising it to forty-five is proper now. And I would ask for your support.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? Senator Lechowicz.

# SENATOR LECHOWICZ:

Thank you, Mr. President. Will the sponsor yield for a question or two?

Senator Watson, how many people will be -- who's in this gap between thirty-five and forty-five thousand for State, local, and school districts?

Senator Watson.

SENATOR WATSON:

Well there's, right now, some hundred and eighteen thousand employees that are employed by those levels of government that are required to file. They -- as I mentioned in my opening remarks, that's going to be raised to some hundred and fifty-five thousand by 1990, if this bill isn't adopted.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Lechowicz.

SENATOR LECHOWICZ:

Mr. President, I think we should really look very carefully at what we're asked to do here this afternoon. When the Ethics Legislation was originally passed, after much heated debate, it was to be inclusive. And if you recall that when we all our elections, many of our ethic statements are thoroughly and rightfully so. Now we're coming up with an exclusion for State employees, units of local government and school districts, saying if you make over thirty-five thousand, we -- you won't have to file anymore. It will be forty-five thousand that'll be the new threshold. I think this is a step in the wrong direction. We, as the Membership of the General Assembly included many, many years ago, of including and making sure that the sun shone upon all of us. And at thirty-five thousand dollars, I don't think it's an annual wage that should be raised. take a look at the budget -- the State budget, there aren't too

many employees that fit in that category. Most of your code directors are above that. And they'd be included. But your day-in-and-day-out employee, unfortunately, is making much less. I think thirty-five thousand dollars is an adequate threshold. And it should remain the same.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Watson, to close.

## SENATOR WATSON:

Well, thank you. I brought this bill before the Executive Committee, I guess it was, and Senator, you supported this in committee. It passed unanimously, 17 to nothing. This was brought to me by a circuit clerk in my district who is concerned about the mayor's office and the people that have to continually file for -- for this Economic Interest Statement. And we're talking about 1990, a hundred and fifty-five thousand people having to send in an Economic Interest Statement. I'm not sure who's going to sift through all those -- all that paperwork, but I just think that this is really a step in the right direction. All we're trying to do is keep up with -- somewhat with inflation over the period of time since 1983 -- was the last time that this threshold was raised. I see no problem with it. As I mentioned, it passed out of committee a 17 to nothing vote. I'd appreciate your Yes vote. Thank you.

# PRESIDING OFFICER: (SENATOR D'ARCO)

Any further discussion? If not, the question is, shall Senate Bill 36 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. On that question, there are 28 voting Yes, 22 voting No, 1 voting Present. And Senate Bill 36, having failed to receive the constitutional majority, is hereby declared failed. Senate Bill 38. Senator Welch. Senate Bill 41. Senator O'Daniel. Read the bill, Madam

Senate Bill 41.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

Thank you, Mr. President. This bill is similar to Senate Bill 34, and was given to me by the County Board Association. And what this -- this bill does, as amended, it requires the Department of Corrections shall reimburse the counties for each person committed to county custody at a rate of forty dollars per day for each day served over thirty days, with a maximum of -- to be eligible to -the maximum amount per a prisoner that counties would be eligible to receive would be thirteen thousand two hundred dollars, you know. And my feeling about this legislation is that Department of Corrections is almost making mini-prisons out of our -- out of our county jails. And I think it's probably cheaper for the counties -- for the Department of Corrections to keep prisoners here and pay this than it probably would to build a new prison. But I think, you know, if they're going to demand all of the upgrading of the jails and all, they have to pick up part of the cost of this.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? Senator Fawell.

# SENATOR FAWELL:

Thank you very much. Here we go again. This has got a fiscal impact of -- of four million dollars. We just spent 4.2 million dollars to help the local jails out. You know, it's -- it's a good idea, except that, very frankly, we -- we're not going to be able to afford all this. It's our judges that put these guys in

jail. Frankly, these are minor offenses, if they are put in county jails, and not felons. And -- and they're not class acts, they're the guys that are -- are drunk on our streets or they're doing minor offenses. You know. Senator O'Donald, we can't afford it. And I think we ought to quit trying to do this. And I would suggest that we vote No.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Donald is in the House. Senator Hawkinson. SENATOR HAWKINSON:

Thank you, Mr. President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

#### SENATOR HAWKINSON:

Senator, I was with you on the last bill. And, depending on how you answer this one, I may be with you on this one as well. I -- I was one who fought, when I was in the House, against the State's limitation of Vandalia and other institutions, where they wouldn't let us put misdemeanors -- misdemeanants again for a And, in effect, they were making us mini-jails, and shifting that cost on to the counties. However, I don't think that it's fair to make the State pay for someone who is simply waiting in a county jail, waiting for trial. And that's my question. Does -- does your bill -- someone who's waiting a hundred days in a county jail or longer, if there's a continuance that the defendant asks for -- if that person is waiting in the county jail for trial, and is -- and may never be sentenced to the Department of Corrections, but then receives a sentence for -- for time served or something, and is simply there because he waiting trial, I don't think the State ought to have to pay for that. And my question is, under your bill, would the State have to pay for that?

I've been informed that probably this just affects the ones that have been sentenced.

## SENATOR HAWKINSON:

My question is, if it's someone who is sentenced retroactively and doesn't have to serve an additional day in jail, but is given credit for that time he or she has served awaiting trial, will the State have to come in retroactively and pick that up? And if that's the case, would you be amenable to an amendment that would not force the State to pay, unless it's a prospective sentence.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

#### SENATOR O'DANIEL:

I -- I think you're probably right. Maybe we ought to take this out of the record. And maybe I want to put it back on the recall list and try to amend it.

PRESIDING OFFICER: (SENATOR D'ARCO)

Take it out of the record. Senate Bill 44, Senator Smith. Read the bill, Madam Secretary.

# SECRETARY HAWKER:

Senate Bill 44.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Where's Kustra? Senator Smith.

#### SENATOR SMITH:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate Bill 44 -- Smoke Limitation Act. Whether it's

etiquette issue or a public health issue, the problem of smoking public places and the effects of passive smoking have been getting the attention of the Illinois citizens. Medical research shows that passive smoking can cause common irritations, headaches, aggravated allergies, and lung-related Therefore, this smoking bill that we have here today is to prevent health care institutions, including physicians, offices, and in child care institutions, which will be classed as a petty offense. With the amendment that we had, it would delete the language requiring the Department of Public Health administer this Act. And with this amendment, the Department of Health supports Senate Bill 44. I ask for your favorable vote. PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? If not, the question is, shall Senate Bill 44 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Take the record. On that question, there are 36 voting Yes, 13 voting No, and none voting Present. And Senate Bill 44, having received the required constitutional majority, is hereby declared passed. Senator Smith. Senate Bill 45. What? You want to hold those? Okay. Senate Bill 50. Senator O'Daniel. Read the bill, Madam Secretary.

# SECRETARY HAWKER:

Senate Bill 50.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

# SENATOR O'DANIEL:

Thank you, Mr. President, Members of the Senate. What this bill does, it -- it kind of makes a clarification and it exempts

-- what it really does is exempts rotary mowers that are used to maintain federal farm programs set aside and -- and conservation reserve acreage. The Department of Revenue has now signed off on this bill. There was some concern about what was eligible and what wasn't. And I think now it's been clarified and -- and the Department of Revenue doesn't have any problem with this now.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? Senator Keats.

SENATOR KEATS:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

SENATOR KEATS:

Why is the Farm Bureau listed in opposition? I can see the Department of Revenue opposing it. Why is the Farm Bureau opposed?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

That's -- that's a mistake if you've got that information. Farm Bureau helped draft the legislation. Farm Bureau, farmers' union and equipment dealers, and all farm organizations support this legislation. And, actually, some dealers were charging tax, some wasn't. And it was -- it was more of a confusion. And actually, it doesn't amount to that much, but it is some clarification. And the Department of Revenue has signed off on it.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Davidson.

SENATOR DAVIDSON:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR D'ARCO)

SENATOR DAVIDSON:

Does this imply that only the sales tax on mowers that's going to be used only on set-aside acres — and you and I both know that no farmer is going to buy a new mower just to mow set-aside acres; he's going to use it for the rest of his farm operation. Does this apply only to that portion of the machine that's going to be used to mow set-aside — set-aside acres? Or is it all inclusive? PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

No. Senator Davidson, what -- what the problem was, the Department of Revenue didn't think that was part of a farming operation to mow the setaside acreage and all. So, you know, I had problems understanding why they thought that wasn't part of a farming operation. So, they weren't allowing -- they weren't allowing the sales tax exemption on -- on some of these rotary mowers. They thought maybe they were used for other purposes other than that. And -- and it is a -- this is just clarification.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Davidson.

SENATOR DAVIDSON:

I thought they were already exempt under the present Act, being the sponsor of the Act that created the exemption for farm machinery sales tax a number of years ago. I thought they were already exempt.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator O'Daniel.

SENATOR O'DANIEL:

I agree with you. I thought so, too. But the Department of Revenue were having some problem with this interpretation, so this

clears it up. And they're in agreement now. It should have never been — there shouldn't have been any question, because that is a piece of equipment that's used to — to vent part of the farming operation.

PRESIDING OFFICER: (SENATOR D'ARCO)

All right. Any further discussion? If not, the question is, shall Senate Bill 50 pass. All those in favor, vote Aye. A11 those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. On that question, there are 55 voting Yes, 1 voting No, none voting Present. And Senate Bill 50, having received the required constitutional majority, is hereby declared passed. Senator Topinka. Senator Welch. Senator Welch. I'm sorry. No. Senator Zito. Senator Lechowicz. Read the bill, Madam Secretary.

## SECRETARY HAWKER:

Senate Bill 61.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Lechowicz.

# SENATOR LECHOWICZ:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 61 does four things. It really corrects the home equity legislation that we passed last year. It provides a mechanism where additional precincts can be added with the request of going to the commission and approval of fifty percent of the voters within those precincts. Requires the commission members be appointed — the reappointments the same way that they were originally provided in the bill. It also clarifies that the home that is sold has to be a bona fide sale. And the fourth thing, it provides a funding mechanism. That's all the bill does. I'd be

more than happy to answer any questions. Ask for your support. PRESIDING OFFICER: (SENATOR D'ARCO)

Any discussion? If not, the question is -- I'm sorry. Senator Collins.

#### SENATOR COLLINS:

Question of the sponsor, please.

PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

#### SENATOR COLLINS:

Senator, did I understand you to say that it -- that in order for additional precincts to be added, it only took fifty percent of the voters and not a majority?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Lechowicz.

## SENATOR LECHOWICZ:

It's a twofold procedure. One, they make an application to the commission. Two, it requires 50.1 or fifty plus one, in order to be approved by the respective precinct to be an adjoining -- or coming into the -- a membership of the home equity area. So it requires two items.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Smith.

#### SENATOR SMITH:

Yes. A question of the sponsor, please.

PRESIDING OFFICER: (SENATOR D'ARCO)

He indicates he will yield.

## SENATOR SMITH:

What about people who own property there? Will they permitted to be -- permitted to stay there? What other requisites? I mean, you -- you have a -- a certain amount of people who are going to pass on the people who are going to live in those communities. Is that right? Is that right? You want to sort of monitor that

community? Is that right?

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Lechowicz.

#### SENATOR LECHOWICZ:

Thank you, Mr. President. Let me just briefly explain the purpose of home equity. Home equity is to provide a insurance mechanism for existing home owners, no matter whether they're white, black, yellow or green, within a certain district that had been approved by the voters within their respective area to be part and parcel of a home equity program. And they, in turn, go to a board, and the board be given an assessment on the property. Then the bill that we passed last year was .10 of the assessed valuation would go into an insurance pool. That pool will only be used if a person who is - and that's with the clarified language in here - makes a qualified sale on his property, and if below the assessed valuation that was assessed when this originally was proposed, then a triggering mechanism would pay the difference. This is a piece of legislation that was modeled after the Oak Park ordinance, which was debated on this extensively last year. I don't believe that there is -- there hasn't been a precinct that I know of where it's been made available, that it's been rejected. And it's -- covers both black and white areas in my community, and it's been approved in both. PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Smith.

#### SENATOR SMITH:

The way our government has been running in the City of Chicago for lo, these many years, it's very few people that are really organized as far as precincts are concerned. And you know that. Will that deprive people who have nice property? How will this affect -- is this just for a certain area? I want to find out. PRESIDING OFFICER: (SENATOR D'ARCO)

SENATOR LECHOWICZ:

Thank you, Mr. President. It affects anyone who's interested in protecting and making sure that the evaluation of his home is a fair market value when he's out there to sell. It affects nice property, medium-income property, low-income property, anybody who wants to participate. All they have to do is vote for it, and be a -- take, as I mentioned earlier, the course of action in order to be included.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Dudycz.

SENATOR DUDYCZ:

Well. Thank you, Mr. President. Senator Lechowicz is absolutely correct. This is merely clarifying language to the home equity bill that we passed last year. It will -- currently the home equity law, as it stands, does not allow certain contiguous precincts, some of which are in my district, to opt in. This will allow those precincts to join this home equity assurance program. And it's just clarifying language. And I urge your support.

PRESIDING OFFICER: (SENATOR D'ARCO)

Any further discussion? If not, the question is, shall Senate Bill 61 pass. Those in favor, vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. On that question, there are 48 voting Yes, 3 voting No, and 3 voting Present. And Senate Bill 61, having received the required constitutional majority, is hereby declared passed. Senate Bill 62. J.J. Joyce. Read the bill, Madam Secretary.

# SECRETARY HAWKER:

Senate Bill 62.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Joyce.

## SENATOR JOYCE:

Thank you, Mr. President. This bill would permit townships who receive no service from the RTA by 7-1-89, this year, to opt out through the referendum process. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR D'ARCO)

Senator Keats.

#### SENATOR KEATS:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. rise in opposition to the bill for two or three reasons. first is sort of a philosophic one - to say that a train station that's not quite in your township, but right across the road, is not an asset, is probably not a realistic assessment. isn't really the issue, because we could argue either side. There's a practical problem of the bill. The Department of Revenue is opposed. And I'll read a little bit of it, because this is a very legitimate problem. I don't know how Revenue is The Department of Revenue is opposed to the going to do it. legislation because it would require that we track businesses in each of the townships are still subject to the RTA sales tax, and which businesses in each of the townships are not. The Department does not have information to do this. Currently, businesses are identified by the Department, according to county and incorporated municipality. For these businesses that are not in an incorporated area, the Department would have no way of determining whether or not they were located in an affected township. Given the sheer volume of businesses in the the collar county area, attempting to track this information would be almost impossible. In addition, errors regarding proper distribution of

the monies would be possible. From a practical point of view, the bill is unworkable. From a philosophic point of view, it's up one, down one, doesn't really matter. But from a practical point of view, you basically can't do it, particularly when you have municipalities that are crossing township lines etc., which, in those collar counties, happens quite regularly.

#### PRESIDENT ROCK:

Further discussion? Senator Watson. SENATOR WATSON:

Yes sir. Thank you. I don't understand the last speaker at all, because in Madison and St. Clair County a few years ago, we did the very same thing. We were concerned about the bi-state issue in our area, and we allowed for townships to opt out by referendum if they so wished, if they don't have this service. I don't see a problem with the approach here. And I don't think that the people that live in a particular township should have to pay for services they're not getting. That's all your asking for, Senator. And I agree with it. Thank you.

#### PRESIDENT ROCK:

Further discussion? Senator Lechowicz.
SENATOR LECHOWICZ:

Mr. President, Ladies and Gentlemen οf the unfortunately I'm going to have to stand in opposition to 61. supported the bill in -- in committee so the gentleman could have the opportunity to debate it on the Floor. But now, in reality, what we're doing is, we're making a total erosion of the RTA Act. And, unfortunately, it's -- I'm sure that all of us can probably remember the fact when the RTA was created, and Bob Blair took a defeat over it in the House as a Speaker. And a couple other friends on the other side of the aisle lost, as well, in McHenry County. What we're doing here is -- when we created the RTA, it was for the purpose of creating a unified system in a six --

northeast area of -- in the six counties of the northeast area of the State of Illinois. And now we're having Will County being excluded for certain townships because there are no buses, supposedly, governing that area. The next area will be McHenry, and possibly Lake. Then you're going to have a justification as far as the elimination of some federal funding. I don't know of the -- anyone from the RTA/Metra who could really support this. because of possible loss of funds. I do know when this bill out of committee, I heard on WBBM Radio that their RTA board is now talking about extending services to this section of Will County, and possibly McHenry. Maybe this bill had this type of an But I, for one, cannot support it on the Floor now, because, in fact, I personally believe it's an erosion of the RTA Act. It's going to seriously affect the possible loss of federal funds. And for that reason, I wanted to bring it to your attention, and ask that you support, whether you're for it or against it, accordingly. Thank you.

## PRESIDENT ROCK:

Further -- further discussion? Senator Dunn.

# SENATOR T. DUNN:

Thank you, Mr. President. I rise in support of this for a very simple reason, and that is that no representation, no tax.

PRESIDENT ROCK:

Further discussion? Senator Karpiel.

# SENATOR KARPIEL:

Thank you, Mr. President. I also rise in support of this bill. I think you don't have any service, there shouldn't be any tax.

## PRESIDENT ROCK:

Further discussion? Senator Collins.

#### SENATOR COLLINS:

Yes. Unfortunately, I have to, too, rise in opposition, for

the same reasons articulated by Senator Lechowicz. If you look at the RTA's plan for the region, you may find that there are plans to extend services to some of those small townships that are now currently not receiving services. So as industry moves and jobs move to the suburban areas, and that is the trend, and it seems to be no indication that there is going to be any changes in the future, there most certainly will be a need to expand public service - transportation service - to those particular areas. And if we stop collecting the taxes, then there will be no possibility of providing for those services. You can't say that we're going to stop collecting the taxes and then put in the service. And then after the service is in, we will now start retaxing you again. So I think it is just ill-advised at this time. And I -- I rise in opposition to the bill.

## PRESIDENT ROCK:

Is there any further discussion? Further discussion? Senator Joyce, you wish to close?

## SENATOR J.J. JOYCE:

Thank you, Mr. President. Well, this would not only impact Will County. It would be Dupage, Kane, Lake, McHenry, And if every township that isn't receiving this service were to opt out, it would cost the RTA the whopping sum of a dollars a year. Now, I tell you, they -- probably only a few townships will opt out. Some of those townships in my district have contributed over the last sixteen years. Now it's not much It's two hundred thousand dollars one of them has money. contributed. Two hundred thousand dollars. You say, well, you know that's not much money. It's a lot of money to those folks in a little town -- a little community. And they don't see And they aren't about to see an RTA bus. And no matter what you hear, they're still not going to see an RTA bus or a rail line or anything else. And if there was one come through there, they'd

probably throw rocks at it, because they don't need it. They don't go anywhere in these communities. They're rural communities. They're going to go to the local store. They're not going to go to work in Chicago. Or they're not going to go to work somewhere else. So they're not going to ride the RTA. All they want to do is a chance to - as a couple of people very eloquently put it - no service, no tax. That's all they want. I'd ask an Aye vote.

#### PRESIDENT ROCK:

Question is, shall Senate Bill 62 pass. Those in favor will vote Aye. Opposed, vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 29 Ayes, 18 Nays, 1 voting Present. Senate Bill 62 -- gentleman has requested further consideration of Senate Bill 62 be postponed. So ordered. On the Order of Senate Bills 3rd Reading. Senate -- I beg your pardon? On the Order of Senate Bills 3rd Reading is Senate Bill 64. Read the bill, Madam Secretary, please.

# SECRETARY HAWKER:

Senate Bill 64.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDENT ROCK:

Senator Demuzio.

#### SENATOR DEMUZIO:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 64 is a bill that was instituted by the community of Jacksonville, Illinois. And what this legislation seeks to do is to prohibit a new potential route, or if you would, well or sand or gravel pit from being drilled within twenty-five hundred feet of a community water supply, if that source lies within a

floodplain and is adjacent to public waters. The EPA has worked on this language as well. And to the best of my knowledge and ability to the -- interpret the language, it does say that simply prohibits that -- that drilling within twenty-five hundred feet of a community water supply. And I would seek your support.

Discussion? Senator Macdonald.

#### SENATOR MACDONALD:

Yes. Senator Demuzio, we passed, in the 85th Assembly, a bill by Senator Welch, and it had the two hundred feet Why now, this soon again, are we going into narrowing down even further - within fifty feet of ground service, thirty feet of the base of the land fill. Can you -- can you just fill us in on that?

#### PRESIDENT ROCK:

Senator Demuzio.

#### SENATOR DEMUZIO:

Senator Macdonald, my -- it's my information that, currently, the Statute is a thousand feet. This would increase it to twenty-five hundred feet. That is what the staff informs me the current -- the current law.

# PRESIDENT ROCK:

Further discussion? Senator Schuneman.

#### SENATOR SCHUNEMAN:

A question of the sponsor, Mr. President.

#### PRESIDENT ROCK:

Sponsor indicates he will yield. Senator Schuneman.

#### SENATOR SCHUNEMAN:

Senator, in my community we have a lot of shallow, private And there's something in our staff analysis that leads me to believe this may affect some of those wells that are less than fifty feet below the ground surface. Am I wrong about that? Or

does this only affect, for example, public water supplies? PRESIDENT ROCK:

Senator Demuzio.

## SENATOR DEMUZIO:

That is absolutely correct. You've answered your own question. And that -- it only -- if it affects a community water supply, not private.

Further discussion? Senator Davidson.

#### SENATOR DAVIDSON:

Question of the sponsor.

## PRESIDENT ROCK:

Sponsor indicates he will yield. Senator Davidson.

#### SENATOR DAVIDSON:

Has the Farm Bureau, who objected to this bill in the beginning, have they withdrawn their objection to this bill after the amendments you put on it? Or is their objection still valid? PRESIDENT ROCK:

Senator Demuzio.

# SENATOR DEMUZIO:

Well, I didn't know they were opposing it, but the staff tells me that with the -- as amended, that they have withdrawn their objection. That's what it's being represented to me as of the moment.

#### PRESIDENT ROCK:

All right. Any further discussion? Further discussion? Senator Demuzio, you wish to close? Question is, then, if --shall Senate Bill 64 pass. Those in favor will vote Aye. Opposed, vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, no Nays, 1 voting Present. Senate Bill 64, having received the required

constitutional majority, is declared passed. On the Order of Senate Bills 3rd Reading is Senate Bill 65. Read the bill, Madam Secretary, please.

SECRETARY HAWKER:

Senate Bill 65.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDENT ROCK:

Senator Demuzio.

SENATOR DEMUZIO:

Well, thank you, Mr. President. This bill is a bill that affects veterans of Illinois. It passed the House in the last Session. It was held in our Senate Rules Committee last year. It would authorize the Secretary of State to issue special license plates to veterans for use on passenger vehicles and for pick-up trucks. As you know, we -- under the existing law, there are a number of special license plate recipients that we grant these special plates to. According to the projections by the U.S. Veterans Administration, it would probably be applicable to about 1.2 million veterans who reside in Illinois as of March the 31st of this year. And it simply suggests that the fee schedule remains the same for the special plates as it is now, but it affords the veterans the opportunity to -- to have a special plate as well. And I would seek your support.

## PRESIDENT ROCK:

Discussion? Senator Topinka.

# SENATOR TOPINKA:

Mr. President, and also to the sponsor, I -- I just didn't catch as he went through his -- his presentation. Just how many veterans in the State of Illinois would be affected by this? And what would be the cost of implementing this program?

PRESIDENT ROCK:

Senator Demuzio.

## SENATOR DEMUZIO:

Oh, I'm sorry. Apparently, it is -- it would be applicable only to twenty-seven thousand veterans in Illinois. I -- apparently, according to the staff analysis, was 1.2 million is what I -- is what I indicated. And the cost is that which is applicable to the special veterans plates or special plates that we have -- that we charge right now to the Secretary of State's Office.

#### PRESIDENT ROCK:

Senator Topinka. I'm sorry.

## SENATOR TOPINKA:

I don't think we've come up with the exact dollars and cents figure and things of that sort. But, you know, shouldn't we be doing other things for veterans that are significantly more important than consistently going -- coming up with these license plate bills? And I suppose, beside the cost, and -- and because I think we have so many different veterans groups that would like to segment the driver's license plates under all these circumstance, not to mention I don't what the heck this was doing in the Public Health Committee, because we, generally speaking, don't handle the public health matters of license plates. would like to bring up what I think is probably the most significant problem that we have with these varying license plates - and that is a police problem. According to the State Police, that -- their concern is that it is a constant problem because of the variations of these plates that we're constantly putting on the street, that law enforcement officers cannot necessarily IDs from witnesses or even they themselves have trouble in IDing these plates, because you don't know where they come from. you've got to have these vehicle IDs if you're going to be able to, you know, take these in court and trace down people. The

other problem is — is that they look very similar to sometimes foreign license plates, and that becomes a problem. You also have the problem that with the different colors that are involved, you can't see them as quickly in the light nor in the nighttime. So I would suggest, maybe we could hold back on this, and for once in our lives kind of pull back and give the veterans something that would be much more tangible in terms of benefits or pension considerations — things of that sort, where they're really hurting, rather than coming up with something like this to leave the police always in the state of flux.

#### PRESIDENT ROCK:

Further discussion? Senator Davidson.

# SENATOR DAVIDSON:

Question of the sponsor.

## PRESIDENT ROCK:

Sponsor indicates he will yield. Senator Davidson.

#### SENATOR DAVIDSON:

Two questions, Senator Demuzio. One is, have you've -- if you've given some consideration to making this amended to make it effective in '92 at the request of the Secretary of State, due to the five-year rotation of plates? As you know and I know, the plate that goes on your cars has a life expectancy of five years and you add the stamp. And secondly, is there an additional fee which we did charge, I don't know if we still do, but we used to charge an additional fee for vanity or special plates when we adopted this several years ago. Does that apply to this special plate for the veterans?

## PRESIDENT ROCK:

Senator Demuzio.

# SENATOR DEMUZIO:

Well, the answer to your last question is that the cost is, in fact, the same that which is afforded that other people with

special plates. And the Secretary of State's Office never made such a request to us with respect to phasing this into 1992. We wouldn't have any difficulty in working with the Secretary of State's Office on that, and if this bill leaves here, we'll be glad to put that amendment on in the House. #### PRESIDENT ROCK:

No, you may not. Further discussion? Senator Geo-Karis.

When you say that it's -- there would be -- they're to be issued to retired members of the U.S. Armed Forces. Does it mean any veteran?

# SENATOR DEMUZIO:

Retired members of the armed forces. That's what it -- that's what the definition in the bill is, yes.

#### PRESIDENT ROCK:

Senator Geo-Karis.

# SENATOR GEO-KARIS:

I mean -- do you mean any veteran? If we served, and now we're not in service? Is that what you mean? Now, I happen to be ready -- what they call retired too, but does that mean I would be eligible for a plate?

## PRESIDENT ROCK:

Senator Demuzio.

# SENATOR DEMUZIO:

If you are a retired member of the United States Armed Forces,

yes, you are entitled.

PRESIDENT ROCK:

Senator Geo-Karis.

SENATOR GEO-KARIS:

Well, I can see issuing a special license plate for the survivors of Pearl Harbor. But we never did that, did we, Senator Demuzio?

Senator Demuzio.

SENATOR DEMUZIO:

Well, Senator I -- I don't know the answer to that question, but they didn't make such a request to me, so that's not in this bill. So -- I -- if you want -- if you want to do that, I'd be happy to help you with your bill.

PRESIDENT ROCK:

Senator Geo-Karis.

SENATOR GEO-KARIS:

Why don't you pull it out of the record, and then we'll amend your bill, so we can do it for those people. I think they would deserve it more than we do.

PRESIDENT ROCK:

Further discussion? Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. I'd like to ask the sponsor a question.

PRESIDENT ROCK:

Indicates he will yield. Senator Watson.

SENATOR WATSON:

What does this bill have to do with Public Health, Welfare and Corrections?

PRESIDENT ROCK:

Senator Demuzio.

## SENATOR DEMUZIO:

Well, it's my understanding that it was erroneously referred to that committee. But it was determined that those individuals were just as qualified as any other committee to hear this particular bill. And therefore, since there was some deadlock with respect to this Senate, it had to repose in that committee. I -- I felt very confident that on the unanimous roll call -- that it managed to come out of there. And if they were serving on Transportation or some other committee, we'd probably have been in the same boat.

#### PRESIDENT ROCK:

Senator Watson.

#### SENATOR WATSON:

Yes. I'd like to know who are the two co-chairs of the Committee on Assignments? Will the sponsor of the bill please respond to that?

# PRESIDENT ROCK:

Senator Demuzio.

# SENATOR DEMUZIO:

Well, Senator Watson, in my fifteen years here, it is not unusual for a bill to be assigned to an erroneous committee. The fact of the matter is — is that on a number of occasions, from time to time, we always get up and re-refer bills to other committees. Unfortunately, that didn't — we weren't afforded that opportunity this — this time. And apparently, Senator Watson, your lights are out, and so your time is up. I don't know how else to tell you that.

# PRESIDENT ROCK:

Further discussion? Senator Watson.

## SENATOR WATSON:

Well, I'm not being facetious at all, because this -- we did have some five license plates bills in the Transportation

Committee. And why this went to that particular committee, I don't know, other than that the sponsor is a member of that Committee on Assignments. Would you be acceptable to a amendment that would provide that this bill or this -- the license plates would be vanity plates, as was previously mentioned? Would you accept an amendment?

PRESIDENT ROCK:

Senator Demuzio.

SENATOR DEMUZIO:

Well, Senator, we -- we provide these kind of plates to Prisoners of War, the Illinois National Guard, the U.S. Purple Heart recipients and et cetera, and I, frankly, don't understand, you know, your rationale for coming down so hard on the veterans of the -- of the State of Illinois. There are only twenty-seven thousand. And they should be afforded that opportunity. And if you want to do anything else, why don't put your own bill in? PRESIDENT ROCK:

Senator Watson.

# SENATOR WATSON:

My next question, Mr. President, was twenty-seven thousand Ι probably have that many in my district alone. don't know where you're coming up with those figures, but I think that might be erroneous. One thing that I -- I was a sponsor -the first bill I ever passed, when I was a House Member, was a Prisoner of War license plate bill. First bill I ever passed. So I -- I have no problem with the -- thank you. Thank you. I'm not against veterans, but I tell you - let me just read to you what we've got now coming in regard to special plates. University of Illinois license plates, county sheriffs' -- county sheriffs' license plates, Purple Heart handicapped license personalized recreational vehicle license plates, Constitutional Convention Delegate license plates, Gold Star license plates,

honorary discharged veterans license plates, dishonorable -- no, Pearl Harbor survivor plates. You know, I'm not opposed to this kind of concept, but the proliferation of this just goes on and on and on. And Senator Topinka brought up an excellent point. The law enforcement community is having a real dilemma out there in trying to cope with the number of plates that are identical numbers. So I -- you know, I -- I understand where you're coming from. As I say, I'm not against veterans, but I think you have to someday say enough is enough. And I think this day is now. And I'd urge a No vote.

## PRESIDENT ROCK:

Further discussion? Senator Maitland.

## SENATOR MAITLAND:

Thank you, Mr. President and Members of the Senate. Senator, you -- you may have responded to this question, and if you did, I apologize. But -- but what is a retired veteran? Is it someone on pension? Or what's the distinction there?

#### PRESIDENT ROCK:

Senator Demuzio.

#### SENATOR DEMUZIO:

Well, I think that's a -- that's a good question. And the fact of the matter is, it is twenty years of service in the United States Armed Forces is the person who is retired. And, Senator Watson, with respect to the twenty-seven thousand, that is what I am told is Statewide that fall within that definition.

#### PRESIDENT ROCK:

Further discussion? Senator Severns.

#### SENATOR SEVERNS:

Mr. President, I'm just wondering if we could have a vote on this bill. Senator Netsch has just found out that the Constitutional Convention plates are available. She said she would like to leave. I'm wondering if we could -- I'm wondering

if we could go ahead and have a vote on this bill so she could go get her plates.

## PRESIDENT ROCK:

The Chair is not aware that those plates are available. And they'll have a heck of a time coming over me. Senator Demuzio, you wish to close?

#### SENATOR DEMUZIO:

I just -- I just think that this -- this bill was given to me by the Veterans of Illinois. It's supported by the various veterans organizations around the State of Illinois. It's not some idea that I came up with. It is something that they are very much interested in. And I would hope that we could do something that Senator Topinka indicated, something more meaningful for veterans. Like we opened up their -- all their offices this past year after the administration closed them. That's one of the definitive things that we did in this General Assembly, and simply to afford them the opportunity to have this distinction on their car or their vehicle seems to me to be a small -- a small token of our appreciation to them, too. And I would urge your support.

#### PRESIDENT ROCK:

Question is, shall Senate Bill 65 pass. Those in favor will vote Aye. Opposed, vote nay. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 39 -- 40 Ayes, 9 Nays, 4 voting Present. Senate Bill 65, having received the required constitutional majority, is declared passed. Senator Philip, I think we have reached the point where we've -- at the end of an otherwise long day. Senator Philip.

# SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Just like to remind the entire Membership, Democrats and Republicans, the Governor is hosting a cocktail party at the
